



Born in Dayton, Ohio, 1932; grew up in the states of New York, Michigan, Illinois and Indiana. Graduated from high school in Birmingham, Michigan; attended the University of Colorado from 1950-52. I married Don Roberts in 1953 and came to Anchorage as his bride in April of that year. Don worked as a game warden in Alaska from 1952 until 1979, employed initially with the U.S. Fish and Wildlife Service under Holger Larson in Anchorage, and finishing out his career with the State of Alaska, Department of Public Safety, Fish and Wildlife Protection. We raised four children in Alaska, all of whom now live in Juneau, although our family of six has lived in Kenai, Haines, Kodiak, Juneau, Fairbanks plus five separate times in Anchorage. My husband is now retired from the State of Alaska, and we have built our dream home (and final resting place) on the bluff overlooking Cook Inlet and Mts. Redoubt and Iliamna, on four acres three miles north of Anchor Point on the Kenai Peninsula.

EMPLOYMENT BACKGROUND:

I began working in the medical field as a Jill-of-all-Trades for Doctor Phil Jones, first resident physician in Haines, in 1958. I was called the receptionist, which was a misnomer. In actuality, I sterilized the instruments, attended Doctor Jones during some examinations, answered the phone, ordered the supplies, developed the x-rays, scrubbed the floors, washed and hung the laundry in the basement, scheduled the patients, typed the correspondence, made the coffee, and assisted during emergencies such as sewing up head lacerations and pumping stomachs. It was during this time that I became acquainted with many facets of medicine, most particularly when I sent out the bills and very few paid the doctor! However, the entire territory/State was in a depression and there was little money available.

In 1961, after we moved to Anchorage, I acquired my initial training as a medical secretary working for the State of Alaska, Department of Health, Tuberculosis Control Section. I transcribed medical x-rays reports for Doctor Reitlinger. After a year I was very fortunate to be chosen for employment in the private sector as a medical secretary to Doctor William J. Mills, Jr., orthopaedic surgeon in Anchorage. I stayed with Doctor Mills for two years from 1962 until 1964; this is no small accomplishment as he was known in those days (and perhaps even now) as the "meanest man in Anchorage", a pseudo-tyrant, but he trained me to be a perfectionist. It was an honor for me to have worked for him, going from a part-time medical secretary to office manager.

In 1964 I left Doctor Mills to become office manager and medical secretary to Gilbert P. Blankinship, M.D., internist. It was also during the early 1960's that I worked part-time in the offices of Doctors Tower, Whaley and Zartman, pediatricians, transcribing their medical dictation. I was sorry to leave Doctor Blankinship's office for one year, due to my husband's transfer to Kodiak. There I worked for an attorney, Roy Madsen (now a Superior Court Judge), and for Doctor Bob Johnson. When we were transferred to Fairbanks, Doctor Johnson offered to pay for a housekeeper for

the family's care during the move if I would stay on an extra month to help in the re-organization of his office. I had to decline his kind offer.

Upon arrival in Fairbanks in 1966 I was immediately hired as a part-time medical secretary to the seven physicians at the Fairbanks Medical and Surgical Clinic, founded by Paul Haggland, M.D. and Arthur Schaible, M.D. For the next seven years there I became the full-time medical secretary, and eventually Executive Secretary for the Clinic Administrator and the twenty-five physicians we grew to include. As Executive Secretary I had a multitude of duties, which included the initiation of an In-Service Training Program for all Clinic personnel. In addition, I made up the monthly Call Schedule of the Clinic physicians at Fairbanks Memorial Hospital, a task which required the utmost in tact and finesse. I was the only non-professional clinic employee to attend three Board meetings in the Administrator's absence to take the minutes. When the North Slope first opened up, the Fairbanks Clinic began a program to staff a clinic there. I was in charge of recruiting physicians from the other forty-nine states, handling reams of correspondence with various applicants, checking their credentials, working out the various shifts and schedules for the Slope Clinic, arranged all transportation for the physician coming off the Slope and for the physician going up to the Slope. At the same time I started, under the Clinic's auspices, an in-house newspaper for the information of our one hundred or more employees; I was editor, reporter, layout artist, typist, news gatherer, Xeroxer, collator, stapler and distributor of this eight page weekly. Naturally, the newspaper was medical-oriented.

While at the Fairbanks Clinic I was also put in charge of taking the ICDA and working out the various diagnoses possible in order to set up our new billing forms, so that the forms could be used for filing the various insurance claims. I was well versed in all medical aspects of paperwork, which is copious, including medical records, release forms, Workmen's Compensation, the Fisherman's Fund, the federal forms for F.A.A. and the U.S. Department of Labor, in addition to the usual Medicare, Blue Cross, and various welfare/Medicaid forms, plus their various rules and regulations. I also prepared medical records for court cases. In addition to all of the foregoing, I was given a large computer printout each month from which I garnered work unit statistics in order to inform each of the twenty-five physicians where they were spending their time and talents on a day-to-day basis in the Clinic. This one job required two full days each month, and was an anxiously awaited event, interrupted by numerous phonecalls from the various doctors. I also served on the Profit Sharing Board of the Clinic, and was active in the many Clinic functions and holiday festivities. I was even employed as an "interior decorator". In the flood of 1967 the entire Clinic was flooded, along with most of Fairbanks. I, along with most of the other employees, spent hours mucking out the building and drying out over 30,000 wet and muddy patient charts...years later you could still open a chart and be overcome by the musty smell! Again, we left Fairbanks for Anchorage because my husband was transferred.

So, in 1973 I went to work for Raymond Gills, M.D., an obstetrician and gynecologist. In this employment I had a one-on-one relationship with each of the patients, and performed the usual office functions as the office manager/medical secretary. I left Doctor Gills after two very enjoyable years when my husband was transferred to Juneau in 1975.

While in Juneau I initially worked for Doctor Akiyama, but left his office in order to become secretary to the Lieutenant Governor, Lowell Thomas, Jr.

I worked for Mr. Thomas for five months, with the most notable accomplishment being in charge of the Declarations of Candidacy for two hundred applicants for public offices, i.e., State House and Senate. Again, this involved screening each candidate to see if he/she met the necessary prerequisites in running for office. I learned much about the election process, working hand-in-hand with the Department of Law. Subsequently, three lawsuits were brought against the Lieutenant Governor due to the fact that I had disqualified four applicants. For the first time ever (according to Patti Ann Polley), we won! I spent the next year in Juneau working for attorney Paul Hoffman, with the firm of Robertson, Monagle, Eastaugh and Bradley. We left Juneau in 1977 because...yes, you guessed correctly!...my husband was transferred back to Anchorage.

While in Anchorage I worked initially for Providence Hospital as a medical transcriber. This was an entirely different aspect of the medical world, doing the dictation for over 125 physicians, bringing my experience full circle by having worked in the field of medicine for the private physician, large clinic, State, bush and hospital settings. I had to leave Providence in order to care for my elderly mother, who was ill for seven weeks (and I got more experience there as a "nurse" and "physical therapist"...the patient made a remarkable recovery!) Then I spent a year as a secretary to eight geologists, becoming Office Manager, for "Chuck" Hawley and Associates. When I left there, I became a woman of leisure after twenty-seven working years in Alaska.

I hope you haven't fallen asleep reading this resume! Please feel free to edit this as you wish...I'm just very proud of having worked with some really fine people, and my enthusiasm spills over with the proverbial Alaskan excesses!



In 1962, I completed all work toward the Ph.D. but the dissertation, including general and special examinations, all course work and field work. I then moved to Alaska, had two more children, and had to postpone full-time work.

My field work included one and one-half years at Hanna Pavilion of University Hospitals in Cleveland with outpatient children and both out and inpatient adults. One full year was financed by a training grant from NIMH awarded to me through University Hospitals, as one of two chosen for this placement from my entire class.

At Case-Western Reserve, I was in the top third of the class in my qualifying examinations and had an excellent APA-approved academic education and APA-approved field placement. My major advisor was George Albee, Ph.D., later president of APA. I did part of the research data collection for validating data using the then experimental Reitan Organic Battery under the direction of Dr. Robert Alvarez.

During my training years, I had additional part-time employment doing clinical evaluations for an industrial psychological firm which was a branch of the University Placement Service.

I have had additional conferences in the Mental Development Center in Cleveland, and a Mental Retardation Clinic associated with Case-Western Reserve under the direction of Dr. Jane Kessler, the author of the well-known text, Psychopathology of Childhood. She was also on my Ph.D. committee.

I also visited many Cleveland agencies dealing with delinquent children and had experience with their policies and approaches to child treatment techniques.

Upon coming to Fairbanks, I worked for six years on a part-time basis at the Alaska State Division of Mental Health, Northern Regional Office, in Fairbanks. I was on several occasions offered the full-time position and directorship during the first year there, but had to decline because of young children and family responsibilities. 
