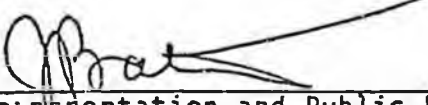
This project is already designed. \$12 million is sufficient to construct the full 3600' causeway, plus the required bridge.

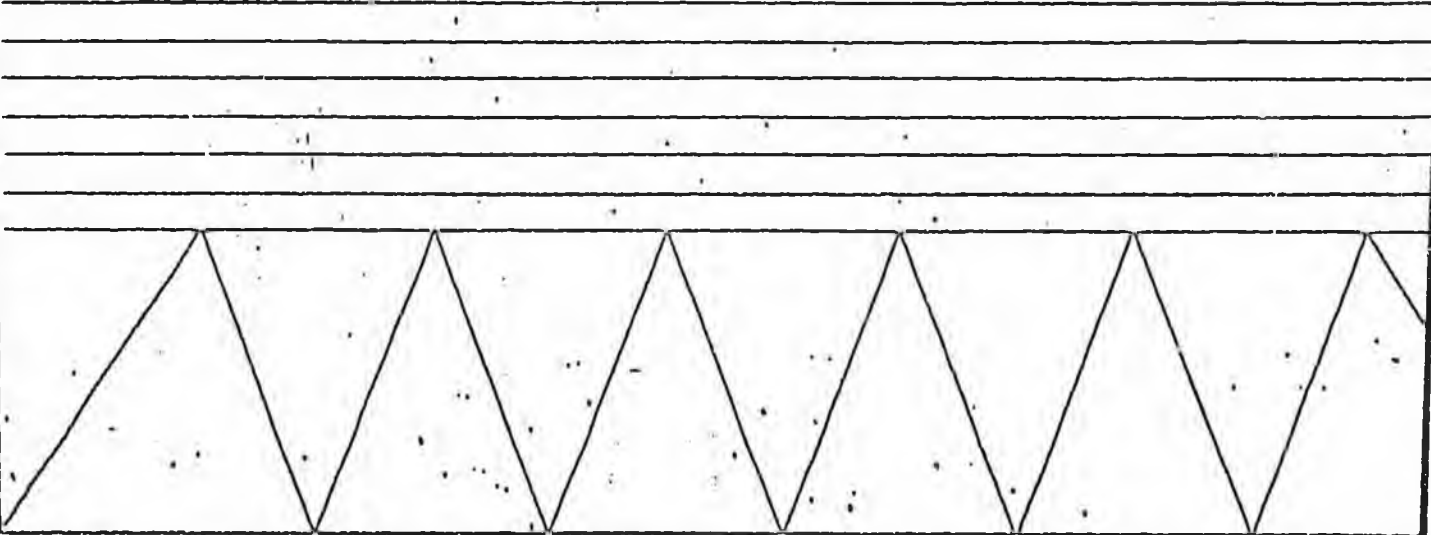

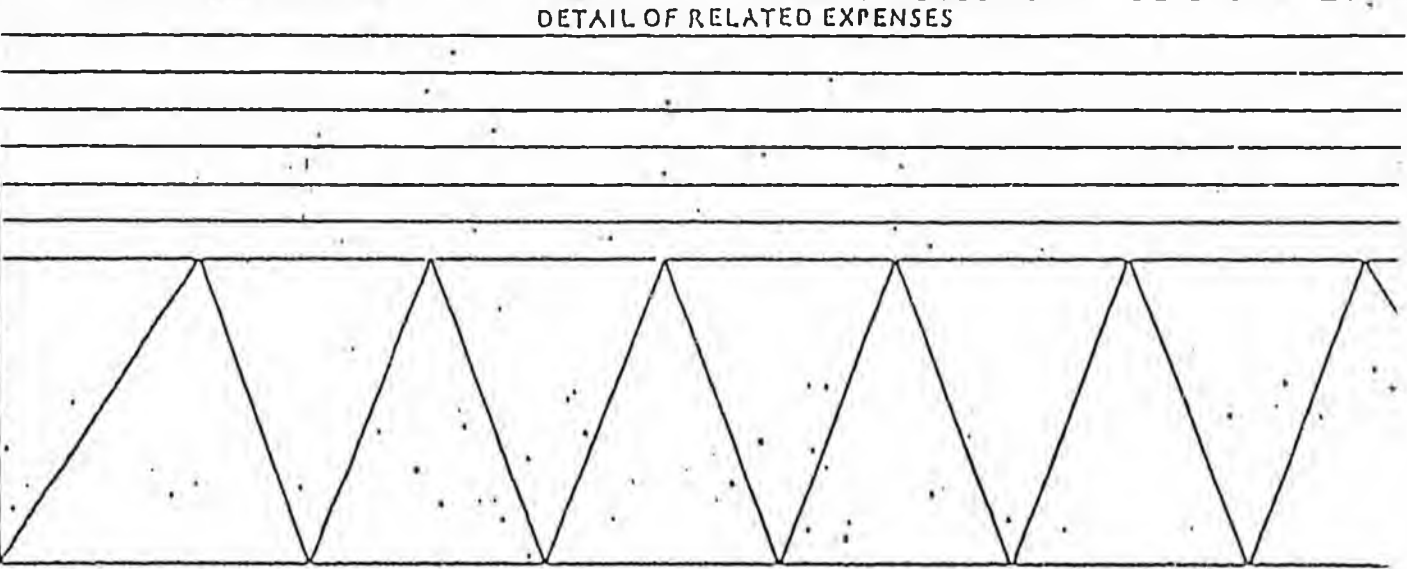

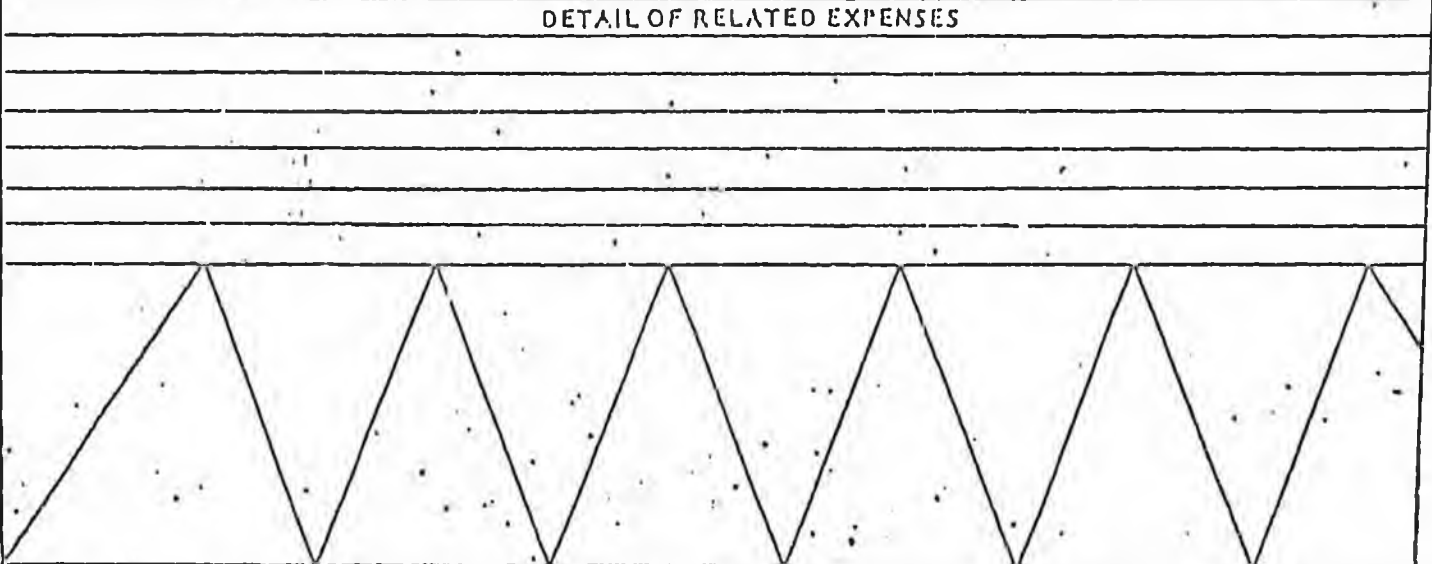
