9 \* Section 1. LEGISLATIVE FINDINGS AND PURPOSE. The legislature finds  
10 that there are insufficient maternal and infant care services available to  
11 women experiencing social and economic difficulties associated with child-  
12 bearing. As a result of these inadequate services, some children may  
13 develop health conditions that require state-supported services throughout  
14 their lives. In order to promote healthier generations of Alaskans, the  
15 legislature wishes to invest in the state's future by providing prenatal  
16 care and social services to pregnant women.

17 \* Sec. 2. AS 47 is amended by adding a new chapter to read:

18 CHAPTER 42. PURCHASE OF SERVICES FOR PREGNANT WOMEN.

19 Sec. 47.42.010. PURCHASE OF SERVICES FOR PREGNANT WOMEN. The

Fiscal Impact Note

The fiscal impact of providing pregnancy related medical care to women without other coverage (i.e. Medicaid, General Relief Medical, Public Health Service or insurance) is estimated to be \$704.0 in FY '84. This impact is based upon the following assumptions.

(1) It is assumed that the intent of this Bill is to provide prenatal outpatient, hospital or birthing center delivery and postpartum medical care which would approximately cost \$2,200 per case (\$750 physician, \$1,450 hospital).

(2) The projected number of births in Alaska for FY '84 is approximately 11,900 assuming an increase of 7% from 1982.

(3) Approximately 475 of the total births would qualify for this service during FY '84. This estimate is based upon experience of a similar service provided through a pilot project at the Fairbanks Health Center during 1981-1982. The project provided financial assistance to 7% of the total births in the North Star Borough. Adjusting the criteria for service to reflect the Department's anticipated definition of social and economic difficulties, approximately 4% would utilize the medical services. Calculating for a 4 month delay in project start, an estimated 320 clients would utilize this service during the fiscal year.

(4) Additional state staff would not be required since the Division of Public Assistance would perform the bill paying, and the Division of Public Health or the Division of Family and Youth Services would provide client intake and eligibility certification.

IV. ANALYSIS:

A. Assumptions

Enactment of this Bill would provide for expansion of pregnancy related health and social services and authorizes State funding of the cost of non-medical service for pregnant women experiencing social and economic difficulties during the prenatal and postpartum periods.

In FY 84 it is estimated there will be 11,800 births to Alaskan residents. 1,900 or 16% will be births to unmarried women.

B. Program Summary

1. Positions - An associate Coordinator, Range 18, would be established to initiate the program on a statewide basis for the initial two years, after which it would be phased out and the duties would be assumed by the regional offices of the Division.

2. Other Expenditures

The Department assumes that the services delineated in this Bill would be utilized mostly by unmarried women. Using this pool as the target group, the Department would further assume that the more youthful unmarried women (ages 13-24) would be more likely to utilize maternity and foster home care; whereas the older group (ages 25-45) would utilize the community services, such as counseling and adoption assistance.

The younger age group consists of 1,346 women. The Department estimates that approximately 190 of this group would avail themselves of the services of a maternity home or foster home (30 maternity and 160 foster), and a total of 300 would utilize available counseling and adoption assistance.

For a Bill entitled: "An Act relating to services for pregnant women; and providing for an effective date."

This Bill provides for expansion of pregnancy related health and social services and authorizes State funding of the cost of non-medical service for pregnant women experiencing social and economic difficulties during the prenatal and postpartum periods. These services are to include adoption assistance, counseling, transportation, care received in maternity and foster homes, and training in parenting skills, as well as birthing centers, midwife services, and postnatal care.

Although the Department offers a wide range of public services, many women experience difficulties and hardships in obtaining timely and adequate pregnancy care. These difficulties are associated with economic barriers to private care and unavailability of many services in rural communities. These gaps in pregnancy related services may be summarized as follows:

1. financial inability of many low income and adolescent women to pay for travel outside of their communities for medically necessary care;
2. fragmentation of the pregnancy care delivery system, that inhibits provision of education, counseling, referral, medical, and follow-up services required by many women;
3. unavailability of many pregnancy-related services in rural communities;
4. lack of appropriate housing near major medical centers, where women from rural communities may stay while obtaining out-patient maternal care services; and
5. insufficient adoption counseling and placement services.

This Bill will expand the types of services available to maternal clients who are experiencing social and economic difficulties associated with childbearing. Medical care services included in this Bill include birthing centers, midwife services, and postnatal care. Since pregnancy related medical services for low income women are already covered by the Division of Public Assistance, the Department assumes the intent of this Bill is to provide the social services related to pregnancy. Therefore, the cost of this program is anticipated to be in the area of social services which come under the Division of Family and Youth Services.

Social services offered will include counseling, placement in a maternity home or foster home, transportation between the client's home and the foster or maternity home, training in parenting skills, and adoption assistance. The Department anticipates that the social services would be contracted out to local community providers, thereby reducing the costs within the Department.

This Bill offers transportation, counseling, adoption assistance, and maternity or foster home care to women experiencing economic and social difficulties associated with childbearing. The Bill at the present time does not include specific definitions of "economic and social difficulties associated with childbearing," but allows the Department to adopt regulations to define those terms. As part of the adoption of regulations process, the Department would plan to conduct public hearings to assist in formulating appropriate standards on which to determine eligibility for services. At this point, it is perceived that draft regulations would define economic need to be up to 200% of the Federal Community Services Administration's Alaska Non-Farm Poverty Guideline (attached), and social needs to include those individuals who are having psychological, emotional, and family problems associated with the pregnancy.

#### RECOMMENDATION

It is the Department's interpretation that the intent of this Bill is to provide non-medical pregnancy related services to women experiencing social and economic difficulties. Since medical care is available to beneficiaries of the Aid to Families With Dependent Children (AFDC) Program, the Department recommends that reference to medical services (birthing centers, midwife, and postnatal care) be deleted. If the legislative intent is to provide additional medical services beyond the scope of current Public Assistance programs, then the Department recommends that reference to other than medical services be deleted.

If this Bill is not adequately funded, the complete services as described in Section 2 cannot be provided to all of those who need and qualify for these services. With reduced fiscal support, the Department recommends that only counseling services be included in Section 2 until a time when sufficient funds are available.

POSITION

The Department recognizes the value of the needed pregnancy-related services that will become available to certain women. We endorse the health promotion concepts of this Bill and feel that it will contribute to the comprehensiveness of pregnancy-related services throughout Alaska, if fully funded.

The costs for the Associate Coordinator position includes: Travel - two trips of three days each to perform program reviews; Contractual - telephone rental and long distance of \$678, postage of \$300, copier usage of \$120, printing and advertising of \$500, and office space rent of \$1,002; and Commodities - \$400 for general office supplies.

A 6% inflation rate has been added to future years' estimated costs. Medical costs will be borne by the Division of Public Assistance.

B. Program Summary

1. Positions - An associate Coordinator, Range 18, would be established to initiate the program on a statewide basis for the initial two years, after which it would be phased out and the duties would be assumed by the regional offices of the Division.

2. Other Expenditures

While this bill offers increased medical and social services for pregnant women, there are several potential problems. The bill does not contain provisions to assure that the State is the payor of last resort after all other third party payors have been approached and found not to be liable for payment.

A second potential problem concerns the provision of medical services. The general intent of the bill is to provide assistance to women seeking to carry their pregnancy to term. If a woman enrolled in this program decides to terminate the pregnancy and is denied an abortion, this bill could be found unconstitutional, because it does not permit equal choice regarding this issue.

Recommendation:

The bill at the present time does not include specific definitions of "economic and social difficulties associated with childbearing," but allows the Department to adopt regulations to define those terms. As part of the adoption of regulations process, the Department would plan to conduct public hearings to assist in formulating appropriate standards on which to determine eligibility for services. At this point, it is proposed that regulations could define economic need to be approximately 125% to 150% of the Federal Community Services Administration's Alaska Non-Farm Poverty Guideline (attached), and social needs to include those individuals who are having psychological and emotional problems associated with the pregnancy.

In order to direct services to those women without other financial resources, the Department recommends the bill be amended to include a provision that all other third party benefits must be exhausted before State funds can be utilized to provide care. This modification will assure that the appropriations under this bill will be utilized as a "last pay" thereby conserving the available funds for those actually experiencing financial difficulties.

It is also recommended that the Department of Law be requested to determine if abortion coverage would be required under the medical care provisions. If the coverage of abortions is confirmed and contrary to legislative intent, an additional amendment concerning the servability of medical care should be considered.

Fiscal Impact Note

The fiscal impact of providing pregnancy related medical care to women without other coverage (i.e. Medicaid, General Relief Medical, Public Health Service or insurance) is estimated to be \$704.0 in FY '84. This impact is based upon the following assumptions.

(1) It is assumed that the intent of this Bill is to provide prenatal outpatient, hospital or birthing center delivery and postpartum medical care which would approximately cost \$2,200 per case (\$750 physician, \$1,450 hospital).

(2) The projected number of births in Alaska for FY '84 is approximately 11,900 assuming an increase of 7% from 1982.

(3) Approximately 475 of the total births would qualify for this service during FY '84. This estimate is based upon experience of a similar service provided through a pilot project at the Fairbanks Health Center during 1981-1982. The project provided financial assistance to 7% of the total births in the North Star Borough. Adjusting the criteria for service to reflect the Department's anticipated definition of social and economic difficulties, approximately 4 % would utilize the medical services. Calculating for a 4 month delay in project start, an estimated 320 clients would utilize this service during the fiscal year.

(4) Additional state staff would not be required since the Division of Public Assistance would perform the bill paying, and the Division of Public Health or the Division of Family and Youth Services would provide client intake and eligibility certification.

This Bill provides for pregnancy related social services to pregnant women experiencing social and economic difficulties. The intent of the Bill is to ensure that women experiencing social and economic difficulties will have services made available to them to enable them to bear healthy children.

DISCUSSION

This Bill removes health related services from earlier versions of the Bill which reduces the cost, and removes potential problems that could have arisen with the inclusion of health related services. Thus, the Bill now makes available counseling; adoption assistance; maternity home and foster home care, as well as the transportation costs associated with bringing women from outlying villages to maternity homes or foster homes; and parenting skills training. Such services will enable women to learn the skills that are involved in parenting and enable them to decide whether they wish to parent their infants or release them for adoption.

This Bill also requires the Department to adopt regulations to implement this program. As a part of the regulation adoption process the Department would hold public hearings to assist in formulating appropriate standards on which to determine eligibility for services. At the present time, the Department anticipates defining economic need at approximately 150% of the Federal Community Services Administration's Alaska Non-Farm Poverty Guideline (attached), and social needs to include those individuals who are having psychological and emotional problems associated with the pregnancy.

Testimony for HB 39

My name is Ann Mattson, and I am President of Pregnancy Aid, an organization begun to assist women in crisis pregnancy. I am here in support of HB39.

Although we are only in the developing stages of our organization, we have seen the need in our community for the services mentioned in this bill. Our organization began because several women saw the need to provide alternatives to pregnant women, support for those who wish to carry their pregnancy to term. We have had a few referrals for emotional support and assistance and provided maternity and infant clothes and equipment for single parents, economically disadvantaged and teenage mothers. In Juneau alone there were 34 teenagers which gave birth between 1978-1981. National statistics state that 9 out of 10 pregnant teenagers opt to keep their babies. There are virtually no programs to teach these young parents how to care for and raise these children or how to deal with the stress inherent in parenting.


A program for training teenage parents at John Hopkins had excellent results with no incidents of child abuse among those parents, most went on to finish school and there were few incidents of repeat pregnancies.

Proper prenatal care is very important, but post natal assistance in the form of education in parenting skills, proper nutrition, and simple infant care techniques is needed.

Money spent to help these women pre and post natally will be money well spent. In fact I believe it will be money saved. If these women are helped to have a healthy pregnancy, they will have healthy babies. If they are helped to deal with the stresses of parenting in a difficult situation and taught these skills, they will have emotionally healthy and stable children. We will not be spending money on a life time of support for preventable physically or psychologically damaged child.

I urge passage of this bill.

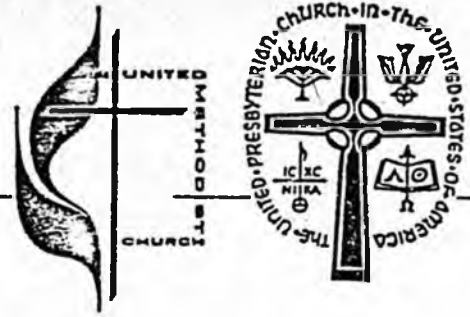

Last year, as you may recall, there was a bill in the legislature called HB 330, which while not dealing directly with the abortion issue, offered a state-funded alternative to abortion for low-income women. The bill provided state funding for prenatal care and counseling, delivery and post-natal counseling in parenting skills or adoption assistance if desired.

The bill passed the House, and all committees of referral in the Senate, but tragically it was awaiting placement on the Senate calendar for final action when the 12th Legislature ended.

I very much affirmed the concepts of HB 330. I understand a similar bill is now before the House Health Education and Social Service Committee. I hope you will move this bill forward quickly, so there is no chance it will again this year miss becoming law due to the ending of the legislative session.

Essentially, the bill makes it possible for poor women who become pregnant to have the same options which other women do. I believe this is good legislation aimed at aiding persons at a uniquely crucial stage of life.

I would like to take this opportunity to express my appreciation and support for House Bill 39.


As the Administrator for The Salvation Army Booth Memorial Home, I have spoken with many of you about the needs that we have in the area of adolescent pregnancies in the State of Alaska. In checking our statistics each year, in 1981 we had to say "no" to 228 young pregnant girls throughout the State of Alaska because of lack of funding. That figure grew in 1982 to 274 and we see the figure will continue to grow.

We at present do have a small grant of \$49,000 from the Municipality of Anchorage, to help alleviate the problem in Anchorage. Needless to say, with only \$49,000 and with only the Municipality of Anchorage involved, our services are extremely limited. However, we do have the facilities and staff to try to enlarge this to statewide, where we could provide the medical care, counseling and support for these young women in need. In 1982, our youngest unwed mother was 11 years of age and the average age is approximately 14 years, 9 months. Something needs to be done!

If I can provide you with any other information or be of any support help, please feel free to call upon me in this very crucial matter for us working with adolescent unwed mothers.

Per your questions of February 18, 1983 pertaining to State-funded abortions, I have obtained the following information from the Division of Public Assistance. Between January 1, 1982 and June 30, 1982, one hundred and fifteen (115) abortions were paid for through the State funded General Relief Medical program for a total cost of \$112,231. In annualizing these figures, the Division of Public Assistance projected 276 State funded abortions in calendar year 1982 for a total estimated cost of \$269,354.

In June, 1982, the Division of Public Assistance converted from a manual to an automated payment system. Because of time lags in processing payments through the new system, Public Assistance felt it would be more accurate to make projections based on the five month period than to use information from the new system which may contain distortions attendant to system start-up.

I would like this opportunity to respond to the Health Education and Social Services Committee request for additional information concerning House Bill No. 39, "An Act relating to services to pregnant women." At the February 16, 1983 hearing, the committee requested clarification concerning the following items:

1) The committee requested a budgetary estimate for providing pregnancy related medical care to women addressed by this bill.

Assuming that the intent of this service would be to provide medical care to women who do not have access to other resources, (i.e., Medicaid, General Relief Medical, private pay, Public Health Service or other insurance) an estimated cost would be \$1,176,000 for FY 84. This estimate is based upon utilization experience by a similar service provided through a pilot project at the Fairbanks Health Center. During 1981-1982, the project provided medical care financial assistance to approximately 7 percent of the total births in the North Star Borough. Assuming that the total number of births in FY 84 will be approximately 12,000, it is estimated that 840 women would qualify for this service at an average cost of \$1,400 per client. Additional state staff would not be required if the Division of Public Assistance would perform the bill paying, and the Division of Public Health would provide client intake and eligibility certification.

2) The committee requested information concerning the state expenditures for abortions, the number provided and the criteria for those receiving state assistance.

The number of abortions provided by the General Relief Medical program during calendar year 1982 is estimated to be 276, with an approximate total expenditure of \$269,354. The criteria for General Relief Medical assistance is \$300 monthly income for one adult, plus \$100 for each additional in adult only households; and \$350 for parent plus 1 child with \$50 for each additional child in parent/child households.


3) The committee requested identification of possible budget reductions in the social services fiscal note to be investigated.
