SECTIONAL ANALYSIS FOR HOUSE BILL 166

An Act making a special appropriation to the Department of Fish and Game

Section 1

Appropriates the sum of \$50,000 to the Department of Fish and Game for the transplanting of elk to Zarembo Island near Wrangell or other appropriate locations in Southeast.

Section 2

Any unexpended or unobligated portion of this appropriation lapses into the general fund on June 30, 1986.

Section 3

Effective date is on the effective date of House Bill 165.
