6 For an Act entitled: "An Act changing the name of the Alaska State Housing
7 Authority."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 18.55.020(a) is amended to read:

10 (a) There is created in the Department of Commerce and Economic
11 Development the Alaska State Building [HOUSING] Authority consisting
12 of the commissioner of commerce and economic development or the com-
13 missioner's [HIS] designee and four residents of the state.

14 * Sec. 2. To be consistent with the change made by sec. 1 of this Act,
15 wherever in the Alaska Statutes and in regulations adopted under those
16 statutes "Alaska State Housing Authority" is used, it shall be read as
17 referring to the Alaska State Building Authority. Under AS 01.05.031 the
18 revisor of statutes shall implement this section in the statutes, and,
19 under AS 44.62.125(b)(6), the regulations attorney shall implement this
20 section in the administrative regulations.

SECTIONAL ANALYSIS FOR SENATE BILL 333

An Act changing the name of the Alaska State Housing Authority

Section 1

Changes the name of the Alaska State Housing Authority to the Alaska State Building Authority. This name change would give the Authority the power to sell bonds for things other than housing.

Also allows the Commissioner of Commerce, who currently sits on the ASHA Board, to appoint a designee.

Section 2

Authorizes the revisor of the statutes to institute this name change in the statutes without specifically having to list each change. This change shall also be implemented in regulations by the regulation attorney.

There is no fiscal impact.
