10 * Section 1. The sum of \$2,700,000 is appropriated from the general
11 fund to the Department of Commerce and Economic Development for the neigh-
12 borhood revitalization and development fund (AS 44.33.431).

13 * Sec. 2. This Act takes effect on the effective date of an Act estab-
14 lishing the neighborhood revitalization and development fund that is
15 enacted by the Fifteenth Alaska State Legislature.
