8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

\* Section 1. AS 21.36.090(d) is amended to read:

(d) A person may not practice or permit unfair discrimination

11

against a person who provides a service covered under a group disabil-

12

ity policy that extends coverage on an expense incurred basis, or

13

under a group service or indemnity type contract issued by a nonprofit

14

corporation, if the service is within the scope of the provider's

15

occupational license. In this subsection, "provider" means a state

16

licensed physician, dentist, osteopath, optometrist, chiropractor,

17

nurse midwife, advanced nurse practitioner, naturopath, physical

18

therapist, or occupational therapist.
