CS for SB 330 (Finance)

It is the intent of the Senate Finance Committee that this bill be enacted by March 1, 1988, to give the Department of education and school districts adequate notice of their FY 89 funding levels prior to their April 1, 1988, budgeting deadlines.

It is also the intent of the Senate Finance Committee that the foundation program and the pupil transportation accounts be funded at 100 per cent entitlement and that the appropriation in CS for SB 330 (Finance) be adjusted upward if additional testimony and research indicates the need to make this increase to provide full funding for public education.

SENATE BILL 330

"It is the intent of the Senate Finance Committee that this bill be enacted by March 1, 1988, to give the Department of Education and school districts adequate notice of their FY 89 funding levels prior to their April 1 budgeting deadlines.

It is also the intent of the Senate Finance Committee that the Foundation Program and Pupil Transportation accounts be funded at 100 percent entitlement and that the appropriation in Senate Bill 330 be adjusted upward if additional testimony and research indicates the need to make this increase to provide full funding for public education."
