6 For an Act entitled: "An Act making appropriations for the state revenue  
7 sharing program and municipal assistance program; and  
8 providing for an effective date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 \* Section 1. The sum of \$53,199,000 is appropriated from the general  
11 fund to the Department of Community and Regional Affairs for the state  
12 revenue sharing program (AS 29.60.100) for the fiscal year ending June 30,  
13 1989.

14 \* Sec. 2. The sum of \$73,176,100 is appropriated from the general fund  
15 to the municipal assistance fund (AS 29.60.350) for the municipal assis-  
16 tance program (AS 29.60.350 - 29.60.375) for the fiscal year ending  
17 June 30, 1989.

18 \* Sec. 3. The unexpended and unobligated portion of the appropriations  
19 made by this Act lapse into the general fund June 30, 1989.

20 \* Sec. 4. This Act takes effect July 1, 1988.
