14 WHEREAS the legislature must give consideration to levels of outstand-
15 ing public debt in making decisions regarding state finances;

16 BE IT RESOLVED that the Senate directs the Senate Advisory Council to
17 conduct a study of outstanding bonded and other indebtedness of the state
18 and its political subdivisions and to submit a report to the Senate on the
19 first day of the First Session of the Sixteenth Alaska State Legislature
20 identifying outstanding public debts, when each was acquired and is ex-
21 pected to be paid in full, and what the debt was used to finance.
