After line 29, add the following:

FURTHER RESOLVED that the Legislature respectfully request the Governor to direct the Division of Personnel to formally recognize the certified professional secretaries as "exceptionally qualified" and to explore methods of adequately compensating employees who attain this designation.

Lines 22 and 23: Change dates; also, it is Professional, not National Secretaries Week/Day, so these lines should read:

WHEREAS April 25-29, 1988, is Professional Secretaries' Week and April 27 is Professional Secretaries Day;

Lines 28 and 29: Change dates, to read:

...to designate April 25-29, 1988, as State Secretaries' Week, and April 27, 1988, as State Secretaries' Day.
