10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 \* Section 1. The sum of \$275,000 is appropriated from the general fund  
12 to the office of public advocacy in the Department of Administration for  
13 payment of outstanding vendor claims and interest for fiscal years 1988 and  
14 1989.

15 \* Sec. 2. The unexpended and unobligated portion of the appropriation  
16 made by this Act lapses into the general fund June 30, 1990.

17 \* Sec. 3. This Act takes effect immediately under AS 01.10.070(c).
