6 For an Act entitled: "An Act making supplemental appropriations to the  
7 Department of Law for oil and gas litigation; and  
8 providing for an effective date." \*

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 \* Section 1. The sum of \$747,600 is appropriated from the general fund  
11 to the Department of Law for expenses incurred in the litigation of oil and  
12 gas matters for the fiscal year ending June 30, 1989.

13 \* Sec 2. The sum of \$7,858,200 is appropriated from the general fund  
14 to the Department of Law for expenses incurred in the litigation of oil and  
15 gas matters for the fiscal year ending June 30, 1990.

16 \* Sec. 3. This Act takes effect immediately under AS 01.10.070(c).
