I. Ruth Apgar

Ruth Apgar is a state employee with the Division of Family and Youth Services. Contact with to the Department of Health and Social Services has indicated that she is a General Government Unit member (ASEA).

Division of Election records indicate that Ruth Apgar registered as a Republican on January 7, 1992. Election records further indicate that she participated in the 1990 primary and general elections as well as the 1992 primary and general election. Prior to January 7, 1992, election records indicate Ms. Apgar was registered as a Democrat. A copy of her 1984 voter registration card is in the file.

The *Anchorage Daily News*, 1/14/93 edition, printed an article which raised the question of her and her husband's involvement in walrus ivory smuggling in 1980. According to the story, Ruth was not prosecuted after she agreed to testify for the government. The article quoted Ruth as saying "I had a feeling we were not on the up-and-up in what we were doing". The article further indicated that the ivory case is irrelevant to her nomination because she was never found guilty. The article then quoted her as saying "I took a course in ethics and the law through U of A, so I know a little bit about ethics." She concluded by saying "there was no way under the sun that this had anything to do with ethics whatsoever."

Ruth was quoted in the *Juneau Empire*, January 19, 1993 edition as saying that the lack of Senate appointees to the panel is unfortunate "because it looks as if things are moving beyond us that need attention." She conclude by saying "If he in fact was using police and troopers for personal reasons, and I

don't think we know if it was personal or not, then we might want to do some investigating."

Since the initial article in the *Daily News*, a couple of letters to the editor have appeared (copies in file) and we have received a copy of a page cut of a book titled "GAME WARS", written about the Fish & Wildlife Protection Agencies pursuit of poachers. Within the article is a reference to the Apgar's and their dealings with illegal ivory.

Additionally, in your file is a letter received from a Ms. Sally McClellan, regarding Apgar.

On Monday, February 1, 1993, the Department of Public Safety completed a routine criminal background check using the NCIC computer system. No criminal history was reported.

II. Jack P. Curry

Review of his credentials indicates that Jack Curry moved to Juneau, Alaska sometime in 1991 when he accepted a teaching position with the University of Alaska Southeast.

Division of Election records indicate that Jack Curry registered to vote as a Republican in the State of Alaska on October 10, 1992, for the first time. Several attempts were made to check voter registration/history with the State of Washington, Division of Election Services, in Olympia, Seattle, and Tacoma. No record of voter participation was found.

Following negative results from Washington, Jack was contacted and he advised that he "had not registered or participated in the election process in the past 10 to 12 years while living in Washington.

Curry is a full-time Associate Professor at the University of Alaska Southeast. The legislature provides necessary funding for University programs.

Upon review of his application, Jack Curry appears to be an average citizen with a background in ethical standards as they relate to the banking industry.

On Monday, February 1, 1993, the Department of Public Safety completed a routine criminal background check using the NCIC computer system. No criminal history was reported.

III. Rodman Wilson

In his letter accompanying the application, Rod Wilson indicated that he helped APOC critique a proposal on legislative ethics that came before the

legislature in 1990. He further stated that he "gained" familiarity with the way the legislature works and the way legislator's behave.

Election records indicate Rod Wilson has been registered as a Democrat since June 6, 1975. He has participated in the election process at least since 1984 and has been a candidate for public office twice, in 1988 and 1990.

Dr. Wilson has served on the board of the Alaska Public Offices Commission and was prior to that the Public Health Director in Anchorage, under Mayor Tony Knowles.

Communications with staff at the APOC indicate that Rod was an exemplary member who was able to form un-biased opinions and served in his position well.

Records at APOC do not show a written critique of any legislative ethics proposal. Dr. Wilson was contacted and he advised that he wasn't sure if any critique was every signed and mailed, but that he would check his file.

In the January 19, 1993 edition of the *Juneau Empire*, he was quoted as saying "This type of conduct, if it's true what I read in the paper, broadly would come under scope of this thing,"... "It's incorrect to try to get in someone's room and doubly incorrect to try and get law enforcement to do it. That's my initial assessment".

On Monday, February 1, 1993, the Department of Public Safety completed a routine criminal background check using the NCIC computer system. No criminal history was reported.

IV. Margie MacNeille

Margie MacNeille was a member a member of the Legislative Ethics Committee which was in place prior to January 1, 1993. She had served on that Committee for 4 years.

Division of Elections records indicate she registered to vote on June 6, 1975 and participated in the election process, at least since 1984.

Ethics Committee records indicate that Margie participated in the rendering of 4 advisory opinions during the 16th Legislature. The opinions rendered dealt with:

1. Disclosure of travel and hospitality gifts from entities other than individuals.
2. Reporting representation by other attorneys in a law firm.
3. Propriety of accepting gift for service to corporation.

4. Disclosure of travel and hospitality paid for by the executive branch of state government.

As of this writing, we have not had the opportunity to review any advisory opinions, if any, from the 17th Legislature.

On Monday, February 1, 1993, the Department of Public Safety completed a routine criminal background check using the NCIC computer system. No criminal history was reported.

V. **Niel (Daniel D.) Thomas**

Division of Election records indicate that Niel initially registered to vote in Alaska on July 22, 1975 under the affiliation of Undeclared. On August 24, 1986, he changed his mailing address and party registration to Democrat. On August 13, 1992, Division of Elections records indicate Niel changed his address and Party affiliation back to Undeclared.

Upon review of his application packet, it was observed that he has written an article how ethics can complicate real estate transactions. On the surface, nothing appears to indicate a particular bias or leaning of one sort or another.

On Monday, February 1, 1993, the Department of Public Safety completed a routine criminal background check using the NCIC computer system. No criminal history was reported.



I am writing this letter of recommendation in reference to Ruth Apgar's application for the Probation Officer position at Kotzebue.


In my capacity as an Alaska State Trooper, I have known Mrs. Apgar and worked with her on numerous DFYS-related cases over the past few years. As a Social Worker for DFYS, many of her cases involved sexual abuse or other types of injury to children, which often required criminal investigation. We have frequently traveled to the villages together in the course of those investigations and I have had many opportunities to observe Mrs. Apgar's skills in conducting interviews of the most difficult type, her ability to establish rapport with people, whether victimized children or hostile adults, and her willingness to accept the adversities of travel to the outlying villages.

I have found Mrs. Apgar to be capable of aggressive pursuit of what is right in carrying out her duties, and I have often seen her take a firm stand toward that end when it would have been easier for her to settle for less satisfactory, albeit acceptable, results. Mrs. Apgar accomplishes those goals without appearing pushy or lacking in objectivity, and maintains a level of courtesy and compassion in dealing with people in unpleasant circumstances.

As a Social Worker, Mrs. Apgar often participates in court proceedings and so has experience with the complexities of the Judicial System which would be of value toward her role as a Probation Officer. I am aware that the duties of a Probation Officer include making recommendations to the court at felony sentencings, and that to do so properly one must understand the sometimes complicated concepts upon which such sentences are calculated. Mrs. Apgar has demonstrated that she is an intelligent woman capable of grasping those concepts.

In summary, I believe that Ruth Apgar possesses the traits of industry, compassion, intellect, and courage, all vital toward performing the duties of Probation Officer, particularly in a remote area such as Kotzebue.

Dear Sir,

I was shocked to hear that Ruth Apgar was nominated for the ethics committee. I must question her qualifications for this committee.

About two years ago, on several occasions I overheard a woman, apparently a counselor or social worker, discussing her clients and co-workers with others at her table at the Nul luk vik restaurant here in Kotzebue. I later learned that this woman was Ruth Apgar.

I'm a retired teacher. One day, after Ms. Apgar was identified, a student of mine stayed after school and mentioned an abusive situation at her home. I discussed the matter with my principal as I had to do. I asked him to avoid Ms. Apgar. I did not want my student's problem to become restaurant gossip.

Then, last year, another student reported abuse in her home to a fellow teacher. That teacher and I went to our principal since both students had mentioned the same problem with the same adult. The other teacher reported her concern about Ms. Apgar since abuse has to be reported to a social worker.

My fellow teacher, Sandy Kawalski, teaches at Kotzebue Middle School where I taught until my retirement after the 1991-'92 school year.

Mrs. Kawalski was in Anchorage last weekend but I left your name and address in her box at school. I've suggested that she contact you with her concerns about Ruth Apgar.

There are many deserving ethical people in Kotzebue. Ms. Apgar unfortunately is not one of them.

Ethics panel nominee may be questioned on trafficking charge

Ruth Apgar, one of five citizens nominated to Alaska's legislative ethics committee, may face questions during confirmation hearings about federal charges she trafficked in illegal walrus ivory in 1980. She was accused of help-

ing deliver more than 200 pounds of raw walrus tusks from Alaska to an undercover federal wildlife agent in Louisiana, according to court documents. The resulting criminal charges were dismissed after she

agreed to testify for the government, according to Apgar and the court papers.

Rep. David Finkelstein, D-Anchorage, an ethics committee chairman for the last four years, said Wednesday that Apgar's alleged violation of the Marine Mammal Protection Act merits inquiry, although she was not

convicted of wrongdoing. "The point of this committee is to create confidence with the public," Finkelstein said. "If there's any doubt about any of the nominees, it would reduce that confidence and I'd certainly want to give her the chance to eliminate any doubts that exist."

The U.S. Fish and Wildlife Service also charged her husband, Steve Apgar, and Kurtis (Kev) Kosters, their partner in a pizza venture, according to court documents. The three were accused of selling illegally harvested walrus tusks. **Page B-1, ETHICS**

walrus tusks. Steve Apgar was convicted and served probation, he said.

Kosters successfully appealed a civil ruling, because the government didn't prove the walrus tusks he sold to a Louisiana ivory dealer working with federal agents were harvested after the law went into effect.

Ruth Apgar told Administrative Law Judge E. Kendall Clarke in a 1983 hearing that she and her husband bought the ivory from hunters on St. Lawrence Island in the Bering Sea, then she helped Kosters deliver it to the dealer in New Orleans.

"I had a feeling we were not on the up-and-up in what we were doing," Ruth Apgar told Clarke, according to transcripts of the hearing in Skagway. "But I had no idea the extent of the crime we were committing at all."

Apgar, 34, was chosen earlier this month to serve on the nine-member panel under new ethics-reform legislation that gives citizens a majority of the committee's seats as well as control of the chair. The committee will be responsible for holding lawmakers to high standards of ethical behavior.

The ivory case is irrelevant to her nomination, Apgar

said, because she was never found guilty.

"That was totally dismissed," she said in a telephone interview this week from Kotzebue, where she works as a state child abuse investigator.

"I took a course in ethics and the law through U of A, so I know a little bit about ethics," Apgar said. "There was no way under the sun that this has anything to do with ethics whatsoever."

Her husband, Steve, added, "She never did anything, I did."

Sen. Al Adams, a Democrat who represents the Kotzebue area, didn't know about the case but didn't think it mattered, said one of his aides, Martha Stewart.

"He doesn't know Ruth well, he knows who she is, he has no problem with her being on the ethics commission," Stewart said. "The senator is one for not holding things like that against people's characters forever."

Apgar said the case never struck her as something worth bringing up on her application. Applicants to the ethics panel were not asked to report non-political activities that may be subjected to ethical scrutiny, Finkelstein said.

"That wasn't a question on the application," Apgar

said. "As far as I'm concerned, there was no problem."

Alaska Supreme Court Chief Justice Daniel Moore picked Apgar and four others out of 84 citizens who applied to serve on the panel. Moore didn't return a call Wednesday asking for comment on the criteria he used to pick the nominees.

Finkelstein said he will ask Apgar for an explanation if he is allowed to participate in her confirmation hearing.

The ethics panel that he headed no longer exists, so the job of holding confirmation hearings will go to another committee. House Speaker Ramonn Barnes hasn't yet made the assignment and won't do so until later this week, according to her office.

Eye of the storm: Jacko flap has lawmakers talking politics

Senators fumbled today when passed the ball in determining their role in a possible investigation into Sen. George Jacko's weekend attempt to gain entry to the hotel room of a female legislative aide.

Senators went into closed-door caucuses this morning after the majority and minority could not agree on appointments to the Ethics Committee, which could be called on to investigate Jacko's conduct.

At least two senators have said they want an investigation into the incident.

In addition to calling police for assistance in gaining access to the woman's room Saturday morning, Jacko asked the desk clerk at the Driftwood Lodge for a key.

Jacko and the woman were guests at the Willoughby Avenue motel.

The Pedro Bay Democrat also pounded on the aide's door repeatedly and called her room in the early-morning hours, said Lucy Perreard, who was working the front desk.

Though the police incident report says Jacko said he needed to talk with the woman on official legislative business, the senator has denied that report. The Empire has requested from Juneau police a copy of the taped phone calls from Jacko.

Though no complaint has yet been filed with the Ethics Committee, the panel could instigate its own investigation.

Senate Democrats today said they want Sen. Suzanne Little, D-Soldotna, as their member on the panel, but Senate President Rick Halford, R-Chugiak, bypassed the

minority's recommendation and asked for Sens. Jay Kerttula and Mike Miller.

Kerttula, a Palmer Democrat, is a member of the minority; Miller, a North Pole Republican, belongs to the GOP-controlled majority. Jacko was the lone Democrat to defect to the GOP majority coalition, giving them control of the Senate.

Jacko was trying to gain entry to the room of an aide to Little, and Halford said that connection concerns him in Little's appointment to the panel that could investigate Jacko.

The legislative aide declined comment today.

Jacko has declined to discuss the incident further.

Senate Minority Whip Judy Savo, D-Kenai, said Little had been selected before this weekend's incident.

During a break in today's closed-door meetings, Senate Minority Leader Jim Duncan, D-Juneau, said Democrats still want Little.

The legislative ethics law sets up a panel with five public members, plus two from the House and two from the Senate split between the minority and majority in each chamber.

The House panelists are men, and three of the five public members are men. "We feel it is particularly important that there should be gender balance of the ethics committee," Duncan said.

Senate Majority Leader Robin Taylor, R-Wrangell, and Halford said politics are behind the nomination conflict.

"I need to go on the floor and try to figure out how to keep this body from tearing its guts out," Taylor said before the start of today's floor session.

The political process is complicated by the reality that Halford needs a two-thirds majority for confirmation of ethics panel appointments, meaning he needs at least three minority members to go along with his selections.

Salo and Duncan were prepared to speak on the Senate floor this afternoon, calling for an interim committee to investigate the weekend incident.

Four of the five public appointees to the Ethics Committee said today the Jacko situation was the type of incident that would likely fall under the the new ethics law.

"This type of conduct, if it's true what I read in the paper, broadly would come under scope of this thing," said Rodman Wilson of Anchorage. "It's incorrect to try to get in someone's room and doubly incorrect to try and get law enforcement to do it. That's my initial assessment."

The lack of Senate appointees to the panel is unfortunate "because it looks as if things are moving beyond us that need attention," said nominee Ruth Apgar from Kotzebue.

"If he in fact was using police and troopers for personal reasons, and I don't think we know if it was personal or not, then we might want to do some investigating," Apgar said.

Under the rules, only the Senate and public members would sit in judgment on a senator's case. Any penalties would have to be approved by the full Senate.

While the Senate debates its role in the matter, further details of the incident show Jacko's persistence went beyond calling police to gain entry to the room.

He asked for a key at about 3:30 a.m. Saturday, desk clerk Lucy Perreard said Monday. "He just persisted over the next two hours," she said. "He wanted into the room bad."

Perreard said Jacko did not seem agitated and was not rude, but didn't seem reasonable either. Although he was a guest at the Driftwood, Jacko refused to identify himself, Perreard said.

The police report said the incident involved alcohol and Jacko has admitted to consuming a couple glasses of wine.

Perreard said Jacko smelled of alcohol and seemed intoxicated.

Jacko made two or three requests for the key, and Perreard turned him down, citing hotel policy and common sense. "When someone comes to the desk at 3:30 in the morning, you just don't give out a room key," she said.

When Perreard would not give him a key, Jacko asked her to enter the room and contact the woman, Perreard said. The clerk refused.

He also tried more direct approaches.

"He pounded on the door all night long," Perreard said, "hard enough that I could hear it in the front office."

The woman's room is near one end of the L-shaped complex. The office is near the middle. The pounding also prompted another guest to call the office and ask whether someone was breaking

into the room, Perreard said.

Jacko also called the woman's room repeatedly. The woman finally took her phone off the hook, Perreard said.

Though Jacko said he "really needed to talk" to the woman, he did not say why, Perreard said. "It was personal," she said. "I don't think business was discussed at 3 in the morning."

In his first call to police, Jacko said he needed to talk about legislative business with the woman. On his second call to police from a phone in the hotel office, the senator was "throwing his name around," said Perreard, who overheard Jacko's end of the conversation.

Police said that Jacko later admitted during the second call that his request involved personal business.

"I remember him backtracking," she said. "I'm not going to say that he did say it was official business."

Jacko made the second call after police visited the hotel, determined that the senator's request was personal, and declined to help him.

Jacko's second call to police actually was for the Alaska State Troopers, whose number rings at the Juneau police department on weekends.

City-borough officials are reviewing media requests for access to tapes of both calls.

Police Capt. Mel Personett said the tapes will not be released until a supplemental report is completed by the investigating officer and municipal attorneys decide the tapes are not evidence in a criminal case.

The city-borough law department also is weighing concerns about the legislative aide's privacy. The tapes may have to be edited to remove her name and any references to her, municipal attorney John Corso said.

"I think that the senator ought to be prepared anyway for the possible release of information," Corso said.

Apgar poor choice for ethics

Ruth Apgar submitted herself as candidate for a seat on an Alaska state committee formed to "hold lawmakers to high standards of ethical behavior." Now it is revealed that she and her husband were accused of transporting and selling some 200 pounds of illegal ivory back in 1980. Although her husband was convicted, Ms. Apgar avoided prosecution by agreeing to be a witness for the government.

I don't necessarily believe that one should be forever branded dishonest because of one incident. Therefore, let's evaluate Ms. Apgar via her own comments in the Daily News.

As to her knowledge that the ivory trafficking was illegal: "I had a feeling that we were not on the up-and-up in what we were doing."

As to its relevance to the ethics committee position: not relevant, she says, she was never found guilty.

As to her qualifications for the ethics committee: "I took a course in ethics and the law through U of A, so I know a little bit about ethics."

As to what she learned about ethics: "There was no way under the sun that this had anything to do with ethics whatsoever."

As to why the ivory affair was never mentioned in her application, she said it never struck her as worth bringing up.

Alaskans have the right to expect that the members of an ethics committee be a cut above average in the integrity department. Realizing that perfection is unattainable, we

should at least be able to avoid those who take refuge in technicalities to excuse wrongdoing, those who omit pertinent information from official documents, and those who have difficulty learning from experience.

Let's find someone else for the job.

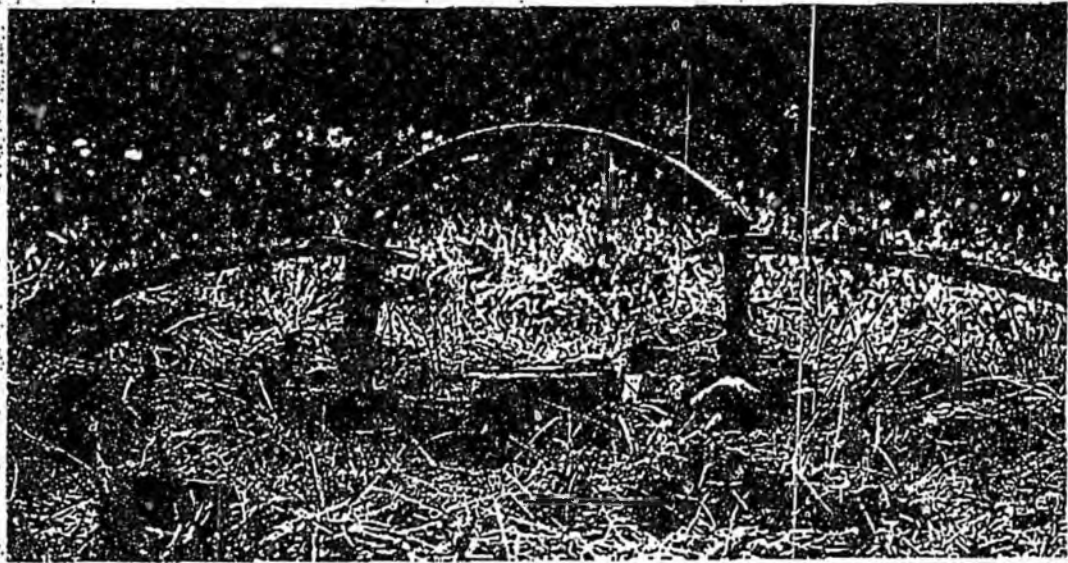

lot of ostensibly legal pieces, finely carved pieces, over the counter for hundreds or thousands of dollars more than they would have brought had Romeo carved them himself.

Dave Hall stayed around for another couple of days, looking for more ivory dealers in Anchorage's bars and the girllie joints and coming up mostly empty-handed. He also called some of the contacts he'd made on his earlier trips. The most promising were the Apgars, Ruth and Steve, who owned the Golden North Hotel in Skagway—the gold-domed Victorian structure whose picture appears in nearly all the cruise ship brochures. Ruth had sold Doak a load of walrus ivory a few months earlier at Endangered Species. The Apgars were up to their elbows in walrus ivory smuggled out of Savoonga, where they once lived. He set up a buy from them and went back home. Being Dave Hall, he would have been frustrated if there was a single ivory dealer he hadn't stung, and there were probably plenty. Mainly, though, he was exhausted.

There were about two hundred telephone messages on his desk. He worked sixteen- or eighteen-hour days for the next week, making thirty calls a day and shoveling paperwork like a front-loader. It had become a pattern with him: he would be gone for weeks, then come home and spend practically all his waking hours at his office. David, his son, was seventeen, and his daughter, Pam, was thirteen—they would soon be out of the house—but he rarely saw them anymore. Sarah Hall was not just sleeping alone but living alone. Dave Hall becomes belligerently defensive when you bring up his absenteeism from family life—"Why the hell can't our women appreciate the importance of what we're doing?"—which a psychiatrist might jot down as prima facie evidence that it troubles him deeply. Yet at the same time, according to his peers, his work obsessiveness has become more and more extreme over the years. It was during the ivory case that his behavior became worthy of clinical interest.

"He realized as soon as he got on that damned ivory case that he was in over his head," a fellow USFWS agent who, like some others, admires him greatly and resents him deeply, told me once. "He about wrecked his health and his family life and his marriage over that case. Sarah finally had it up to here with being the sweet dutiful southern-belle wife, and Dave began to see that she has a will as strong as his, and the




Dear Rep. Finkelstein:

Real Estate

Ethics can complicate real estate transactions

Over coffee at the office someone says he might be house hunting. Do you have a real estate agent to recommend?

Your colleague ends up working with the agent you recommend. Later a very generous gift certificate arrives from the agent, with a thank you note.

How do you feel about the ethics of the situation?

Try another case.

You locate a home and the seller accepts your offer. You need to have the home inspected and to get the deck rebuilt. The agent gives you the

name of a contractor he says is competent.

You don't know what business or personal relationships there might be between the agent and the contractor. Are you going to take the recommendation?

Another case.

You have been shopping the inventory of resale homes and nothing seems quite right. You decide to consider building and start to shop for a lot. You enlist an agent's help and say there is one neighborhood in particular that appeals to you.

A week goes by and the agent suggests three lots. Each has similar appeal. You choose the one that is

priced better, which happens to be the one the agent says he owns personally.

When the title report comes out, you learn the agent bought it the week after you voiced interest in obtaining a lot for yourself. Do you ask how this happened? Since it's the best priced lot, do you care?

Some of these scenarios have legal implications. The law governing agent conduct is designed to protect the public. It draws some clear lines. Not so clear sometimes are the ethical considerations of real estate practice in Alaska today.

The law, for instance, forbids anyone who is not licensed from receiving payment for real estate services. You may be able to send a lot of business to your favorite agent, but the agent isn't allowed to give you anything of value.

Chances are your relationship is partly friendship, too. Can he or she charter a plane for day of fishing, or take you out to dinner? Probably no one would quarrel with that. If you get a certificate good for you and the family to go fishing, that might be different.

Even the "mostly social" event could be viewed as a technical legal violation. Chances of enforcement are small. The ethics of the situation are troublesome, however, since the agent is going to be motivated by an honest desire to say thank you.

Nothing in this scenario approaches the blatant kickback, where a return is requested in exchange for the referral.

There are also ethical considerations when the agent refers you to a service provider. As a real estate consumer you need title insurance, a mortgage loan officer, an insurance agent, an appraiser, and maybe an attorney, a contractor, a home inspector, and an engineer.

Agents work with such people all the time and can make a recommendation that takes into account your unique need. The recommendation can be colored by the experience of the service provider. It can take into account price and who is available on your schedule.

The ethical problem develops when there is a more than an arm's length business relationship between the agent and the service provider and

the relationship is not disclosed.

The business practice locally is to provide more than one name, accompanied by information about the provider's qualifications and recent history that is relevant to the current need. You might be told for instance that both contractors are licensed, bonded and insured but contractor A has just completed a similar repair and the report on the job was favorable.

There is nothing illegal in an agent suggesting a relative for a service you need. The risk, from the agent's point of view, is that if you are unhappy with the service you are going to be unhappy with the agent, too. For this reason some agents

will shy away from recommending people they are close to.

How do you feel about the last case, where the agent bought a property and now wants to resell it to you? If you ask, you will learn that the agent knew of a distressed seller who "just wants out." The agent may have told him the property was worth more, but in the interest of a quick, sure sale the seller sold at a discount. The discount was so deep that the agent is now offering you the property at a favorable price.

Recent changes in the real estate law require the agent to decide who is the client. Every party to the transaction has the right to know whom the agent is representing. (The law has always required disclosure when an agent is selling his or her own property.)

To whom does the agent owe complete loyalty? If the seller is the client, was it a breach for the agent to buy a deeply discounted property from him or her? Can the agent close on that property and then make you, the buyer of that property, a client?

Were you in effect the client all along? If so, did you have the right to expect the agent would give you the opportunity to make a good buy in the market?

The legalities may not be absolutely clear in each of these cases. In the less greedy '90s, however, it is possible that the ethical considerations will receive greater weight.

Buyer must be diligent, seller must disclose

When buying real estate, there is no substitute for a competent inspection. Sellers are understandably nervous about the process, however. In commercial real estate the industry term is "due diligence." This standard recognizes the buyer's responsibility to make a reasonable investigation of a property before closing.

A due diligence investigation begins with seller disclosure. Sellers are expected to disclose any information about the property that could affect its value.

Under current real estate practice, sellers fill out a form that asks lots of questions about the condition of the property and the seller's experience with it. Buyers are asked to sign that they got a copy.

If an agent is in the picture, Alaska case law says the agent must point out adverse facts about a property that he or she, as a real estate professional, reasonably should be expected to know. This could extend to things even the seller didn't appreciate. The case involved a well that wasn't on the property, where a look at a survey would show this to be the case.

The choice of home inspector may be dictated by what is known about the property to begin with. A new home carrying a builder warranty may need no additional inspection if

the buyer has confidence in the city's building inspection process.

One should remember that Anchorage only conducts building inspections in the Anchorage bowl. Most smaller communities have no building inspection program. Even in Eagle River the Municipality of Anchorage issues a building and use permit and the building codes apply, but there are no inspections during construction.

A pre-owned home that is only a few years old and that appears to have been well cared-for may only need a check-out by a competent general contractor. More care may be appropriate, however, if a lending institution has foreclosed on the property and the owner is out of the picture.

Another third-party owner prevalent in Anchorage is the relocation company.

These companies acquire properties from corporate and governmental employees because the terms of that transferee's employment provided a home sale benefit.

Relocation companies routinely hire inspection services to check out properties. If there is a defect the relocation company often first requires the employee to make the repair. This is why buyers often believe that a relocation company property can be a safe bet.

Most purchase agreements include an addendum that reserves a right of inspection. The understanding is that the buyer takes the property as-is, after having a reasonable opportunity to inspect it as closely as he or she wishes. Nothing requires the buyer to inspect. If the buyer doesn't inspect, the sale closes as-is without recourse against the seller, short of provable misrepresentation or fraud.

Some properties invite inspection by someone with a high degree of expertise in a particular discipline. I once hired a structural engineer to look at the foundation of a foreclosed duplex I wanted to buy. It was a modular structure that had been moved to the site. I wanted to know whether the building was going to stay there in adverse conditions.

"Everything looks great," he said,

brushing aside all the cowboys. "What's all that wire down there?" I asked, naively assuming the former owner was a telephone lineman. "We'll this was once a great pot farm with tons of grow lights," he replied.

So there's a lot one can learn from a home inspector!

Inspection reports get passed around, often with unanticipated side effects. Many lenders insist on a copy and will pointedly ask buyers if they have obtained a report. Not wanting to risk being charged with committing fraud on a lender, a copy ends up with the underwriter.

Even if the buyer and seller didn't have a problem with a seemingly minor property defect, the underwriter may, if the underwriter makes repair a condition of the loan, the buyer and seller may have no choice but to negotiate the cost in order to close the sale.

An example was a deck at ground level that was not even attached to the structure of a home in Geneva Woods that sold two years ago. The seller told the buyer some of the support posts were weak. The buyer said he'd have a relative fix it during his visit to Alaska the month after closing.

The lender balked, convinced someone might break a leg, sue the buyer, cause him to go bankrupt and therefore default on the loan. "Fix that deck support or we won't give you the loan," they said. So instead of a weekend family project, the hapless buyer and seller hired a general contractor, at considerable expense.

Not satisfied that the job got done, the lender next insisted on an inspection signed and stamped by an engineer holding an Alaska license.

The work was done over Labor Day and supervised by the home inspector, an engineer who did not hold an Alaska license. By the time all the other engineers came back from fishing there was no way short of tearing up the deck again for the engineer to be able to see the work and sign that the contractor did the work properly.

The lesson is that if the home inspector is not an engineer licensed in Alaska and a lender insists on repairs, someone needs to plan on the expense of hiring a second engineer to write the sign-off letter.

If an adverse inspection report causes a transaction not to close because the buyer and seller do not agree on the fix, all later prospective buyers are entitled to the report. In many cases an adverse inspection report can make a property unmarketable.

These unfortunate scenarios grow out of the lending community's experience with bad properties acquired in the mid-1980s through foreclosure. As partners with the buyer because of their loan, lenders are understandably skittish. The pendulum may be at an extreme today.

A final caution is to realize that a property being marketed as an assumption or with 100 percent owner financing won't have a new lender scrutinizing it. This means that an owner with a property that can't qualify for new financing can still get it sold.

The buyer needs to appreciate, however, that unless he or she addresses the problem some day, new financing may never be available.

There are forums for real estate complaints

The most nervous real estate buyer I ever worked with came to our relationship convinced he was going to have problems. Suspicious of absolutely everything, he took nothing at face value.

It's smart to look ahead to where a transaction's rough spots might be. But this fellow was a genius at thinking up far-out, worst-case scenarios. Virtually nothing he created in his head ever came to pass, happily.

At the end of it all—after a three-hour closing which included a solemn reading of every word of every document—he told me the experience was the worst thing he had been through since the death of his mother!

If your real estate deal is driving you crazy, you aren't limited to personal advisors and the medical profession. Where you go for help depends on the nature and seriousness of the problem.

The place to start is with the agent and his or her organization. Real estate agents are independent

contractors in their own organizations. Every real estate office has a broker. By law the broker must supervise the agents.

Whatever your problem with an agent, march to the broker first. Do you have a negotiation going and a deal that should go together just isn't happening? Do things not seem to be as the seller represented? Is your buyer making unreasonable demands which are different from what you first agreed to? Has the lender matched a problem? If the agent doesn't seem to be addressing the issue to your satisfaction, march to the broker.

Remember that the brokerage probably won't get paid unless it can resolve your problem.

But not every problem with an agent or a transaction can be resolved at the broker level. You may need to press on to forums provided by Realtors, the Real Estate Commission, and the courts.

Most brokerages and their agents are members of the National Association of Realtors. A licensee can be called an agent and say that he or she is a Realtor—with a capital "R"—only if a member of this professional society.



The Anchorage Board of Realtors started a mediation program for homebuyers and home sellers this spring. Local Realtor President Joan Sheppara reports two completed mediations, with requests for four more pending.

The parties to the dispute choose the mediator from a list provided by the Board of Realtors. The only possible result is an agreement the parties themselves structure. The mediator can only facilitate this non-adversarial process. Earnest money disputes, claims of problems with a property after closing, disagreements over advice from an agent or his or her professional conduct, and landlord-tenant disputes are fair game for mediation.

Fees range from \$50 to \$100 per party. Involvement with the process does not require that anyone give up the right to pursue any other legal options. The Anchorage Board of Realtors phone number is 561-2335.

The Alaska Real Estate Commission oversees the actions of all licensees. This is probably not the place to go with a pure buyer-seller dispute. If the agent's conduct is questionable, however, a call to the commission opens up two avenues.

The first is an administrative proceeding directed at the agent's license. The broker's license can be involved, too, if the case involves conversion of trust funds or alleged failure to supervise the agent. There are no fees.

The result can be license suspension or revocation. Any victim of the misconduct receives no direct benefit from the process. For redress, you may have to work through the commission's

misrepresenting something. These are the cases where someone says an agent should have known better: repeating the seller's statement that the well is on the property when looking at a survey would show otherwise; saying one can run a business out of a building when zoning regulations say no, for example.

Arbitration differs from mediation because the results are binding. What the arbitrator rules is almost impos-

Not every problem with an agent or a transaction can be resolved at the broker level. You may need to press on to forums provided by Realtors, the Real Estate Commission, and the courts.

sible to overturn, even in court. If you win an arbitration, a judge will turn it into a court order.

Arbitration is built into many business contracts. An example is language in the standard real estate purchase contract of the Anchorage Multiple Listing Service, in which buyer and seller agree to arbitrate disputes over the disposition of earnest money if the deal comes apart.

The informality of arbitration has been characterized as "trial by ambush" because the protections of formal rules of evidence and civil procedure do not apply. You can say or do just about anything in an arbitration and the arbitrator will listen to it "for what it is worth."

Arbitrators can be appointed by mutual agreement. Lists of arbitrators with particular skills are available from the American Arbitration Association in Seattle. A judge will

appoint an arbitrator if there is an agreement to arbitrate and the parties can't agree on one.

Arbitrator's fees are billed with the award. You may have the additional expense of a legal representative, although you can go it alone if you wish. The American Arbitration Association

Surety Fund.

The Surety Fund is funded by fees collected from the agents, in lieu of their being bonded. To collect from the Surety Fund there must be a link between agent conduct and a loss. If the parties to the transaction damaged each other and the agent wasn't involved, then you may find yourself in arbitration or in court.

To collect from the Surety Fund you have to show that the agent's misconduct was intentional. The Surety Fund is also available in fraud cases and where trust funds were unlawfully converted. The Alaska Real Estate Commission phone number is 563-2169.

Alaska is the only state that holds agents to account for damaging someone by negligently or innocently

If you are headed for court, you need a lawyer. Hardly any cases get that far, but many threaten to and settle long before trial. In many jurisdictions attorneys go to closings and even write purchase agreements. Here, attorneys prepare deeds accompanied by a letter disclaiming that they represented anyone in the transaction and that's about all.

If things go bump — better tell your buyer

If things go bump in the night at your house, be prepared to tell your buyer before you sell it next year.

Gov. Walter J. Hickel signed a real estate disclosure bill into law June 22. Its effective date is July 1, 1993. The Real Estate Commission has until then to come up with a list of what you must disclose.

Some facts that might become legal requirements may go beyond the current practices of the real estate industry.

For instance, the commission's recently published newsletter discusses "psychologically-impacted properties." The most drastic cases are those in which unsavory events took place: murders, suicide, drug dealing.

"The safest course to follow, therefore, is to disclose any psychological factors which could impact the buyer's opinion of the value of the property," says the commission. The italics are theirs.

Consider the true story of a homeowner who bought the home of someone who died in a car crash nearby. The despondent husband subsequently shot himself, not in the house, but outdoors, probably on the property.

Suppose you had bought that property. Maybe you felt OK about it. You might have hired a "house cleanser" - there are such folk - to say the right prayers, burn a few herbs, and gently encourage unwanted lingering spirits to leave.

A few years later you want to sell. Will the earlier facts about the property hit a hot button in your buyer's mind? How do you tell? Send your buyer to a psychologist?

The disclosure requirement of the new law mostly ratifies current industry practices. What's new is giving the Real Estate Commission the authority to tell you what you must disclose.

"The bill was one of the most hotly debated of the session," according to Rep. Max Gruenberg, co-sponsor with Rep. Pat Parnell and Rep. Bettie Davis. "It is great consumer legislation."

Principal sponsor Rep. Parnell agrees, saying that "lots of politics" surrounded the decision to take out of the bill a list of mandatory disclosures. Earlier drafts included most of the text of the form most real estate companies now use.

None of these forms asks questions about "psychologically-impacted properties." Even the Real Estate Commission's article is quick to say that sellers should not disclose that people in a home had HIV or died from AIDS, since this violates fair housing laws.

The law only applies to single family homes and duplexes, one of the points of compromise from earlier

drafts that would have included larger multifamily and commercial properties. Rep. Parnell notes the irony that the transaction which first inspired the legislation involved a poorly constructed condominium.

Disclosures, once made, insulate the owner from liability for the defect. To qualify, the owner must make his or her disclosures before the buyer makes an offer. If the disclosure comes later the buyer has the right to cancel

the offer. Circumstances can change and the law creates an additional obligation to disclose these facts, in writing. Up to the day of closing the seller who wants to comply and escape liability for undisclosed defects should amend the disclosure.

There are two standards of care for seller. The negligent

failure to disclose makes the seller liable for actual damages. Willful violations make the seller liable for up to three times as much.

The building industry won an exemption for new homes, in recognition of builder warranties common in Anchorage.

The buyer and the seller have the right to agree to skip all these legal requirements. This recognizes that in rural areas real estate transactions tend to be less formal.

Eye of the storm: Jacko flap has lawmakers talking politics

Senators fumbled today when passed the ball in determining their role in a possible investigation into Sen. George Jacko's weekend attempt to gain entry to the hotel room of a female legislative aide.

Senators went into closed-door caucuses this morning after the majority and minority could not agree on appointments to the Ethics Committee, which could be called on to investigate Jacko's conduct.

At least two senators have said they want an investigation into the incident.

In addition to calling police for assistance in gaining access to the woman's room Saturday morning, Jacko asked the desk clerk at the Driftwood Lodge for a key.

Jacko and the woman were guests at the Willoughby Avenue motel.

The Pedro Bay Democrat also pounded on the aide's door repeatedly and called her room in the early-morning hours, said Lucy Perreard, who was working the front desk.

Though the police incident report says Jacko said he needed to talk with the woman on official legislative business, the senator has denied that report. The Empire has requested from Juneau police a copy of the taped phone calls from Jacko.

Though no complaint has yet been filed with the Ethics Committee, the panel could instigate its own investigation.

Senate Democrats today said they want Sen. Suzanne Little, D-Soldotna, as their member on the panel, but Senate President Rick Halford, R-Chugiak, bypassed the

minority's recommendation and asked for Sens. Jay Kerttula and Mike Miller.

Kerttula, a Palmer Democrat, is a member of the minority; Miller, a North Pole Republican, belongs to the GOP-controlled majority. Jacko was the lone Democrat to defect to the GOP majority coalition, giving them control of the Senate.

Jacko was trying to gain entry to the room of an aide to Little, and Halford said that connection concerns him in Little's appointment to the panel that could investigate Jacko.

The legislative aide declined comment today.

Jacko has declined to discuss the incident further.

Senate Minority Whip Judy Salo, D-Kenai, said Little had been selected before this weekend's incident.

During a break in today's closed-door meetings, Senate Minority Leader Jim Duncan, D-Juneau, said Democrats still want Little.

The legislative ethics law sets up a panel with five public members, plus two from the House and two from the Senate split between the minority and majority in each chamber.

The House panelists are men, and three of the five public members are men. "We feel it is particularly important that there should be gender balance of the ethics committee," Duncan said.

Senate Majority Leader Robin Taylor, R-Wrangell, and Halford said politics are behind the nomination conflict.

"I need to go on the floor and try to figure out how to keep this body from tearing its guts out," Taylor said before the start of today's floor session.

The political process is complicated by the reality that Halford needs a two-thirds majority for confirmation of ethics panel appointments, meaning he needs at least three minority members to go along with his selections.

Salo and Duncan were prepared to speak on the Senate floor this afternoon, calling for an interim committee to investigate the weekend incident.

Four of the five public appointees to the Ethics Committee said today the Jacko situation was the type of incident that would likely fall under the new ethics law.

"This type of conduct, if it's true what I read in the paper, broadly would come under scope of this thing," said Rodman Wilson of Anchorage. "It's incorrect to try to get in someone's room and doubly incorrect to try and get law enforcement to do it. That's my initial assessment."

The lack of Senate appointees to the panel is unfortunate "because it looks as if things are moving beyond us that need attention," said nominee Ruth Apgar from Kotzebue.

"If he in fact was using police and troopers for personal reasons, and I don't think we know if it was personal or not, then we might want to do some investigating," Apgar said.

Under the rules, only the Senate and public members would sit in judgment on a senator's case. Any penalties would have to be approved by the full Senate.

While the Senate debates its role in the matter, further details of the incident show Jacko's persistence went beyond calling police to gain entry to the room.

He asked for a key at about 3:30 a.m. Saturday, desk clerk Lucy Perreard said Monday. "He just persisted over the next two hours," she said. "He wanted into the room bad."

Perreard said Jacko did not seem agitated and was not rude, but didn't seem reasonable either. Although he was a guest at the Driftwood, Jacko refused to identify himself, Perreard said.

The police report said the incident involved alcohol and Jacko has admitted to consuming a couple glasses of wine.

Perreard said Jacko smelled of alcohol and seemed intoxicated.

Jacko made two or three requests for the key, and Perreard turned him down, citing hotel policy and common sense. "When someone comes to the desk at 3:30 in the morning, you just don't give out a room key," she said.

When Perreard would not give him a key, Jacko asked her to enter the room and contact the woman, Perreard said. The clerk refused.

He also tried more direct approaches.

"He pounded on the door all night long," Perreard said, "hard enough that I could hear it in the front office."

The woman's room is near one end of the L-shaped complex. The office is near the middle. The pounding also prompted another guest to call the office and ask whether someone was breaking

into the room, Perreard said.

Jacko also called the woman's room repeatedly. The woman finally took her phone off the hook, Perreard said.

Though Jacko said he "really needed to talk" to the woman, he did not say why, Perreard said. "It was personal," she said. "I don't think business was discussed at 3 in the morning."

In his first call to police, Jacko said he needed to talk about legislative business with the woman. On his second call to police from a phone in the hotel office, the senator was "throwing his name around," said Perreard, who overheard Jacko's end of the conversation.

Police said that Jacko later admitted during the second call that his request involved personal business.

"I remember him backtracking," she said. "I'm not going to say that he did say it was official business."

Jacko made the second call after police visited the hotel, determined that the senator's request was personal, and declined to help him.

Jacko's second call to police actually was for the Alaska State Troopers, whose number rings at the Juneau police department on weekends.

City-borough officials are reviewing media requests for access to tapes of both calls.

Police Capt. Mel Personett said the tapes will not be released until a supplemental report is completed by the investigating officer and municipal attorneys decide the tapes are not evidence in a criminal case.

The city-borough law department also is weighing concerns about the legislative aide's privacy. The tapes may have to be edited to remove her name and any references to her, municipal attorney John Corso said.

"I think that the senator ought to be prepared anyway for the possible release of information," Corso said.


I would like to apply for a public position on the Ethics Committee. I have been an Alaska resident for only a year and a half, but I plan to make Alaska my permanent home.




