This memorandum is to request confirmation of COL Sigurd E. Murphy, Jr. in the grade of Brigadier General with assignment as Assistant Adjutant General Army, Alaska Army National Guard. The position has been vacant since the 12 November 1992 C-12 accident, however, I have had COL Murphy in the position as an (Acting) Assistant Adjutant General Army.

An Alaska Guardsman since November 1979, COL Murphy served with distinction as a Staff Judge Advocate and Deputy Commander, State Area Command. As a civilian, COL Murphy is an Alaska District Court judge in Anchorage.

COL Murphy has demonstrated the skills, potential and vision necessary to serve in positions of increased responsibility and authority. He exceeds the prerequisites of AS 26.05.180 for appointment as Assistant Adjutant General. I am preparing the paperwork necessary to seek federal recognition of COL Murphy in the grade of Brigadier General. I will forward it to National Guard Bureau after state confirmation.

COLONEL MURPHY

Colonel Sigurd E. Murphy joined the Alaska National Guard in 1979. After completing the Judge Advocate Officer Advance Course in 1981, then Captain Murphy was appointed to the position of Staff Judge Advocate of the Alaska Army National Guard. As the principal military attorney, he provided legal advice, prepared legislation for a state code of military justice, and implemented a program to provide wills, powers of attorney, and other legal services to all members of the Alaska Army National Guard.

He continued as the Staff Judge Advocate until September 1990, at which time he was promoted to his current rank of colonel and was assigned as the Deputy State Area Command Commander. He is an Army Pathfinder, a 1984 graduate of the United States Army Command and General Staff College and a 1986 graduate of the United States Army War College Defense Strategy Course.

He has received numerous military awards, including the Meritorious Service Medal, the Army Commendation Medal, the Army Achievement Medal, the National Defense Service Medal, the Armed Forces Reserve Medal, the Army Reserve Component Achievement Medal, the Alaska Commendation Medal, the Alaska Domestic Emergency Ribbon and the Alaska State Service Medal.

Colonel Murphy holds a Juris Doctorate Degree from the University of Southern California.

He is a State District Court Judge in Anchorage. He is involved with numerous civic organizations, including the Anchorage Downtown Rotary Club, Commonwealth North, the Boy Scouts, and various church activities. He is also a lifetime member of the National Guard Association of the United States and the Alaska National Guard Officers Association. He is a pilot and master diver, which activities he enjoys for recreation. He is married to the former Mary Ellen Jablonski and has two children, Anne Marie Murphy who is attending Vassar College and Sigurd E. Murphy III who is attending Service High School in Anchorage.
