My name is Richard Seward. I vote in Senator Wilken's and Representative Davies district. I am the State Field Director of the AFL-CIO. I am a member of Pride At Work, the AFL-CIO constituency group for the concerns of gay and lesbian workers. My daughter is graduating from West Valley High School in May. My husband is Stephen Palmer. Steve and I are gay. My daughter tells me she is not.

I ask you to vote NO on SJR-42 which invades the privacy provisions of the Alaska Constitution. I am proud to be an Alaskan and I am proud to live in a state where the people voted to put the right to privacy in our very constitution. We are fairly unique in that respect.

I firmly believe that when the good folks of Alaska voted on the constitution they understood exactly what the right to privacy means. I think they understand that right today. I can think of no more private decision I have ever made than the choice of an adult with whom I wanted to be family, intimate and committed family.

I know there are many who would not choose to be family with a member of the same sex. Likewise I know that the beliefs and practices of many Alaskans are not the beliefs and practices I would choose. But I strongly believe in their right to exercise their religion and their values in choosing and living with their families. I want the same privacy protections for my family.

I believe in equality of Alaskan families. As long as the State wants to sanction marriage, then I believe my marriage to Stephen Palmer deserves all the rights, privileges, AND legal responsibilities as any other marriage in this state.

I urge you to vote NO on SJR-42 and protect the privacy provisions of the Alaska Constitution. If the State can arrive at a compelling reason to invade that privacy, then so be it. However, the right to privacy in Alaska is too precious to be attacked and invaded without a compelling State reason. I firmly believe that SJR-42 takes the discussion away from Alaskan values and allows popularity and prejudice to determine the question.

Our organization, the Alaska Gay & Lesbian Association, is 94% Alaskan and we have been working diligently for over twelve years to ensure equality for Alaska's gay, lesbian, and bisexual citizens at the UAF campus.

I know full well that you have been flooded with hundreds of messages supporting HJR-42 with a variety of arguments, most of them based on a religious foundation. I would like to ask you to look at HJR-42 now from another perspective, the perspective of an individual legally denied the right to marry the individual of their choice.

If HJR-42 passes, gays and lesbians will be unable to provide insurance coverage to their partners. If HJR-42 passes, hospitals can deny visiting privileges for their partners. If HJR-42 passes, gays and lesbians cannot assume legal responsibility for their partners' children. If HJR-42 passes, long-term gay and lesbian relationships will be invalidated and their ability to serve as role-models to young gays and lesbians will be neutralized.

The lack of recognized, stable, long-term same-sex relationships has been tied to both the high rate of suicide among gay and lesbian teens and the unsafe sexual practices of gays and lesbians, which increases the risk of contracting sexually transmitted diseases.

Although these may seem to be extremely far-reaching consequences of HJR-42, they are the reality that our community has been facing for decades. Please do your part to stop the destructive cycle and allow gays and lesbians to join in the fight for family values.

Dear Senator Sharp,

Judging from letters to the editor in the Anchorage Daily News, I have the impression that many people think that they do not know any gay or lesbian people, let alone couples. Moreover they have the illusion that this country is "a Christian nation." Let's save the latter for another time; I would like to address the first.

As for myself, I am a retired physician, living in Anchorage since 1958. I "came out" as homosexual two years after my wife of 22 years died of cancer in 1977. I had known that I had these desires all my life, but had repressed them during marriage. (For me it was not a question of "either/or" but rather one of "both/and".) When Louise died, our three sons were 6, 8, and 10. I continued to raise them as a single parent. They live here in Anchorage and you are welcome to talk with Jon, Andrew or Rob, if you have questions about what it was like for them. Or talk with any of my five grandchildren.

In the church that I attend, about ten percent of the active congregation are lesbian or gay male individuals, including three lesbian couples with children, two of whom I know well. I can assure you that these lesbian parents do the best parenting of any parents I have observed over the years, and far better than the job I did myself. Being somewhat of an activist in the gay and lesbian "community", I am also acquainted with a number of couples, some with grown children, some without, and these coupled relationships appear to me to be better than those of many of the heterosexual marriages I have seen among my friends and colleagues, certainly no worse. The divorce rate among my straight physician colleagues has always been amazing to me.

Contrary to the letters to the editor, historically marriage was a legal matter regarding property and inheritance for a millennium before it became a matter for the Christian Church. Marriage did not become a sacrament until 1215 A.D. (For a detailed account of this history please see "Same-Sex Marriage in Premodern Europe," by Yale historian John Boswell, Villard Books, 1994, ISBN 0-679-43228-0.) Marriage is still is a legal matter, and a significant number of worthy people are being excluded from the legal advantages that the state grants to married couples. It is beside the point to argue that gay people are not good parents, or that some gay relationships do not last, or that some straight people object because the concept is against THEIR religion, or that somehow the existence of a legal marriage between two men or two women will threaten other marriages or other families, or impair the quality of parenting in other families, or somehow weaken the fabric of society. No, it is a simple matter of fairness.

As you are all certainly aware, the issue of defining what and whom constitute a legal marriage is one being addressed in every state of the Union. It is not a new issue, nor is it one which should be given a perfunctory or "knee-jerk" response. In the United States of America the denial of rights to an individual based purely on status or self-designation is anathema to the basic precepts our Nation was formed on. I personally do not support the efforts to deny the sanctity of marriage to same sex couples. Why should anyone be denied the opportunity to form a healthy, COMMITTED, and stable union which can only serve to support the community at large? Men and women are already coming together, in spite of the lack of support, and forming lifelong partnerships. This is undeniable, and it will continue. Zealots will not and can not stop this merely by an endless barrage of legislation. The only result of the non-stop negative reactionism we have seen in the past twenty years has been to bring these issues to the table where they can be

discussed and addressed.

It is truly a travesty that this country DOES NOT offer marriage benefits to ALL OF ITS CITIZENS. I pray that with this issue as with all others you will step back from the frenzied exchange of words and look through unclouded eyes at the truth of this situation. As was stated in the majority opinion of the recent U.S. Supreme Court case Romer v. I urge you to read this decision, and contemplate its ramifications. If this constitutional amendment is passed, it will be challenged in court. If it is challenged in court, it will lose. It will lose because it goes against every intent of the Constitution of the United States of America (another document which bears re-reading, along with the Declaration of Independence). This is a free country, and Alaska is truly the last frontier. Please act to keep it the last frontier of FREEDOM, not discrimination.

This e-mail is sent in support of Alaska State Senate Bill SJR 42, the proposed constitutional amendment to protect traditional heterosexual marriage.

Strictly speaking a traditional marriage is the union of one man and one woman for life. My biggest concern with allowing gays the same status in marriage is the possibility of legitimizing adoption of children into unnatural settings. Life style is a personal choice but if a life style is chosen that does not provide for the possibility of natural child birth then an artificial form of obtaining children should not be allowed.
