4 present authority of the governor to request and receive federal disaster relief and emergency
5 assistance.

11 no longer exists. The governor may terminate the disaster emergency by proclamation.
12 A proclamation of disaster emergency may not remain in effect longer than 30 days

15 and the conditions that have brought it about or that make possible the termination of

You have requested a sectional summary of a draft CSSB 101(FIN); An Act relating to disasters and to the disaster relief fund.

As a preliminary matter, note that a sectional summary of a bill is not an authoritative interpretation of the bill. The bill itself is the best statement of its contents.

Section 1 of the bill amends AS 26.23.020(c) to provide that a proclamation of disaster emergency is effective for only 30 days unless extended by the legislature by law.

Section 2 of the bill repeals and reenacts AS 26.23.025 relating to the legislature and disaster emergencies.

Subsection (a) sets out the information that the governor must provide to the legislature upon declaring a disaster emergency. This subsection also sets out the procedure that the governor must follow to obtain approval for additional money or expenditure authority from the legislature to cope with the disaster. Approval for additional money or expenditure authority may only be obtained by act of the legislature.

Subsection (b) provides that if the declaration of a disaster emergency occurs while the legislature is in session, or if a special session is held, actions taken by the governor chapter that are not ratified by law adopted during that session are void.

Subsection (c) provides that the legislature may terminate a declaration of disaster emergency at any time by law.

Section 3 of the bill repeals and reenacts AS 26.23.300 which provides for the creation and operation of the disaster relief fund.

Subsection (b) provides that the governor may expend up to \$500,000 from the fund to address an event that poses a direct and imminent threat of disaster that warrants state action, in the opinion of the governor.

Subsection (c) provides that the governor may expend up to \$1,000,000 from the fund to address a disaster.

Subsection (d) provides that the governor may expend up to \$5,000,000 from the fund to address a disaster resulting from certain specified events that are set out in the subsection.

Subsection (e) provides that the governor may not exceed the spending limits set out in (c) and (d) of this section unless the President of the United States declares the disaster to be a major disaster and the legislature approves the expenditure of additional assets from the disaster relief fund.

Subsection (f) provides that a community or area is eligible only once for flood disaster relief that is funded from the disaster relief fund.

Subsections (g) and (h) provide that the governor shall provide an annual accounting of expenditures from the disaster relief fund and that the governor may adopt regulations to implement this section.

Section 4 of the bill amends AS 26.23.900(2), definition of "disaster".

I would like to bring to your attention some concerns with CSSB101 relating to the Disaster Relief Fund. There are portions of this bill that will create difficulties in the implementation of the wildland fire management program. As you are aware, basic funding for wildland fire suppression necessitates periodic and regular utilization of the Disaster Declaration process to obtain fire-fighting funds. Since the Disaster Relief Fund itself never has sufficient funding, wildland fire funds are always provided from other state funds identified by the Governor. However, this legislation will negatively impact the process that wildland fire must use to obtain other funding.

Wildland fire suppression is funded for \$3.2M and the average year expenditures are \$11.7M. The program currently uses the following process to obtain funding when the appropriated funds are exhausted:

. A Draft Declaration of Wildland Fire Disaster is prepared by the Division of Forestry complete with a detailed financing plan identifying initial appropriation, fixed costs, daily fire costs, anticipated expenditures, current balance and anticipated date funds will be depleted. The Draft Declaration will be prepared to cover contractual fixed expenses, current fire fighting expenditures and projected fire expenditures for the remainder of the fiscal year.

. The Draft Declaration is transmitted from DNR to DMVA for a determination if sufficient funding is available in the Disaster Relief Fund. In recent years the answer from DMVA has almost always been that the fund appropriations are insufficient. OMB is also informed that a Declaration is in process and provided with a copy - or copies as cost updates are provided by Forestry during the approval process.

. DMVA then transmits the Draft Declaration to the Governor's Office indicating there is insufficient funding in the Disaster Relief Fund and that other state funding will need to be identified.

. The Governor declares a Disaster Declaration for Wildland Fire and sends notification to the Speaker of the House and President of the Senate and Chairs of the Finance Committees.

. The Speaker and President respond at which time funding is identified to continue wildland fire fighting.

. A Supplemental Appropriation is submitted to the legislature when it is in session that reflects the Declaration expenditures to date and updates projected expenditures for the anticipated fires during the spring fire season and the legislature has then funded those expenditures.

In looking at the changes in process that CSSB101 would create, we believe that the following system would be required.

. A Declaration of Wildland Fire Disaster is prepared by the Division of Forestry complete with a detailed financing plan identifying initial appropriation, fixed costs, daily fire costs, anticipated expenditures, current balance and anticipated date funds will be depleted. The Declaration will occur early in the new fiscal year because the appropriation is \$3.2M and historically direct fire suppression costs have exceeded this by mid-July. Depending on the intensity of the fire season, a second Declaration for direct fire fighting may be required before fall. Regardless, a Declaration will be necessary to fund fixed costs of fire suppression which are \$5.2M for FY'00. Currently fires in the spring frequently require a separate Declaration if funding does not extend to June 30.

. The Declaration is transmitted from DNR to DMVA for determination if sufficient funding is available in the Disaster Relief Fund. The decision will be negative since basic appropriation to the fund is insufficient. OMB is also provided with a copy of the Declaration and informed that it is in progress.

. DMVA transmits the Declaration to the Governor's Office indicating there is insufficient funding available in the Disaster Relief Fund and that other state funding will need to be identified.

. The Governor declares a Disaster Declaration for Wildland Fire and sends notification to the Speaker of the House, President of the Senate and Chairs of the Finance Committees. Since the bill provides that the Governor may not expend more than...\$5,000,000 of the assets of the disaster relief fund ...unless the disaster described in the governor's declaration of a condition of disaster emergency is determined by the President of the United States to cause damage of sufficient

severity and magnitude to warrant major disaster assistance under the federal Robert T. Stafford Disaster Relief and Emergency Assistance Act (sic. FEMA) - a further problem is created.

In order to access federal disaster money, state expenditures for wildland fires must exceed \$17.7M (floor cost) in a calendar year, at which point the state is eligible for 70% recovery for FEMA declared incidents. If the expenditures in one calendar year exceed \$35.4M we are eligible for 100% recovery. These requirements are specific to wildland fire suppression and not to other types of disasters.

As noted above, average year expenditures for wildland fire suppression are only \$11.7M, thus denying access to any wildland fire monies beyond \$5M in the bill because we cannot qualify for a federal FEMA declaration. We have only had two FEMA declarations - the Tok Fire in 1990 and Miller's Reach in 1996.

As we interpret this bill, to request the average year funding of \$11.7M, or any amount beyond \$5M, would require a special session of the legislature.

We have had more than one occasion when this process had to be accomplished at the very beginning of a new fiscal year over the 4th of July weekend due to fire activity. The ability to expeditiously contact key individuals and proceed with fire suppression is critical, as without the funding we cannot legally continue to fight fire.

The wildland fire season in Alaska typically starts in mid-April and can last through the end of September. The Division of Forestry suppresses from 400 to 600 fires annually. We declare disasters in order to fund our fire suppression program. Recent examples where multiple declarations would have been necessary are the 1996 fire season which included the Miller's Reach Fire in a total of 565 fires, the 1997 fire season which included the Innowuk fire in a total of 562 fires, and the 1998 fire season which included the Carla Lake Fire in a total of 338 fires. The provision for legislative action with each \$5M increment will create problems for wildland fire suppression. Historically, the State has had to implement 2-3 Declarations of Disaster during a normal fire year to obtain funding, none of which have been less than \$5M. The state can also readily exceed this dollar limit without the fire disaster being declared a federal disaster.

We have identified three potential approaches to resolving these concerns in CSSB101.

- Wildland fire suppression activities can be exempted from the requirements of CSSB101. The process for obtaining funding under AS 26.23.050 can be maintained and a Supplemental submitted in the next session.



- The legislature could appropriate the average year's funding for wildland fire suppression into either the Department's Fire Suppression Budget or into the old Fire Suppression Fund. If additional funding is necessary it would occur through the proposed disaster funding process in CSSB101.
- CSSB101 can be implemented as written which will result in the following:
 - It is anticipated that the first Declaration of Disaster will be required in May of this fiscal year since the current supplemental request before the legislature does not include funding for this spring's wildland fires. The \$5M provision could conceivably result in more than one declaration.
 - Based on current funding levels and historical need for supplementals, we can anticipate frequent declarations of disaster requiring immediate legislative response. The wildland Fire Suppression component is funded for \$3.2M and the
 - average year expenditures are \$11.7M, with the highest year being \$27.5 in FY91. The \$5M ceiling will generate declarations to obtain normal funding. After reviewing the supplemental request history for recent years, and assuming an average fire occurrence year, we anticipate that the Department and the legislature will be dealing with 4-5 declarations every fiscal year as a result of the \$5M provision.

Wildland fire differs from other disasters in that we know there are historically 400-600 fires annually, we can geographically predict high fire risk areas daily based on scientific information, and we are prepared to respond. We cannot predict when, exactly where or how large fires will be - but we will have fires. I appreciate the concern over disaster expenditures and hope that we have been able to provide information that will be of assistance.

(a) In the performance of contracts awarded by the state in an area impacted by an economic disaster, residents of the area shall be employed where they are available and qualified so that the economic effects of alleviating the disaster will be maximized. If resident labor is not available, the contractor shall inform the Department of Labor of the number of additional workers needed, the positions to be filled, and the efforts made at recruitment in the area. If the Department of Labor is satisfied that a good faith effort has been made by the contractor to hire residents of the area, it may issue a certificate allowing other hire for designated positions. A clause requiring these provisions shall be part of each state contract awarded.

(b) Wages paid for employment under this section shall be in conformance with the minimum rates of pay schedule published by the Department of Labor in accordance with AS 36.05.030. (§ 1 ch 277 SLA 1976)

Dear Chairman Torgerson,

At the March 22, 1999 Senate Finance Committee hearing, I testified on the subject bill via teleconference from Anchorage. In accordance with your directions, I am submitting my written comments on the subject bill and am faxing these comments to your office today, March 22, 1999. In the interest of brevity, my comments are restricted to Sections 3 and 4 of the subject bill.

Section 3, page 3, lines 23 through 31:

1. Recommend communities, such as this jurisdiction, not be restricted to an "only once" receipt of disaster funds as a result of flood.

Rationale:

- a. Floods can occur with varying degrees. This jurisdiction could have floods as in 1989 and 1995 that affect only a portion of our community (jurisdiction). A flood can also vary in its scope, for example, a flood in the 100-year flood plain versus a flood in the 500-year flood plain. This legislation could be used to refuse funding if an area of our jurisdiction suffered flooding, such as Girdwood/Eklutna/South Fork/Peters Creek/Eagle River in 1995, yet suffered future flooding of a much higher intensity or from different streams.
 - b. This bill could also have the effect of eliminating the 25% traditional match by State of Alaska in federally declared flood disasters, thereby forcing local communities to absorb this cost, whether it be response, mitigation, or recovery.
 - c. What constitutes a community or area is unclear and ambiguous, as is the bill's possible application.
2. If the "only once" receipt of disaster funds is retained in the bill, then recommend mitigation funds be appropriated as a pre-requisite to future cut-off of disaster funds.

Rationale:

The current version of the bill would be punitive on local governments unless mitigation funds are provided to insure actions are taken to lessen or avoid future impacts of flooding. Without a

significant infusion of state mitigation funds as a pre-requisite to limiting future state disaster response and recovery funds, this provision would impose an unfunded mandate on local jurisdictions while at the same time, penalizing the local jurisdiction if it did not expend mitigation funds. Even if mitigation funds were provided/expended, this bill could still be used to curtail state disaster expenditures, if the mitigation actions did not "prevent" future flooding.

Section 4, page 4, lines 6 through 18:

1. Recommend the definition of "Disaster" remain general in scope, rather than enumerative.

Rationale:

Attempting to enumerate all type of disasters invariably eliminates unanticipated disasters. I concur with Commissioner Oates' testimony on this issue.

2. If the bill retains its disaster enumeration, then recommend, at a minimum, the words "shelter" be added at line 8 and "y2k and Aviation Disaster" be added at line 13.

Rationale:

Inclusion of "shelter" and "y2k" would insure disaster funds availability as a contingency should electrical power become an issue during changeover to year 2000. It would also address one of the basic human needs. Inclusion of "Aviation Disaster" would also insure disaster funds availability as a contingency should an incident occur similar to the New York area TWA Flight 800 accident. A similar aviation incident for the Anchorage area could be catastrophic in nature and would require immediate state assistance.

Thank you for the opportunity to testify on this important local government issue.

SB 101 an act amending the definition of disaster

First, the division welcomes any opportunity to discuss the process under which communities seek help from the state and federal governments in times of disaster. In accordance with AS 26.23.050, it has always been the policy of the state that funds to meet disaster emergencies will be available. This policy has served the citizens of this state well.

Under the new definition, which narrows the events under which the governor could declare a disaster, the state would be constrained to assist Alaskans when an unusual, natural event occurred. In addition, we would not be able to respond to a man-made event unless it was a release of oil or hazardous substance or an equipment failure but only if the failure was not predictably frequent or recurring event or preventable by adequate equipment maintenance or operation.

Examples of events which occurred in the past which would not have been declared under the new definition:

1979 Matanuska-Susitna Borough severe snow and high winds which closed roads and stranded residents. Rescue vehicles were unable to reach citizens in danger. The state declared and enabled DOT and the AK National Guard to clear the roads.

1980 Anchorage Windstorm damaged over 5000 homes and businesses in the Anchorage Bowl.

1983 Ketchikan A ship mishap damaged the dock on Gravina Island which was need for fuel transport between the city and the airport. State declared and used National Guard equipment to provide temporary alternate transport until the dock was repaired.

DAVID LIEBERSBACH - DIRECTOR ADES 2/3

1985 Metlakatla severe drought reduced water levels so the hydroelectric system could not generate sufficient power.

1989 Statewide Cold-record breaking temperatures of -85. The state declared as did the federal government in order to provide emergency repairs to maintain and prevent damage to water, sewer and electrical systems, emergency resupply of essential fuels and food. DOT provided support in maintaining access to isolated communities

1991 Mat-Su Erosion-severe erosion of the banks of the Matanuska River destroyed or threatened homes along the banks.

1991 Seward-the sewage treatment lagoon on Lowell Point road suffered a catastrophic failure from undetermined causes.

And finally

1998 Western Alaska Fisheries Disaster-record high water temperatures in the Bering Sea, poor survival rate of salmon from all drainages in the area, changes in migratory pathways which led to a collapse in the salmon runs. The state declared and requested a federal disaster. The federal government responded as they did under the Texas drought crop failures due to extreme unusual weather patterns.

Other events, which would not be covered under the new definition of an event are:

any acts as a result of terrorism (biological releases, weapons of mass destruction)

Train or ship wrecks due to human error

Events which MAY not be covered

Y2K events if the determination is that the events could or would have been preventable by adequate equipment maintenance or operation

The division respectfully cautions the committee to carefully consider this new definition because:

It is extremely difficult to define and list each possible event that may harm the people or property of the state. For example:

Recent Event occurred in the valley recent-meteor hit-had it been larger and in a populated area, the state would not be able to declare a disaster in order to assist the affected community.

Summarize what will not be included:

extreme temperature conditions
 drought, crop failure
 train or ship wrecks
 High winds not defined as tornado, typhoon or hurricane
 Severe snow storms
 Erosion
 Catastrophic sewage system failures
 And many others that haven't happened yet which we have no way of describing.
