FOR AN ACT ENTITLED

1 "An Act relating to management of game."

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

3 \* Section 1. AS 16.05.255 is amended by adding a new subsection to read:

4 (i) Notwithstanding any other provision of this title, in an area for which the  
5 board has adopted regulations under (e) of this section to provide for intensive  
6 management of an identified big game prey population, a person may take a wolf on  
7 the same day the person was airborne; however, a person may not shoot a wolf from  
8 the air under this subsection. For purposes of this subsection, a valid hunting or  
9 trapping license is a permit to take a wolf on the same day airborne for purposes of  
10 protecting wildlife, and no additional permit may be required by the board or  
11 department as a prerequisite to taking a wolf on the same day airborne.

12 \* Sec. 2. AS 16.05.783(b) is amended to read:

13 (b) This section does not apply to

14 (1) a person who was airborne the same day if that person was airborne  
15 only on a regularly scheduled commercial flight; or

- 1 (2) an employee or agent of the department who, as part of a game  
2 management program, is authorized to shoot or to assist in shooting wolf, wolverine,  
3 fox, or lynx on the same day that the employee or agent has been airborne.

## Sponsor Statement

### Senate Bill 267

#### **“An Act relating to management of game.”**

Senate Bill 267 directs the Commissioner of Fish and Game to “accord a high priority to the implementation of programs and regulations adopted by the Board of Game under AS 16.05.255(e) – (i)” which provides for intensive management programs to restore the abundance or productivity of identified big game prey populations as necessary to achieve human consumptive use goals of the board. This bill directs the commissioner to allocate fiscal and staff resources to implement intensive game management programs and regulations in a timely and effective manner.

Senate Bill 267 amends AS 16.05.255 by adding a new subsection which provides for the taking of wolves on the same day airborne. Further, a hunting or trapping license is a permit to take a wolf. The board or department may require no additional permit. The prohibition of same-day airborne hunting (AS16.050783) would not apply when the Board of Game has adopted regulations to provide for intensive management of an identified big game prey population.

This bill also authorizes an agent of the Department of Fish and Game, as part of a game management program, to shoot or assist in shooting predators on the same day airborne.
