ANALYSIS: (Attach a separate page if necessary)

HB 489 adds seeing someone commit animal cruelty, and then knowingly fail to report the crime to law enforcement, to the definition of cruelty to animals. The bill further increases the penalty for cruelty to animals from a misdemeanor to a class C felony.

During 2000, the Department of Law got convictions in eight cruelty to animal cases. Due to the relatively low number of these cases, increasing the penalty for animal cruelty to a felony as defined in current law is expected to have a negligible fiscal impact on the agency. However, making failure to report animal cruelty a felony is expected to cause many new referrals for prosecution, which will need to be investigated and reviewed, even if the state cannot ultimately prosecute. While we believe passage of section 2 of HB 489 will increase the department's workload, we have no way of reliably estimating the impact.

This legislation elevates cruelty to animals from an A misdemeanor to a C felony. It also broadens the elements of the crime to include "failure to provide the necessary standard of care" but removes "and as a result, causes the death of the animal or cause severe physical pain or prolonged suffering to the animal". Finally, this legislation would make the observation and knowing failure to report a violation to a law enforcement agency a C level felony also.

The Department of Law reports that in 2000 there were 8 convictions of cruelty to animals with an average sentence of about 10 days. It difficult to estimate what an average sentence would be if this becomes a felony. There will undoubtedly be additional imprisonment as well as probation supervision imposed. While the impact to the Department is difficult to quantify, there will be an impact. Most

Sponsor Statement House Bill 489

It is a well documented that animal abuse is a precursor to child abuse. In fact studies by the American Humane Society and the American Psychiatric Association strongly suggest that if animal cruelty is identified and treated as a juvenile problem, we could avoid a good deal of adult domestic abuse.

House Bill 489 simply allows a prosecutor to charge a person with cruelty to each animal found to be neglected or abused. It also strongly suggests that the courts mandate behavior counseling.

The Bill allows for "duty to report" abuse to authorities and holds a person harmless who in good faith reports animal abuse to the authorities.

Troopers find 4 dead dogs Sterling woman told to clean yard

A Sterling woman has been given until Friday to start taking better care of her collection of dogs, or Alaska State Troopers will confiscate the **animals** and recommend charges to the district attorney's office.

The dogs belong to Carolyn Boughton and are housed on a Spruce Lane lot about 5 miles east of Sterling. The property was searched by troopers with warrants Monday evening, according to Trooper 1st Sgt. Charles Tressler of E Detachment in Soldotna.

He said there were no more than 40 dogs on the property, though other estimates put the total at more than 60. Nancy Wall, a Sterling volunteer with the Society for the Prevention of **Cruelty to Animals** of Alaska in Anchorage, said the difference could be several litters of puppies that were out of sight.

Tressler said four dogs were found dead, possibly from malnutrition, but none of the rest were in such bad shape as to need euthanasia. Four were given immediate medical attention.

"We've received a couple of complaints," Tressler said. "If she doesn't comply with certain conditions by Friday, we'll have to seize the dogs."

The conditions include feeding and watering the dogs better and giving them longer leashes and better shelters.

The troopers specifically want the dogs out of the bus, Tressler said.

From the road, about 20 dogs, mostly Bouvier des Flandres -- large black herding and guard dogs originally from Belgium -- could be seen tied to trees scattered about the periphery of the yard. Most had shelters.

There also were huskies and mixed-breed dogs in the yard, including four husky pups, which reportedly belong to the property owner. The huskies seemed well fed and had doghouses.

The rest of the dogs were inside a 40-foot tour bus in one of the two driveways. A distinct odor of feces and urine emanated from a broken window and could be smelled several feet away.

Some of the dogs were Kerry Blue Terriers, which Wall said look much like Bouviers, only smaller.

Two of the four dead dogs were terriers found inside the bus; the other two, Bouviers, were frozen to the ground outside. They appeared to have been dead between a few days and a week or more, Tressler told The Associated Press. There also were at least two dead cats, Wall said.

"It's not a normal dog yard. Mine is normal, and it's below mine," Tressler said.

He said the condition of the dog yard was not as much a danger to the **animals** as not having proper shelter or proper food.

Tressler said Boughton was cooperative with the troopers and indicated to them she will attempt to meet the conditions.

Boughton could not be reached for comment.

Wall, however, was upset that troopers did not cite Boughton for **cruelty to animals**.

"It's shocking to me that they would give her until Friday to get it cleaned up. What more evidence of **cruelty** do they need than dead dogs in the yard?" Wall said. "I don't know how they went home and slept in their warm beds. I know I didn't get much sleep."

She speculated that troopers just didn't know what to do with the **animals** if they did confiscate them.

Wall got permission from the home owner to visit the yard and was there when troopers arrived with a warrant.

"We don't know how many dead dogs there might be under the snow," she said. "And the dead cats were pretty flat, we could have been walking on them. It was horrible."

She said one of the dead Bouviers had wrapped its feet around its tether and apparently froze to death.

"It was pretty gruesome," she said.

She did not know if there had been any cannibalism among the dogs.

"I couldn't tell if something was eaten or was rotten," she said.

Wall said she's known Boughton for two years and knows her to be a loving **animal** owner who is very knowledgeable of Bouviers.

"I don't know what happened. This is not how her yard looked last September on Robinson Loop. There was food everywhere then," she said. "What I saw last night was not what I saw last year."

Boughton was visited by Wall, a veterinarian and troopers in September 2000 after reports of **animal cruelty**. What Wall found was to the contrary, that while the **animals** were living in junked cars, they were well fed and clean.

Wall, who coordinates the visits of SPCA's mobile spay and neuter clinics to Sterling, said she offered to bring the trailer to Boughton's dog yard and spay or neuter the dogs but was turned down. She has, however, placed many of the cats and dogs Boughton has collected into loving homes.

"I've always been welcome in Carolyn's yard," she said. "The Carolyn I've known the last two years loved those dogs and worked hard to take care of them."

Wall said she has contacted authorities from Kenai Peninsula Borough Assembly member Grace Merkes to Rep. Ken Lancaster to Sen. Ted Stevens complaining about the situation.

"My concern is that people who wish to be kind will donate food, and by Friday, Boughton will be looking pretty good to the troopers," Wall said.

"I think it's inexcusable the troopers went down there and found dead dogs on a chain and did nothing. This should have stopped last night," she said Tuesday.

Wall said there are three scenarios that could play out: 1) Boughton could comply with the demands of the troopers and better care for the dogs; 2) she could release ownership of them, in which case Wall said the Bouvier rescue organization in Colorado could accept and place them; or 3) troopers could seize the **animals**, charge Boughton and wait for a judge to determine ownership. If any **animals** are in too bad of shape, they may have to be destroyed.

"It'd be a shame to have to put them down. They are very friendly, beautiful dogs," Wall said. "Some are finished

Dear Representative Chennult:

The recent animal abuse case involving Caroline Boughton in Sterling, Alaska has caused great outrage. She was allowed to continue running her "puppy mill" despite a prior record of abuse. When she was caught this time the live dog body count was 49 dogs. Some were barely alive. The frozen carcasses of other dogs and cats who died of neglect or were eaten by the others to survive were horribly evident. The animals were packed into a filthy bus living in their own feces and urine. The animals outside had no food, shelter and water. The images from the media coverage will cause many of us anguish for a long time. Amazingly, she was allowed to keep five of the dogs.

This is the second time Caroline Boughton has done this. Shockingly the troopers are not pursuing this case. Apparently there is no State law or enforcement available to punish and deter such abuse. The D.A. in Kenai is "reviewing it". Nancy, a 25 year volunteer with the Alaska Society for the Prevention of Cruelty to Animals was working with Boughton. Is Caroline Boughton walking away after one of the most horrible crimes imaginable against animals? Where are the laws to protect and prevent this cruelty?

We are asking that you exercise your influence and authority to stop this inhumane treatment. The penalty for such despicable behavior should be considerable. Only this can deter its commission. There should never be second time offenders. Caroline Boughton should have been prohibited from ever owning or caring for any animal. The laws are woefully inadequate if such abuse cannot be prosecuted and stopped the first time. To allow a second offense to occur and not be able or willing to do anything must not be permitted. This conduct should be punishable with mandatory jail time; mandatory community service; and/or mandatory counseling. Only this will prevent such abuse and deter those causing innocent animals to suffer.

If you need further persuasion please let me send you the video made by the rescuers. I have attached a few of the signature pages I have collected. More signatures are coming in every day. As you can see there are many who are asking for your assistance to stop such abuse. Let's act now!


Dear Representative Kott:

Thank you for responding to my letter co signed by 140 Alaskans. The video will be sent to you under seperate cover. More completed signature pages are coming in every week. We respectfully request that you consider sponsoring the following amendments to AS. 11.61.140 currently the only state law addressing cruelty to animals and the alleged abuse committed by Ms. Boughton.

1. Make cruelty to animals and abuse of animals a felony not a misdemeanor.
2. Mandate fines which would cover the costs of recovery, care, maintenance and adoption of such abused animals.
3. Provide for the forfeiture of such abused animals to authorities who may care for these animals during pendency of any investigation and during the course of any criminal proceedings.
4. Include a section that a person convicted of this crime cannot own, possess or house any animals. Provide penalties for any violation.
5. Provide for the strict licensing of so called "puppy mills" requiring periodic inspections; establishing regulations on proper care, maintenance of facilities; and providing for licensing fees which will provide funding to enforce inspections and the purposes of this statute.

We are hoping you can make these changes a reality. Please let me know what the next step is to get this process started.
