Sponsor Statement for SB 145 "An Act Relating to Municipal Impoundment & Forfeiture"

SB 145 allows municipalities to impound a motor vehicle owned by a person who has more than \$1,000 in unpaid traffic fines. Under current law municipalities are authorized to adopt local ordinances for impoundment and forfeiture of vehicles for crimes including driving while intoxicated, driving with a suspended license and driving without insurance. SB 145 would add accumulation of more than \$1,000 in unpaid citations to the list.

The Municipality of Anchorage currently has \$7.57 million in unpaid fines. Currently, 1017 individuals have over \$1,000 in unpaid fines. One person has 43 citations totaling \$9,310, another has 70 traffic citations totaling \$7,853 in unpaid fines. This law targets the habitual, repeat offenders who time and again violate traffic laws, blatantly disregard public safety and refuse to pay citation fines. Many of these offenders refuse to pay their fines because they know the municipality has little recourse to collect.

SB 145 simply allows the municipality to use forfeiture as a way to encourage compliance with the law. SB 145 has no fiscal impact to the state.

Municipality of Anchorage Breakdown of Delinquent Fines/Multiple Offenders

In total, 23,718 individual offenders owe the MOA \$7,572,060.69 in delinquent fines from unpaid traffic citations. These numbers do not include unpaid parking tickets.

1017 offenders have \$1000 or more in delinquent fines for multiple traffic citations

This amounts to \$1,656,865.85 in delinquent fines.

Of those offenders:

1 person has two delinquent traffic citations

11 people have three delinquent traffic citations

1059 have four or more delinquent traffic citations

5 or more traffic citations = \$2,570,939.17 in delinquent fines (33.95% of total).
2401 offenders

4 or more traffic citations = \$3,279,849.40 in delinquent fines (43.31% of total).
3644 offenders

3 or more traffic citations = \$4,284,599.20 in delinquent fines (56.58% of total).
5974 offenders

**Written Remarks before Senate Community & Regional Affairs Committee

Thank you, Chairman Olson, for the opportunity to provide testimony before your Committee today regarding SB 145, more specifically the working draft Committee substitute which addresses 2 closely related issues dealing with repeat violators owing multiple delinquent traffic citations and criminal fines, all of which are judgment cases that have run through the Alaska Court System. Please note that the Municipality is a formal collection agent of the Court System for these judgment cases.

Unpaid default judgment cases are at a crisis point and local governments and the Alaska Court System need to be empowered with the highest levels of enforcement / collection tools available.

The Municipality strongly supports the concept behind both major elements contained in the Committee Substitute for SB 145, which is before you today. Our objective in promoting this legislation is to enhance public safety, to rightfully hold individuals accountable for past violations of the law, and to strongly encourage greater compliance with the law going forward.

The focus of my testimony today will be on the need for access to employer records held by State Department of Labor (DOL). While we generally support the concept espoused in the draft bill regarding access to employment records we are not comfortable with the proposed language because it is too vague and does not provide adequate assurance that DOL will follow-thru within a reasonable amount of time to requests for employment information from authorized parties. We have literally worked for 2 full years now with various individuals at DOL to gain access to employer records under the existing "may" clause in AS 23.20.110P but DOL has repeatedly delayed and obstructed our requests. New statutory language that is clear and accountable to both DOL and any authorized local government official requesting employer data is what is needed. Below is our suggested language to remove ambiguity from the bill:

Section 1. AS 23.20.110 is amended by adding a new subsection to read:

CURRENT DRAFT

- (r) The department ~~may~~ shall provide information obtained under this chapter to a municipal attorney to assist the municipality in the collection of civil or criminal fines, penalties, or other payments or judgments ordered by a court. The department may not release information under this section to a municipal attorney until the

department and the municipal attorney have entered into a written agreement that governs the release of the information. The written agreement must specify

- (1) The purpose for the information;
- (2) A description of the information to be provided;
- (3) A description of the procedure for transmitting, securing, using and disposing of information; and
- (4) The method of reimbursement for the cost of providing the information.

Background:

The Municipality of Anchorage has for the past several years dramatically revamped its approach to collection of delinquent traffic citation and criminal fine judgment cases. During this period we have cleansed our data, hired additional internal and external expertise, and worked closely with a task force comprised of the Court System, DMV, the municipal prosecutor and the Anchorage Police Department to address a serious and ever growing problem of individuals not being held fully accountable for paying traffic fines and criminal fines that have been assessed by the Court.

Magnitude of the Problem:

The statistics are staggering and the problem is growing worse every year despite all our current collection efforts. Below are statistics which quantify the problem for traffic and criminal fine judgment cases for Anchorage alone:

- Currently there are [REDACTED] owed to the Municipality. This represents 53,603 unpaid outstanding citations (please see Excel spreadsheet provided to Committee staff, for a detailed listing).
- Owing 4 or more Traffic Citations. There are 3,644 unique individuals who owe \$3.3 million in unpaid traffic citations (i.e., this equates to an average individual owing a cumulative citation balance of \$917). This group represents 15% of the delinquent debtor population and 43% of all the money owed on traffic citations. The average individual citation value for this group is \$138 per ticket (i.e., \$3.3 million owed, divided by 23,974 outstanding citations).
- Owing 1-3 Traffic Citations. There are 20,073 unique individuals who owe \$4.3 million in unpaid traffic citations (i.e., this equates to an average individual owing a cumulative citation balance of \$215). This group

represents 85% of the delinquent debtor population and 57% of all the money owed on traffic citations. The average individual citation value for this group is \$145 per ticket (i.e., \$4.29 million owed, divided by 29,629 outstanding citations).

- Currently there are [REDACTED] owed to the MOA. This represents 25,930 unpaid criminal fines with an average balance owed of \$626 per judgment case (please see Excel spreadsheet provided to Committee staff, for a detailed listing).

The extreme balances owed by tens of thousands of individuals represent a systemic disregard for the justice system. Individuals are choosing not to pay the fines that have been ordered by the Court. And, to this point, they have become accustomed to PFD garnishment being a means to passively pay off small portions of what is owed. Note: historically the MOA receives approximately 25% realization on the PFD file we submit each year; in 2006 th's 25% realization rate equated to \$3 million. The above figures represent balances still owed after applying 2006 PFD money. Every year approximately \$6 million of new judgment cases are passed to us by the Court. We are losing ground in collecting each year due to the volumes of new cases and the existing limitations on our ability to garnish funds.

Proposed Solution:

The Wage Garnishment issue, along with impounding vehicles where > \$1,000 in delinquent traffic fines is owed, were both proposals that came out of a local task force recommendation comprised of Court System, DMV, APD, Municipal Prosecutor and MOA Treasury. Both proposals were also included as top priorities within the Public Safety legislative section of the Municipality's 2007 Legislative Program.

A State Law change would provide DOL with clear authority to work with municipalities to enforce collection of court-ordered fines. We believe that having the ability to use wage garnishment on a large scale will send a strong message to the violators (and to the rest of the population) that we are no longer going to allow these violators to evade paying the traffic and criminal fines that they have been assessed after receiving due process through the court system. We want to ensure that violators are held fully accountable for their actions.

The Municipality is not asking for any information related to unemployment claims made or in-process. MOA only needs to receive Employer Name &

Address for those individuals who are currently working, as of the most recent quarterly filing received from private employer.

Note: DOL already has pre-existing established practices to share information with other agencies such as Child Support and DHSS. There are specific provisions in State law currently that authorize DOL to share information with other named agencies. The proposed legislation would explicitly add one more set of authorized entities able to receive Employer Name / Address information from DOL.

Benefits Derived:

We believe that full enforcement of Court orders on public safety matters is what the public expects. The Department of Revenue and the Alaska Court System have worked closely with the MOA for the past 12+ years to share confidential information in order to pursue collection. We literally have access to 600,000 PFD applications with name, phone, address, SS # and D.O.B. While this is a very effective garnishment tool it's limited by the amount of PFD money available each year. Wage garnishment, on the other hand, would provide a garnishment tool many times greater than PFD.

Initial concerns of DOL, addressed in our REVISED Committee Substitute draft language for SB 145:

With respect to confidentiality of information there is no federal restriction on sharing Employer Name / Address information between DOL and the Municipality. And, with respect to fiscal impact, there would be no need for increased budgetary authority since the authorized requestor of the Employer Name / Address information would be the entity required through State law to bear 100% of all direct costs + a not-to-exceed 30% overhead rate (i.e., indirect costs).

DOL will be able to select the IT vendor of their choice to create an electronic data interface. This IT project is not considered complicated. The data sharing requests literally can be done with a few pushes of the button, once the interface is created. The Municipality, as a requestor, would pay all direct costs incurred + a maximum 30% overhead markup. The Municipality expects to request information from DOL only 1-4 times per year. There would be no need for DOL to add any additional staff. The legislation would give them clear, up-front authority. There would be no need for a special attorney to review each and every request. The Municipality already fully complies with security requirements of the DOL, per questions asked of us by Pat Shier of DOL - anyone from DOL/Anchorage or DOL/Juneau can audit the Municipality's

confidential information (i.e., Social Security number), only non-confidential information (i.e., Employer Name / Address).

This legislation promotes the greatest public good by holding debtors accountable for breaking public laws. This can only help to encourage greater compliance with laws in the future and improve public safety. In addition, every dollar collected via wage garnishment by Municipality will go back to the Anchorage Police Department's budget to fund police enforcement, in addition to reimbursing the Court for their portion of Court collection costs.

Dear Senator McGuire:

Thank you for sponsoring Senate Bill 145, "An Act Relating to Municipal Impoundment and Forfeiture," which will help make Anchorage's streets safer.

In Anchorage, we have traffic citations totaling over \$7 million in unpaid fines. Currently more than 1,000 individuals have more than \$1,000 in unpaid fines, including two individuals who owe more than \$7,000 in unpaid fines. We assume these individuals are continuing to drive and they will possibly accrue even more tickets. These frequent abusers obviously do not feel there are adequate consequences to deter their behavior.

Just as legislators constantly look for ways to cut the budget or increase revenues without reducing services, having the ability to seize property due to egregious unpaid fines will allow the municipality to recoup revenue without impacting innocent taxpayers.

Please let me know if we can help you with the passage of this legislation.

Dear Senator McGuire:

The purpose of this letter is to endorse the bill you are sponsoring that deals with habitual offenders. This legislation is a positive step towards addressing the present problem posed by having no mechanism to keep drivers who simply refuse to obey traffic laws and refuse to pay the fines associated with their driving violations.

Anchorage has instances where individuals have up to seventy unpaid tickets, and there are numerous cases where persons have ten or more outstanding fines for tickets. This is not only about fines; it is an attempt to address the reality that these people continue to drive unencumbered by respect for the law and a sense of responsibility for their actions.

This legislation targets those persons who are unwilling or unable to learn from their mistakes. The majority of our citizens, when stopped, will either exercise their due process to challenge the citation or will pay the assessed fine. It is only those whose blatant disregard for the law and the safety of the road who will be impacted by this new law.

The Anchorage Police Department supports efforts to make it more difficult for habitual offenders to drive, which will make our streets safer for all Alaskans.

Any concern about a fiscal note is completely inconsistent with the DOLWD pre-existing established practices to share information with other agencies such as Child Support, Alaska State Troopers, and DHSS. There are specific provisions in State law currently that authorize DOLWD to share information with other named agencies. The MOA's proposed legislation would explicitly add one more set of authorized entities able to receive Employer Name / Address information from DOLWD.

State government will absolutely not need to grow as a result of the MOA proposed legislation. In fact government (State, Local and Court System) will act many times more efficiently and effectively by enactment of the MOA proposed legislation. DOLWD's assertion regarding financial effects is clearly inflated and not based in reality.

DOLWD will be able to select the IT vendor of their choice to create an electronic data interface. This IT project is not considered complicated. The data sharing requests literally can be done with a few pushes of the button, once the interface is created. MOA as a requestor would pay all direct costs incurred plus a maximum 30% overhead markup.

The MOA expects to request information from DOLWD only 1-4 times per year. There would be no need for DOLWD to add any additional staff. SB-145 legislation would give them clear, up-front authority. There would be no need for a special attorney to review each and every request. MOA already fully complies with security requirements of the DOLWD, as defined and presented to us by Pat Shier of DOLWD - anyone from DOLWD/ Anchorage or DOLWD/Juneau can audit the MOA's secured environment at anytime without any material cost impact to DOLWD. Legal review and security checks are upfront tasks that would be done as part of initial setup and then only periodically on an as-needed basis going forward.

ISSUE/PROJECT NAME: Impoundment of Vehicle Operated During Suspension of Driver's License

PRIORITY: 5

ISSUE/PROJECT DESCRIPTION:

There are 21,000 unique individuals who currently owe the Municipality of Anchorage on 80,000 delinquent court fine (DCF) cases. The ratio of DCF cases to unique individuals is therefore approximately 4:1. Considering traffic cases alone, nearly 40% of all traffic violators are choosing not to pay court-imposed fines. The proposed legislation would provide a tool to enhance MOA's collection and enforcement ability, allowing seizure of monies owed year round, rather than just at PFD time, through impoundment of vehicles driven by repeat offenders of traffic laws.

Following is proposed language for a bill amending AS 28.15.031:

"An Act relating to payment of traffic-related civil fees and criminal fines, suspension of drivers license privileges, and impound of vehicle operated during suspension of drivers license"

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

* AS 28.15.031(g) is amended to read as follows:

(g) The court may suspend the driver's license, privilege to drive, or privilege to obtain a license of a person who fails to appear in court as required by a citation for an offense involving a moving motor vehicle, or who fails to pay a fine as required by the court for an offense involving a moving motor vehicle. If the court suspends a driver's license under this subsection, the court shall also provide notice of the suspension to the department. A suspension imposed under this subsection remains in effect until the person appears in court as required by the citation, or pays the fine as required by the court. When the person appears in court or pays the required fine, the court shall terminate the suspension imposed under this subsection and provide the department and the person with written notice of the termination.

(1) The vehicle of a person, with a suspended license pursuant to AS 28.15.031(g) who is subsequently cited for an offense arising under traffic laws is subject to impound.

**ISSUE/PROJECT NAME: Municipal Access To Debtors Employment Information Held
by State Employment Security Division**

PRIORITY: 6

ISSUE/PROJECT DESCRIPTION:

The alteration of AS 23.20.110 would allow the Municipality access to private employee records to obtain employment information regarding specific individuals with unpaid delinquent criminal fines and fees owed to Municipality of Anchorage (MOA). The information would allow MOA the ability to enforce consequences, utilizing court authorized due process wage garnishments, against those individuals who fail to take responsibility for their unlawful actions. Further, by effecting a garnishment of wages on a wholesale basis, we hope for a positive change in behavior both in how people respond to court ordered judgments but, more importantly, in their respect for public safety.

Following is proposed language for a bill amending AS 23.20.110:

"An Act relating to release of information by Employment Services Division to municipal or borough attorneys for purposes of providing employer information to assist with collection or enforcement of a civil or criminal fines and fees."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

* Section 1. AS 23.20.110 is amended to add a new section to read as follows:

Upon written request by a municipal or borough attorney of a political subdivision of the State of Alaska, the department shall provide the most recent or currently available employer data to be used by requestor for wage garnishment purposes. The department shall make every effort to provide, in an electronic format, a data match to the requestor-provided listing of debtors owing a criminal or civil fine or fee resulting from a court judgment. At a minimum, matched records provided to the requestor shall:

- (1) first be provided within 180 days of enactment of legislation;
- (2) subsequently be provided within 30 days of request;
- (3) include required data elements necessary to effect wage garnishment, specifically:
 - (a) verification data of the person including name and social security number, and
 - (b) current legal business and employer names, physical work site address, and business phone number.

(a) Except as provided in (b) and (i) of this section, the department shall hold information obtained from an employing unit or individual in the course of administering this chapter and determinations as to the benefit rights of an individual confidential and may not disclose them or open them to public inspection in a manner that reveals the identity of the individual or employing unit. A claimant or an employing unit, or the legal representative of the claimant or the employing unit, is entitled to information from the records of the department to the extent necessary to properly present or protest a claim or determination under this chapter. Subject to restrictions that the department prescribes by regulation, the information may be made available to an agency of this state or another state or federal agency charged with the administration of an unemployment compensation law or the maintenance of a system of public employment offices, or, for the purposes of the Federal Unemployment Tax Act, to the Internal Revenue Service of the United States, or, for tax purposes, to the Department of Revenue. Information obtained in the course of administering this chapter or in connection with the administration of the employment service may be made available to persons or agencies for purposes appropriate to the operation of a public employment service or the administration of employment and training programs planned or coordinated by the Alaska Workforce Investment Board under AS 23.15.550 — 23.15.585.

(b) Upon request the department shall furnish to an agency of the United States charged with the administration of public works or assistance through public employment, and may furnish to a state agency similarly charged, the name, address, ordinary occupation, and employment status of each recipient of benefits and the recipient's rights to benefits under this chapter.

(c) Upon request of an agency of this or another state or of the federal government which administers or operates one or more programs of public assistance under either federal law or the law of this state, or which is charged with any duty or responsibility under any such program, and if that agency is required by law to impose safeguards for the confidentiality of information at least as effective as required under this section, the department shall provide, with respect to any named individual specified by the requesting agency, the following information:

(1) whether the individual is receiving, has received, or has made application for unemployment compensation under this chapter;

(2) the period, if any, for which unemployment compensation was payable and the weekly rate of compensation paid;

(3) the individual's most recent address; and

(4) whether the individual has refused an offer of employment, and, if so, the date of the refusal and a description of the employment refused, including duties, conditions of employment, and rate of pay.

(d) The department may require that an agency or authorized person to which it provides information under this section reimburse the department for its costs of furnishing that information.

(e) The department shall provide information

(1) requested by a state or federal agency under an income and eligibility verification system that meets the requirements of 42 U.S.C. 1320b-7 (Social Security Act); or

(2) as required by federal law for child support purposes.

(f) *[Repealed, § 2 ch 60 SLA 1985.]*

(g) The requirements of this section concerning the confidentiality of information obtained in the course of administering this chapter apply to officers and employees of a state or federal agency to whom the department provides information as authorized by this section.

(h) The department shall make information obtained from an employing unit or an individual available on request to an administrator of a joint administered defined pension benefit plan established under 29 U.S.C. 1001 — 1461 (Employee Retirement Income Security Act) to assist the administrator in verifying whether a person receiving a retirement benefit from the plan has been employed in the last six months. To the extent the information is available to the department, the department shall provide the administrator with the name and address of the person's current employer and the person's current occupation. The administrator shall keep information received under this subsection confidential. However, the administrator may reveal the information if it is relevant to a legal proceeding in which the administrator or the plan is a party. The department may require the plan to reimburse the department for the cost of furnishing the information.

(i) The department shall publicly disclose information obtained from an employing unit or an individual as provided in this subsection to encourage employers to voluntarily consider the availability of qualified job seekers who are residents of the state. The department shall issue a report that discloses the names of all public and private employers who employ at least 20 employees. The report must address the employment record of each employer subject to this subsection and must contain the results of the department's analysis of the employers' practices of hiring persons who are not residents of the state. The department may not use the results of the analysis to limit or deny services or benefits or to discriminate against an employer. The department may not disclose information under this subsection that would individually identify an employee.

(j) Notwithstanding (h) or (i) of this section, the department may not release information to an administrator under (h) of this section or on an employer's hiring practices under (i) of this section if the United States Secretary of Labor rules that release of the information would be grounds to find that the state is in substantial noncompliance with 42 U.S.C. 503(a).

(k) If an individual who is applying for or participating in a housing assistance program administered by the United States Department of Housing and Urban Development gives authorization, the department shall disclose, to the United States Department of Housing and Urban Development or to representatives of the housing assistance program operating the program, wage information and unemployment compensation information. The authorization shall be made by the individual on a consent form

approved by the department. The form must state the information authorized to be released and require the signature of the individual. In this subsection,

(1) "unemployment compensation information" means whether the individual is receiving, has received, or has applied for unemployment compensation, and the amount of unemployment compensation that the individual is receiving or will receive;

(2) "wage information" means the social security number, or numbers if there are more than one, and quarterly wages of an employee, and the name, address, state, and, if known, federal employer identification number of an employer reporting wages under this chapter.

(l) The department may provide information obtained under this chapter to an agency of this state or to a person under contract with the state to

(1) verify the eligibility of an applicant for a public benefit or a publicly financed payment;

(2) assist the state in the collection of fines, penalties, judgments of restitution on behalf of victims of crimes or delinquent acts, or other payments ordered by a court or an administrative agency; or

(3) collect money owed to the fund under this chapter.

(m) The department may not release information under this section to a state agency or to a person under contract with the state until the department and the agency or person have entered into a written agreement that governs the release of information.

The written agreement must specify

(1) the purpose for the information;

(2) a description of the information to be provided;

(3) a description of the procedure for transmitting, securing, using, and disposing of the information; and

(4) the method of reimbursement, if any, for the cost of providing the information.

(n) The department may produce statistical and other public reports based on information obtained in the course of administering this chapter, so long as the reports do not reveal wage and payroll data for an employing unit or the name or number identifying an individual. The reports may include the firm name, address, North American Industry Classification System code, census area code, number of workers employed, and occupational staffing patterns for an employing unit.

(o) Upon request and for child support purposes authorized under law, the department shall provide to the child support enforcement agency created in AS 25.27.010, or the child support enforcement agency of another state, the following:

(1) the name, address, social security number, ordinary occupation, and employment status of each applicant for or recipient of benefits under this chapter;

(2) information about the applicant's or recipient's right to benefits under this chapter;

(3) the name, address, and employer identification number of the applicant's or recipient's current or former employer;

(4) information, if available, on the applicant or recipient concerning

(A) earnings or other income of the applicant or recipient;

(B) benefits from employment, including rights to or enrollment in group health care coverage; and

(C) the type, status, location, and amount of assets of or debts owed by or to the applicant or recipient.

(p) In this section, "judgment of restitution" has the meaning given in AS 09.38.500. Cindy—

Thank you for the update. **Q: Do you have a point of contact at Dept of Labor who could provide us more specifics?** We had spoken to Mel Torgeson at ESD last October 2006 and he stated that the Legislature determines which parties are authorized to their agency's information. He further stated that ESD would follow any revised Statute. In recent years the Legislature did make a change authorizing ESD to release employer information to law enforcement agencies seeking to track down individuals with arrest warrants; this is a recent example of how the Legislature chose to allow use of employer data to serve the greater public good. With respect to federal confidentiality requirements, we've heard this referenced previously by ESD but they have yet to provide any specific cites to us.

We believe that full enforcement of Court orders on public safety matters is what the public expects. The Department of Revenue and the Alaska Court System have worked closely with the MOA for the past 12+ years to share confidential information in order to pursue collection. We literally have access to 600,000 PFD applications with name, phone, address, SS # and D.O.B. While this is a very effective garnishment tool it's limited by the amount of PFD money available each year. Wage garnishment, on the other hand, would provide a garnishment tool many times greater than PFD. It is my understanding that ESD has an established relationship with Child Support Division to supply employer information to garnish wages. So as a matter of public policy there appears to be inconsistency in ESD working with 1 government agency to enforce Court-ordered judgments but not with another (i.e., MOA / AK Court System). The MOA literally works as a collection agent for the AK Court System – there is a formal agreement in place.

Unpaid default judgment cases are at a crisis point and the MOA / AK Court System need to be empowered with the highest levels of collection tools available. Below are statistics which quantify the problem for traffic and criminal fine judgment cases:

- Currently there are **\$7.57 million in unpaid Traffic Citations owed to the MOA by 23,717 unique individuals.** This represents 53,603 unpaid outstanding citations (*please see attached detail listing*).
- Owing 4 or more Traffic Citations. There are 3,644 unique individuals who owe \$3.3 million in unpaid traffic citations (i.e., this equates to an average individual owing a cumulative citation balance of \$917). This group represents 15% of the delinquent debtor population and 43% of all the money owed on traffic citations. The average individual citation value for this group is \$138 per ticket (i.e., \$3.3 million owed, divided by 23,974 outstanding citations).
- Owing 1-3 Traffic Citations. There are 20,073 unique individuals who owe \$4.3 million in unpaid traffic citations (i.e., this equates to an average individual owing a cumulative citation balance of \$215). This group represents 85% of the delinquent debtor population and 57% of all the money owed on traffic citations. The average individual citation value for this group is \$145 per ticket (i.e., \$4.29 million owed, divided by 29,629 outstanding citations).
- Currently there are **\$16.2 million in unpaid Criminal Fines owed to the MOA by 16,745 unique individuals.** This represents 25,930 unpaid criminal fines with an average balance owed of \$626 per judgment case (*please see attached detail listing*).

The extreme balances owed by tens of thousands of individuals represent a systemic disregard for the justice system. Individuals are choosing not to pay the fines that have been ordered by the Court. And, to this point, they have become accustomed to PFD garnishment being a means to passively pay off small portions of what is owed. Note: historically the MOA receives approximately 25% realization on the PFD file we submit each year; in 2006 this 25% realization rate equated to \$3 million. The above figures represent balances still owed after applying 2006 PFD money. Every year approximately \$6 million of new judgment cases are passed to us by the Court. *We are losing ground in collecting each year due to the volumes of new cases and the existing limitations*

on our ability to garnish funds.

Key summary points regarding MOA's proposed legislative change (with ESD's perspective in mind):

The MOA is proposing to receive matched records on delinquent debtors owing State Court mandated judgment cases only. We are not asking to receive Dept of Labor's full file of employer data. We are prepared to fully fund the cost of an IT firm building a bridge to Dept of Labor's records. The IT firm would be chosen and controlled by Dept of Labor, to guard information. The MOA could provide SS # to Dept of Labor to guarantee a match but they wouldn't necessarily have to provide SS# back to the MOA, just name and D.O.B. and employer information.

We highly respect the need for confidentiality and control of data. We believe that the new State law will give Dept of Labor the explicit authority they need to help the MOA match its debtor files to Employers records. If DOL were to cite an overriding state or federal law that they believe explicitly prohibits our proposed legislation then we'd want to receive the specific cites to such law so that our Municipal Attorney could review such law and discuss further with the State Attorney General.

I know this e-mail is rather lengthy but I wanted to pull together as many pieces as possible to illustrate the massive significance of the problem and how ESD is without question the best possible tool to help the MOA / AK Court System enforce justice. We'll talk internally about the next step and be back in touch. In the mean time, if you could please provide us a point of contact at ESD that would be very helpful. Thanks again, Cindy, for providing us with timely feedback.

Senators French and McGuire:

The Senate Judiciary Committee has scheduled a hearing for 1:30 p.m. today to consider SB 145. One of the matters addressed in this bill is the co-called "scofflaw" provision that will authorize municipalities to provide by ordinance for the impoundment and forfeiture of a vehicle operated by a person who owes more than \$1,000 in delinquent fines for moving violations. The Municipality of Anchorage strongly supports this measure. Indeed, the Anchorage Assembly recently passed an ordinance providing for impoundment and forfeiture in this situation, subject to the necessary state statutory authorization which the Assembly hopes to see this session.

It bears emphasis that this is a public safety measure, not simply a device to enhance debt collection. The predicate for depriving the operator of a vehicle of the vehicle by the summary procedure of impoundment is that allowing the operator to continue using the vehicle would endanger the public. A law authorizing impoundment and forfeiture whenever the operator of the vehicle owes money for past traffic violations, where no current traffic violation is involved, will invite a constitutional challenge by owners of vehicles alleging that there should be a prior notice and hearing before the vehicle is seized. But summary impoundment is more readily justified when the impoundment takes place in the context of a current violation. For this reason, we recommend that the bill be amended to include a provision authorizing municipalities to provide by ordinance that it is a misdemeanor to operate a vehicle when one has \$1,000 or more in delinquent traffic fines.

Attached is the proposed amendment that was provided to Rep. Gardner's office by Anchorage Assembly member Allan Tesche several weeks ago. We urge you to amend SB 145 to include this provision.

I will attend the hearing this afternoon and will be prepared to answer any questions you might have about this.

CS FOR HOUSE BILL NO. 169(CRA)

"An Act relating to municipal impoundment and forfeiture."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

* Section 1. AS 28.01.015(a) is amended to read: (a) Notwithstanding other provisions in this title, a municipality may adopt an ordinance providing for the impoundment or forfeiture of a (1) motor vehicle, watercraft, or aircraft involved in the commission of an offense under AS 28.35.030, 28.35.032, or an ordinance with elements substantially similar to AS 28.35.030 or 28.35.032; (2) motor vehicle involved in the commission of an offense under AS 28.15.291 or an ordinance with elements similar to AS 28.15.291; (3) motor vehicle used by a person whose license is suspended under AS 28.22.041; [OR] (4) motor vehicle used by a person who fails to carry proof of insurance as required under AS 28.22.019; or (5) motor vehicle used by a person who has \$1,000 or more in delinquent traffic fines if the municipality has made it a misdemeanor to drive or operate a motor vehicle where the driver has accumulated \$1,000 or more in delinquent traffic fines for moving violations committed within the municipality.
