IDITAROD FINISHER LICENSE PLATES

By passage of this legislation, a new provision is added for special issue license plates to honor those who have shown the dedication, perseverance and exemplary athletic ability that finishing the Iditarod Trail Sled Dog Race requires.

Design work for the new plate must be approved by the Department of Administration. It's anticipated that the Iditarod Trail Committee and the Iditarod Official Finishers Club will be advisors and participants in the design. The finishers will be able to purchase these exclusive specialty plates by providing specific proof of participation and completion of the race. The race finisher must have an automobile registered in the state of Alaska on which the plates would be displayed.

I request your support for this new category of specialty license plates honoring mushers who have endured the challenges and shown the courage and ability to complete what is affectionately known as the "last great race," the Iditarod Trail Sled Dog Race.

Senate Works on Bill to Provide Special Iditarod Finisher License Plates

(JUNEAU) – With the start of this year’s Iditarod Trail Sled Dog Race just a few days away, Alaska’s legislators are considering a bill that would create special license plates for people who are official finishers of the Iditarod.

“I am proud that the district I represent is home to the start of the ‘last great race’,” said Senator Charlie Huggins (R-Mat-Su), sponsor of the legislation. “It is fitting that we honor the more than 600 hearty souls who have finished this grueling competition which is so synonymous with our state.”

Senate Bill 50 would allow Iditarod finishers, upon proving that they have finished the race, to get a special “Iditarod finisher” license plate for \$50. Presently, there are specialty plates for National Guard members, military veterans, Purple Heart recipients and custom collector vehicles.

SB 50 was passed out of the Senate State Affairs Committee Tuesday, and will be considered next by the Finance Committee. “I am pleased the bill is before us now, during Iditarod season; it adds to the celebration of the start of the 37th running of this great competition,” said Senator Huggins. “A lot of folks who have run the race have expressed enthusiasm about getting one of these license plates, which highlights the pride Alaskans have for the Iditarod and the state as a whole.”
