Frank Palmer Ferry Terminal

Frank Palmer was an icon who worked for nearly five decades at the Auke Bay Ferry Terminal. Palmer, who died last year at the age of 69, first began pulling trailers off the Alaska Marine Highway System's ferries in 1962, the year service from Prince Rupert started. Since then, Palmer drove trucks and met ferries for Lynden Incorporated, Orme Transfer, Douglas Trucking (of which he was also a co-owner), and Alaska Marine Trucking. No matter which company he was working for, Palmer's reliable presence at the Auke Bay Ferry Terminal was a constant.

He was well known as a man who could skillfully get large vehicles on and off of ferries with ease. Although most of them are completely unaware, the list of Alaskans whose lives were touched indirectly by Palmer as he helped move their goods on and off of ferries is long.

Frank Palmer grew up in Auke Bay and for the entirety of his working life (47 years) he was a staple at the Auke Bay Ferry Terminal. Through his decades of work loading and unloading ferries, he was an integral part of the marine highway system that serves as the road that connects the communities of Southeast Alaska.

It would be a fitting and appropriate tribute to a man so intertwined with the Auke Bay Ferry Terminal to rename it the Frank Palmer Ferry Terminal.

Juneau resident Frank Edward Palmer died Feb. 28, 2010, when he drowned while swimming in the ocean during a family vacation in Kauai, Hawaii. His beloved wife, Patti, adored son Billie, cherished grandson Bill, and dear friends, Bud and Joy Hansen, were with him. He was 69.

He was born March 3, 1940, in Tacoma, Wash., to Clayburn F. "Bill" and Nona Palmer and grew up along the shores of Auke Bay. He attended elementary and high schools in Juneau, playing organized baseball and basketball throughout his youth, and he was a member of the Juneau Crimson Bear 1958 State Championship basketball team.

In his youth, he enjoyed fishing and hunting and relished learning those skills from his father. Except for attending college in North Dakota and a short stint in the Air Force, he spent most of his life in Alaska, which he loved. His passion for the outdoors enhanced his excitement for his annual hunting trip to Swan Island with his buddies and fishing with family and friends.

His work passion was the trucking industry, and he was widely known for his expert ability to spot and remove large vans from the Alaska ferries. All his working life, he worked with or for trucking companies. He worked for Orme Transfer, was part owner in Douglas Trucking for many years, and later worked for Lynden Transport and Alaska Marine Lines. The familiar sight of Frank traveling up and down Egan Highway in his truck, will be sorely missed.

"Frank was a beloved husband, father, grandfather, brother and friend," his family wrote. "His love for his family and friends is cherished by all who knew him, and his great spirit and zest for life will live on forever."

He was preceded in death by his parents.

He is survived by his wife, Patti Palmer; son, Bill Palmer; step-daughters, Kate and Leslie Becker, and Karen Ford Powell; step-sons, Randy and Rick Ford; grandson, Bill Palmer; granddaughters, Katie, Linda and Lisa Palmer, of Juneau, and Greta Olson, Margot and Hazel Liebrecht, of Portland, Ore.; sister, Marlene Palmer Ciraulo and husband, Joe, of Issaquah, Wash.; brother, Earl "Bosco" Palmer and wife, Sheila, of Shelton, Wash.; uncle, Earl L. Palmer and aunt, Geraldine Palmer, of Tacoma; and many nieces and nephews, as well as an endless group of friends.

A memorial service is planned for 2 p.m. March 20 at the Chapel by the Lake, followed by a celebration of Frank's life at the Sandbar. 
I knew Frank since the early 1960s and considered him a good friend. In 1969 my wife and I purchased a home "out beyond the ferry terminal" on Lena Loop Road. Thus my life and the life of my wife and 3 daughters began each day and ended each day with a trip past the Auke Bay Ferry Terminal. Over the years since, my family and I have used the ferry system far more than the average Southeast citizen. We traveled regularly on the ferries using them for access to places like Anchorage, Mat-Su, Tok, Haines & Skagway. Our trips north number in the hundreds. The trips were for pleasure but also for business and education. All this travel required that I spend many hours at the ferry terminal waiting to be loaded or waiting to pick up family or friends arriving.

During all this time at the terminal there was one thing that was a constant and that was Frank Palmer. Be it 3 in the morning or 3 in the afternoon -- be it raining, snowing, blowing or (occasionally) sunny -- Frank was always there. He was always pleasant and never too busy to say hello with a hand shake or a good natured headlock. It seems that not only when we were traveling on the ferry but also when just driving by -- there was Frank pulling in with a load or pulling out with one.

When traveling one would see different AMHS employees at the terminal depending on their shift but Frank was always there. Watching him was always interesting as he had the skills to load those trailers quickly into the tightest places. I learned the difficulty of his task and appreciated his skills by having had to personally load horse trailers on and off the ferries -- sometimes by backing up or backing down a steep ramp -- doing so gave me a great appreciation for Frank's skills.

It seemed impossible to think about the Auke Bay Ferry Terminal without thinking about Frank Palmer. He was a good person with great skills and a pleasant manner that set standards for all of us to strive for in life. Your support for this name change will be appreciated.




