5 address.

6 * **Sec. 2.** This Act takes effect January 1, 2013.

House Bill 287¹: **An Act Relating to Absentee Voting** **Sponsor Statement**

Currently, most voters must request a ballot each time they vote absentee. Under AS 15.20.081(i) uniformed service members and qualified overseas voters receive a ballot for the following two general elections after they apply for an absentee ballot. This bill will extend the same right to all Alaskans. Under the bill, an absentee ballot application from a qualified voter will be valid through the next two general elections. Furthermore, each time the voter casts an absentee ballot, the application will continue to be valid through the next two general elections. However, if the absentee ballot is returned to the Division of Elections as "undeliverable," the division will need no longer send a ballot to that voter at that address.

You have requested a sectional summary of the above-described work order.

As a preliminary matter, note that a sectional summary of a bill should not be considered an authoritative interpretation of the bill and the bill itself is the best statement of its contents. If you would like an interpretation of the bill as it may apply to a particular set of circumstances, please advise.

Section 1. Amends AS 15.20.081(g) to require the director of elections to submit to the commissioner of revenue a list of voters who cast absentee ballots.

Section 2. Requires that an absentee ballot application be valid through the two regularly scheduled elections following the date that the application is submitted. Provides that, if a person casts an absentee ballot as a result of an absentee ballot application, the application will remain valid through the two regularly scheduled general elections after the election at which that ballot was cast.

On behalf of the AARP members in Alaska, we encourage you and your colleagues on the House State Affairs Committee to support HB 287, authored by your Committee colleague Representative Max Gruenberg.

HB 287 would allow qualified citizens to have absentee voting status for a period of two elections. AARP believes the right to vote is the most basic of all political rights.

Normal aging and disabilities often interfere with a citizen's ability to exercise his or her right to vote. If someone has a physical problem that prevents their ability to vote on a regular basis and they qualify for an absentee ballot, it will be much easier if they can be given absentee voting rights for two more elections, if they so choose.

AARP recommends an "AYE" vote on HB 287.

House Bill 287: **An Act Relating to Absentee Voting** **Explanation of Changes from "B" version to "D" version**

Section 1 of the "B" version has been deleted on the recommendation of the Department of Revenue. This was accomplished through an amendment to the "B" version during the first committee hearing on this bill.

Section 2 of the "B" version (now section 1 of the "D" version) has been modified to allow for the repeal and reenactment of that subsection to remove language that would otherwise be redundant.

Section 3 of the "D" version has been added to provide an immediate effective date. This allows the new absentee ballot system to be used in the 2012 primary election.

After further review of the requirement to extend an absentee by-mail application following the act of voting, the division has determined that programming modifications will be required in the statewide voter registration system. This amount is \$21.0. In order to ensure the integrity of the process, the division would send confirmation notices at the beginning of each election year to all voters designated as permanent absentee voters to ensure the address on file is still accurate. The division estimates postage and printing costs of \$20.0. This amount would be a recurring cost during each election year.

SUBJECT: HB 287

Thank you for the opportunity to comment on the proposed amendment to HB 287. I assume that the purpose of the proposed amendment to AS 15.20.081(g) is to supply the PFD Division with a list to be used in cross reference with PFD applicants for an audit.

Absence from Alaska for up to 180 days a year is allowed for any reason consistent with maintaining Alaska residency, including vacation. Alaskans are only required to report absences if they exceed 90 days during the qualifying year.

Annually, the division performs the following audits:

- Registered to vote in another state (As reported to us by Division of Elections)
- Applications received from out of state, filed both online and by paper claiming to be in Alaska when they filed.
- Alaska Court System list of those who decline jury duty claiming not to be residents of Alaska.
- Applications for which we receive a fraud tip.
- Applicants who permanently change their address with the USPS to another state or country through the National Change of Address Registry and claim to be residents of Alaska.

If an applicant is identified as an exception to an audit, they are required to provide additional information/documentation to prove their eligibility. We are currently creating two new audits using data elements that had not previously been collected (physical address and immigration status/visa expiration). These data elements are now required in order to receive a dividend.

Identifying and establishing new audits is a priority for this administration. After investigating the possibility of using absentee voter lists, I found that many Alaskans who vote absentee do so while remaining in Alaska. Also, snowbirds vote absentee, which is perfectly acceptable. I appreciate your interest in assisting the division with our audit process, but don't see this particular approach producing the desired result. I am happy to work with your office to investigate other avenues for identifying PFD fraud.

Voting rights are extended to non-residents.
By using their corporate or business addresses as personal residence addresses, out-of-state business owners are obtaining Alaskan voting rights. A state voter’s card then allows these non-residents to vote in elections for the Community of Elfin Cove Non-profit Association – our local governing board. This infiltration has allowed outside parties to gain positions of power and to make major decisions for a community they don’t even live in. Oftentimes, these decisions are made with little or no input from the legal Alaskan residents living here.

Additionally, the monies from grants have been used to the benefit of these businesses, rather than to the benefit of the community at large. One example, State DOT grant monies were used to rebuild a fire-damaged boardwalk to a former CECNPC BOD member, Gordy Wrobel’s property after his lodge was destroyed by fire. As another example, a fish processing and freezing float is hardwired to the new State and Federally funded electric system on the state dock. The float is used by current CECNPC Director Joe Kulavik for his two LLC charter fishing operations.

We need to enforce our voting laws. We need to take control of our state’s destiny and in how our monies are used in our own communities.

Please join us in stopping the corporate takeover of our community. Talk to your state legislators. Talk to your local business owners. Talk to your neighbors about these issues. United, our voices can make a difference and our votes will once again have strength.

Take a look at some of our community’s out-of-state business owners and see where their domiciles, their homesteads are actually located. This list contains the out of state lodge owners who currently hold a voter registration card from the State of Alaska.

General Definition of Residency: AS Sec. 01.10.055 Residency

- (a) A person establishes residency in the state by being physically present in the state with the intent to remain in the state indefinitely and to make a home in the state.
- (b) A person demonstrates the intent required under (a) of this section
 - (1) by maintaining a principal place of abode in the state for at least 30 days or for a longer period if a longer period is required by law or regulation; and
 - (2) by providing other proof of intent as may be or regulation, which may include proof that the person is not claiming residency outside the state or obtaining benefits under a claim of residency outside the state. required by law
- (c) A person who establishes residency in the state remains a resident during an absence from the state unless during the absence the person establishes or claims residency in another state, territory, or country, or performs other acts or is absent under circumstances that are inconsistent with the intent required under (a) of this section to remain a resident of this state.

Title 5: Fish and Game: 5 AAC 39.975. Definitions

- 30) "domicile" means the same as in AS 16.05.940 ; evidence of a person's domicile may include, but is not limited to, the following:
 - A. statements made to obtain a license to drive, hunt, fish, or engage in an activity regulated by a government entity;
 - B. affidavit of the person, or of other persons who may know of that person's domicile;
 - C. place of voter registration;
 - D. location of residences owned, rented, or leased;
 - E. location of storage of household goods;
 - F. location of business owned or operated;
 - G. residence of spouse and minor children or dependents;
 - H. governments to which taxes are paid;
 - I. whether the person has claimed residence in another location for the purpose of obtaining benefits provided by the governments in that location.

Statewide Definitions – continued

- **Domicile** means the true and permanent home of a person from which the person has no present intention of moving and to which the person intends to return whenever the person is away; domicile may be proved by presenting evidence acceptable to the boards of fisheries and game.
- **Resident** means (A) a person who for the 12 consecutive months immediately preceding the time when the assertion of residency is made has maintained the person's domicile in the state and who is neither claiming residency in another state, territory, or country nor obtaining benefits under a claim of residency in another state, territory, or country. (B) a partnership, association, joint stock company, trust, or corporation that has its main office or headquarters in the state; a natural person who does not otherwise qualify as a resident under this paragraph may not qualify as a resident by virtue of an interest in a partnership, association, joint stock company, trust, or corporation. (C) a member of the military service, or United States Coast Guard, who has been stationed in the state for the 12 consecutive months immediately preceding the time when the assertion of residence is made; (D) a person who is the dependent of a resident member of the military service, or the United States Coast Guard, and who has lived in the state for the 12 consecutive months immediately preceding the time when the assertion of residence is made; (E) an alien who for the 12 consecutive months immediately preceding the time when the assertion of residence is made has maintained the person's domicile in the state and who is neither claiming residency in another state, territory, or country nor obtaining benefits under a claim of residency in another state, territory, or country.
