Sponsor Statement

SB 13 – Waive Park Fee for Disabled Veterans

Alaska's veterans served our country with pride. This legislation shows a small token of our appreciation, by providing disabled veterans in our state with free access to state park facilities.

Our parks provide all Alaskans with the opportunity explore and recreate in Alaska's wild places. To provide these opportunities to those with disabilities, many park facilities are compliant with ADA standards. Six cabins have been modified to include features like wheelchair ramps. Two boat launches, 14 campgrounds, 10 historic sites and dozens of day use locations provide handicap accessible facilities. Regardless of disability, the system is truly open to all Alaskans.

In 1991, Alaska passed a law which created a special disabled veteran camping permit, providing disabled veterans with free camping in state park campgrounds. Senate Bill 13 extends this free benefit to public use cabins, boat ramps, RV facilities and day parking.

Please join me and support this meaningful piece of legislation.



You have requested a sectional summary of the above-described bill.

As a preliminary matter, note that a sectional summary of a bill should not be considered an authoritative interpretation of the bill and the bill itself is the best statement of its contents. If you would like an interpretation of the bill as it may apply to a particular set of circumstances, please advise.

Section 1. Amends AS 41.21.026(a) to reference to the exceptions in AS 41.21.026(d) and (f).

Section 2. Amends AS 41.21.026(d) to refer to a veteran in the singular to conform to the amendment to AS 41.21.026(e) in sec. 3 of the bill, and to new subsection AS 41.21.026(f) that would be added by sec. 4 of the bill.

Section 3. Amends AS 41.21.026(e) by adding a definition of "veteran" for purposes of AS 41.21.026.

Section 4. Adds a new subsection -- AS 41.21.026(f) -- to describe the fees in AS 41.21.026(a) that may not be charged or collected from a resident who is a disabled veteran.

BILL NO. SB 13

Analysis

The current statute (AS 41.21.026(d)) provides an exemption to disabled veterans from paying fees for overnight camping in a state park facility. SB 13 would expand the exemption from state park fees for disabled veterans to include the following additional park fees:

- Rental of public use cabins
- Use of an RV dump station
- Admission or guided tours to a visitor center or historic site
- Use of an approved boat ramp
- Day use
- Attendance to educational programs

It would cost approximately \$10,000 in programming changes to the online cabin reservation system to implement the exemption from fees for disabled vets.

This legislation would result in a annual loss of revenue to the state of up to \$252,000 in park user fees. This fiscal note includes \$252,000 in general funds to replace the anticipated loss of revenue, to allow the same level of service in state parks to continue . If the lost fees are not replaced, the Division of Parks could lose approximately three park ranger positions.

It is likely some public use cabins could be vacant but not available to the public because they would be reserved by disabled vets but not used. There may be an increase in use and demand of park facilities as a result of this legislation.

Current Statutes

Sec. 41.21.026. Fees for the use of state park system facilities.

(a) Notwithstanding (b) of this section, the department may charge or collect a fee in a park unit for

- (1) rental of public use cabins or other overnight lodgings;
- (2) overnight use of a developed campsite;
- (3) special park use permits;
- (4) competitive and exclusive commercial use permits;
- (5) noncompetitive and nonexclusive commercial use permits;
- (6) use of a sewage holding tank dump station;
- (7) admission to or guided tours of visitor centers and historic sites;
- (8) use of an improved boat ramp in a park facility developed principally for boat launching;
- (9) sale of firewood;
- (10) sale of merchandise for informational or educational purposes related to public use and understanding of parks, including maps, plans, and other graphic materials;
- (11) use of a developed facility that has developed parking and rest rooms; and
- (12) presentation or attendance at programs related to natural or cultural history, outdoor skills or education, or other topics concerned with public use, enjoyment, or understanding of parks.

(b) The department may not charge or collect a fee for an ordinary use of a park unit or the use of a restroom in a park unit.

(c) The department shall establish the fees that may be charged or collected under (a) of this section by regulation. Before setting the fees, the department shall consider at public hearings

- (1) the cost to the state of operating the facility or managing the activity;
- (2) the normal fees charged for similar facilities or activities by governmental and nongovernmental entities;

(3) the cost of administering a fee collection program for the facility or activity; and

(4) the public interest.

(d) The department shall issue free of charge to disabled veterans of this country an annual state park developed campsite permit. The permit shall allow a disabled veteran to use a state park developed campsite for personal recreation use without a charge or fee under (a)(2) of this section. While utilizing a developed campsite without charge under this subsection, the disabled veteran shall comply with all other statutes or regulations pertaining to the use of the developed campsite. The department shall provide a form for use by a disabled veteran when applying for a permit under this section. Not later than February 1 of each year, the department shall prepare a report on the number of permits issued to disabled veterans under this subsection during the previous calendar year and notify the legislature that the report is available.

(e) In this section, "developed campsite" means a campsite having access to the following public facilities:

(1) restrooms;

(2) a picnic table;

(3) an outdoor cooking facility; and

(4) an approved water source.

Current Statutes

Sec. 38.05.067. Preference for veterans for unoccupied residential land.

(a) Except as provided in (d) of this section, before offering to the general public any unoccupied residential land, the director shall offer the land at a restricted sale at which only veterans may buy.

(b) The director may not sell the land under this section at less than the fair appraised market value. The director shall adopt regulations necessary to ensure that land sold under this section is for bona fide residential use and not for speculation.

(c) When not in conflict with this section, other provisions of AS 38.05.045 - 38.05.067 apply to sales under this section.

(d) This section does not apply to the sale of state land under AS 38.05.057, AS 38.08, or AS 38.09.

(e) In this section, "veteran" means a person with 90 days or more of active service in the armed forces of the United States who has been honorably discharged or a person with 90 days or more of service in the Alaska Territorial Guard.

Current Statutes

Sec. 01.10.055. Residency.

(a) A person establishes residency in the state by being physically present in the state with the intent to remain in the state indefinitely and to make a home in the state.

(b) A person demonstrates the intent required under (a) of this section

(1) by maintaining a principal place of abode in the state for at least 30 days or for a longer period if a longer period is required by law or regulation; and

(2) by providing other proof of intent as may be required by law or regulation, which may include proof that the person is not claiming residency outside the state or obtaining benefits under a claim of residency outside the state.

(c) A person who establishes residency in the state remains a resident during an absence from the state unless during the absence the person establishes or claims residency in another state, territory, or country, or performs other acts or is absent under circumstances that are inconsistent with the intent required under (a) of this section to remain a resident of this state.

Boat Launches

- [Kenai River Special Management Area - Cooper Landing Boat Launch](#), near [Sterling](#)
A 250 foot boardwalk connects parking, toilets and the boat ramp. The boardwalk has a maximum gradient of 5%. There are also viewing areas and interpretive displays. Pressurized water is available.
- [Kenai River Special Management Area - The Pillars Boat Launch](#), near [Kenai](#)
Accessible dock with a less than 5% gradient to it. Dock is only for boat exit/entry - no fishing allowed from dock. There is paved parking with easy access to viewing deck with interpretive displays. Pressurized water is available.

Cabins

- [Chena River State Recreation Area - Chena River Cabin](#), near [Fairbanks](#) with road access
There is a ramp up to the porch and a ramp from the cabin to the latrine. North Fork Cabin, in the same park, also has road access, but is not fully accessible.
- [Chena River State Recreation Area - Twin Bears Camp](#), near [Fairbanks](#) with road access
This facility has 12 rustic cabins, mess hall and recreation hall. It can be rented by an individuals or group. Ramps exist between three cabins, mess hall, recreation hall and main latrine.
- [Chugach State Park State Park - Yuditnu Cabin](#), near [Anchorage](#)
The cabin is accessible, but the latrine is not. Therefore, help may be needed when

Where the gradient exceeds 5%, the paved width is 12 feet. Restrooms and picnic shelters are at approximately one mile east of Bird Point, and two miles west of Girdwood.

 Lower section of trail is paved, a distance of approximately 0.3 miles. Viewing areas at either end of pavement, with accessible restrooms at the upper end. Disabled Veteran's Annual Camping Pass

The legislature granted Disabled Alaskan Veterans (DAV) the right to receive one Alaska State Park Camping Pass free of charge. The DAV Camping Pass, which is valid in all developed Alaska State Park campgrounds, is good for two years. There is no DAV pass for boat launch or day use, nor can the DAV camping pass be used to purchase a boat launch or day use pass as the second pass at the discount rate.

To receive a free DAV camping pass, an eligible disabled veteran must present proof of a **service connected disability and Alaska residency** at either the Anchorage or Fairbanks DNR Public Information Centers (see below). Alaskan resident is defined as a person who is physically present in the state with the intent to remain indefinitely and to make a home in the state, has maintained the person's domicile in the state for the 12 consecutive months prior to requesting the issuance of a Disabled Alaskan Veteran (DAV) camping pass, is not claiming residency in another state, territory or country, and is not obtaining benefits under claim of residency in another state, territory or country. Proof of residency can be in the form of an Alaskan Driver's License, Alaska Sport Fishing or hunting License, Alaska Voters Registration Card, or other documentation suitable to the department that proves Alaska residency.



Evidence of service connected disability can be provided by the presentation of a Veteran's Administration Patient Data Card (red, white, and blue) imprinted with "service connected disability" under the photo identification, or a current year letter from the US Department of Veteran's Affairs, which states the person has a service-connected disability and is signed by the Veteran Services Officer. Other types of VA cards exist, but cannot be accepted as proof of disability. Information on obtaining either the card or the letter can be found through the local Veteran's Administration office or calling 1-800-827-1000. Please note: A Veterans Universal Access Identification card with the veteran's social security number and birth date printed on the card will no longer be accepted, in compliance with the Personal Information Protection Act which passed the Alaska Legislature in 2008.

The Disabled Alaska Veteran camping pass is non-transferable. If the qualified DAV's vehicle is sold, the decal must be removed. Or, if the windshield is broken and must be replaced, the individual is requested to scrape as much of the decal off as possible and return the remains to any area office. In either of these cases, a replacement decal will be issued for \$10 upon receipt of the removed decal. If the decal is lost or if no remains of a previous decal can be produced, and the DNR has record of the owner's previous issuance of the DAV decal, a one-time replacement decal may be purchased for \$100.
