Analysis

CSHB 32 amends AS 43.70 to provide for the issuance of one business license for multiple trades, services, professions, or activities and for the issuance of a new business license to make a change on the license.

Service costs of 8.5 include modifying the Business License database and provide for legal costs associated with regulation change. The database will be modified to allow for filtering and search of the primary and secondary NAICS (North American Industry Classification System) codes on the database and printing the primary and secondary trade, service, profession, or activity on the business license certificate.

The division estimates that approximately 750 business licenses with the same business name could potentially consolidate from two to one business license. At \$50 per license this is potentially a \$37,500 decrement to revenue.

House Bill 32 Sponsor Statement

"An Act providing for the issuance of one business license for multiple lines of business; and providing for reissuance of a business license to correct a mistake on the license."

Currently Alaska requires a business license for every line of business operated by a business. This is an unnecessary burden for many small businesses that may perform various lines. For example, an individual that plows driveways in the winter and sells firewood in the fall must purchase two business licenses.

Business licensing not only carries the cost of the activity in the Department of Commerce, Community, and Economic Development, it is a significant profit center. Yet, many Alaskans are charged extra fees when they need to do several things to feed their families.

Small businesses do not have large margins, and this is one added expense they should not need to pay. Small businesses that are required to purchase multiple licenses are likely to be those that must be involved in several lines just to make ends meet. These businesses ought not be required to subsidize activities not relative to the licensing process.

Proposed legislation would require one fee be paid and allow a business to register all its lines of business on the one license.

The proposed legislation would also allow for a business license to be corrected or changed once during its term at no charge. Currently, changes to information on a business license require the purchase of a new business license.

Three changes were made to House Bill 32 in the House Labor and Commerce Committee:

- Throughout the bill the term "lines of business" has been replaced with "trades, services, professions, or activities."
- Section 3. AS 43.70.030 has been replaced to limit changes made at the discretion of the licensee to 30 days after issuance of the license. Changes due to errors by the department may be made at any time the license is valid.
- The title has been changed to reflect changes made in Section 3. In the title "correct a mistake on the license" has been replaced with "make a change on a license."

Current law requires a business owner to purchase a separate state license for each line of business they operate out of a registered business. House Bill 32 would reduce that requirement to one license for each business.



The Juneau Chamber of Commerce representing over 400 Alaskan businesses would like to add our support to the passage of House Bill 32.



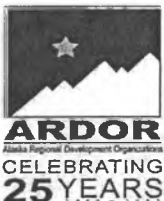



Subject: HB 32 impact on federal taxes

Hi Denny,

I am writing regarding HB 32 which would provide relief for business owners operating multiple trades under the same name, by issuing one business license from the State of Alaska Department of Commerce, rather than a separate one for each line of business. I understand there is some concern about whether the change would have an impact on the business owner's federal tax filing requirements. I am an active CPA in Alaska, and have over ten years experience preparing tax returns for a wide range of entity types. Based on my knowledge of income tax preparation, and experience with the Internal Revenue Service, I do not believe the proposed change to business licensing regulations would have any effect on the business owner's federal tax filing requirements or procedures. While it is a critical compliance function under state law, business licensing does not affect the tax return. The taxpayer is required to provide the principal business activity code (based on the North American Industry Classification System (NAICS)) for their trade or business on the applicable tax form(s); however the IRS does not have jurisdiction to monitor or regulate whether the entity is in compliance with state licensing requirements. Simply put, the federal tax forms are designed to calculate and report taxable income and tax liability, including those derived from a trade or business. The absence of a business license (specific to the trade or business income being reported) would not preclude the IRS from assessing and collecting tax from the taxpayer, nor should it influence how many tax forms or schedules are completed or filed by the taxpayer. The IRS instructions for Schedule C are fairly clear that different business activities should be reported on separate schedules C, in the case of a sole proprietor, but they are silent with regard to state compliance, including business licensing, except for a brief mention that the taxpayer may also incur state licensing fees or taxes.

I hope this information helps, please contact me if you have any questions, or if I can be of further assistance. I support this bill, as I believe it will offer welcomed administrative relief to both the taxpayer and the Department of Commerce, presumably having few licenses to administer and monitor.
