As a recently retired business executive and development engineer, I have almost no time constraints and offer business skills derived from a long career in evaluating and developing large-scale resource development projects. Some salient points from my career:

- **US Army:** 1965 – 1968; Honorable discharge in Alaska.
- **Bureau of Land Management:** 1968 – 1976; Seasonal fire suppression while obtaining engineering degrees.
- **Alaska Department of Highways:** 1975 – 1978; Local Service Roads & Trails Engineer, designing and constructing projects in Native villages.
- **Arctic Slope Regional Corporation:** 1978 – 2005

As **Vice President/Business Development** evaluated proposals for development of lands and resource projects involving minerals, coal, oil & gas. Conduct M&A negotiations in the \$5 million to \$200 million range. Manage corporate holdings. Issues lobbyist at state and federal levels. Conducted ASRC's first strategic plan, which drove revenues from \$90 Million to over \$1 Billion in six years.

As **President/CEO** of ASCG Incorporated, grew from two-man Anchorage start-up to, at my retirement, 800 staff in 18 offices in five Western states with revenues of about \$200 million annually. ASCG in 2004 was named in the *Top 100 Engineering Firms* nationwide, and in *The World's Top 200 Consulting Engineering and Architectural Firms*. Negotiated sale of firm to NANA in 2005; retired in 2007.
