This Act will waive vehicle registration fees for active members of the Alaska National Guard.

There are approximately 4,000 Alaskans serving in the Alaska Army Guard and the Alaska Air Guard. Their dedication and service are greatly appreciated by all. The Guard provides support to the state and local governments with fire suppression, flood management, and other emergency services.

Currently, Guard members receive free hunting and fishing licenses, and limited benefits that depend on service from the VA.

This bill is a small gesture of thanks to our Alaska Guard members.

FISCAL NOTE ANALYSIS

BILL NO. SB 141

Analysis

This bill will entitle current members of the Alaska National Guard free vehicle registration for a passenger vehicle or motorcycle.

Assumptions

There are approximately 4,000 members in the Alaska National Guard. The yearly growth rate of new Alaska National Guard members is unknown and the number of members who use a motorcycle as a primary vehicle is also unknown. For the purposes of estimating loss of revenue DMV assumes each current Alaska National Guard member owns a motor vehicle and any motorcycle would be a secondary vehicle. Therefore, DMV assumes there will be 4,000 vehicles eligible for a registration fee exemption.

Programming Costs:

The DMV ALVIN database will require programming to add a field to identify the motor vehicles or motorcycles registered to Alaska National Guard members and allow us to account for the fee exemption waiver.

Estimated contract hours: 80

Cost per hour: \$143

Total contact cost: \$11,440

Revenue loss

\$100 - biennial vehicle registration fee

4,000 - current Alaska National Guard members

$\$100 \times 4,000 = \$400,000$ loss of revenue (\$200,000 per fiscal year)

Vehicles are registered every two years (biennially). DMV expects half of all Alaska National Guard members to renew in each subsequent fiscal year resulting in a loss of \$200,000 per fiscal year. This loss does not factor in a yearly growth rate of members in the Alaska National Guard.

You wished to know about the benefits that active and retired members of the National Guard receive in Alaska and how these compare to benefits received in other states.

All states, including Alaska, provide a wide range of benefits to active and retired members of the National Guard. We attach a 2011 National Governors Association report, "State and Territorial Support for Members of the National Guard, the Reserves and Their Families," which summarizes, for each state, the following types of benefits: family support; education benefits; licensing and registration benefits; tax and financial benefits; state employee benefits; protections, recognition, and employment support; and reintegration programs and initiatives. Although specific programs vary widely by state, all states offer some form of educational benefits, support to state employees in the National Guard, and support to families of Guard members. The majority of states also offer licensing and registration benefits, financial benefits, employment support, and reintegration programs. Below we outline some of the main benefits offered in Alaska as compared to other states. The attached report summarizes benefits in all states (see page 3 for Alaska information).

Tuition Assistance

Most states have some form of tuition assistance for National Guard members, and often for family members as well. Many states place limits on the amount of tuition assistance available and often restrict education benefits to state schools. Alaska provides up to 100 percent tuition and fee reimbursement for in-state educational or vocational training for the member (AS § 26.05.296) as well as free tuition and fees for a spouse or dependent of a member of the armed services, including the National Guard, if the member died in the line of duty (AS § 14.43.085). Some states offer benefits to a limited number of members: for example, California provides up to 100 percent of college tuition, fees, and expenses to 1,000 members a year.

Vehicle registration and licensing

At least three states—Hawaii, New Mexico, and Tennessee—provide free motor vehicle registration for members of the National Guard. In Virginia, National Guard members may receive special license plates for one-half the regular fee. At least 37 other states—including Alaska—offer special plates to members of the National Guard. These states charge the regular registration fee, and in most cases also charge a fee (typically between \$5 and \$25) for special plates. In Alaska, members of the National Guard pay the regular motor vehicle registration fee and may also purchase special plates for \$30.

Sport fishing and hunting licenses


In Alaska, active National Guard members and disabled veterans are eligible for free resident hunting and sport fishing license (AS § 16.05.341). Several other states also offer active members free licenses, including Kansas, New Hampshire, New Jersey, and New York. Alabama authorizes National Guard members on leave in the state the authority to hunt and fish without a license. Many states offer free or reduce fee licenses to disabled veterans.

Financial Benefits


The Alaska Housing Finance Corporation (AHFC) offers financing for qualified veterans at reduced interest rates (AS § 18.56.01) as well as certain property tax exemptions for qualified disabled veterans. Many other states offer property tax exemptions to disabled veterans. A significant financial benefit offered by most states is to exempt some portion of National Guard compensation from state income tax.

Summary: Alaska offers special benefits for its military Service members and Veterans. These benefits include the Permanent Dividend Fund (PFD), Military Credit toward State Retirement, Property Tax Exemptions, State Employment Preferences, Education and Tuition Assistance, Veterans Land Discount/Purchase Preference, Vehicle Tags, as well as Hunting and Fishing License privileges. Eligibility for some benefits may depend on residency, military component and Veteran disability status.

State Benefit Highlights and Eligibility

State Taxes:

State Tax Advantage: Alaska has no state income tax and no state sales tax in most locations. However, 62 municipalities impose a sales tax that can range up to 7.5%. Typical sales tax rates are from 2% - 5%.

Retirement Income: Retirement Income is not taxed by the State of Alaska.

Property Tax Exemptions: A qualified disabled Veteran is exempt from taxation on the first \$150,000.00 of assessed value of the real property they own and occupy as their primary residence and permanent place of abode. Contact the local municipal tax assessor's office by March 15 for exemption for current year.

Eligibility: A disabled Veteran who, 1) separated under condition other than dishonorable from the military service of the United States whose disability was incurred or aggravated in the line of duty and is rated as 50 percent or more by the military service or the U.S. Department of Veterans Affairs or, 2) served in the Alaska Territorial Guard, is a resident of the state, and disability is rated as 50 percent or more and was incurred or aggravated in the line of duty while serving in the Alaska Territorial Guard; evidence of the disability rating must be provided [AK code Sec. 29.45.030]

Education Benefits:

Alaska Tuition Assistance: The Alaska Adjutant General may authorize payment of up to 100 percent of the cost of tuition and required fees at an Alaska educational, vocational or technical training school.

Eligibility: Alaska National Guard or Alaska Naval Militia member that participates satisfactorily in unit training activities and is a student in "good standing" (enrolled, attending and meeting the minimum success requirements for completion of the program or class) [Alaska Code Sec. 26.05.296]

Free Tuition for Spouses or Dependents: Waiver of undergraduate tuition and fees at a state supported educational institution physically located within Alaska.

Eligibility: The Spouse or dependent of an armed services member who died in the line of duty or who died as a result of injuries sustained while in the line of duty or who was listed by the Department of Defense as a Prisoner of War or Missing in Action. Students must be in and maintain good standing within a state supported educational facility in Alaska.

Interstate Compact on Educational Opportunity for Military Children: It is the purpose of this compact to remove barriers to educational success imposed on children of military Families because of frequent moves and deployment of their parents by:

Facilitating the timely enrollment of children of military Families and ensuring that they are not placed at a disadvantage due to difficulty in the transfer of educational records from the previous school district or variations in entrance or age requirements.

Facilitating the student placement process through which children of military Families are not disadvantaged by variations in attendance requirements, scheduling, sequencing, grading, course content or assessment. Facilitating the qualification and eligibility for enrollment, educational programs, and participation in extracurricular academic, athletic and social activities.

Facilitating the on-time graduation of children of military Families.

Providing for the promulgation and enforcement of administrative rules implementing the provisions of this compact.

Providing for the uniform collection and sharing of information between and among member states, schools and military Families under this compact.

Promoting coordination between this compact and other compacts affecting military children.

Promoting flexibility and cooperation between the educational system, parents and the student in order to achieve educational success for the student.

Employment Benefits:

Military Credit toward State Retirement:

--Public Employees' Retirement System (PERS) credit: Qualified individuals may be eligible to receive up to five years of PERS credit for active military service.

Eligibility: Honorably discharged Service members of the U.S, Armed Forces that are vested in the PERS; surviving Spouses of Service members may also be eligible. Members first hired under the PERS after 30 June 1986 that retired from regular service and are eligible for a federal benefit for the same military service are NOT eligible. Retired National Guard and Reserve unit members may be eligible to claim active military service even though they are eligible for a federal benefit for the same military service.

--National Guard and Naval Militia Retirement System (NGNMRS): Upon separation from the Alaska National Guard or Naval Militia qualifying individuals may receive a small benefit payment.

Eligibility: 20 years of service in the Alaska National Guard, National Guard of any other state, Active military service, or Reserve military service combined; at least five years must have been satisfactory service in the Alaska National Guard unless discharge was involuntary and for reasons other than misconduct. Information can be obtained from the administrative section of the Alaska National Guard

State Employment Hiring Preference:

--Veterans and Prisoners of War: Veterans are eligible for a state employment hiring preference. In a numerical rating system, Veterans will receive points equal to five percent of the total points available from the assessment device(s) added to their score; for disabled Veterans or former prisoners of war, points equal to 10 percent of the total points available from the assessment device(s) will be awarded. If numerical ratings are NOT used, a Veteran will be given consideration and a disabled Veteran or prisoner of war will be given an opportunity to interview.

Eligibility: An honorably discharged Veteran with 181 days or more of active service in the armed forces of the United States with service, 1) between 27 June 1950 and 14 October 1976 or, 2) for which a campaign badge, expedition medal, Purple Heart, award or decoration for heroism or gallantry in action was awarded or, 3) of 181 days or more in the Alaska Territorial Guard; disabled Veteran entitled to compensation by the U.S. Department of Veterans Affairs, honorably discharged or released from active duty due to a service-connected disability or disabled in the line of duty while serving in the Alaska Territorial Guard; prisoner of war [Alaska Code 39.25.159]

--Alaska National Guard: Members of the Alaska National Guard are eligible for a state employment hiring preference. In a numerical rating system, National Guard members will receive points equal to five percent of the total points available from the assessment device(s) added to their score. If numerical ratings are NOT used, National Guard members will be given consideration (entire application will be reviewed).

Eligibility: A presently serving member of the Alaska National Guard with at least eight years of service in the Alaska National Guard

Division of Motor Vehicles (DMV) Benefits:

Special Vehicle License Plates

To honor those who have served or are serving with the United States Armed Forces, Alaska offers special license plates for no charge to those qualifying for Prisoner of War (POW), Pearl Harbor Survivor, Purple Heart or Gold Star Family. There is a \$30 per plate fee charged at initial application or replacement for Veteran plates and National Guard plates.

Veteran Plate: License plate with **specified branch of military service** with the word 'Veteran'; or a **Unit Designator Personalized Veteran Plate** with approved military unit organizations insignia. Fee is \$30.

Eligibility: Proof that Veteran has served or is currently serving with a branch of the U.S. Armed Forces. Acceptable proof includes DD Form 214, a letter of Verification from the VA, Military ID card or other comparable proof of service.

National Guard Distinctive Plate: National Guard members are eligible for distinctive plates for a fee of \$30. Members must solely or jointly own the vehicle that displays the plates.

Eligibility: Active Member of Alaska National Guard with proof of service (NG ID card). The plates may only be issued to a motor vehicle owned solely or jointly by the active member of the National Guard.

Purple Heart Plate: Recipients of the Purple Heart Award are entitled to one set of plates for use on a motor vehicle. There is no fee for the plate.

Eligibility: Applicants must prove receipt of the Purple Heart Award by providing to DMV official documentation such as DD 214 or a copy of the orders awarding the medal.

Pearl Harbor Plate: No charge for Veteran who participated in Pearl Harbor.

Eligibility: Proof of participation in Pearl Harbor.

Gold Star Family Plate: Gold Star plates are eligible to the Spouse, parent, guardian, sibling or dependent of a member of the U.S. Armed Forces killed in the line of duty. There is no fee for the plate.

Eligibility: Applicant must submit a Report of Casualty (DD Form 1300) to be eligible. If the applicant is not listed on the Form 1300, further proof must be submitted to connect the applicant to the fallen Service member.

Prisoner of War: Each eligible applicant may obtain one set of POW plates, free of charge, for display on a non-commercial vehicle.

Eligibility: Applicants must provide written verification from the United States Department of Veteran's Affairs that they were POWs.

Disabled Veteran With Parking Privileges Free Disabled Veteran Parking Permit and Disabled Veteran plates with the wheelchair logo with proof of a service related disability and documentation of a mobility impairment

Eligibility: Applicant must provide an Application for Disabled Parking completed by their Alaska licensed physician plus a certificate issued by an agency of the U.S. federal government, such as the U.S. Department of Veterans Affairs, proving a service related disability.

Disabled Veteran Without Parking Privileges: Free Disabled Veteran plates without the wheelchair logo to those with a service related disability that don't meet the criteria for parking privileges

Eligibility: Applicant must provide certification from the U.S. government that they have a 50% or greater service related disability

Disabled Veteran Vehicle Registration: A disabled Veteran that qualifies for disabled Veteran plates can register one vehicle with special plates free of Motor Vehicle Registration Taxes or registration fees. Subsequent plates are available with payment of full fees.

Death Gratuity: The surviving Spouse of a qualified Veteran, upon application, will receive a death gratuity in the amount of \$750.00 from the Department of Military and Veterans Affairs. If there is no surviving Spouse the gratuity will be paid to the personal representative of the Veteran.

Eligibility: Veteran who was a resident of the state of Alaska at the time of death and, 1) burial occurred in Alaska on or after 13 May 1984; 2) death occurred on or after 19 September 1990; 3) received an honorable discharge or general discharge under honorable conditions; 4) was a resident of Alaska for at least one year prior to entry into the military service, and returned to the state as a resident within one year after retiring from military service with the intention of remaining, OR was a resident for at least one year prior to death; 5) served in the Alaska Territorial Guard, Alaska Army or Air National Guard, Alaska Naval Militia, a Reserve unit of the U.S. Armed Forces in Alaska (if the Reserve unit required a minimum of one weekend of duty per month and 15 consecutive days of active duty training each year for at least three years).

--Active duty military; Alaska National Guard and Alaska Military Reserves: Once **military residency requirements**, of being stationed in the state for at least 12 consecutive months, are met, active duty military may purchase licenses at the resident rate. Nonresident military license rates must be paid when stationed in Alaska for less than 12 months before date applying for license.

--Resident Disabled Veteran: Resident hunting and sport fishing licenses are available at no charge.

Eligibility: Veteran must meet the **residency definitions**, be honorably discharged from military service, eligible for a loan under AS 18.56.101, and certified by the U.S. Department of Veterans Affairs as having a 50 percent or greater service-connected disability. Or, Veteran must have served in the Alaska Territorial Guard, be eligible for a loan under **AS 18.56.101** and incurred a 50% or greater disability while serving in the Alaska Territorial Guard. State Veteran Loans: The Alaska Housing Finance Corporation (AHFC) administers the Veterans Mortgage Program that offers financing for qualified Veterans at lower interest rates.

Eligibility: Qualified Veterans may be retired or active duty personnel. A Veteran must apply to AHFC within 25 years of his/her date of discharge from "active duty service." (Active duty service is full-time duty, other than for training.) Active duty service in the Armed Forces, US Public Health Service, NOAA or service as a cadet at the US Military, Air Force, Coast Guard, or Naval Academy may qualify.

Permanent Fund Dividend (PFD): Offered to State of Alaska residents. The amount of the 2012 dividend is \$900 per person.

Eligibility: A resident of the State of Alaska for the entire calendar year preceding the date you apply for the dividend and intend to remain an Alaska resident indefinitely at the time you apply.

Recording Veterans Report of Separation Form: A Veteran may record, without fee, the original or a certified copy of his or her Armed Forces Report of Separation (DD-214 Form, NGB Form 22 or DA Form 1569) at any **State Recorder's office of the Department of Natural Resources**.

Veterans Land Discount/Purchase Preference: The Veterans Land Discount program allows certain Veterans up to a 25% discount on the purchase price of state residential/recreational land. The discount may be used only once during the Veteran's lifetime and may not be used in conjunction with the Veterans preference. Under the Veterans Land Sale Preference, before offering to the general public any unoccupied residential land by auction, a Veteran has the exclusive opportunity to purchase the land at a restricted sale at fair appraised market value. Parcels that are offered under this preference must be five acres or less, classified as settlement land and zoned for residential use only.

Disabled Veteran's State Camping Pass: An eligible Disabled Alaskan Veterans (DAV) has the right to receive one Alaska State Park Camping Pass free of charge. The DAV Camping Pass, which is valid in all developed Alaska State Park campgrounds, is good for two years.

Eligibility: To receive a free DAV camping pass, an eligible disabled Veteran must present proof of a service connected disability and Alaska residency at either the Anchorage or Fairbanks DNR Public Information Centers. Proof of residency can be in the form of an Alaskan Driver's License, Alaska Sport Fishing License, Alaska Voter's Registration Card, or other documentation suitable to the department that proves Alaska residency. Evidence of service connected disability can be provided by presenting

a Veteran's Administration Patient Data Card (red, white, and blue) imprinted with "service connected disability" under the photo identification, or

a current year letter from the US Department of Veterans Affairs, which states the person has a service-connected disability and is signed by the Veteran Service Officer.

Alaska Marine Highway Pass: A one-year pass on the ferries of the Alaska Marine Highway is available for disabled Veterans. This pass entitles the disabled passenger and an attendant (if required by a physician) to travel at 50% of the regular passenger fare, between Alaska ports only, on all vessels, year-round. Birthday Cards from the Governor: Birthday greetings from the Governor are available to Veterans 80 years and older. High School Diplomas for World War II Veterans: Operation Recognition, a nation-wide effort, recognizes that many World War II Veterans went off to war and never returned to high school to receive a diploma. In Alaska, the Department of Education and Early Development may award diplomas to World War II vets living in Alaska, including Alaska Territorial Guard members, who served during the period of 7 August 1940 to 25 July 1947 and were honorably discharged or died in active service or were released from active duty because of a service-related disability. A family member may apply on behalf of a Veteran who is deceased or incapacitated. Even ex-GIs with a Graduation Equivalency Diploma are eligible to apply.
