The Senate State Affairs Committee introduced SCR 16 on April 18th, 2015 in anticipation of the call for a special session after adjournment of the First Regular Session of the 29th Alaska Legislature. The Committee held the bill until March 25, 2016, when it became apparent once again that the Governor may call a special session following adjournment of the Second Regular Session of the 29th Alaska Legislature.

The CS(STA)\W simply replaces references to “the First Regular Session” with references to “the Second Regular Session.”

13 session of the Twenty-Ninth Alaska State Legislature, if called after adjournment of the

15 and most accessible location; and be it

1 **FURTHER RESOLVED** that the Alaska State Legislature urges the Governor to

Dear Alaskan Legislator:

As we move into the last few weeks of this legislative session, I felt it important to once again touch base with you regarding an "end game." I have consistently expressed my expectation that this session must result in a complete solution to our fiscal situation. There is much uncertainty across our state due to the lack of a plan in place to achieve a balanced and sustainable budget in the future. The New Sustainable Alaska Plan does that. While it would not all be effective this year even if passed, it is a plan that gets us to a balanced and sustainable budget by 2019. Such a plan passed this year would remove the uncertainty over Alaska.

I continue to hear from many of you that a complete solution is not realistic this year; that if we can get to a partial solution, that should not only be acceptable, but celebrated. While I do not wish to diminish the tremendous effort necessary to get us to any part of the solution, I'm forced to point out that concluding the session with only a partial solution only creates great sacrifice for many Alaskans, without removing the uncertainty that a full plan will ever come to fruition.

Alaska's future requires and deserves a 100 percent solution now (with a reasonable implementation horizon). Partial solutions that insist on continued draws from our reserves, without a solid plan toward self-sufficiency are wholly unacceptable, and will ultimately cause the system to fail. Partial solutions will keep the cloud of uncertainty over our economy and unnecessarily delay growth toward a prosperous and vibrant Alaska. Fixing our fiscal problem this year ensures we can once again get back to the business of building Alaska next year.

As I have mentioned to you before, failing to implement a complete package this year will compromise the sustainability of any endowment plan going forward. It will reduce the revenue that can be sustainably withdrawn from our fiscal assets in perpetuity. It will necessitate higher taxes in the future to compensate for less draw from our fiscal assets. It will drive down the State's credit rating, inhibiting future investment and infrastructure development, and it will foster a general downward economic spiral throughout the entire state.

None of us want to see this happen, so that requires a new expectation for what is possible this year.

There are three things that must happen in 2016 to achieve the goal of a truly sustainable balanced budget: Reduced State spending, restructure of Permanent Fund Earnings and Dividend program, and new revenues to include some form of a broad-based tax. Make no mistake, I consider all these requirements written in pen; how they all come together, however, is still very much in pencil.

Working together in true collaboration, and aggressively pursuing this common goal, we can still get this difficult work done now to avoid the need for additional legislative sessions on this issue. My team and I are ready with specific ideas to help modify existing legislation to address some of the concerns already identified (see enclosures). There is still time before the regular session gavel out to meet with you on your plan for closing this gap.

I am looking forward to a spirit of cooperation and can't thank you all enough for taking this very challenging situation as seriously as you have.

Capitol Seismic & Exterior Remodel Interim Project

Jeff Goodell, Project Director, Wayne Jensen, Architect and I met with Dawson Construction today and received their 2016 schedule and additional cost information if we ask them to delay because of an extended or special session.

We are in the fourth year of a Legislative Council project to correct life and safety issues and make improvements to the Capitol on the exterior; switching from steam to hot water baseboard; new windows; additional infill office areas; seismic retrofit; and replace worn and broken sandstone and brick with energy efficient insulation and new brick and cast concrete.

In order to substantially complete the work for this season, Dawson Construction Inc. will need to erect the crane at the parking garage at the Capitol by May 2, 2016. As we have done in the past, staff working in Juneau for the interim will be assigned parking in one of our other legislative parking lots or the Downtown Parking Garage. I will send a parking request form to all offices to inquire about your parking needs, or you may send me your parking request via email. We will lose all of our parking in the upper and lower Capitol lots to Dawson Construction beginning May 2; after Dawson Construction demobilizes sometime in November, we will have use of the Capitol lots again. I will notify you when that happens.

The project in 2016 encompasses the following: completion of courtyard masonry, Seward Street demolition and reconstruction, 4th Street (front of building) demolition and reconstruction, 3 week interruption of service to the two elevators for seismic upgrade, completion of new infill areas on the 4th and 5th floors. Street closures this year will be Seward Street and 4th Street.

Before the demolition can begin on the front of the building envelope, Dawson will need to complete the micro pile structural reinforcement. This will involve the closing of 4th Street in front of the Capitol with one emergency front door exit. All visitors will be instructed to use the 2nd floor catwalk until May 2. This will also be entrance and exit for Legislators and legislative staff moving in and out of the building in addition to the Seward and Main Street exits and the fire escapes until May 2.

The micro pile structural reinforcing must be sequenced before the demolition can begin; Dawson is scheduled to begin that work on April 18, 2016. Dawson will close down 4th Street on April 18, 2016 in order to begin work on the front of the building. The importance of the micro pile work is to secure the building foundation to bedrock. This will involve drilling two piles per day for a four hour period. They will be doing test piles and eight individual micro piles. For DBM to do their work, Dawson Construction needs to demolish the ADA ramp at the front of the building and bore holes in the foundation.

DBM is their selected subcontractor for the micro pile installation, and their contracted delay rates are as follows:

- DBM would be mobilized, so a delay to their work would have the impact of incurring their standby rates, as well as additional operating rates for every day beyond their bid. (i.e., if the Legislature delays them for nine hours they're on standby for nine hours and charge nine hours when they are free to do the work)

- Standby cost for DBM are approximately \$840/hr (\$7560.00/ day)
- Operating costs for DBM (pushing them past their duration) are \$1200/hr (\$10,800.00/ day)

Daily costs if we delay DBM will be ~\$18,000/day and they are scheduled to be onsite April 18. The Dawson cost after mobilizing and current daily cost would be ~\$15,000/day with supervision, onsite management, crew, secured housing, utilities and fuel and insurance. Total cost to the project would be ~\$33,000/day once all parties have been mobilized. To ask Dawson Construction to delay more than one day will require a Legislative Council meeting to approve this expenditure.

Maintaining our schedule is critical to our ability to substantially complete the structural and masonry work on the building this construction season. The scheduled completion for DBM is a two week time period. After that, Dawson Construction will start with scaffolding the front of the building, demolition and reconstruction work.

In many states, reconstruction and seismic retrofits take in excess of 3 or 4 years with no occupancy during the entire project. We have been fortunate that our work during the last three years has occurred during the interim only, enabling us to use our Capitol during the regular session. This year, with the elevators being unavailable for 3 weeks, and the lack of access and egress, we will vacate the building with the exception of the Security Guard and Maintenance crew working in the building until Dawson Construction demobilizes in November. **Our deadline for vacating the building for everyone except Maintenance and Security will be May 2, 2016.**

We have space available in the Thomas Stewart and Terry Miller Legislative Office Buildings to relocate our Juneau Legislators, as well as any legislative staff working in Juneau during the interim. Senator Gary Stevens, Chair of Legislative Council, who is in charge of interim office space, will be assigning alternate office space for Legislators and legislative staff.

Jeff Goodell will send each office explicit instructions on how to leave your Capitol offices for the interim. Supply and Maintenance will take pictures of each office to ensure a before and after record during this renovation.

Those offices most effected this interim will be south of the sky bridge on Seward Street and the entire front of the Capitol. Furniture and office supplies will need to be moved back at least six feet from the window to enable Dawson Construction to do their work. Please ensure you box and label all items stored in your offices. Any questions, please contact Jeff Goodell on what will be required.

Notes:

- Costs specific to special sessions have been tracked since 1997. Since that time, the legislature has convened in special session 23 times, for a total of 297 days.
- During special sessions called by the governor, consideration is limited to subjects the governor designates and to bills vetoed following adjournment of the last regular session. Under subjects considered, we do not include measures to suspend uniform rules or to override vetoes.
- Lawmakers extended the second regular session of the 22nd Legislature from May 14, 2002, through May 16, 2002, at which time members of both chambers voted to convene in special session on the following day, May 17, 2002. By so doing, the legislature was able to dictate the topics of consideration, rather than being limited to the governor's agenda (subsistence).
- The first special session of the 25th Legislature was held in Anchorage and marks the first time the full legislature has met outside of the Capital.
- The third special session of the 25th Legislature marks the first time a session has toured the state.
- The first special session of the 26th Legislature is the second to have been held in Anchorage.
- The legislature at impasse, the first regular session of the 27th Legislature was adjourned by the governor, who then called a special session for the following day.
- In an unprecedented move, the governor on April 25, 2012, issued a supplemental proclamation withdrawing his oil tax bills (SB and HB 3001) from consideration by the third special session of the 27th Legislature. A Legal Services opinion deemed that action to be unauthorized, but the senate concluded that without the governor's support of the bill, there was no realistic chance of meaningful policy discussion. The Senate adjourned, leaving the only bill in play, HB 9--the instate gasoline bill--unaddressed. After lengthy caucus considerations, the House also adjourned.
- Lawmakers went beyond the 90-day statutory limit for regular sessions in the 29th Legislature, extending to the 98th day, relying on the constitutional limit of 121 days. The Legislature then adjourned and held technical session during budget standoff in the first special session. Despite the governor's call for the session to be held in Juneau, the special session was reconvened in Anchorage on 5/21/15, at which time both bodies adjourned the first special session sine die and immediately called themselves into the second special session, in Anchorage.

ALASKA LEGISLATURE 2015 SALARY AND BUSINESS EXPENSE REPORT

SALARY

1. Salary (Part A, column six)

The Alaska State Officers Compensation Commission sets salaries for Legislators. Each member of the Legislature is entitled to a salary of \$4,200 per month or \$50,400 per year. The President of the Senate and the Speaker of the House of Representatives are each entitled to an additional \$500 a year during tenure of office. These annual salaries are reflected in this report.

- a. Salary amounts for Presiding Officers should not be compared with other Legislators as they receive an additional \$500 annually.

BUSINESS EXPENSE

Legislators expend funds during the calendar year in the performance of their duties. The majority of these expenses are paid directly to third parties. The remainder are reimbursed to Legislators for receipted expenditures.

2. Business Expense Allowance (Part A, column five)

Legislators receive an annual allowance for postage, stationery, stenographic services and other expenses. Senators receive up to \$20,000 and Representatives receive up to \$16,000. The allowance is administered under an accountable plan, which means all invoices and receipts are turned into the Legislative Affairs Agency for expenditure or reimbursement, respectively.

3. Relocation Expense Reimbursement (Part A, column two)

Legislative Council policy provides that the 57 Legislators who are required to move to and from Juneau for the 90 day session be reimbursed for those relocation expenses. This reimbursement or payment of expenses covers the cost of transportation to the State Capital for a Legislator, as well as any spouse and/or dependents, and personal household goods up to 10,000 pounds. The cost varies depending on the method(s) of transportation available to a Legislator and the weight of personal goods that a Legislator needs to relocate for session. For instance, it is more expensive to ship a car by trailer or van than to drive a vehicle to Juneau. Legislators relocating their family are allowed to move two vehicles. Relocation expenses are also covered for a special session of the Legislature.

- a. Relocation expenses from one individual Legislator to another vary greatly due to the distance and limited shipping and travel methods available from the more remote parts of Alaska to the State Capital. As such, relocation expenses for Legislators from different districts should not be compared.
- b. Legislators may or may not relocate their families to Juneau for the session. The relocation expenses for Legislators with large families should not be compared to single Legislators, Legislators with small families, or Legislators who choose not to relocate their families to Juneau for the session.

PER DIEM REIMBURSEMENTS

4. Session Per Diem Reimbursement (Part A, column four)

Legislators are reimbursed per diem for lodging and meal expenses during a session. During the regular session held in the capital city, the 57 Legislators whose place of permanent residence is not Juneau were reimbursed \$237 per day from January 20, 2015 through February 28, 2015, and \$223 per day from March 1, 2015 through April 27, 2015. Juneau Legislators received \$177.75 and \$167.25 per day, respectively. In 2015, the 29th Legislature convened for 98 days in regular session.

- a. Regular session per diem amounts received by Juneau Legislators should not be compared to session per diem amounts received by Legislators whose place of permanent residence is not Juneau as the daily rates are lower for Juneau Legislators.

The 29th Legislature convened in three Special Sessions. The first Special Session ran from April 28, 2015 through May 21, 2015, and lasted for 24 days. There was an extended recess and the per diem rate varied depending on location of meetings. The Juneau per diem rate was \$223 per day through April 30, then went up to \$249 on May 1. Juneau Legislators received \$167.25 and \$186.75, respectively.

The second Special Session of the 29th Legislature ran from May 21, 2015 through June 11, 2015, and was held in Anchorage. The Anchorage per diem rate was \$292 per day, and Anchorage Legislators received \$219 per day, 75% of the full Anchorage per diem rate.

The third Special Session of the 29th Legislature was held in Juneau from October 24, 2015 to November 6, 2015, and lasted for 14 days. The Juneau per diem rate was \$223 per day, and Juneau Legislators received \$167.25, or 75% of the full Juneau per diem rate.

5. Short Term Per Diem Reimbursement - varies depending on location and time of year (Part A, column one)

Legislators in travel status to a place other than their place of permanent residence are reimbursed a short term per diem rate or actual lodging expenses plus a meal allowance to cover costs associated with their business travel.

- a. Legislators have differing official responsibilities and their travel and mileage reimbursement figures vary greatly.

6. Other Business Expense Reimbursements (Part A, column one)

Legislators are entitled to be reimbursed for conference fees, business phone calls made while in travel status, or other business expenses. Receipts are submitted to LAA for reimbursement or direct payments are made to third parties.
