Museum Construction Grant Program

House Bill 166 establishes a matching grant program in the Department of Commerce, Community and Economic Development, for eligible museum construction, expansion or major renovation projects.

Museums are eligible for this program if they are located in Alaska, entitled to receive state grants, and provide matching funds from other sources of at least 50 percent of the project costs.

Alaska has more than 60 museums throughout the state that provide cultural, tourism, and educational programs. Alaska museums receive 380,993 annual visitors and they serve 29,469 school children each year. Alaskan communities are enriched with the art, history, and cultural language and education provided at the museums. The approval of this bill will enable museums to access and leverage funding so that they may improve, expand or upgrade as needed, when funds are appropriated. Included with the bill documents you will find twenty-three letters of support from nine different Alaskan museums, four regional or statewide museums organizations and Senator Bishop.

The award is subject to appropriation and cannot exceed more than 50 percent of the total proposed project costs. HB 166 is a companion bill for SB 7, Sponsors: STEVENS, Bishop, Stedman and Egan.

BILL NO. HB 166

Analysis

HB 166 establishes a museum construction grant program in the Department of Commerce, Community, and Economic Development. The department does not anticipate a fiscal impact until and unless legislative grant funding is appropriated.

This bill intends to provide State matching grant funds for museum construction, expansion, and major renovation. Major renovation means a significant physical upgrade that allows a museum to better preserve artifacts and present artifacts to the public or improve space to allow a museum to provide improved education services to the public.

Once funds are appropriated, the department anticipates a large number of applications which is indicated by the supporting documents to HB 166. In addition to the estimated 60 museums and cultural centers that are already in existence in 30 communities around the state, it is expected that numerous Alaska Native communities and tribes would be interested in applying for museum construction grants under the expanded definition of museum.

The department will adopt regulations similar to those for the Public Library Construction and Expansion Grants Program. However, unlike the public library grants program the department will neither accept applications for a grant nor draft regulations unless the legislature first makes an appropriation for the grant program.

Hello my name is Linda Lucky. I'm a docent at the Anchorage Museum of Art, History, and Science. I call the museum the Jewel in the Crown of Anchorage.

I am here today in support of HB166.

The matching grant program builds, renovates, and expands facilities that exhibit and preserve Alaska collections that are held in the public trust. It supports creative vision of the institution. Exhibition space, increase in facility size, collections storage expansion, and security improvements are listed among the top priorities.

I like that the program takes the politics out of applying for a grant. A support of this bill is an investment in a community's well being.

The Anchorage museum connects people through its programs. Through workshops, new experiences, exhibitions, and series of events, the museum expands our view of the world. One of our greatest shows was the one just after our first expansion was completed: STAR WARS! It was the perfect segue between the old and the new. It was fabulous because 1) it celebrated IMAGINATION which is at the core of all our disciplines, 2) it brought in people who had never been to the museum before, 3) it brought in families: parents and children, second generation of Star War fans, and 4) there were lots of hands-on activities to challenge the ~~guests~~ *visitors'* imagination.

The biggest thrill was going into outer space via a film aboard the replica of the Millennium Falcon cockpit!!

I'd like to ~~close with~~ *share* these words from the director and CEO of the Anchorage Museum, Julie Decker:

"We think museums matter more now than ever before. In an age where everything is online, visitation rates to museums around the world are rising. Museums are not storehouses of the past. They are an active record of where we come from, who we are, and where we are going. Museums activate curiosity about the world in which we see and come to know ourselves as part of a continuum of shared human identity."

I urge you today to support this bill. Thank you.



As a member of Museums Alaska, a statewide association of museum professionals and the Director of the Juneau-Douglas City Museum, I would like to thank you for your support of HB 166, an act establishing a museum construction grant program and companion bill to SB 7.

Recently, as a board member of the American Association of State and Local History, I attended the American Alliance of Museums Advocacy Day in Washington, D.C., to share the important work that Alaskan museums do. We were proud to share our advancing state bills and report that in 2014-2016 Alaskan Museums competitively applied for and were awarded almost 4 million dollars in project support from the National Endowment for the Humanities, the National Endowment for the Arts, and the Institute of Museums and Library Services. These grant funds produced projects that serve the public and preserve public trust collections.

With over 65 museums, cultural centers, historic houses and sites in operation in Alaska we know that small and large communities rely on museums and cultural centers as anchor institutions to deliver education services, research opportunities, exhibit local art and culture; provide public programs, and generate revenue through cultural tourism. Many of these institutions are in buildings never intended to be museums, yet they are preserving and exhibiting irreplaceable artifacts and history.

In 2014 the McDowell Group completed an **Infrastructure Needs Study of Alaska Museums and Capital Improvement Planning Guide** for the Foraker Group. This study documents capital improvement needs within the next five years. Exhibition space expansion or improvement; increase in facility size; collections storage expansion; and security improvements are the top four priorities for our institutions. The report states that capital needs are often deferred to staff to raise funds for projects "at least 10 times larger than a museum's annual budget." This same staff member can also be tasked with collections care, exhibits, programs, education, and generating operating funds.

HB 166 & SB 7 are zero fiscal note bills that create pathways for capital improvement projects when funding becomes available. Future capital funding requests can be ranked by the Department of Community and Regional Affairs subject to appropriation of funding through the legislative process. This grant program awards up to 50 percent of proposed costs to help build, expand, or renovate existing facilities, providing an effective framework to advance eligible shovel-ready projects if grant funding becomes available.

Demonstrated by the letters of support for SB 7, communities support their museums and are committed partners in their success and longevity.


Like the successful library construction grant program, HB 166 & SB7 encourages resourcefulness, partnering, and careful community planning. If this bill is passed it could enable the State of Alaska to receive federal infrastructure monies if they become available. This grant program can encourage

efficient and cost-effective energy usage in planning by encouraging sustainable energy initiatives and systems analysis.

Our Museum worked for over ten years to fund a ventilation and humidity retrofit in our museum housed in a historic building listed on the national register of historic places. These specialized museum environments are essential for best practices collection care and care of our wooden artifacts such as a rare fish trap, canoe, and other collections. Before our new system was put in place we were operating with the building's original 1951 oil fired-boiler. Our new all-electric air-source heat pump system has eliminated the need for oil, uses renewable energy and saves us on average \$10,000 annually in heating costs while adding cooling, humidification, and de-humidification into our Museum environment.

Advancing HB166 & SB7 to establish a construction and matching grant program is an effective framework to support current and growing capital needs of Alaskan museums as state and local economies improve and capital funding becomes available. I look forward to providing information and answering any questions that you may have. Thank you for your public service.





The Yupiit Piciryarait Museum is housed in the Yupiit Piciryarait Cultural Center, the facility that was built in 1994 for purposes of housing the former Yugtarvik Museum collection, when the original museum burned down due to electrical fire in May, 1980. Over the years, the museum has lost the capability of managing the humidity control when our HVAC was shut down. In addition, we have lost critical museum space to the Kuskokwim Campus, despite having to pay the same lease amount. We are struggling to keep the museum open and need the extra space to bring in funding to keep our doors open.

I urge you to support SB7, establishing a museum construction grant program, so that museums throughout the state of Alaska may continue to serve their communities. Help us make this bill a reality, speak up for Alaska's museums!

Thank you for your sponsorship of Senate Bill 7, establishing a museum construction grant program in the Department of Commerce, Community and Economic Development. Museums Alaska stands ready to partner in efforts to ensure that the new grant program effectively assesses needs of museum capital projects statewide, much as the Alaska Library Association partners with the state to provide a ranking of library capital projects under the library construction grant program.

Museums Alaska, a 501(c)(3) nonprofit, is the professional association of museums and cultural centers in Alaska. We serve over 100 members, providing an annual conference for professional development, newsletters, advocacy, and a re-grant program by administering two Rasmuson Foundation funds. We partner closely with the Alaska State Museum to expand statewide services to museums and collaborate regularly with the Alaska State Council on the Arts and the Alaska Historical Society.

Following the state's model for library construction projects, we support developing a mechanism that provides equitable access to funding through a competitive grant program and statewide ranking of projects. SB 7 accomplishes that mechanism through which future funding may be sought. Even without immediate appropriations into the fund, the mechanism can provide a solid ranking of capital projects to aid in legislative decision-making during the capital budget process, as is currently the case with the library program.

Thank you for introducing this important piece of legislation that will allow us to better fund the needs of our aging museums and cultural centers across the state. They are the keepers of our collective history.

Foresight: Museums Alaska clearly recognizes the fiscal challenges our state and communities are facing.

- ❖ We advocate for the passage of SB 7 to establish an effective framework to support current and growing capital needs of Alaskan museums as state and local economies improve and capital funding becomes available.
- ❖ **This bill is void of a fiscal note.** Future capital funding requests will be ranked by the Department of Community and Regional Affairs subject to appropriation of funding through the legislative process. The matching grant program is designed to award up to 50 percent of proposed costs to help build, expand, or renovate existing facilities exhibit and preserve Alaskan collections held in the public trust.

Goal: Advancing SB 7 will establish a construction and major expansion matching grant program to successfully build, expand, or renovate facilities that exhibit and preserve Alaskan collections.

Reality: A 2014 McDowell Group survey for the Foraker Group demonstrated critical infrastructure needs for our cultural institutions that care for and exhibit Alaskan collections.

- ❖ Of the 36 museums contacted 75% identified significant capital improvement needs within the next five years. Exhibition space or improvement; increase in facility size; collections storage expansion; and security improvements were listed as the top priorities.

Basis: Since the passage of SB 119 in 2008, the Library Construction and Major Expansion Matching Grant Program has successfully provided fourteen Alaska communities with financial assistance to help construct and expand public libraries.

- ❖ SB 7 sponsored by Senator Stevens continues a commitment to our cultural institutions to facilitate a capital program for museums in creating an act establishing a museum construction grant program in the Department of Community and Regional Affairs.

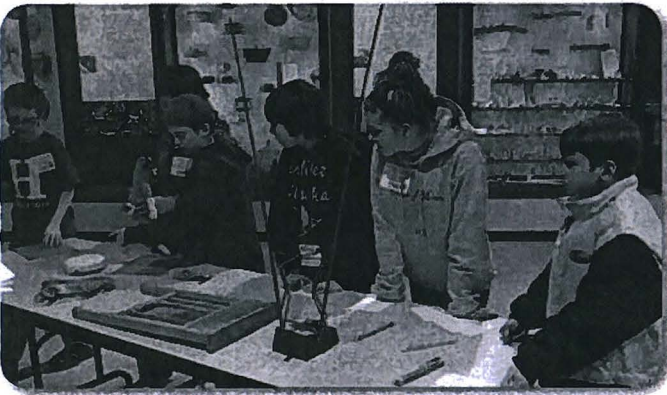

I am contacting you today to thank you for your support of SB7, establishing a museum construction grant program. Research shows that almost half of all museums in the state are either currently involved in a construction project or will be in the next five years, and that includes the UA Museum of the North. This bill provides the structure for establishing a systematic approach to prioritizing museum capital project funding requests in the state.

Museums and cultural organizations in Alaska are a critical part of the educational and economic infrastructure, spurring tourism and partnering with schools to teach the local curriculum. They contribute to our economy and wellbeing by:

- Employing over 260 Alaskans (~92 Fairbanksans alone);
- Spending over \$23,553,294 annually in the State (UAMN's annual operating budget is \$4.9 million, approximately 1/3 of which is a result of grants and contracts);
- Hosting over 624,695 visitors annually (UAMN welcomed around 90,000 visitors in FY16); and
- Serving over 36,290 school children annually (approximately 2500 Fairbanks kids visited UAMN last year).

Despite this vital role of museums, our facilities and collections are at risk through decreasing federal, local, and charitable giving. As collections grow and visitation increases, the pressure on our aging infrastructure must be managed. The UA Museum of the North is no stranger to this dilemma. We are proud of our accomplishments: we're expanding and developing new public programming, adding new private and corporate sponsorships to those established supporters, successful in-house curated exhibitions focusing on Fairbanks-based expertise and collections strengths, increasing visitation and collections usage by professional and amateur researchers (over 2,000 individual contacts with researchers or visitors to collections last year), while continuing to add thousands of artifacts and specimens (over 73,000 items last year) through donations, scientific field collecting, and agreements with agencies. Regardless of these achievements, we are hampered by a 37-year-old exhibit gallery and increasingly diminished collections curation space. In order to maintain and improve our world-class reputation as the largest assemblage of natural, cultural, and art history collections in the state and as a top visitor attraction for Interior Alaska, we will need to renovate our public gallery as well as identify a solution to our growing collections curation space crisis. And we are but one of dozens of Alaskan museums and cultural centers who desperately need infrastructure improvements who could be helped through this new grant program.

Thank you for supporting SB7, establishing a museum construction grant program, so that museums throughout the state of Alaska may continue to serve their communities by preserving our collective heritage. By helping us make this bill a reality, you are speaking up for Alaska's museums.

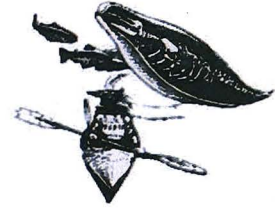

I am writing to thank you for sponsoring SB7, establishing a museum construction grant program, and to provide testimony in support of this bill. In May 2018, the Pratt Museum will celebrate its 50th year as a culture-bearer and gathering space on the southern Kenai Peninsula. As someone who grew up in Soldotna, I can testify to the critical role this museum plays in providing inspiration and education related to natural history, human history, art, culture, and community dialogue. Despite the additions that have been added to the original building over the years, the museum is in critical need of upgrades, further expansion, or a new facility.

In an effort to protect our valuable collection items according to best practices in the industry and to become physically accessible to all of our community members, the Pratt Museum began a capital campaign over 10 years ago. As a private nonprofit, it is challenging to compete for priority on city, state, or federal budgets, despite the services that a museum provides for the community. To date, we have secured less than one-third of the funds needed to address our needs and to protect the cultural and historical objects housed in our facility.

Our story is not unique. Almost half of all museums in the state are currently involved in construction efforts or plan to be within the next five years. SB7 would help these nonprofit entities by establishing a systematic approach to prioritizing museum capital project funding requests in the state. In addition to the tangible impact of protecting the public's assets, museums and cultural organizations in Alaska are a critical part of the educational and economic infrastructure, spurring in-state and out-of-state tourism. Our organizations employ over 260 Alaskans, spend over \$23million dollars within the State, host nearly 625,000 visitors and serve over 36,290 students annually.

Arts and culture are critical components of human and community development, and our mission is best achieved through the participation of all stakeholders. Thank you for speaking on behalf of the important work being done through Alaska's museums and cultural organizations.

I am the director of the Tanana Valley Train Museum at Pioneer Park in Fairbanks. The Friends of the Tanana Valley Railroad (FTVRR) supports SB-7 that pertains to museum construction. Our museum was built in 2006 by a matching grant from FTVRR and the FNSB to support construction with DOT IceT funding for historic transportation museums.

Our museum is the most recent one that was built at Pioneer Park since it was founded as Alaskaland in 1967. The train museum is a modern structure opened in 2006 that houses our 1899 built steam engine which was the first locomotive in Fairbanks since 1905. However, I am not speaking on behalf of any benefit of this bill directed at our museum, *but more in support for a neighboring museum across the playground at the park, the Pioneer Air Museum (PAM) under the leadership of Pete Haggland.*

Pete has been proactive in trying to upgrade the facilities at the PAM since 1992 after the geodesic gold dome was converted from a skating rink to house a small collection of historic aircraft that brought the Alaska interior into the age of flight. The dome was unheated until 1994 and has had some upgrades for fire and safety since then. *But the most needed upgrade is the abysmal condition of sanitary facilities for the visiting public and the museum staff.*

The museum has no potable water inside except by bottled containers, nor does it have any restrooms available other than a waterless porta potty outside or the requirement that people must either go to the public facility cabins near the playground, civic center or our train museum located several hundred feet away.

Pete has been diligent in obtaining design studies on spec from supportive A&E firms that have provided rough design estimates to construct an addition onto the museum that would provide the much-needed sanitary facilities for the public along with a small meeting room and an extension for the shop area used in aircraft restoration work.

I feel that SB-7 will be useful to help remediate clear-cut problems of public need like those facing the PAM and other more aged museums in Pioneer Park and elsewhere throughout Alaska that have fallen onto hard times due to long term service to Alaskans to let them know how they got here today.



Chugachmiut has several projects that are outgrowths of concerns, voiced by tribal parents from all seven of the Region's communities, that their children had little substance upon which to build a positive identity, including recognition of the value of their indigenous cultures. In response to those concerns, our Heritage Preservation Department staff is creating several projects to connect youth with their traditional cultures.

The heritage department has two tasks requiring collaboration with midsize museums in the Region. They are: first, to create Heritage Kits, cultural curricula aligned with the *Content Standards for Alaska Students* and the *Alaska Cultural Content Standards* to be used in schools, and second to continue development of Llangarklluku Lucillerpet Cuumi: *Becoming Aware of Our Beginnings*, an exhibition of artifacts collected from Chugach Region communities beginning with Captain James Cook's voyage into Alaskan waters in 1778 and continuing through the American Colonial Period.

Chugach youth, Valdez and Cordova Museums, the Ilanka Cultural Center, and the Pratt Museum, and Chugachmiut have all benefited from our partnerships. The Region's youth have high quality, interactive, place-based cultural programs. The museums have in turn used our kits to meet their charge of providing community outreach and education. We depend on museum professionals for guidance in program development.

For the purpose of providing testimony in support of SB7, I would like to take this opportunity to let you know how much the Valdez Museum means to me and to the community of Valdez Alaska.

The museum has in the past several years provide myself and fellow community artists with a place to display our art work. Annually the museum hosts community art shows to showcase the wide variety of medias and talents of local artists. The museum also hosts regular shows to support the local quilters and other fiber artists.

Personally, the museum staff encouraged me to have a solo art show and provided me with tremendous support. There are no other museums or venues for over a 300 miles radius in which an artist can hope to hold a show and display their work.

Every year the Valdez Museum has a student art show that showcases young artists from kindergarten age through college. This show has grown so large over the years that much of the student art is also displayed in our local library, along with the art displayed in the museum.

The museum holds regular art and crafts classes for people of all ages. The museum hosts an annual summer art camp for kids, and also holds many Valdez and Alaska themed history events throughout the year.

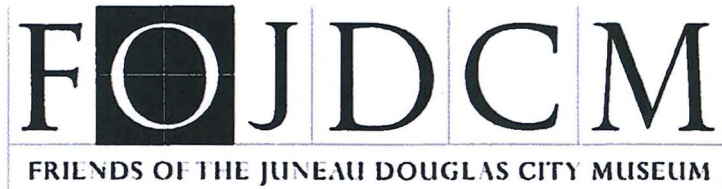

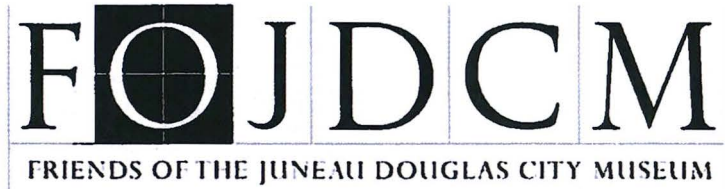

WHEREAS, Governor Bill Walker issued a proclamation in October 2016 designating 2017 as a "The Alaska Year of History and Heritage to encourage all Alaskans to take the occasion of the 150th anniversary year to study, teach, reflect upon our past, and apply its lessons to a brighter, more inclusive future.

WHEREAS, the Legislature of the State of Alaska, in its current legislative session, will be considering whether to approve SB 7 sponsored by Senator Gary Stevens of Kodiak and co-sponsored by Senator Click Bishop, Senator Dennis Egan, and Senator Stedman, acts establishing a matching grant program for museum construction, expansion, and major renovation; and

WHEREAS, an entity, individual, organization, or municipality in charge of construction, expansion, or major renovation of an eligible museum may apply to the department for a matching grant under regulations adopted by the department; and

WHEREAS, subject to appropriation, the department shall award not more than 50 percent of the total proposed grant project costs to an eligible applicant; and



WHEREAS, “major renovation” means a significant physical upgrade that allows a museum to better preserve artifacts and present artifacts to the public or improve space to allow a museum to provide improved educational services to the public; and

NOW, THEREFORE, BE IT RESOLVED by the Friends of the Juneau-Douglas City Museum as follows:

Section 1: That the Friends of the Juneau-Douglas City Museum support the passage of Legislative Senate Bill 7.

Section 2: This resolution shall become effective immediately upon adoption.



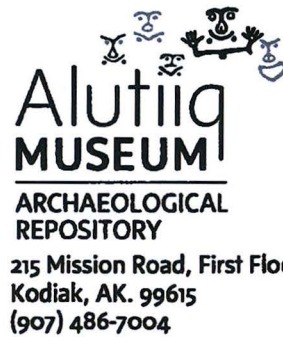
From a broad perspective, we believe that this legislation will have an invaluable impact on the long-term preservation of Alaska cultures and history. In our large, diverse state, museums play a central role in making the past accessible to the present. Yet, this role carries the solemn responsibilities to provide exceptional care for collections and to make them publically accessible. Good facilities are at the heart of this work. Capital grants for facilities development will allow collecting institutions to upgrade and improve their repositories and insure the best possible care of our collective heritage.

For the Alutiiq Museum, this legislation is particularly timely. As you may know, the museum has outgrown its 5,000 square foot facility. The process of returning our ancestor's collections to Kodiak, conducting research, and accepting historic materials from our community, has filled our collections storage. Moreover, the success of our programs has increased our staff. A building once designed to hold four staff members will soon be home to ten! We have spread into the Alutiiq Center basement to accommodate this growth, but this is a short-term solution. Our long-range strategic goals is to develop a larger facility. A matching grant program from the State of Alaska would be a key piece of our funding strategy, and help us to secure significant funds from foundations, private investors, and community members to advance our work.

Dear Senator Stevens:

I am contacting you today to express the Kodiak Historical Society and Baranov Museum's **support for Senate Bill 7, establishing a museum construction grant program**. A 2014 McDowell Group survey for the Foraker Group demonstrates critical infrastructure needs for our cultural institutions that care for and exhibit Alaskan collections. Many of the buildings our Museums are in were never meant to be used as museums or cultural centers, are over 50 years old, and have deferred maintenance needs that surpass operating budgets of the institutions.

Museums and cultural organizations in Alaska are a critical part of the educational and economic infrastructure, spurring tourism and partnering with schools to teach the local curriculum. Despite the vital role of museums, our facilities and collections are at risk through decreasing federal, local and charitable giving. As collection grows and visitation increases, the pressure on our aging infrastructure must be managed. This bill would establish an effective framework to support current and growing capital needs of Alaskan museums as state and local economies improve and capital funding becomes available.

The Baranov Museum is no stranger to this trend. We opened with centennial funds in 1967. Though we have been lucky enough to receive needed funding to care for our building, originally built by the Russian-American Company in 1808 and the oldest building in Alaska, we do need funding for an exhibit renovation project. Our current exhibits were developed piecemeal over the last 50 years and are reflective of an older museums aesthetic which no longer adequately communicates Kodiak's rich history. Thanks to federal, state and private funding, we've been able to develop an exhibit design plan, but we need further support to construct the new permanent exhibits. Doing so would help us better use the incredible resources of our buildings and the collections built up over the last 50 years to share Kodiak's history with residents and visitors.

I thank you for your sponsorship of Senate Bill 7, establishing a museum construction grant program, so that museums throughout the state of Alaska may continue to serve their communities. The board and staff of the Kodiak Historical Society greatly appreciate and support your efforts.
