3 **April 6, 2018, as Go Blue Friday.**

4 **BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

5 **WHEREAS** sexual assault affects women, children, and men of all racial, cultural,
6 and economic backgrounds and occurs through acquaintance rape, stranger rape, sexual
7 assault by a partner, child sexual abuse, incest, sexual harassment, prostitution, and
8 pornography; and

9 **WHEREAS** the crime of sexual assault violates an individual's privacy, dignity,
10 security, and humanity and leaves long-lasting physical and emotional scars that can influence
11 every aspect of an individual's life; and

12 **WHEREAS** results from the 2015 Alaska Victimization Survey show an estimated
13 33.1 out of every 100 Alaska women have experienced sexual assault within their lifetime;
14 and

15 **WHEREAS** results from the 2015 Alaska Victimization Survey reflect alcohol- or

1 drug-involved sexual violence dropped from 26.8 percent in the 2010 survey to 22.6 percent;
2 and

3 **WHEREAS**, despite tremendous progress, Alaska still has the highest rates of sexual
4 violence in the nation; and

5 **WHEREAS** 2,126 children were evaluated by child advocacy centers in the state for
6 possible sexual abuse last year; and

7 **WHEREAS** 1,625 adult victims of sexual assault sought services at rape crisis centers
8 in the state last year; and

9 **WHEREAS** it is important to recognize the compassion, commitment, and dedication
10 of the individuals who provide services to sexual assault survivors and work to reduce and
11 eliminate sexual violence; and

12 **WHEREAS**, in 2016, 16 communities--Anchorage, Barrow, Bethel, Cordova,
13 Dillingham, Eielson Air Force Base, Fairbanks, Fort Wainwright, Juneau, Kodiak, Kotzebue,
14 Nome, Palmer, Seward, Unalaska, and Valdez--have sexual assault response teams to
15 investigate more effectively crimes of sexual violence; and

16 **WHEREAS** research indicates the need to develop comprehensive sexual violence
17 prevention programs that target multiple, interacting risk and protective factors in

8 all state employees and other residents of the state to support child abuse prevention and
9 education efforts.

Explanation of Changes

Senate Concurrent Resolution 2 – April 2017 as Sexual Assault Awareness Month

The Rules Committee substitute for SCR2, April 2017 as Sexual Assault Awareness Month, expands the resolution to include information and resolved clauses relating to another destructive evil in Alaska: the abuse and neglect of children. The rationale for this expansion is to increase awareness of sexual assault, child abuse, and child neglect, especially during April, and to show commitment by the 30th Alaska State Legislature to prevent these wrongs whenever possible.

The committee substitute makes the following changes:

- Adds whereases stating
 - the rates and the number of incidents of child abuse in Alaska;
 - the number of Alaskan children removed from unsafe homes and placed into foster care;
 - the societal impacts of child abuse and neglect, including the rates of those abused or neglected as children who will abuse or neglect their children, go to prison, and be involved in criminal activity;
 - the long-term effects of child abuse on individuals; and
 - the moral imperative to prevent child abuse and support the efforts of those who care for abused and neglected children;
- Adds resolves stating that the Alaska State Legislature
 - proclaims April 2017 and April 2018 to be “Child Abuse Prevention Month” in the state;
 - proclaims April 7, 2017 and April 6, 2018 as “Go Blue Friday”, a day to wear blue, the official color of prevention; and
 - supports and encourages all state employees and residents of the state to support child abuse prevention and education efforts.
