10 \* Section 1. AS 19 is amended by adding a new chapter to read:

11 CHAPTER 65. ALASKA MARINE HIGHWAY REVIEW COMMITTEE.

12 Sec. 19.65.010. REVIEW COMMITTEE CREATED. There is created in  
13 the Department of Public Works, division of marine transportation, the  
14 Alaska Marine Highway Review Committee consisting of members of the  
15 traveling public in Alaska and residents of the coastal communities  
16 served, as well as commercial users of the state ferry system and  
17 representatives of the tourism industry in the state.

18 Sec. 19.65.020. MEMBERSHIP. (a) The committee consists of

19 (1) five persons appointed by the governor and confirmed by a  
20 majority of the members of the legislature in joint session;

21 (2) two members of the legislature, one each from the house  
22 and senate appointed by the governor from a list of nominees provided by  
23 the president of the senate and the speaker of the house of represen-  
24 tatives; the legislative members shall not be members of the same  
25 political party.

26 (b) The commissioner of public works, the director of the division  
27 of marine transportation, and the director of the division of tourism in  
28 the Department of Commerce and Economic Development, or their designees,  
29 shall be ex officio members of the committee, but without a vote.

1           Sec. 19.65.030. TERM OF OFFICES; VACANCIES. (a) The members of  
2 the committee except legislative members shall serve four-year staggered  
3 terms, or until their successors are appointed and certify. One initial  
4 gubernatorial appointee shall serve for one year, one for two years, two  
5 for three years, and one for four years.

As such, it is a substitute for a network of roads and highways along and through the maritime areas of the state where geography makes the construction and maintenance of that network economically unfeasible, environmentally unsound, and impractical from the standpoint of engineering. It is the purpose of this chapter to provide passengers, shippers, and other users of the state ferry system, as well as the taxpayers of the state, with a stable ferry service operated and managed for their benefit under a fair, just and reasonable tariff schedule and to ensure that marine transportation services will be rendered equitably, economically and efficiently to all users and to the residents and communities of the state dependent on or desiring them, without unjust discrimination or undue preferences or

1 advantages. It is also the purpose of this chapter to make certain that  
2 the state ferry system is properly developed and improved, in coordina-  
3 tion with other transportation modes and services, and to assure the  
4 traveling and using public of adequate, complete and dependable marine  
5 transportation services in all aspects. Thus, the state ferry system is  
6 uniquely affected with, and shall be managed and operated in, the public  
7 interest.

8 Sec. 19.70.020. AUTHORITY TO ESTABLISH TARIFF SCHEDULE. After  
9 public notice, hearing, and receipt of the recommendations of the Alaska





III. ANALYSIS (See Fiscal Note Preparation Instructions, Section III)

The advisory committee consists of seven (7) members plus three (3) ex officia members for a total of ten (10). Members will receive no compensation but are allowed per diem and travel expenses. The committee is to meet at least once quarterly, for a minimum of four (4) each fiscal year. Due to the nature of the subjects the committee will review, it will require a minimum of two (2) staff members attend each meeting as advisors.






