
Dear Senator Ray:

The principle of relating pay of exempts, partially exempts, and classified employees into one coordinated salary administration program is one to be greatly desired by those to whom salary administration falls as a duty. Senate Bill 404 ties into one package many of the details that must be considered. By virtue of the interrelatedness of the various types of employees in the bill, equity can be established and maintained automatically.

It is my feeling that SB 404 is a long step in the right direction. I must point out, however, that missing from this legislation is a rational device for determining what the basic salary schedule is to be. I would therefore call your attention to Senate Bill 318 wherein the Personnel Board is charged with the responsibility of recommending adjustments to the salary schedule. Through this arrangement appropriate consideration can be given to cost of living increases and, equally important in maintaining balance, any salary settlements based on negotiations with represented employees can be weighed. It follows that the entire wage and salary program will be more equitable if all factors can be fairly considered in recommendations to the Legislature.

I therefore recommend to you that sections 4, 5 and 6 of SB 404 be attached to SB 318 with an effective date of July 1, 1975, for those sections only.



Dear Senator Ray:

Attached is a copy of a proposed bill entitled "An Act relating to the frequency of paying statutory salaries" that I would request you consider as an amendment to any one of the employee pay bills presently under your consideration. The purpose of the proposed legislation is to allow the State to pay judges, commissioners and legislators bi-weekly as opposed to monthly as is now statutorily mandated. As you know the State is in the process of developing a new payroll system and one of the proposals we have under our consideration is to change the State's pay period from a monthly one to that of a bi-weekly one. Presently we pay some employees bi-weekly, some employees semi-monthly and some employees monthly. Adoption of this amendment would give the State the flexibility of paying all employees at the same time.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

* Section 1. AS 22.05.140[a] is amended to read:

Sec. 22.05.140 COMPENSATION. [a] The chief justice and each associate justice shall receive \$44,000 annually as compensation. The compensation is payable at least monthly in [12] equal installments. Compensation of the chief justice or of an associate justice shall not be diminished during his term of office, unless by general law applying to all salaried officers of the state.

* Section 2. AS 22.10.190[a] is amended to read:

Sec. 22.10.190. COMPENSATION. [a] Each superior court judge shall receive \$40,000 annually, as compensation, payable at least monthly in [12] equal installments. The compensation of a judge shall not be diminished during his term of office, unless by general law applying to all salaried officers of the state.

* Section 3. AS 22.15.22[a] is amended to read:

Sec. 22.15.220. COMPENSATION. [a] Each district judge shall receive \$33,500 annually as compensation, payable at least monthly in [12] equal installments.

* Section 4. AS 22.15.220[b] is amended to read:

Sec. 5 AS 22.15.220[b] Each magistrate shall receive annual compensation to be determined by the supreme court. Salary increases shall be determined on the basis of percentage of pay increase the legislature provides for state employees in the classified service. A magistrate's annual compensation shall [MAY] be payable at least

[, AT THE OPTION OF THE MAGISTRATE, EITHER] monthly in equal installments [OR SEMI-MONTHLY IN 24 EQUAL INSTALLMENTS].

* Section 6 AS 24.15.02 is amended to read:

Sec. 24.15.020 ¹⁴ ANNUAL LEGISLATURE SALARIES. The annual salary of each member of the legislature is \$9,000 to be paid at least monthly in equal installments [IN APPROXIMATELY EQUAL MONTHLY INSTALLMENTS].

The president of the senate and speaker of the house of representatives are entitled to an additional \$500 a year during tenure of office.

* Section 7 AS 39.20.010 is amended to read:

Sec. 39.20.010. ANNUAL SALARY OF GOVERNOR. The annual salary of the Governor is \$50,000. The salary shall be paid at least [IN EQUAL] monthly in equal installments.

* Section 3 AS 39.20.030 is amended to read:

Sec. 39.20.030. ANNUAL SALARY OF LIETENANT GOVERNOR. The annual salary of the Lieutenant Governor is \$ 44,000. The salary shall be paid at least [IN EQUAL] monthly in equal installments.

* Section 9 AS 39.20.080[a] is amended to read:

Sec. 39.20.08 SALARY OF EXECUTIVE DEPARTMENT HEAD AND DEPUTY.
[a] The annual salary of the head of each principal executive department of the state upon appointment and confirmation is \$40,000. This salary shall be paid at least [IN EQUAL] monthly in equal installments.

Dear Senator Willis:

This is written to express our comments on Senate Bill 318, "An Act relating to public employment; and providing for an effective date". We feel the bill needs some modification to be acceptable to Tri-Trades and I hope this letter will serve as a suggestion as to how the bill could be amended. For purposes of convenience, I will refer to numerical sections of the bill and comment only on those sections we have suggestions.

Section 1 amending AS 23.40.200(b) is fine.

Section 2 of the bill adds language to AS 23.40.215 which confuses us and doesn't appear to add anything to existing law but could, if enacted, diminish the contract theory of upon which state employees might have to rely should legal enforcement of their collective bargaining agreement become necessary. I refer specifically to the language appearing on page 1, line 27-29 of the bill reading:

No payment of salary increases or fringe benefits called for in any such agreement may be made until the effective date of an appropriation which is enacted for the specific purpose of providing the funding for that agreement.

We feel this language is unnecessary and could eventually be detrimental to state employees no matter what bargaining unit they belong. We strongly urge this language be stricken from the bill.

We request at this juncture that a new section be added to the bill amending Section 4, Chapter 113 SLA 1972 adding language to that Chapter of the session laws of 1972. Why this particular section of the 1972 Session laws was not given an AS number in our statutes is a mystery. Nevertheless, we would like incorporated in this bill a new section to read:

Section _____, Section 4, Chapter 113 SLA 1972 is amended to read:

This Act is applicable to organized boroughs and political subdivisions of the state, home rule or otherwise, unless the legislative body of the political subdivision, by ordinance or resolution, rejects having its provisions apply; provided, however, should the legislative body of the political subdivision by ordinance or resolution reject having this Act's provisions apply, it shall enact its own act not inconsistent with provisions of this Act.

Section 3 repeals and re-enacts the definition section of the act found in AS 23.40.250. We have no objection to the definition of "collective bargaining" found in sub-paragraph (1) of Section 3 of the bill. Likewise, we have no objection to the definition of "Confidential employee" in subparagraph (2); no objection to "election" in subparagraph (3); no objection to "labor relations agency" in subparagraph (4); no objection to "managerial employee" found in subparagraph (5); no objection to "organization" found in subparagraph (6).

In subparagraph (7), we find the definition of "public employee" such to inclusive and strongly urge you to delete the words "and noncertificated employees of school districts;" found on page 3, lines 7 and 8 of the bill. If this language is not stricken from the bill, noncertificated employees of school districts i.e., maintenance, janitorial, clerical, etc., are exempted from the Alaska Public Relations Act.

As written, subparagraph (7) of the bill reads:

"public employee" means any classified employee of a public employer, except confidential employees, managerial employees, supervisory employees, and teachers and noncertificated employees of school districts;

We would ask the Committee to delete the words "and noncertificated employees of school districts;" so that subparagraph (7) would read:

"public employee" means any classified employee of a public employer, except confidential employees, managerial employees, supervisory employees, and teachers.

Subparagraph (8) defining "public employer" is OK. We urge that subparagraph (9) defining "supervisory employee" be defined a bit more clearly by adding language found in the National Labor Relations Act defining "supervisor" (29 USC 152 (ii)) as one who appoints, promotes, etc., and whose duties as a supervisor "is not of a merely routine or clerical nature, but requires the use of independent judgment." If you would incorporate this language in subparagraph (9) on page 3 of the bill it would read:

"supervisory employee" means an individual having substantial responsibility on behalf of the public employer regularly to participate in the performance of all or most of the following functions: appoint, promote, transfer, suspend, discharge, evaluate or adjudicate grievances of subordinate employees, except if in connection with the foregoing the exercise of such authority is not of a merely routine or clerical nature, but requires the use of independent judgment, except supervision aboard vessels of the Marine Transportation System;

We strongly urge you to incorporate the above individual language. We have no objection to subparagraph (10) defining "terms and conditions of employment."

We have no comment on Section 4 or 5 of the bill that relates to the Powers and Duties of the Personnel Board. Likewise, we have no objection to Section 6 through 12 amending Title 22, repealing certain sections of Title 39 and providing for an effective date.






In response to your telephone inquiry, the following information is provided concerning funds appropriated under Senate Bill #404 passed during the last session.

As we discussed there were no funds appropriated to pay for benefit payments during FY 76. Since the retirement system was established on January 1, 1976 it wasn't felt at the time that there would be any benefits due and payable during FY 76.






Dear Senator Ray:

The principle of relating pay of exempts, partially exempts, and classified employees into one coordinated salary administration program is one to be greatly desired by those to whom salary administration falls as a duty. Senate Bill 404 ties into one package many of the details that must be considered. By virtue of the interrelatedness of the various types of employees in the bill, equity can be established and maintained automatically.

It is my feeling that SB 404 is a long step in the right direction. I must point out, however, that missing from this legislation is a rational device for determining what the basic salary schedule is to be. I would therefore call your attention to Senate Bill 318 wherein the Personnel Board is charged with the responsibility of recommending adjustments to the salary schedule. Through this arrangement appropriate consideration can be given to cost of living increases and, equally important in maintaining balance, any salary settlements based on negotiations with represented employees can be weighed. It follows that the entire wage and salary program will be more equitable if all factors can be fairly considered in recommendations to the Legislature.

I therefore recommend to you that sections 4, 5 and 6 of SB 404 be attached to SB 318 with an effective date of July 1, 1975, for those sections only.



Attached is a copy of a proposed bill entitled "An Act relating to the frequency of paying statutory salaries" that I would request you consider as an amendment to any one of the employee pay bills presently under your consideration. The purpose of the proposed legislation is to allow the State to pay judges, commissioners and legislators bi-weekly as opposed to monthly as is now statutorily mandated. As you know the State is in the process of developing a new payroll system and one of the proposals we have under our consideration is to change the State's pay period from a monthly one to that of a bi-weekly one. Presently we pay some employees bi-weekly, some employees semi-monthly and some employees monthly. Adoption of this amendment would give the State the flexibility of paying all employees at the same time.

The president of the senate and speaker of the house of representatives are entitled to an additional \$500 a year during tenure of office.

* Section 7 AS 39.20.010 is amended to read:

Sec. 39.20.010. ANNUAL SALARY OF GOVERNOR. The annual salary of the Governor is \$50,000. The salary shall be paid at least [IN EQUAL] monthly in equal installments.

* Section 8 AS 39.20.030 is amended to read:

Sec. 39.20.030. ANNUAL SALARY OF LIETENANT GOVERNOR. The annual salary of the Lieutenant Governor is \$ 44,000. The salary shall be paid at least [IN EQUAL] monthly in equal installments.

* Section 9 AS 39.20.080[a] is amended to read:

This is written to express our comments on Senate Bill 318, "An Act relating to public employment; and providing for an effective date". We feel the bill needs some modification to be acceptable to Tri-Trades and I hope this letter will serve as a suggestion as to how the bill could be amended. For purposes of convenience, I will refer to numerical sections of the bill and comment only on those sections we have suggestions.

Section 1 amending AS 23.40.200(b) is fine.

Section 2 of the bill adds language to AS 23.40.215 which confuses us and doesn't appear to add anything to existing law but could, if enacted, diminish the contract theory of upon which state employees might have to rely should legal enforcement of their collective bargaining agreement become necessary. I refer specifically to the language appearing on page 1, line 27-29 of the bill reading:

No payment of salary increases or fringe benefits called for in any such agreement may be made until the effective date of an appropriation which is enacted for the specific purpose of providing the funding for that agreement.

We feel this language is unnecessary and could eventually be detrimental to state employees no matter what bargaining unit they belong. We strongly urge this language be stricken from the bill.

We request at this juncture that a new section be added to the bill amending Section 4, Chapter 113 SLA 1972 adding language to that Chapter of the session laws of 1972. Why this particular section of the 1972 Session laws was not given an AS number in our statutes is a mystery. Nevertheless, we would like incorporated in this bill a new section to read:

Section _____, Section 4, Chapter 113 SLA 1972 is amended to read:

This Act is applicable to organized boroughs and political subdivisions of the state, home rule or otherwise, unless the legislative body of the political subdivision, by ordinance or resolution, rejects having its provisions apply; provided, however, should the legislative body of the political subdivision by ordinance or resolution reject having this Act's provisions apply, it shall enact its own act not inconsistent with provisions of this Act.

Section 3 repeals and re-enacts the definition section of the act found in AS 23.40.250. We have no objection to the definition of "collective bargaining" found in sub-paragraph (1) of Section 3 of the bill. Likewise, we have no objection to the definition of "Confidential employee" in subparagraph (2); no objection to "election" in subparagraph (3); no objection to "labor relations agency" in subparagraph (4); no objection to "managerial employee" found in subparagraph (5); no objection to "organization" found in subparagraph (6).

In subparagraph (7), we find the definition of "public employee" much too inclusive and strongly urge you to delete the words "and noncertificated employees of school districts;" found on page 3, lines 7 and 8 of the bill. If this language is not stricken from the bill, noncertificated employees of school districts i.e., maintenance, janitorial, clerical, etc., are exempted from the Alaska Public Relations Act.

As written, subparagraph (7) of the bill reads:

"public employee" means any classified employee of a public employer, except confidential employees, managerial employees, supervisory employees, and teachers and noncertificated employees of school districts;

We would ask the Committee to delete the words "and noncertificated employees of school districts;" so that subparagraph (7) would read:

"public employee" means any classified employee of a public employer, except confidential employees, managerial employees, supervisory employees, and teachers.

Subparagraph (8) defining "public employer" is OK. We urge that subparagraph (9) defining "supervisory employee" be defined a bit more closely by adding language found in the National Labor Relations Act defining "supervisor" (29 USC 152 (ii)) as one who appoints, promotes, etc., and whose duties as a supervisor "is not of a merely routine or clerical nature, but requires the use of independent judgment." If you would incorporate this language in subparagraph (9) on page 3 of the bill it would read:

"supervisory employee" means an individual having substantial responsibility on behalf of the public employer regularly to participate in the performance of all or most of the following functions: appoint, promote, transfer, suspend, discharge, evaluate or adjudicate grievances of subordinate employees, except if in connection with the foregoing the exercise of such authority is not of a merely routine or clerical nature, but requires the use of independent judgment, except supervision aboard vessels of the Marine Transportation System;

We strongly urge you to incorporate the above individual language. We have no objection to subparagraph (10) defining "terms and conditions of employment."

We have no comment on Section 4 or 5 of the bill that relates to the Powers and Duties of the Personnel Board. Likewise, we have no objection to Section 6 through 12 amending Title 22, repealing certain sections of Title 39 and providing for an effective date.

For your convenience, we have attached a draft of Committee Substitutes for Senate Bill No. 313 incorporating our suggestion. Thank you for your courtesy in soliciting our views on this important legislation.






