The transportation category has been separated into three categories (small boat harbor or port, airport, and mass transit). The air/water pollution control category has been separated into two categories (air and water pollution), with military populations eligible. Ambulance services and solid waste disposal are new categories. \*All populations are rounded upwards to the next 100 (except military populations, which are to be the actual number).\*\*
