Dear Mr. Speaker:

Under the authority of art. III, sec. 18, of the Alaska Constitution, I am transmitting a bill which would extend the lapse date for certain appropriations made in 1980.

Section 1 would provide for a June 30, 1982 lapse date for the appropriation made to the University of Alaska, School of Mineral Industries. That appropriation is being used to appraise the mineral potential in various districts. A sufficient amount of money was appropriated for over two years of work, but, since this is not a capital appropriation, and is in fact a one-year appropriation under the current provision, the date for lapsing into the general fund should be extended.

In sec. 2, the first four subsections would extend lapse dates for appropriations of federal receipts. Each of the budget request units involved receives federal funds on the basis of the federal fiscal year of October 1 -- September 30. Since all appropriations in ch. 120 SLA 1980 will lapse on June 30, 1981, unless otherwise specified, the affected agencies must determine their lapse balances and seek authorization by way of revised programs to carry forward the remaining funds. The time required to compute lapse balances and seek approved revised programs often results in a delay of grant awards to municipal and nonprofit subgrantees. Since this delay occurs for no reason other than mismatched fiscal years, the extended lapse dates are a sound solution.

The fifth subsection in sec. 2 would remove the lapse date for approximately two-thirds of the appropriation to the Department of Environmental Conservation for prevention and control of oil pollution. This money was earmarked by the department for the oil pollution spill expense reserve as a ready source of money to control oil spills. A memo accompanying the fiscal note prepared by the department for consideration by the legislature last year indicates that the department wanted to treat the funds as continuing. Removing the lapse date would be an appropriate solution.

Section 3 of the bill would extend the lapse date to June 30, 1982 for two appropriations made in ch. 173 SLA 1980 to the Department of Education for instructional television. Because of the amounts of money involved in the two appropriations (\$770,500 and \$700,000, respectively) and because of the time required to develop requests for proposals to accomplish the necessary objectives of the legislation, it will be virtually impossible to conclude all instructional television activities this fiscal year for which FY 81 general fund money has been budgeted. Therefore, the lapse date should be extended to June 30, 1982.

Under the authority of art. III, sec. 18, of the Alaska Constitution, I am transmitting a bill which would extend the lapse date for certain appropriations made in 1980.

Section 1 would provide for a June 30, 1982 lapse date for the appropriation made to the University of Alaska, School of Mineral Industries. That appropriation is being used to appraise the mineral potential in various districts. A sufficient amount of money was appropriated for over two years of work, but, since this is not a capital appropriation, and is in fact a one-year appropriation under the current provision, the date for lapsing into the general fund should be extended.

In sec. 2, the first four subsections would extend lapse dates for appropriations of federal receipts. Each of the budget request units involved receives federal funds on the basis of the federal fiscal year of October 1 -- September 30. Since all appropriations in ch. 120 SLA 1980 will lapse on June 30, 1981, unless otherwise specified, the affected agencies must determine their lapse balances and seek authorization by way of revised programs to carry forward the remaining funds. The time required to compute lapse balances and seek approved revised programs often results in a delay of grant awards to municipal and nonprofit subgrantees. Since this delay occurs for no reason other than mismatched fiscal years, the extended lapse dates are a sound solution.

The fifth subsection in sec. 2 would remove the lapse date for approximately two-thirds of the appropriation to the Department of Environmental Conservation for prevention and control of oil pollution. This money was earmarked by the department for the oil pollution spill expense reserve as a ready source of money to control oil spills. A memo accompanying the fiscal note prepared by the department for consideration by the legislature last year indicates that the department wanted to treat the funds as continuing. Removing the lapse date would be an appropriate solution.

Section 3 of the bill would extend the lapse date to June 30, 1982 for two appropriations made in ch. 173 SLA 1980 to the Department of Education for instructional television. Because of the amounts of money involved in the two appropriations (\$770,500 and \$700,000, respectively) and because of the time required to develop requests for proposals to accomplish the necessary objectives of the legislation, it will be virtually impossible to conclude all instructional television activities this fiscal year for which FY 81 general fund money has been budgeted. Therefore, the lapse date should be extended to June 30, 1982.



Section 1. \$750,000 for erosion control assessments at the 15 communities listed is adequate to accomplish the work.

Section 2.

- (1) Deering Sea All. - \$1.2 million - \$1.2 million will build a seawall of class III riprap, 10' wide, 3,500' long.
- (2) Shishmaref Erosion Control - \$1.2 million - The U.S. Army Corps. of Engineers prepared a reconnaissance report in December of 1979 for erosion control at Shishmaref. This report gave 3 possible alternatives:
  - (a) Gabions with sandbags - cost of \$2.8 million.
  - (b) Mixed sand and cement in place - cost of \$1.6 million.
  - (c) Sand filled gabions with filter fabric - cost of \$600,000.

\$1.2 million would build some combination of (b) and (c).

- (3) Southwest Alaska region dredging - \$2.0 million - This item is intended to fund a series of dredging projects on the Kuskokwim and Johnson Rivers using the dredge purchased for the City of Bethel in 1980. Recommend appropriation to Municipal Grant account.
- (4) Unalakleet Seawall Construction - \$800,000 - A seawall long enough to cover \$800,000 should be sufficient to protect the community by itself. Recommend \$1.8.

Section 3. \$80,000 to Community and Regional Affairs to complete the Port Heiden erosion project is adequate for what the community intends to do (relocate another 20 buildings).

- D. Economic Impact: The capital projects in sections 2 and 3 should provide short-term construction employment on the local level.



Ladies and Gentlemen:

The City and Borough of Juneau urges your affirmative action on the proposed committee substitute for House Bill 279 which has been drafted by Senator Stimson's special subcommittee.


The feature of this bill which we feel is most important is that which would authorize reimbursement for debt service during the year in which the debt service payment is made, thus eliminating the current two year lag. If a municipality issues a relatively constant volume of school debt over the years it will have a relatively constant portion of its mill levy diverted to school construction debt service. However, if a municipality goes for a number of year without issuing debt for school construction and is then placed in the position of issuing a large amount over a short period of time, there will be a significant impact on the mill levy until the municipality gets through the two year lag on reimbursement.

Attached is a memo from the City and Borough of Juneau Budget Director to me which projects the impact on the Juneau mill rate for the bonds which are currently authorized by the voters for school rehabilitation and construction. Incidentally, approximately two-thirds of the authorization is for the upgrade, remodeling and rehabilitation of existing schools. Mr. Kennedy made these projections under the assumption reimbursement would be at the current 80% and that the bonds would be issued to meet the cash flow requirements projected by the school district's construction manager. Note that in fiscal year 1985, the city and borough will require 6.35 mills just to support the debt service on the recently authorized school bonds. This will drop and level off at 1.83 mills in fiscal year 1988. If the two year lag is eliminated, the maximum mill levy impact would be 1.83 mills in fiscal year 1985 and would remain at that level for this series of bonds until they were retired. Actually, there would be some decrease in the mill rate which would correspond to any increase in the assessed valuation of the city and borough.

We urge you to pass out the proposed committee substitute for House Bill 279. The elimination of the two year lag for reimbursement will probably do more for boroughs and unified municipalities to assist them in keeping property taxes down and fairly consistent from year to year than almost any other action the legislature could take this year.
