- Section 11 Clarifies and cleans up the requirements and process for transferring exceptional children to schools or programs outside their school districts of residence.
- Section 12 Clarifies the scope of services considered necessary for the child's program.
- Section 13 Makes it clear that disagreement over the transfer of an exceptional child does not eliminate the school district's obligation to provide services to the student.
- Section 14 Clarifies the meaning of the section which deals with services provided to hospital or home bound exceptional children.
- Section 15 Sec. 14.30.315 makes clear that state aid for programs for gifted students is conditioned upon prior state approval of those programs. Sec. 325 largely restates the existing federal requirements on the subject.
- Section 16 Sec. 14.30.335 would give the department the authority to alter requirements imposed upon school district programs for exceptional children in conformity with changes in the federal law which may occur from time to time.
- Section 17 Clarification.
- Section 18 Would adopt the existing federal definitions of all of the listed items except (3), (4)(C) and (7).
- Section 19 Would repeal various sections replaced or made unnecessary by this Act.
- Section 20 Effective date.

- (1) sue and be sued;
- (2) contract with the department, the Bureau of Indian Affairs, or any other school district, agency, or regional board for the provision of services, facilities, supplies or utilities;
- (3) determine its own fiscal procedures including but not limited to policies and procedures for the purchase of supplies and equipment; the regional school boards are exempt from the Fiscal Procedures Act (AS 37.05);
- (4) appoint, compensate and otherwise control all school employees in accordance with this title; these employees are not subject to the State Personnel Act (AS 39.25);
- (5) adopt regulations governing organization, policies and procedures for the operation of the schools;
- (6) establish, maintain, operate, discontinue and combine schools subject to the approval of the commissioner;
- (7) recommend to the department projects for construction, rehabilitation, and improvement of schools and education-related facilities as specified in AS 14.11.010(a), and plan, design, and construct the project when the responsibility for it is assumed under AS 14.11.020;
- (8) exercise those other functions that may be necessary for the proper performance of its responsibilities;
- (9) by resolution adopted by a majority of all the members of the board and provided to the commissioner of the department, assume ownership of all land and buildings used in relation to the schools in the regional educational attendance area. (§ 2 ch 124 SLA 1975; am § 2 ch 57 SLA 1976; am § 1 ch 147 SLA 1978; am § 4 ch 92 SLA 1982)

(6) keep the records and files of the school board open to inspection by the public at the principal administrative office of the district during reasonable business hours;

(7) establish procedures for the review and selection of all textbooks and instructional materials before they are introduced into the school curriculum; the review includes a review for violations of AS 14.18.060. (§ 1 ch 98 SLA 1966; am § 3 ch 17 SLA 1981)


There continues to be concern relative to the issue of letting teachers know of the circumstances before hiring, and hopefully, HB 196 will put us on track to resolution of this part.

SUBJECT: House Bill 196 - Provision of Adequate Housing  
for Public School Teachers in Rural Areas

HB 196 is pending in your committee and I would appreciate an opportunity for a hearing at your earliest convenience.

Basically the Bill does three things:

Section 1. Adds to the powers of regional school boards the ability to enter into leases to provide rental housing for teachers;

Section 2. Adds to the duties of regional school boards the requirement to inform all employees of the housing situation where they will be working and to assist them in securing housing. (The bill does not require school boards to provide housing or subsidize housing; and

Section 3. Adds additional duties to school boards in municipalities which are the same as those in section 2. (Municipalities already have the general power to provide housing).

For your further information, enclosed is a copy of the recently completed Rural Housing Survey completed by the National Education Association. I hope the committee members will find it helpful in understanding the housing conditions in rural Alaska.

Should the committee require any additional information or have further questions, please let me know.

The responses received to the above two questions did not lend themselves to simple groupings. In general, the responses fell into five categories summarized below:

1. Legislative: District should be required to provide teacher housing; District should be encouraged to be involved in teacher housing; legislature should establish standards for teacher housing; land should be made available to teachers to build their own housing; legislature should fund teacher housing; loans should be available to teachers to build; require districts to be truthful in describing housing; protect teachers from retaliation if they break their contract because of bad housing; and require housing as a condition of opening school.
2. NEA-Alaska: Go public with the problem and its impact on instruction; become the provider/landlord; research and document; support local bargainers; keep trying; stop trying; and work with regional corporations to supply housing.
3. Local Associations: Help locate and list available housing (or make district do it); bargain hard; negotiate equitable rents; policies and procedures; build units; stay out of housing; and address the unique problems of single teachers.
4. Responsibility: District should provide all housing; district should provide housing when individuals, villages, or corporations do not; teachers and villages should independently (from the district) arrive at a solution; take housing away from district to avoid it being used as a threat.
5. Independence: Housing should not be mandatory, get out and stay out of housing, teachers should live under same conditions as villages.

The overwhelming majority of responses fell in the first 4 categories.

A conclusion that can be drawn from the responses is that no one solution will work in all districts or even among all villages within a district. The message was clear; keep trying and be flexible.

6. Is there an alternative housing unit available to you at your site?

In general multiple respondents from the same site concurred on the answer to this question, wherever there was a difference of opinion the majority response was recorded with the minority response noted below.

Per the request from your office, enclosed is a recent survey conducted by NEA and NEA-Alaska attendant to rural teacher housing and other matters pertaining to teaching in rural Alaska.

Since we have recieved additional responses subsequent to the tabulation we are asking NEA to re-run the tabulation and provide greater specificity as to site and geographic location. When this information is available to us it will be forwarded on to your office.

NEA-Alaska appreciates your continued efforts to deal with the problem through your sponsorship of HB 196. Is it possible that the provisions of section 1 in the bill could also be applied to the responsibilities of school boards other than REAAs, where appropriate? In some places like Kenai and Kodiak the village teaching situation is similar to many of the REAA.

As you well know, this issue is complex and defies an easy solution. Some districts have taken the initiative to begin to address it and in others, through negotiations, we have been able to find viable options toward solution.


There continues to be concern relative to the issue of letting teachers know of the circumstances before hiring, and hopefully, HB 196 will put us on track to resolution of this part.

SUBJECT: House Bill 196 - Provision of Adequate Housing  
for Public School Teachers in Rural Areas

HB 196 is pending in your committee and I would appreciate an opportunity for a hearing at your earliest convenience.

Basically the bill does three things:

Section 1. Adds to the powers of regional school boards the ability to enter into leases to provide rental housing for teachers;

Section 2. Adds to the duties of regional school boards the requirement to inform all employees of the housing situation where they will be working and to assist them in securing housing. (The bill does not require school boards to provide housing or subsidize housing; and

Section 3. Adds additional duties to school boards in municipalities which are the same as those in section 2. (Municipalities already have the general power to provide housing).

For your further information, enclosed is a copy of the recently completed Rural Housing Survey completed by the National Education Association. I hope the committee members will find it helpful in understanding the housing conditions in rural Alaska.

The responses received to the above two questions did not lend themselves to simple groupings. In general, the responses fell into five categories summarized below:

1. Legislative: District should be required to provide teacher housing; District should be encouraged to be involved in teacher housing; legislature should establish standards for teacher housing; land should be made available to teachers to build their own housing; legislature should fund teacher housing; loans should be available to teachers to build; require districts to be truthful in describing housing; protect teachers from retaliation if they break their contract because of bad housing; and require housing as a condition of opening school.
2. NEA-Alaska: Go public with the problem and its impact on instruction; become the provider/landlord; research and document; support local bargainers; keep trying; stop trying; and work with regional corporations to supply housing.
3. Local Associations: Help locate and list available housing (or make district do it); bargain hard; negotiate equitable rents; policies and procedures; build units; stay out of housing; and address the unique problems of single teachers.
4. Responsibility: District should provide all housing; district should provide housing when individuals, villages, or corporations do not; teachers and villages should independently (from the district) arrive at a solution; take housing away from district to avoid it being used as a threat.
5. Independence: Housing should not be mandatory, get out and stay out of housing, teachers should live under same conditions as villages.

The overwhelming majority of responses fell in the first 4 categories.

A conclusion that can be drawn from the responses is that no one solution will work in all districts or even among all villages within a district. The message was clear; keep trying and be flexible.

6. Is there an alternative housing unit available to you at your site?

In general multiple respondents from the same site concurred on the answer to this question, wherever there was a difference of opinion the majority response was recorded with the minority response noted below.

SECTION 3. ADDS TO THE DUTIES OF LOCALLY OPERATED SCHOOLS IN RURAL AREAS (LOCAL ADMINISTRATION OF SCHOOL CHAPTER) THAT THEY SHALL PROVIDE PROSPECTIVE EMPLOYEES WITH INFORMATION ON HOUSING. IT ALSO CONTAINS THE SAME QUALIFIER AS IN SECTION 2 THAT THE DISTRICT IS NOT OBLIGATED TO SUBSIDIZE OR PROVIDE HOUSING.

In an effort to effectuate the Legislative Budget and Audit Committee's responsibilities, I respectfully urge the Committee's approval of this bill.

This legislation is a direct result of the transitional problems the Legislative Budget and Audit Committee faced earlier this year, due to organizational problems in the other body. Two years hence, however, this same problem occurred due to organizational problems in the House.

The Legislative Budget and Audit Committee, being a permanent interim committee, with certain statutory mandates to uphold, will be greatly enhanced by this legislation. It will insure continuity in carrying out the Committee's responsibilities. By adopting this proposed amendment, there will be a definite date when the new Legislative Budget and Audit Committee members take on their respective responsibilities, resulting in the Committee's continuous operation.

The intent of incorporating the confidentiality language on lines 24 and 25, is to do just that. Audit records and reports are confidential until approved by the Committee. This amendment will provide a statutory mandate to uphold this recognized procedure.

Again, I respectfully urge the House Finance Committee's approval of H.B. 198.

RE: HB 198 "An Act relating to membership of the Legislative Budget and Audit Committee and to records of the legislative audit division; and providing for an effective date."

I appreciate the fact that the Legislative Budget and Audit Committee has taken action to change the duration of the committee and to confine the committee members terms of office to the duration of the legislature in which they had been appointed. The present statute has created some difficulties. I recall that in 1981, the House did not organize until February 2 and the Legislative Budget and Audit Committee was not appointed on the House side until February 6. It was not until February 13 that a Committee meeting could be held and a new chair, in that instance myself, could be elected. You can well imagine that there was considerable confusion as to space allocations and Committee responsibilities during this in between time.

A similar circumstance arose during the current session. Although the statute is clear and there has been an Attorney General's opinion regarding the ongoing role of the Committee until such time as the reappointment or appointment of the committee members successors take place, considerable confusion has resulted from the current practice as set forth by statute. I strongly support the submission of your legislation. I think it will make future transition times much clearer. The one negative factor, of course, is in the event of delays in organizing that there would not be a chairman and a committee in place to conduct special needed business. However, since the Legislature would be in session, alternative methods of solving emergency situations are certainly available.

I would like to bring to your attention another matter which has some bearing on the Legislative Budget and Audit Committee. It has to do

with the allocation of legislative space. Apparently through the years there have been various non-binding intent statements placed in the budget document that appear to give some authority to the Budget and Audit Committee and/or the Finance Committees to make space allocations. I did not feel that was appropriate and the Committee did not take any action to implement these non-binding intent statements. I do feel, in addition, that there is a major unresolved area between the Legislative Council and the Rules Committee as to space allocations that needs clarification. I am enclosing for your review a copy of a memo that speaks to this issue. I am also making a copy of this memo available to the Special Committee on Legislative Reform since I think this area of possible overlap and confusion is one they may wish to address.

Please contact me further if I can give you more information regarding the issue raised in HB 198.

I appreciate the fact that the Legislative Budget and Audit Committee has taken action to change the duration of the committee and to confine the committee members terms of office to the duration of the legislature in which they had been appointed. The present statute has created some difficulties. I recall that in 1981, the House did not organize until February 2 and the Legislative Budget and Audit Committee was not appointed on the House side until February 6. It was not until February 13 that a Committee meeting could be held and a new chair, in that instance myself, could be elected. You can well imagine that there was considerable confusion as to space allocations and Committee responsibilities during this in between time.

A similar circumstance arose during the current session. Although the statute is clear and there has been an Attorney General's opinion regarding the ongoing role of the Committee until such time as the reappointment or appointment of the committee members successors take place, considerable confusion has resulted from the current practice as set forth by statute. I strongly support the submission of your legislation. I think it will make future transition times much clearer. The one negative factor, of course, is in the event of delays in organizing that there would not be a chairman and a committee in place to conduct special needed business. However, since the legislature would be in session, alternative methods of solving emergency situations are certainly available.

I would like to bring to your attention another matter which has some bearing on the Legislative Budget and Audit Committee. It has to do

with the allocation of legislative space. Apparently through the years there have been various non-binding intent statements placed in the budget document that appear to give some authority to the Budget and Audit Committee and/or the Finance Committees to make space allocations. I did not feel that was appropriate and the Committee did not take any action to implement these non-binding intent statements. I do feel, in addition, that there is a major unresolved area between the Legislative Council and the Rules Committee as to space allocations that needs clarification. I am enclosing for your review a copy of a memo that speaks to this issue. I am also making a copy of this memo available to the Special Committee on Legislative Reform since I think this area of possible overlap and confusion is one they may wish to address.

Please contact me further if I can give you more information regarding the issue raised in HB 198.

Ø statement of fiscal impact

HB 198 by the Rules Committee by the request of the Budget and Audit Committee - relates to membership of the Legislative Budget and Audit Committee and the Legislative Council, providing members serve for the duration of the legislature during which they are appointed. The law currently provides that members serve for the duration of the legislature during which they are appointed & that a member who is reelected or whose term of office extends into the next succeeding legislature continues to serve until reappointed or until the appointment of their successor.

The bill also amends the section relating to records of the Legislative Audit Division, by adding that audit records are confidential and audit reports are confidential unless the report has been approved for release under AS 24.20.311 (Reports, "...Reports shall be approved by a majority of the [Legislative Budget & Audit] committee before their release and shall be open to public inspection after their release to the legislature.")

Provides Act takes effect immediately.
