Provides general criteria, but does not establish a specific priority system.

Expenditure of state funds prohibited for hockey rink, planetarium, residential space, sauna, and other single purpose sporting/recreational facility (14.11.105(b))

Same (14.11.100(h))

Expenditure limited for reimbursement, but not for grants.

General fund or proceeds of general obligation bonds. Interest earned must be applied to project costs.

General fund with local indebtedness. Interest earned on bond proceeds must be applied to project costs or costs of the bond issuance (14.11.100(k)).

General fund for bonds; general fund with local indebtedness for debt retirement. Interest is spent at the district's discretion.



6 For an Act entitled: "An Act relating to state aid for school construc-
7 tion; and providing for an effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 14.11 is amended by adding a new section to read:

10 Sec. 14.11.005. SCHOOL CONSTRUCTION GRANT ACCOUNT. (a) There
11 is established the school construction grant account to consist of
12 money appropriated from the general fund and the proceeds of general
13 obligation bonds to the account for school construction. The state
14 may appropriate funds from the school construction grant account to
15 school districts for the costs of school construction.

16 (b) A school district that receives a grant under this section
17 shall repay the state 10 percent of the grant within 10 years of
18 receiving the grant. In lieu of repayment a school district may,
19 subject to the approval of the commissioner, donate to the project 10
20 percent of the project cost in the form of real property, site prepa-
21 ration, or capital improvements to the property.

22 * Sec. 2. AS 14.11.010(a) is amended to read:

23 (a) The assembly or council of a municipality that is a school
24 district or a regional school board may submit a request to the de-
25 partment for a grant from the school construction grant account for a
26 school or education-related facility construction, rehabilitation, or
27 improvement project together with a report evaluating the condition of
28 school or education-related facilities in the municipality or regional
29 educational attendance area and a determination of the need for the

1 project. To be eligible for a grant, a school district must submit a
2 request under this section no later than October 15 of the fiscal year
3 before the fiscal year for which the request is made.



ANALYSIS FOR SENATE BILL 52

An Act making a special appropriation for the 1985 Iditarod sled dog race

Senate Bill 52 appropriates \$72,000 to the Department of Commerce and Economic Development for a grant to the Iditarod Trail Committee. The Committee will apply this grant toward the expenses of conducting the 1985 Iditarod sled dog race.

As the longest sled dog race in the world, the Iditarod has become a major international challenge. Not only does the race commemorate an historic event, it also promotes tourism by portraying a positive image of Alaska throughout the world.

The Iditarod race furnishes Alaska with media exposure which could not be purchased for an equivalent sum. In 1983, the CBS Television Network broadcast the start of the race nationwide and last year a Japanese company produced an hour long film on the race which was shown on the Tokyo Broadcasting System. The Iditarod has been the focus of articles in National Geographic, GEO Magazine, Newsweek, People Magazine, and a recent book, The Last Great Race. This year's race will be featured on CBS's "Sports Saturday".

During recent years, the Legislature has made the following appropriations to support the race:
