20 * Sec. 2. The sum of \$3,727,650 is appropriated from federal disaster

23 Affairs for payment as a grant under AS 44.19.048 to the North Slope

This memo will give a current status of the Disaster Relief Fund (DRF), and indicate likely demands on the fund from recent disasters. The bottom line is that it appears inevitable that a supplemental will be needed to appropriate additional general funds to the DRF.

The current unobligated fund balance of the DRF, according to AKSAS, is \$2,205,566. This is the balance after the most recent allocation of \$50,000 to the Beaver Electrical System Disaster, as shown in Raydene Garrison's memo to you of March 24, 1988. There are several declared disasters or disasters pending declarations which will likely require allocations from the DRF. These include the following:

Chenega Bay Electrical failure (approved)	40.0
Chefornak Power Plant Fire (approved)	100.0
Chefornak Fire (additional needed)	125.0
Pitkas Point Fire-VSW (pending approval)	105.0
Nondalton Fire-City Bldg (pending approval)	886.0
TOTAL	1256.0

In addition to the above, HB413 will require an additional \$1,317,550 for additional disaster relief to the Wainwright and Barrow school fires. As currently drafted, HB413 only allocates money from the DRF, and does not appropriate additional general funds to the DRF.

The only additional funds likely to be returned to the DRF through the close-out of disasters in the next few months are expected to be \$99,000, due to the close out of the Unalaska Windstorm disaster of November 1985.

If it is assumed that all of the funds likely to be needed for disasters are actually allocated from the DRF, the DRF would be \$268,984 short of the demands on it (or \$367,984 short not counting the close-out funds returned to the DRF). This does not consider the need for additional funds likely to be needed to respond to disasters between now and June 30, 1988. Any unobligated funds remaining in the DRF on June 30, 1988 would be lapsed back to the general fund.

Please advise what action you would like us to pursue.

You have asked for a reconciliation of the Disaster Relief Fund (DRF), specifically explaining how to relate the information in my memo to Jay Hogan of March 29, 1988 to the information provided by ADES concerning the cash balances remaining in specific disasters.

There are several attachments to this memo which will explain how all the information provided to date fits together. These attachments include:

1. A current status of the DRF, based on AKSAS reports dated 3/28/88. This status report updates the information included in the budget pages referenced as attachment 2 below, and shows a cash available balance (per AKSAS) of \$2,205.6. This matches the balance shown in my memo of 3/29/88 to Jay Hogan. This status also includes projections for additional funds needed for disasters based on current information available. The projected amounts also match those in my memo to Jay Hogan of 3/29/88, except for the additional amount needed for the Wainwright disaster (in HB413). It now appears, based on the House Finance subcommittee meetings held last night, that the Wainwright amount may need to be increased by \$200,000.
2. Pages 271 and 272 of the DMVA operating budget submission, providing a statement of the available cash balance of the DRF as of 11/24/87, starting from the DRF statement in the Annual Financial Report. These pages are referenced in attachment 1.
3. A copy of a memo from the DMVA finance officer, Raydene Garrison, to Jay Hogan dated 3/31/88, which allocates funds for the most recent disasters (Cheformak and Chenega Bay), and which shows a cash available balance of \$2,205.6. After the allocation of the DRF funds for the Cheformak and Chenega Bay disasters, the DRF balance will be reduced to \$2,065.6.

4. A spreadsheet showing all open disasters, and the DRF amounts currently allocated to each, including federal funds allocated. These figures were obtained from AKSAS, and screen print documentation is available if you wish to review it. The total of all the DRF balances for the open disasters (\$8,248,429) matches the amount shown on the 3/31/88 memo from Raydene Garrison to Jay Hogan.

A brief explanation of the difference between cash balance and allocations is necessary to understand how these relate to each other: Once disaster funds are recorded to a disaster's account in AKSAS (as Cheformak and Chenega Bay have just been), the allocation and the cash balance are the same. As soon as expenditures take place, however, both the cash balance and the allocation are reduced equal to the amount spent.

For example, at the beginning of FY88, the DRF had a starting cash balance of \$12,162,000. This was the sum of the \$6,162,000 shown as cash in the treasury in the Annual Financial Report, and the \$6,000,000 appropriated to the DRF in the FY88 budget act. However, now the cash balance is only \$10,53,995. This means that there has been a total of \$1,708,005 in DRF expenditures since the beginning of FY88.

Even though there is a cash balance of over \$10 Million in the DRF, a very large part of that is allocated to disasters which have already been approved. The spreadsheet which shows all open disasters demonstrates that the cash balance of DRF funds for all open disasters totals \$8,248,429. Included in this figure are the amounts for each of the disasters listed on the data sheet prepared by ADES. Any differences between the cash balances shown for any single disaster on the ADES sheet and the attached spreadsheet are due to one or both of the following: 1) the information on our spreadsheet is more current, since expenditures are constantly being recorded against each disaster, or 2) the expenditure information provided by ADES included encumbrances, which are not included as expenditures in the cash balances included in our spreadsheet.

You will also note that the (net) authorizations for each of the individual disasters shown on the attached spreadsheet (i.e., the second column of numbers) are no longer the original allocations. When funds are spent on a disaster, the cash balance is reduced, but the net balance of the allocation is also reduced.

A review of the cash balances remaining for all of the open disasters will reveal that there are large sums of the DRF allocated to some older disasters. ADES staff has assured me that these amounts are still needed, since it takes several years to completely close out larger disasters. I am sure Erv Martin would be happy to provide you with specifics on any disaster you wish to know more about.

I trust that the information provided in this memo and the attachments will explain how the accounting information in AKSAS is used to calculate the amounts actually available in the DRF to make available for new disasters. If any additional information is needed, please contact me.

Dear Mr. President:

Under the provisions of Section 302(b), Public Law 93-288, as implemented by 44 CFR 205.41, I request that you declare a major disaster for Alaska as a result of a multi-structure conflagration that occurred in the City of Barrow, North Slope Borough, on February 10, 1988. This conflagration completely destroyed the community's only Early Childhood/Kindergarten/Bilingual school.

The amount and severity of disaster-related damages are broken down by type in the following preliminary estimate:

The insurance policies will cover approximately \$3,000,000 of these damages, leaving an uninsured loss of a minimum of \$4,970,200. We anticipate that as full recovery needs are identified, uninsured costs will escalate to in excess of \$10,000,000.

I declared a State Disaster for the North Slope Borough on February 16, 1988. I have directed all appropriate actions under state law.

I have determined that this incident is of such severity and magnitude that effective response is beyond the capabilities of the state and the affected local government, and that supplementary federal assistance is necessary. Preliminary

estimates of the nature and extent of federal public assistance needed under Public Law 93-288, as amended, are tabulated in Enclosure A. Federal individual assistance is not required; however, Department of Education assistance is required.

The State of Alaska has a disaster fund which is used to support relief efforts for both communities and individuals who have suffered losses during disaster events. For the fiscal year beginning July 1, 1987, the Alaska Legislature appropriated \$6,000,000 to the Disaster Relief Fund. The state has committed to recovery from disasters a total of \$3,900,000 from this fund, and the remaining balance is \$2,100,000. The Barrow disaster commitment and anticipated spring river flooding disasters will deplete the fund to a dangerously low level.

The state has committed disaster funds to be used as the state share in support of this emergency relief effort (\$1,000,000 through the state disaster declaration and \$242,550 as the state's remaining commitment). This amount equates to approximately 25 percent of the total funds required by the federal government. An additional \$75,000 is dedicated for hazard mitigation planning.

The State of Alaska and the North Slope Borough are currently recovering from several multi-million dollar major disasters. The most recent disaster involved a school and power plant fire in the village of Wainwright in September 1987. A severe winter storm in September 1986 caused major damage to both public and privately-owned facilities throughout the coastal region of the Borough. A Federal Disaster Declaration was requested, but was not approved, for the Wainwright disaster.

Pursuant to Federal Emergency Management Agency regulations, I certify that the total expenditures and obligations for this major disaster for which no federal reimbursement will be requested are \$1,317,550 in accordance with the table in Enclosure B.



SUPPLEMENTARY JUSTIFICATION
STATE DAMAGE ASSESSMENT

REQUEST FOR A MAJOR DISASTER DECLARATION

I. BACKGROUND

Barrow is the community affected by this disaster. It is located on the coast adjacent to the Chukchi and Beaufort Seas and is the northern most community in the State of Alaska and the largest in the North Slope Borough. Barrow is the seat of borough government. The majority of its 3,075 residents are Native American Inupiat Eskimos.

Unemployment within the North Slope Borough is extremely high, ranging from 36 percent in Barrow to over 60 percent in villages throughout the borough. Most residents live a subsistence lifestyle and depend primarily upon the bowhead whale and other wildlife resources for their dietary needs. The North Slope Region is comprised of featureless lowland tundra with numerous small lakes and swamps. Barrow is not connected by road or railroad to any other community, and access is limited to air traffic year round or barge traffic for approximately three weeks during the summer months. The arctic climate is one of the harshest climates to which human beings have adapted.

The following is a background summary of the local governments involved in the disaster.

The North Slope Borough is the areawide local government for the northern portion of the State of Alaska. The borough exercises responsibilities for taxation and assessment, education, planning and zoning, housing and urban renewal, preservation and maintenance of historic or archaeological sites, environmental protection, streets and sidewalks, sewers and sewage treatment, solid waste collection and disposal, water supply and flood control, health services and hospital facilities, electric and heating utilities, transportation systems, search and rescue, aviation facilities, fire and police protection, and other matters.

The borough has responsibility for most government functions that are normally assumed by cities, towns and counties in other areas of the United States. The North Slope Borough owns all of the facilities affected by this disaster. The

borough encompasses an area of 88,281 square miles, which is comparable in size to the State of Oregon. Its physical size makes it the largest municipality in the world, but its population of only 8,308 persons makes it one of the most sparsely populated. It is one of the most isolated regions on earth.

The fire damage resulted in the total loss of the Early Childhood Education and Kindergarten sections of the Ipalook Elementary School; smoke damage to adjacent school buildings and teachers' living quarters; and damage to sewer and water systems in adjacent buildings due to loss of power and heat. Associated recovery costs include site cleanup; the provision of temporary facilities to continue the education program for the 265 displaced children; restoration of electric power; sewer and water to adjacent school facilities and living quarters, and clean up of smoke damage, as well as facility replacement costs that exceed insurance settlements.

Since the major governmental functions are assumed by the borough, the municipal government of Barrow is relatively small with very limited capabilities.

All disaster-relief funds will be channeled through the North Slope Borough since it has areawide responsibility for education. Total public sector damage is estimated to be \$7,970,200, of which approximately \$3,000,000 is covered by insurance. Borough officials estimate that actual cost of relocation and replacement of the facility will be in excess of \$15,000,000.

The school cannot be rebuilt on the same site due to numerous safety and code requirements. Rebuilding on a different site will require equipping the facility with independent support facilities that were previously shared with the adjoining elementary school. These include recreational area, food service, and mechanical support. Costs that cannot be supported by federal public disaster assistance will amount to an additional \$7,000,000 which must be borne by state and/or local government.

The North Slope Borough budget for FY 88, beginning July 1987, is \$331,797,315. Property taxes, primarily from oil-producing lands and facilities, will contribute approximately 70 percent of borough revenues, with the balance coming from state revenue sharing, sales taxes, and user fees.

The borough debt service is \$231,797,315 which is 70 percent of its total budget. The borough has incurred an indebtedness of over \$1 billion in recent years. These funds have been devoted to construction of facilities such as schools, water and sewer systems, airports, health facilities, and police and fire protection facilities and equipment. With the exception of schools, these facilities were not previously available in the community. Communities in other states have had these services for at least the past 100 years.

Within the non-debt service operating budget, education costs comprise \$28,412,000. Public works and utilities expenditures are authorized at \$16,877,000.

The borough maintains hazard insurance on public facilities, with annual premiums of approximately \$2,500,000. The Barrow and Wainwright disasters and other fires that occurred over the past year are expected to result in an increase of both premiums and deductibles by an estimated 75 percent. Any additional financial demands on the borough would have a serious and deleterious impact in such areas as schools, fire and police protection, health, and essential public works and utilities.

II. IMPACTS

1. Significant effects on people include the following:
 - a. The most serious impact of this disaster falls upon the 265 children who will be displaced and deprived of adequate education facilities. These students will be forced to relocate to substandard conditions in scattered facilities throughout the community. The older facilities were not constructed or designed for arctic, frigid temperatures.
 - b. The majority of children who attend this preschool program are from homes in which Inupiaq Eskimo is the first language. Many of the parents still engage in a subsistence hunting and fishing way of life. The program is considered by borough school officials to be the most important of all their education programs. Bilingual and bicultural children who attend a good developmentally appropriate preschool program are significantly more likely to graduate from high school, enroll in post-secondary education and find employment.

They are less likely to drop out of school and become dependent on welfare assistance or have social problems.

2. Significant effects on state or local government:

- a. Loss of this key facility and the capital investment it represents poses a severe financial hardship on the North Slope Borough government. Although this facility was covered by limited insurance, uninsured costs associated with this disaster are beyond the effective capability of the borough.

3. Significant effects on private, nonprofit organizations (educational, utility, emergency, medical, or custodial care facilities):

None

4. Significant effects on business:

None

5. Significant factors not otherwise covered above: This is the second major fire disaster in the borough within a five-month period and within FY 88. The unreimbursed costs incurred by the borough over the past year as a result of several fires have put a severe strain on its budget. In addition, some \$10,500,000 of emergency and unanticipated costs were incurred by the borough this year due to a failure in the main gas field that supplies the City of Barrow.

III. STATE AND LOCAL RESPONSES

A. State

1. The State of Alaska declared a Disaster Emergency (AS 26.23.020) for the North Slope Borough on February 16, 1988. The state Emergency Plan was implemented.
2. Specific assistance provided as a result of the disaster emergency includes:
 - a. The Governor has authorized up to \$1 million, as provided for in Alaska statutes, for necessary disaster assistance, administrative and disaster management expenses.

- b. State response has involved a minimum of seven staff and 24 staff days.
3. The Alaska Constitution prohibits expenditures without appropriation of funds. Funds appropriated by the Legislature for specific purposes cannot be used by the Governor for emergencies.
 4. The Alaska Disaster Relief Fund is used to provide assistance to individuals and families, and to assist local governments to recover from disaster losses.
 5. At the beginning of the current state fiscal year, July 1, 1987, the Legislature appropriated \$6 million for the State Disaster Relief Fund. State declared disasters currently being serviced have reduced the fund down to \$2.1 million. Of the funds from the Disaster Relief Fund committed, \$2 million are directed to recovery from a school fire in the village of Wainwright in the North Slope Borough, for which a request for a Presidential Declaration in October 1987 was denied. The \$1 million already committed to the Barrow school disaster will further deplete the fund to a dangerously low level. Furthermore, Alaska will soon enter the season of spring flooding which is historically the most disaster prone time of the year. Last year spring flooding alone accounted for expenditures of state disaster funds in the amount of \$1.25 million. The state disaster account does not have sufficient funds to recover from the Barrow school disaster.
 6. The state operating budget for FY 88 is \$1.913 billion, with many formula programs and commitments. Funds are committed by direct appropriations that require legislative action to change programs and emphasis. The recent decline in oil prices has had a very direct and serious impact on the state's economy. Unemployment and mortgage foreclosure rates are at an all-time high. Present projections are for a state revenue shortfall during FY 88 in excess of \$299 million, which will seriously jeopardize many programs.

7. The State of Alaska has a Permanent Fund, established by a constitutional amendment as an endowment to balance the long-term needs of the state against the short life span of petroleum production activities which currently provide approximately 70 percent of state government revenues. The balance of this fund is \$8.583 billion.

Like the endowments established by many states for special purposes such as education, health, etc., the principal of the Permanent Fund is constitutionally protected from appropriation by the Legislature. Use of earnings of the fund is restricted to reinvestment in the principal and distribution to residents through the Permanent Fund Dividend Program. Neither the Permanent Fund nor its earnings may be legally used for disaster relief.

8. The state has committed a minimum of \$1,317,550 in disaster funds to be used to support recovery from this disaster. Allocation of these funds are as follows:
 - a. \$1,242,550 to be applied as the state's 25 percent share of those items found to be eligible for Federal disaster assistance,
 - b. \$75,000 to provide funding for mitigation of a reoccurrence of similar disasters in the future.

B. Local

1. The North Slope Borough has committed \$200,000 and its personnel and resources to provide support for emergency response and recovery.
2. The North Slope Borough budget for FY 87/88 (beginning July 1987) is \$331,797,315. Property taxes, primarily from oil-producing lands and facilities, will contribute \$249,000,000. The remainder of its revenue comes from state revenue sharing, fees for services and sales tax.

3. A debt service of \$231,797,315 makes up 70 percent of the borough's total budget. The borough has incurred indebtedness of over \$1 billion in recent years. However, it should be noted that all of these funds have been devoted to community improvements such as schools, water and sewer systems, airports, health facilities, police and fire protection facilities and services that communities in other states have had for at least the past 100 years.
4. Within the non-debt service operating budget, education costs comprise \$28,412,000. Public works and utilities expenditures are authorized at \$16,877,000.
5. The North Slope Borough maintains fire and hazard insurance policies on public property, with annual premiums of approximately \$2,500,000. It will continue to maintain these policies in the future.

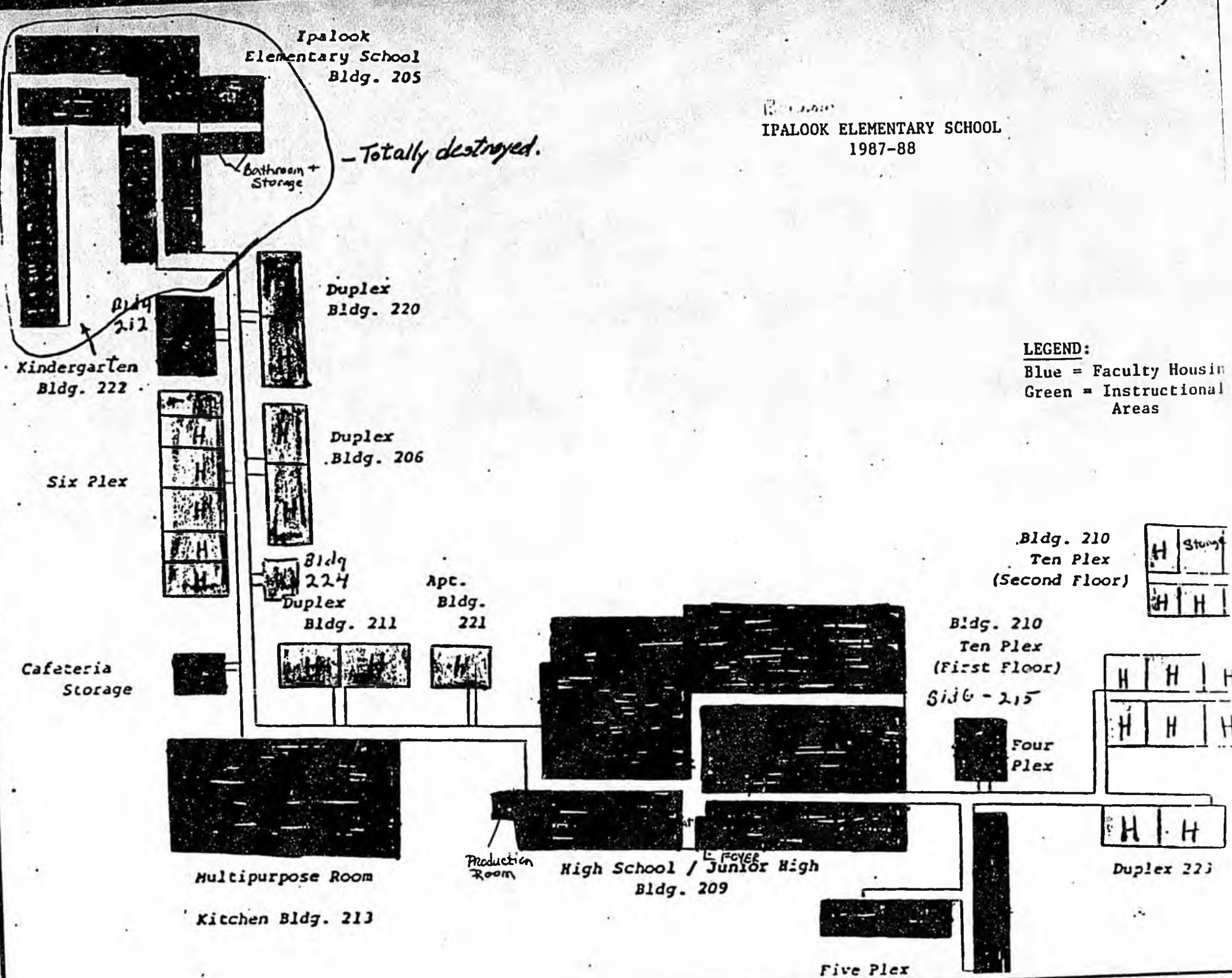

You have requested that I confirm the amount of federal funds needed for the Barrow fire disaster, for inclusion in the House Finance Committee Substitute for HB413.

The total federally-approved amount for the Barrow fire disaster is \$4,970,200. Of this amount, the federal government will provide 75%, or \$3,727,650, and the state will match at a 75/25 ratio, requiring \$1,242,550 in state matching funds. In addition, the state is also obligated to commit \$75,000 toward preparation of a disaster mitigation plan to ensure that this disaster does not repeat itself in the future. This brings the total state funds needed for the disaster to \$1,317,550. Since the Governor has already allocated \$1,000,000 in disaster relief funds to this disaster, the balance of \$317,550 in disaster relief funds is needed to be authorized by the legislature. The amount of federal funds needed to be authorized is \$3,727,650. Inclusion of the federal funds in HB413 will relieve the Department of the need to request federal authorization by revised program (RPL), as has been done in the past.



Of the total funds budgeted in the SIR accounts for FY88, \$6.345 million are identified as "Self-Insured Retention Reserve" funds; that is, they may not be spent except by Assembly action and are to remain reserved according to the North Slope Borough's negotiated insurance agreement. The other \$1.2 million are identified as "Self-Insured Retention Expenditure" funds, and may be accessed by the administration to make necessary SIR payments without assembly action. Neither of these SIR accounts may be spent for uninsured emergency disaster activities.

QUESTION #2: What portion of these funds was applied to the Wainwright Disaster?

ANSWER #2: Following the Wainwright fire the North Slope Borough "borrowed" the \$1.2 million SIR Expenditure Account total and appropriated it to a newly created Emergency Corrective Actions Account to cover uninsured emergency costs concerning Wainwright. This left no money to pay the SIR for Wainwright.

QUESTION #3: How much North Slope Borough money has been appropriated for use on the Ipalook Disaster?

ANSWER #3: None of the above discussed SIR monies have been designated for the Ipalook fire because the Expenditure Account had been depleted for Wainwright and it is necessary to maintain the Reserve Account to comply with Insurance Company agreements. When the Ipalook fire occurred, \$1.244 million was borrowed from the North Slope Borough Assembly Reserve Account to cover Emergency Corrective Actions in connection with that event. The Assembly Reserve Account is required by municipal code to fund unexpected operating and maintenance costs. Because uninsured emergency disaster costs are not operation and maintenance items, monies taken from this account to cover uninsured costs in connection with the Ipalook fire must be repaid.

QUESTION #4: Are any other North Slope Borough funds available for expenditure on uninsured disaster costs related to these two incidents?

ANSWER #4: No. The present situation of "borrowed" funds which must be repaid leaves a deficit of \$2,000,000 in SIR funds necessary for both fires and a deficit of funding necessary to cover uninsured costs arising from both incidents beyond the \$939,700 now approved by ADES for Wainwright.

QUESTION #5: What is the explanation of the difference between the \$726,000 amount originally requested in HB 413 and the \$1,156,154 amount requested in the March 28, 1988 North Slope Borough submittal?

ANSWER #5: The \$726,000 originally requested in HB 413 was based on the North Slope Borough's January 19, 1988 total revised estimate of uninsured costs of \$1,600,480.29, less the State Approved amount of \$939,700. This amount, \$660,780.29, plus approximately 10% for administration, was the most accurate estimate of uninsured costs that the North Slope Borough had at that time.

The revised request of \$1,156,154 submitted on March 28, 1988 includes actual expenditures as of that date, some of which have already exceeded our original estimates made immediately following the fire. It also reflects our most recent reasonable estimates of additional anticipated costs, such as costs associated with the replacement of the 500 KW generator that was provided by ADES immediately following the disaster and has since been removed.

QUESTION #6: What is the basis for the \$10,200,000 estimate for replacement of the Ipalook school?

ANSWER #6: This figure is based on replacement of the damaged portion of the Ipalook school which has been identified as a 19,000 square foot structure. This figure places the reconstruction on the same site as the burned facility. Although the \$10,200,000 figure is presently the best estimate available, it has already been determined substantially inadequate because the old site and structure did not meet present set back, safety and fire codes.

QUESTION #7: Can a general overview of all recent North Slope Borough disasters be provided?

ANSWER #7: Yes. The attached chart (Attachment A, Page 4) provides the best overview now available. Unfortunately, due to evolving information, it unavoidably contains many estimated figures.

Documentation

I have reviewed the documentation on the Wainwright Fire Disaster in a cursorial manner. Without being able to go into the depth and specifics of a full audit because of the lack of time to do so, I feel confident that the required backup information is in order. I have spot checked the items pertaining to DSR 1 through 3. For the purposes of providing assurance to both ADES and the State Legislature, I feel that the expenditures summarized by the Grants Division are within acceptable confidence levels for \$751,680.00

As of this writing, the School District is in the process of copying the required documentation for DSR 4 and 5 for the Borough. A summary of each line item for \$283,150.00 with reference to check numbers was provided. With the School District's involvement with the Ipalook Elementary fire just at the time that the Borough was compiling documentation, the delay is understandable.

This only falls short of the \$939,700.00 requested by \$188,100.00. The documentation will be Express Mailed with the documentation that I looked at.

A thorough and final audit will take longer than the time available before HB 413 is considered by committee. This is especially so with the business of the Ipalook Elementary School fire at hand.

The Borough will be faxing a summary of DRS's by line item to ADES by Friday. These line item expenditure figures are the ones with which I am in basic agreement. The Borough is in the process of making copies of the documentation which they will Express Mail to ADES on Friday.

III. APPLICATION TO WAINWRIGHT SCHOOL/POWER PLANT FIRE

The Wainwright Fire occurred in September of the above listed insurance coverage period. At the present time the North Slope Borough expects the replacement of the school and power plant facilities to be covered under the above described property insurance coverage. The North Slope Borough has applied the \$1,000,000 SIR to losses sustained in this disaster. The North Slope Borough School District will apply the full contents coverage to losses.

Funding for uninsured costs has been requested from ADES which has approved \$939,700.00 for this purpose. The North Slope Borough is requesting an additional \$957,123.94, also necessary to cover uninsured costs in addition to those previously approved by ADES.

Examples of uninsured costs include, but may not be limited to, those items discussed in the February 19, 1988 letter to Representative Adams (copy attached). Briefly, items discussed in the Adams letter are:

- temporary power for the entire village
- temporary classroom facilities
- furnishings for temporary classrooms
- contents in excess of coverage

These costs are routinely excluded from commercial property insurance policies.





Introduction

The North Slope Borough (NSB) carries property insurance as described below. This plan applies to all NSB facilities; these include, but may not be limited to, schools, administration offices, maintenance shops, day care centers and all other public facilities whether or not in the exclusive use of the School District. The Borough's total property insurance schedule is approximately \$634,000,000.

In addition, the North Slope Borough School District (NSBSD) insures the contents of School District buildings only, for \$1,000,000 per occurrence with a \$25,000 deductible per occurrence. The details of this coverage are also presented below.

Wainwright School/Power Plant Fire

On September 23, 1987 at approximately 8:00 PM the majority of the school facility and the entire power generation plant in the NSB community of Wainwright were destroyed by fire.

This catastrophe left the City of Wainwright without a primary source of power, without education and cafeteria facilities for grades 4 through 12, without school administration areas, and without recreation and adult education facilities for the entire city. A total population of 507 was affected, including 186 Elementary and High School students who were left without a cafeteria, gymnasium or pool. Eighty one (81) High School students were left without classrooms.

Emergency actions were initiated by several NSB agencies and departments, the residents of Wainwright and the Alaska Division of Emergency Services (ADES) to cope with the disaster at hand; to protect life, health and safety of the residents, and to mitigate further damage and hazard potential within the city.

The NSB relocated three (3) portable trailers to the school site for use as temporary administration, storage, and kitchen facilities; two small wooden structures were moved and two more small wooden buildings were constructed to serve as temporary classrooms. The ADES flew a 500 KW generator to Wainwright. These emergency measures were intended to meet the community's power and school facility needs until new facilities could be built. The cost of these emergency measures is not insured under current NSB/NSBSD coverage as described on the following page.

Property Insurance (NSB/NSBSD)

The North Slope Borough insurance plan, effective June 1, 1987 to June 1, 1988, provides a total of \$30,000,000 per occurrence. This includes a NSB carried Self Insured Retention (SIR) in the amount of \$1,000,000 per occurrence. Regarding the next \$4,000,000 loss (in excess of the SIR), three insurance carriers will participate in varying amounts as follows: Mt. Hawley Insurance Company at 50%, First State at 25% and Century Indemnity at 25%.

Regarding the next \$10,000,000 loss (in excess of the first \$5,000,000), five (5) insurance carriers will participate, each at 20%, as follows: Lexington, Cal Union, Century Indemnity, Landmark and Fireman's Fund. Regarding the next \$15,000,000 loss (in excess of the first \$15,000,000), TransAmerica will provide 100% coverage. Perils covered by these policies are "all risk" of physical loss, including earthquake and flood, subject to policy terms, conditions and exclusions as follows:

1) Property Excluded:

- A. aircraft, watercraft, vehicles (except while in storage), jewelry, precious stones, fur or fur trimmed garments;
- B. data processing media;
- C. power transmission and feeder lines not on the insured premises, unless on the schedule on file with the underwriter;
- D. property in transit;
- E. all properties in the course of construction;
- F. properties owned but omitted intentionally on the Statement of Values (SOV) at inception;
- G. contractor's equipment unless in storage and on SOV;

2) Perils Excluded:

- A. steam boiler explosion and/or machinery breakdown;
- B. employee infidelity;
- C. theft or damage due to weather conditions to personal property left in the open;
- D. nuclear war;
- E. demolition/increased cost of construction due to code or civil authority requirement;
- F. cost of making good faulty or defective workmanship, material, construction or design;
- G. loss or damage caused by freezing unless resulting from damage occasioned by other insured perils;
- H. loss or damage to materials and/or equipment in the course of ocean marine shipment;

3. Special Conditions: Newly acquired properties, except newly acquired property with values in excess of \$5,000,000 must be reported within 90 days of acquisition or completion.

Recovery of school properties is based upon REPLACEMENT COST of real and personal property with like kind and quality according to stated values. The actual loss standard for figuring recovery is applied to extra expense, business interruption and rental income as these relate to NSB concerns located in Prudhoe Bay only. The actual loss standard does not apply to NSB School District properties.

Contents Coverage (NSBSD Only)

The NSBSD insures the contents of those buildings used by the District for \$1,000,000 per occurrence with a \$25,000 deductible per occurrence. This plan is effective June 1, 1987 to June 1, 1988 and covers "all risk" of physical loss including earthquake and flood, subject to policy terms, conditions and the exclusions listed above under the Property Insurance section of this document.

Insurance Selection Process

The NSB begins property insurance marketing 120 to 90 days prior to the policy renewal date.

The NSB property policy is in manuscripted form and is much broader than most commercial property policies. Once the property schedule (approximately \$634,000,000 for the subject coverage period) is finalized, a marketing package is submitted to both domestic and foreign carriers. Quotations from the carriers are submitted to the NSB broker Bayly, Martin and Fay (BMF) and then forwarded to the Borough.

The NSB Risk Manager and the Director of the NSB Department of Administration and Finance review all quotations and balance the insurance products available with internal budgetary constraints to produce a financially feasible program based on past loss history. Before entering into the selected program, a determination is also made that it will meet insurance industry standards, and provide coverage comparable to or broader than that acquired by other similar public entities within the state.

Uninsured Emergency Costs - Wainwright Fire

Expenditures for emergency work associated with the restoration of temporary power in Wainwright; including labor, travel, materials, freight, professional fees, miscellaneous costs and equipment; have been reported at \$117,198.78. The cost of bringing the existing elementary wing up to operational standards prior to initiating temporary school facilities; including labor, travel, materials, freight, professional fees, miscellaneous costs and equipment; has been reported at \$26,565.36.

The cost of construction and/or relocation of facilities to provide a temporary school for the next two years; including sub-contractor expense, house moving costs, labor, travel, materials, freight, other professional fees, miscellaneous costs and equipment; have been reported at \$607,916.79.

The cost of refurbishing elementary facilities and furnishing temporary school facilities and reassignment of personnel to allow for development and implementation of educational plans using the temporary facilities, including labor, travel, materials, freight, temporary furnishing, curriculum materials and miscellaneous costs; has been reported at \$85,629.70. In addition approximately \$108,370 of reported expenditures under this category are still the subject of negotiations with the insurance company.

The cost of replacing School District contents destroyed in the building has been estimated at \$122,700 in excess of the \$1 million dollar NSBSD insurance coverage.

Materials procured from other NSB projects for use in emergency actions or on temporary facility construction, which must be replaced, have been estimated to cost approximately \$100,000. Approximately \$133,443 of uninsured costs have been encumbered under construction contracts, but have not yet been expended.

Uninsured architectural redesign costs are estimated at \$539,000. The cost of replacement of the 500 KW generator; including labor, materials, freight, travel and subsistence, equipment and fencing; is \$76,000.

The above listed actual, encumbered and estimated emergency and temporary measures which are uninsured now amount to a total of \$1,896,823.94. ADES has approved a total of \$939,700 based upon initial estimates. The additional amount necessary to cover uninsured costs is \$957,123.94. The above discussed uninsured costs are presented in greater detail in NSB Mayor George Ahmaogak's February 18, 1988 letter to Representative Adams (copy attached).

NSB/NSBSD CONTRIBUTION

The NSB has paid a premium of approximately \$1,100,000 for the current property policy which expires June 1, 1988. In addition, the amount of \$1,000,000 was budgeted by the NSB to cover the current year's SIR. This amount will be contributed to the cost of replacement of the facilities. The \$1,000,000 amount was budgeted in anticipation of only one major loss during the pertinent fiscal year. The NSB does not maintain a separate disaster relief fund for uninsured costs. The NSBSD paid a \$42,785 premium for the current contents policy which expires June 1, 1988.

These contributions are reflected in the Uninsured Damage Estimates previously provided to Representative Adams, Senator Hensley and House Finance Committee members.

Conclusion

The NSB has suffered a massive financial blow in the form of the Wainwright fire disaster. The Self Insured Retention and various policies entered into with commercial insurance companies provide NSB insurance coverage according to the needs and capabilities of the NSB; this insurance is consonant with state standards. NSB insurance will cover replacement of the destroyed facilities.

Despite adequate replacement insurance, certain essential emergency and temporary facility construction activities have resulted in uninsured costs. These costs are beyond the fiscal capabilities of the NSB and fall within the intent of the State Disaster Relief Fund.

The North Slope Borough respectfully requests Disaster Relief Assistance in the amounts previously identified.
