4 (i) The director shall design the form of the voter's certificate appearing on

6 information required for registration by AS 15.07.060(a) may be obtained from a voter
7 who votes a questioned ballot. If the voter voting a questioned ballot has completed
8 all information on the voter registration portion of the questioned ballot voter's

You're correct. In CSHB 211(STA), references to "the deadline set in AS 15.20.220(b) for completion of the review of ballots . . . for a primary election" that appear in AS 15.20.207(i)(1) (added by bill section 9) and in AS 15.20.211(d)(1) (added by bill section 10) are inaccurate. AS 15.20.220(b) sets no deadline.

I'd suggest trying to get a committee to adopt an amendment that does the following:

page 3, lines 30 - 31, and page 4, lines 20 - 21:
Delete "the deadline set by AS 15.20.220(b) for"

So that the respective provisions are left to read:

(1) 10 days after completion of the review of the ballots set by
the state review board for a primary election;

The objective, of course, is to require the director to advise questioned ballot voters and partial count voters relatively soon after the wrap-up of the primary so that the voter may act to correct the omission or other cause of rejection of the ballot cast at the primary election in time to avoid recurrence of the same problem at the following general election.
