1 (3) the state's fiscal year 1996 fiscal gap between recurring revenues and
2 expenditures is estimated to be \$316,600,000;

3 (4) petroleum revenue currently accounts for about 80 percent of unrestricted
4 general funds and Alaska's petroleum production is projected to decline by one-third during
5 the next 10 years;

6 (5) the fiscal gap is projected to grow steadily if the state does not effectively
7 address annually recurring revenues and expenditures in the context of a long-range plan;

8 (6) without changes in projected revenues and expenditures, current reserves
9 in the constitutional budget reserve fund (art. IX, sec. 17, Constitution of the State of Alaska)
10 may be depleted by fiscal year 2000;

11 (7) the Long Range Financial Planning Commission and other fiscal policy
12 forums around the state have identified various fiscal tools that can be employed in a long-
13 range plan, including expenditure reductions, revenue increases, and use of reserves;

14 (8) in these fiscal policy forums, the conclusion has been that no single tool
15 is sufficient to address the fiscal gap and that several tools must be used in combination in
16 any viable plan to bring about state economic stability;

17 (9) the Alaska permanent fund is a cornerstone of the state's economic future
18 and should continue to grow as well as to provide reliable dividends to the general public.

19 (b) The legislature intends that a 10-year plan to address the state's fiscal gap will

20 (1) put the state on firm fiscal ground for at least the next 10 years, fiscal
21 years 1997 through 2006, and strike a balance between current public service needs and
22 protection of the permanent fund for future generations;

23 (2) close the fiscal gap between annually recurring revenues and expenditures
24 by the end of fiscal year 2001;

25 (3) use a combination of fiscal tools such as budget cuts, new development
26 revenues, other taxes, and use of reserves;

27 (4) disclose and review all funding sources, not just general funds;

28 (5) deposit \$1,288,000,000 from the permanent fund earnings reserve to the
29 fund's principal;

30 (6) fully inflation-proof the principal of the permanent fund;

31 (7) maintain permanent fund dividends;

- 1 (8) consider future use of permanent fund earnings only with a vote of the
2 people in 1998;
- 3 (9) cut the budget not less than \$180,000,000 during fiscal years 1997 through
4 1999, acknowledging the additional impact of absorbing inflation;
- 5 (10) use the Alaska Department of Labor's population and inflation estimates
6 and Department of Education's school enrollment projections;
- 7 (11) fully fund the equivalent of the current K-12 foundation formula,
8 including increases for enrollment;
- 9 (12) recommend streamlining measures and legislation each year as part of the
10 budget process;
- 11 (13) endorse a six-year capital plan that addresses schools, transportation, water
12 and sewer, prisons, and other basic needs with a stable level of funding from year to year;
- 13 (14) plan for adequate maintenance of facilities and other infrastructure;
- 14 (15) use Department of Revenue mid-case projections for existing revenues
15 such as oil and gas revenues and corporate taxes;
- 16 (16) include new development revenues beginning in fiscal year 1998;
- 17 (17) diversify state revenues to reduce dependence on volatile oil and gas
18 revenues through measures such as increased user fees and increased excise taxes;
- 19 (18) consider dedicating fuel taxes;
- 20 (19) maintain a balance of at least \$1,500,000,000 in the constitutional budget
21 reserve fund (art. IX, sec. 17, Constitution of the State of Alaska) until the fiscal gap is
22 eliminated and then conduct a policy review of the state's reserve level to ensure that an
23 appropriate amount of liquid reserves is available to deal with revenue volatility and
24 emergencies;
- 25 (20) include projections for new oil and gas settlements of \$800,000,000 to be
26 deposited in the constitutional budget reserve fund over the next four years;
- 27 (21) manage the constitutional budget reserve fund with a goal of achieving
28 at least a 6.5 percent return in fiscal year 1997;
- 29 (22) fix the sweep and payback provisions of the constitutional budget reserve
30 fund (art. IX, sec. 17(d), Constitution of the State of Alaska) through constitutional
31 amendment; and

1 (23) develop a cash management and reserves policy to be implemented by
2 statute in 1997.

3 (c) The legislature intends to work with the governor and with all parties to implement
4 this long-range financial plan and meet the needs of Alaskans.

5 (d) The legislature urges all Alaskans to become knowledgeable about the fiscal
6 situation of the State of Alaska and to support actions necessary to close the fiscal gap.

7 (e) The legislature thanks all members of the Long Range Financial Planning
8 Commission for their hard work and efforts to address the state's fiscal future and assist the
9 legislature and governor in addressing the economic challenges we face as a state.

10 * Sec. 2. CONSTITUTIONAL BUDGET RESERVE FUND. (a) Amounts equal to the
11 deposits in the budget reserve fund (art. IX, sec. 17, Constitution of the State of Alaska) for
12 fiscal year 1996, that were made by operation of art. IX, sec. 17(d) to repay appropriations
13 from the budget reserve fund are appropriated from the budget reserve fund to the funds and
14 accounts from which they were transferred.

15 (b) If the unrestricted state revenue available for appropriation in fiscal year 1997 is
16 insufficient to cover the general fund appropriations made for fiscal year 1997, the amount
17 necessary to balance revenue and general fund appropriations is appropriated to the general
18 fund from the budget reserve fund (art. IX, sec. 17, Constitution of the State of Alaska).

19 (c) The appropriations made by (a) and (b) of this section are made under art. IX,
20 sec. 17(c), Constitution of the State of Alaska.

5 * Section 1. LEGISLATIVE FINDINGS AND INTENT. (a) The legislature finds that

6 (1) the members of the Long Range Financial Planning Commission (LRFPC)
7 who were jointly appointed by the governor and the legislature, conducted hearings across the
8 state, raising the awareness of and educating Alaskans about the fiscal gap;

9 (2) the state has spent more than it has collected in annually recurring revenues
10 during six of the past nine fiscal years;

11 (3) the state's fiscal year 1996 fiscal gap between revenues and expenditures
12 is estimated to be \$238,000,000;

13 (4) petroleum revenue currently accounts for about 80 percent of unrestricted
14 general funds and Alaska's petroleum production is projected to decline by one-third during

1 the next 10 years;

2 (5) the fiscal gap is projected to grow steadily if the state does not effectively
3 address annually recurring revenues and expenditures in the context of a long range plan;

4 (6) without changes in projected revenues and expenditures, current reserves
5 in the Constitutional Budget Reserve fund may be depleted by fiscal year 2000;

6 (7) the LRFPC and other fiscal policy forums around the state have identified
7 various fiscal tools that can be employed in a long range plan, including expenditure
8 reductions, revenue increases, use of reserves, and use of permanent fund earnings;

9 (8) in these fiscal policy forums, the conclusion has been that no single tool
10 is sufficient to address the fiscal gap and that several tools must be used in combination in
11 any viable plan to bring about state economic stability;

12 (9) the Alaska permanent fund is a cornerstone of the state's economic future
13 and should continue to grow as well as to provide reliable dividends to the general public.

14 (b) The legislature intends that a ten year plan to address the state's budget gap will

15 (1) put the state on firm fiscal ground for at least the next 10 years (fiscal year
16 1997 through 2006) and strike a balance between current public service needs and protection
17 of the permanent fund for future generations;

18 (2) close the fiscal gap between annually recurring revenues and expenditures
19 by the end of fiscal year 2001;

20 (3) use a combination of fiscal tools such as budget cuts, new development
21 revenues, income tax, other taxes, and use of reserves and permanent fund earnings;

22 (4) disclose and review all funding sources, not just general funds.

23 (5) deposit \$1,288,000,000 from the permanent fund earnings Reserve to the
24 fund's principal;

25 (6) fully inflation-proof the principal of the permanent fund;

26 (7) maintain Permanent Fund dividends;

27 (8) consider future use of permanent fund earnings with a vote of the people

- 9 (15) use Department of Revenue mid-case projections for existing revenues
10 such as oil and gas revenues and, corporate taxes;
- 11 (16) include new development revenues beginning in fiscal year 1998;
- 12 (17) diversify state revenues to reduce dependence on volatile oil and gas
13 revenues through measures such as increased user fees, income tax, and increased excise taxes;
- 14 (18) dedicate fuel taxes;
- 15 (19) maintain a balance of at least \$1,500,000,000 in the Constitutional Budget
16 Reserve until the budget gap is eliminated and then conduct a policy review of the state's
17 reserve level to ensure that an appropriate amount of liquid reserves is available to deal with
18 revenue volatility and emergencies;
- 19 (20) include projections for new oil and gas settlements of \$800,000,000 to be
20 deposited in the reserve over the next four years;
- 21 (21) manage the reserve with a goal of achieving at least a 6.5 percent return
22 in fiscal year 1997;
- 23 (22) fix the reserve's sweep and payback provisions through constitutional
24 amendment; and
- 25 (23) develop a cash management and reserves policy to be implemented by

28 this long range financial plan and meet the needs of Alaskans.

- 31 (e) The legislature thanks all members of the Long Range Financial Planning

In 1991 two appropriations were made for Cambridge Way/Tudor Road Intersection Improvements and Traffic Signal. These two appropriations totaled \$170,000. As of 6/30/95, only \$35,105 of these funds were expended, and the remaining \$134,895 was due to lapse into the General Fund on 7/10/95. Arrangements were made with the Commissioner of Administration to allow a one year extension on both grants in order to work with the Municipality of Anchorage to reappropriate the funds.

Former Municipal Grants Division staff extended one grant which has an available balance of \$1,997. Without advising district legislators, the other grant which had a remaining balance of \$132,898 was permitted to lapse in July, 1995. The Department of Administration's failure to properly communicate with legislative leaders regarding lapse of these funds was grossly negligent, and contradictory to previous arrangements. As a result, the above appropriation totaling \$134,895 represents the remaining balance of \$1,997 from the first grant, which was extended, plus the \$132,898 which lapsed.

As you know, the two budget bills that passed the Senate and House last night do not constitute a balanced budget for FY97 as required by the state constitution. There was no legislation passed to approve the labor contracts negotiated in good faith with public employee bargaining units or to approve adjustments to the salaries of non-covered employees in the executive and legislative branches, university and court system. The tobacco tax increase, which passed the Senate by a vote of 17-3, was not brought up for a vote in the House.

I believe these important budget-related issues could have been successfully completed if time had not run out last night. I am limiting the agenda for this special session so the most essential work will be completed first. If these items are successfully completed in the next two days, we could consider completion of other unfinished business, particularly several bills that were simply awaiting concurrence by the other body.

In an effort to focus the budget work ahead of us, I have prepared identical bills which address all remaining FY96 supplementals, FY97 operating and capital appropriations, reappropriations, fiscal notes, and budget intent language. They also amend the budget bills passed last night (HB412 and SB136) to add effective dates and authorization for use of the Constitutional Budget Reserve.

My administration stands ready to work with you as much as necessary to complete the state's budget in a responsible, timely manner.

Re: **One year restoration of Medicaid Options (SB/HB 1005 Section 9 (c))**

I am writing to explain the willingness of the Trustees to commit \$1,000,000 of Trust income toward restoring several Medicaid options for one year. These options include optometrist service and eyeglasses, care for hearing and language disorders, and dental services for adults.

The Trustees recognize that the rising cost of basic health care has made it difficult for the State to meet these important needs. The only thing certain about the future of health care delivery and financing is that major change is needed and inevitable. The Trustees have allocated these funds to help the State address beneficiary needs that fall through the cracks during this transition period. However, federal changes have been slower than expected and the State continues to struggle with long term strategies to meet these needs.

In the meantime, the beneficiaries suffer from the lack of these basic services. Beneficiaries who can't see, can't hear, can't be understood, can't use what abilities they do have and who can't even get dental attention until they have to go to the emergency room can only become more dependent on the system. This is not only bad for the beneficiaries but bad for the State and the Trust as well as we attempt to stretch limited dollars as far as possible.

The Trustees believe that this one year stop gap measure would be a good investment of both Trust income and reappropriated general fund dollars. It would assist the State by minimizing the commitment of general fund dollars while providing critically needed services to beneficiaries. The Trustees and beneficiaries look forward to working with the State in its health care reform efforts to develop a system that will meet the ongoing need for these basic services.

Finally, the Trustees understand that a special session is a difficult time and offer any assistance to the legislature you may require. On behalf of the beneficiaries, thank you for your consideration of this proposal.

Under the authority of art. III, sec. 18, of the Alaska Constitution, I am transmitting a bill making the statutory changes necessary to provide adjustments for judges, justices, officers, and employees of the judicial, legislative, and executive branches of state government, and the University of Alaska, who are not covered by collective bargaining agreements.

AS 39.27.011, the statute that sets out the salaries of employees not covered by collective bargaining agreements, and to which the salaries of many officers and employees are tied, has not been changed since 1991. The increases provided in this bill are modest, the same negotiated for most union contracts. The bill also makes the statutory changes necessary to provide University and judicial branch officers and employees raises commensurate with the collective bargaining agreements for those agencies.

An appropriation bill that I also am introducing appropriates the money necessary to cover the changes in the salaries of noncovered employees, as well as to fund the monetary terms of collective bargaining agreements negotiated with employees covered by collective bargaining agreements under the Public Employment Relations Act (PERA), AS 23.40. Those collective bargaining agreements were negotiated in good faith. The largest unit of state employees, the general government unit, negotiated a bare bones contract, with no raise in the first year, and modest raises of either 1.5 percent or one-half the consumer price index for successive years. The supervisory unit, unlicensed marine highways vessel employees, and labor, trades, and crafts unit of state employees, returned to the bargaining table in response to the legislature's rejection of the monetary terms of their contracts last year, and negotiated less expensive agreements. Other units followed suit. Overall, the contracts save \$34 million over those negotiated by my predecessor.

The state's agencies and their employees heeded the legislature's fiscal concerns and reacted appropriately. The legislature has not yet acknowledged that the agencies and their employees have done what was asked of them. I ask that the legislature do so now by funding the agreements, and by providing commensurate increases to those not covered by agreements who have not received cost-of-living increases for several years.

At the start of the special session, I introduced a budget bill to complete the work left undone in the operating and capital budget bills passed in the regular session. As I indicated at the time, the bill represented all our issues of concern after the Conference Committee completed its report. I remained willing to work through a compromise package with you to complete a balanced budget for FY97.

As you return to finish the special session, I am transmitting to you a pared down version of my earlier request. This reduced budget package balances the budget and meets your goal of cutting \$70 million from the current year. It does so while fully funding the employee contracts and non-represented employee wage adjustments so we can avert a government shutdown next month.

The budget you passed on May 7 left some critical holes in programs and capital projects for Alaskan families and jobs. I believe this is unwise and, in some cases, unsafe. I continue to believe that a few of the legislature's budget cuts should be restored. Most of these can be funded with reappropriations from completed capital projects or anticipated left-over FY96 funds from formula programs which will cost less than projected a year ago.

Despite characterizations of my proposals as a "budget addition", it is not an increase over FY96. Some legislators have flatly rejected our proposals to use prior year funds to meet critical FY97 needs. However, I would point out that the budget you passed on May 7 already includes the legislature's own proposals for more than \$6.4 million in capital reappropriations and \$3.2 million in anticipated lapsed school foundation funds.

I have been discussing our current budget situation with people around the state over the past two weeks. I find them to be incredulous that we would allow government services to come to a standstill over such a small difference in a \$2.4 billion budget. The public understands that we will have more cuts to make and public service challenges to meet. They want us to complete a balanced budget without further delay and know that it will require compromise on both sides to achieve this.

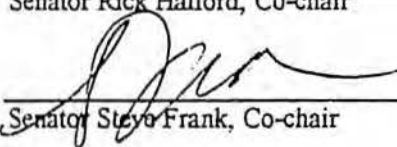
