SR7 creates the Senate VPSO Task Force. The Task Force will consist of three Senators, two public members, and the Commissioner of Public Safety or designee. The Chair of the Task Force will be a Senator. The Task Force will review the Village Public Safety Officer (VPSO) Program and deliver a report to the Senate by February 15, 2008 containing their recommendations and findings. For the purposes of the fiscal note, it is assumed an existing employee of the Chair of the Task Force will staff the Task Force. Travel funding for Senators and public members for 6 meetings of the Task Force is included in this fiscal note. Travel costs for Executive Branch members will be paid for by Executive Branch Departments. A small contractual budget is included in this fiscal note for minimal phone expenses and postage to mail the report to interested parties. The Legislative Affairs Agency will absorb the costs for printing the report and teleconferencing the meetings.

SPONSOR STATEMENT

SR 7

"A Resolution creating and relating to the Senate VPSO Task Force"

SR 7 establishes a task force to find ways to strengthen and improve public safety in rural Alaska by identifying problems with the Village Public Safety Officer (VPSO) program and ways those problems might be addressed.

Many rural areas of the state, including those located on the road system, depend on VPSOs for protection and public safety. However, residents of rural Alaska, the public in general, and the Department responsible for the VPSO program all agree there are problems with the program as it now exists. Recruiting and retention of VPSOs; as well as other problem areas with the program, prevent rural Alaskans from having adequate public protection as they deserve.

It is time to look for ways to better protect the safety of the residents of rural Alaska. The Senate, the Commissioner of Public Safety, and the Attorney General are willing to work together, and include the public, to generate ideas for needed changes to the VPSO program.

This task force will look at the role of the VPSO program and ways in which the program can be improved to better serve rural areas of the state, including areas located on roads.

Members of the task force will meet over the interim in various areas of the state. A report of findings and recommendations will be prepared and delivered to the Senate by February 15, 2008, at which time the task force will terminate.
