

MEMORANDUM

To: House Special Committee on Fisheries

From: Representative John Binkley 

RE: HB 227 "An Act relating to fish processors and primary fish buyers."

HB 227 is introduced to attempt to provide some protection to fishermen and other persons furnishing labor to a primary fish buyer or fish processor. 42 fishermen and 20 employees in Quinhagak are owed an estimated \$21,000 by a fish buyer who had filed for bankruptcy in Oregon. The buyer had other court judgements against him by other fishermen and buyers. The same problem occurred in Elim where about 16 fishermen are owed \$11,000 and the buyer was using someone else's bond. This has been a long standing problem in many areas of the state where transient fish processors or buyers come into an area, acquire fish and for various reasons do not pay the fishermen. The buyer or processor usually leaves the state with the fish.

The bill requires the Department of Fish & Game to provide some notice of a fish processor and primary fish buyer's business standing and compliance to licensing and bonding requirements. It also requires the Enforcement Division to inspect the fish processor and primary fish buyer for proper licensing. The bill applies an across the board \$100,000 surety bond rate. A local appraiser can be used to assess the lienable property. According to the Department of Labor, the bond would apply to all locations. One company with multiple locations would be required to have a bond for each location. A floater/processor would be required to have two bonds - one for buying the fish and one for processing.

Several options were explored for the bond rate and enforcement: sliding fee scale based upon prior year tax information or amounts intended for purchase; separate rate for non-resident floating fish processors; lower rate for those who did not have liens filed against them in the last few years; lower rates for small mom & pop type operations; exclusion of some small catcher processors; different rates for buyers and processors with multiple locations; involving fishermen in the enforcement process; deny operating rights to fish processors and buyers who have outstanding liens against them until the lien is settled.

An across the board rate would have a negative effect on small operators and others who would not qualify for a bond, and there are numerous problems with enforcement, however, it is my intention that such issues be taken up and considered during the teleconference hearing process. And, that the testimony provided on bond rates and enforcement process be used to help in preparing a substitute to the bill.

A hearing was held yesterday, 3/6/85 on a similar bill (SB 164). J.J. O'Connor, Wage & Hour Division, Department of Labor, testified that the increase is acceptable however some fish buyers & processors may not qualify for the bond, and as a result may operate with out a bond. Rick Lauber of the Pacific Seafood Processors Association explained that the association does not have a problem with the amounts presented in the Senate bill but that they have a concern for the smaller operators. He also explained that there would be legitimate differences of opinion on the amounts to be paid when a lien is claimed. The Department would likely rule against the processor or buyer. Bob Blake, President of the United Fishermen's Association and the Cordova Fish Cooperative, said that he would like to see an across the board bond rate of \$100,000. He expressed his concern for smaller operators and that the bill should consider the smaller fish markets that would be impacted around the state. He also suggested a tier arrangement on the bond rate based upon the amount they will buy. Other information presented at that hearing is attached to this transmittal memo.

BACKGROUND/LEGISLATIVE INTENT

Currently, the ADF&G requires an approved "Notice of Intent to Operate" before a fish buyer/processor operates. This approval process cannot be completed until they have submitted their bond to the Dept. of Labor and received a valid business license for the Dept. of Revenue. We currently update this list of approved fish buyers/processors weekly and provide the information to 21 ADF&G offices, located in: Anchorage, Bethel, Chignik Lagoon, Cold Bay, Cordova, Dillingham, Dutch Harbor, Fairbanks, Glenallen, Haines, Homer, Juneau, Ketchikan, King Salmon, Kodiak, Kotzebue, Nome, Petersburg, Sand Point, Sitka and Wrangell. (continued)

ANALYSIS OF BILL/PROGRAM EFFECTS

In Section 1, we are concerned about how the Chamber of Commerce and the Better Business Bureau requirements can be met. We are also concerned about the timing of the publication. There are many commercial season openings and often times buyers/processors are not approved until after the seasons have began. Therefore, this may not meet the intent of the legislation. We have included a fiscal note to cover the cost of publications.

In Sections 2 and 3, the legislation increases the bonding requirement from \$10,000 to \$100,000. This may adversely effect some of the approximately 300 small buyer/processors (under \$100,000 in purchases) in the state.

AMENDMENTS PROPOSED

Remove the requirement that we include information from the Chamber of Commerce and Alaska Better Business Bureau. We would also suggest changing the publication requirement to make it more timely; this may require additional funding.

BACKGROUND/LEGISLATIVE INTENT

The pending legislation would require us to include information regarding membership in the Chamber of Commerce and Better Business Bureau, and to publish the list in the newspaper prior to each season opening. It would also raise the bonding requirement from \$10,000 to \$100,000.

FISCAL INFORMATION

Fishing is a year-round industry in Alaska, depending on the species sought and areas open for fishing. Therefore, lists of approved fish buyers and processors must be published in many newspapers on a year-round basis. Cost to the Department of Fish and Game would be high, e.g., on ad (quarter page) per month in 20 statewide newspapers would cost approximately \$50,000, annually. The cost to mail out these monthly lists to local governments, village councils, and fishermen's associations should not exceed \$500, annually in postage. The Department of Fish and Game staff costs to perform these functions would be additional. Add 3 man months, range 14 time.



MEMORANDUM

To: House Special Committee on Fisheries

From: Representative Johne Binkley 

RE: HB 227 "An Act relating to fish processors and primary fish buyers."

As I mentioned in my memorandum of March 6, 1985, I introduced this bill to attempt to provide some protection to fishermen and persons furnishing labor to a primary fish buyer or fish processor. 42 fishermen and 20 employees in Quinhagak are owed an estimated \$21,000, and about 16 fishermen in Elim are owed \$11,000.

An appropriate bond rate should be applied that would protect these and other people as much as possible. Today I would like to receive testimony about these types of problems and hear suggestions on applicable bond rates, and then, discuss possible committee substitutes to the bill. I would like to offer the following to include in a committee substitute:

Suggested Committee Substitute Changes to HB 227:

Section 1. Require ADF&G to provide to each primary fish buyer and processor, that has met licensing and bonding requirements, a notice (similar to business licenses provided by the Department of Revenue), to be posted at each location. The notice shall specify that the primary fish buyer or fish processor has complied with the security bond requirements of AS 16.10.290 - 16.10.296 and has been issued a valid Alaska Business License or Fisheries Business License by the Department of Revenue.

I would also like to require the ADF&G to post notice of this notice requirement in the spring of each year in a newspaper of general circulation that serves each area of the state, and to offices of local governments and village councils and to fishermen's associations. Another alternative to the above could be to have the ADF&G issue cards similar to the limited entry permits cards that would indicate that the requirements have been met.

Section 2. Replace the first sentence with the following: The amount of the bond shall be \$20,000 for fish processors and primary fish buyers who, for the last three years immediately preceding the date on which the bond is filed, have been licensed under AS 16.10.290 (d) and have not been required to pay a claim under this section. The amount of the bond for other fish processors and primary fish buyers shall be \$100,000. The remainder of Sec.2. shall remain the same.

Section 3. This section would be changed to reflect the changes noted above. The local appraiser requirement would stay the same.

A sliding fee scale based upon prior year tax information or on projected purchases was explored. However, the general concensus was that this type of system would create more problems than it would solve. Having the bond rate fluctuate from year to year could encourage unrealistic projections or be complicated by late payments such as bonuses. A rate based upon speculated amounts of purchases would be complicated by various problems encountered during each fishing season. Buyers and processors could simply be operating at levels much different than that speculated for the bond rate.

Specifying separate rates for non-resident floating fish processors creates constitutional problems. The same applies for excluding those who have outstanding liens filed against them. Involving fishermen in the enforcement process would be better addressed by local communities and fishermen's associations who determine themselves who they wish to do business with. Cather-processors such as some small mom and pop type operations can receive a bond waiver as long as they are not in the business of buying fish. Excluding those buyers and processors who do business with cash would not work. The buyer or processor could simply decide not to operate with cash at anytime during the season, get their fish and disappear without paying the fishermen.

Overall, the general concensus was that the two tier rate as presented above was acceptable. However, this still does not take into consideration those small operations who are starting out and have not yet established credibility in the industry. I am prepared to discuss alternatives to address this.

Dear John:

Thank you for the opportunity to respond to this issue.

First of all, I find fault in the proposal that the surety bond be necessary for each location. For example, last year we leased a facility in Togiak where we purchased and dressed out the fish. The expense necessary to fly product elsewhere for freezing and packaging, encourages me to defend against yet another expense. Does it mean our Bethel operation would have to add a bond to buy at Goodnews or Platinum? What if we buy at both places and fly from both, is that one or two locations?

Any attempt to have the bond amount fluctuate from year to year, might encourage unrealistic projections or be complicated by late paying methods of reward to fishermen, such as "bonuses".

I favor the plan proposed to recognize processors that have demonstrated reliability over the years, and some incentive be present for them to continue business in Alaska. The suggested amount of \$20,000. is acceptable and appreciated.

I would guess that enforcement would be easy in some fisheries and very difficult in others. It would be necessary for their presence most of a season since buyers might move in at any time during the course of a season.

I'm hopeful this letter is timely in reaching you.

SECTIONAL ANALYSIS OF HB 227

"An Act relating to fish processors and primary fish buyers."

Section One: This section requires the Alaska Department of Fish and Game to maintain a list of fish buyers who have obtained the required state permits and bonds. The Department also is directed to publish the list in newspapers serving areas of Alaska in which fish buying takes place, and to distribute copies of the list to local governments and villages and fishermen's groups.

The division of fish and wildlife protection in the Department of Public Safety is required to regularly inspect fish buyers and processors for possession of the required state licenses.

Section Two: This section raises the amount of required surety bonds for fish buyers from the present \$10,000 to \$100,000. The bond is designed to ensure that fishermen are paid for their deliveries to fish buyers and that employees of fish processing operations have the ability to recover wages dues.

Section Three: This section amends another portion of the statutes to raise the surety bonds from \$10,000 to \$100,000, and ensures that leinable property can continue to be substituted for the bond. Language is added to the statutes to clarify that local appraisers may be used to determine the value of leinable property to be substituted for the bonds.

(c) A person applying for a license as a fish processor or primary fish buyer who has less than \$10,000 in lienable property in the state, with proof of the property satisfactorily made to the commissioner, shall file with the application a bond or other security as specified in this section. No bond is required if the fish processor or primary fish buyer has more than \$10,000 in lienable property as specified in this subsection.

(d) Upon certification by the commissioner that a person applying for a license as a fish processor or primary fish buyer has complied with AS 16.10.290 — 16.10.296, the Department of Revenue may issue that person a license to engage in the business of fish processor or primary fish buyer.

(c) If a licensed fish processor or primary fish buyer fails to fulfill the obligations as set out in AS 16.10.290, the license of the processor or buyer shall be suspended for a period of time the commissioner determines is appropriate. After three suspensions the license may be permanently revoked.

(d) Proceedings to suspend or revoke a license are governed by the Administrative Procedure Act (AS 44.62).

(e) If the commissioner determines that a fish processor or primary fish buyer is acting in violation of AS 16.10.270 — 16.10.296, the commissioner shall give written notice prohibiting further action by the person as a fish processor or primary fish buyer. The prohibition continues until the person has submitted evidence acceptable to the commissioner showing that the violation has been corrected.

(f) A person affected by an order issued under this chapter may seek equitable relief preventing the commissioner from enforcing the order.

SUBJECT: House Bill 227

Attached are background materials on House Bill 227 which the Fisheries Committee will hear at 4:30 p.m. Friday, March 29. Public testimony on the measure will be taken via teleconference from a number of locations and at least two state agencies will testify in person.

A similar bill (SB 164) has been heard in Senate Resources committee and a number of changes have been suggested. A committee substitute for the senate bill should be available for your review by Friday's hearing.

I have scheduled a work session on HB 227 for 8:30 a.m. Tuesday, April 2. A measure we considered earlier, HB 120 (Leasing of limited entry permits by minor heirs), also will be considered at the work session.

SECTIONAL ANALYSIS OF CSHB 227

"An Act relating to fish buyers and primary fish processors;
and providing for an effective date."

Section One: This section clarifies existing statutes so it is clear that the surety bond is required before a person or company can be licensed to purchase or process fish. This provision now is contained in 16.10.290 (c) which this legislation would repeal and reenact.

Section Two: This section would automatically raise the amount of the required bond for primary fish processors and fish buyers who fail to pay fishermen or processing workers. The amount of the bond would be raised in those cases where final judgments against a processor or fish buyer have exceeded the amount of the posted bond or other security in the past. If the amount of the final judgments were between \$10,000 and \$50,000, the processor or fish buyer would be required to post a \$50,000 bond. If the amount of judgments exceed \$50,000, the applicant would be required to post a \$100,000 bond.

Section Three: This section re-writes AS 16.10.290(c) to make it conform with the requirements for higher bond amounts this legislation would enact.

Section Four: This section exempts "mom and pop" operators who do not buy fish or hire non-family employees. The existing 16.10.291 provides for a waiver process which has resulted in unnecessary paperwork for such operators and the Department of Labor.

Section Five: This section would ensure the legislation becomes effective in advance of the 1986 salmon season.

LETTER OF INTENT CSHB 227 (Fisheries)

This legislation is designed to help ensure that Alaska fishermen have some recourse when a fish processor or primary fish buyer fails to make promised payments for the delivery of raw fisheries resources. The effectiveness of this surety bond program is questionable unless fishermen are aware of how the program works.

The Fourteenth Alaska Legislature respectfully requests the Alaska Department of Labor to work closely with the Office of Commercial Fisheries Development, Alaska Department of Commerce and Economic Development in the development of an educational program for the surety bond program. These agencies should work through the Alaska Marine Advisory Program, commercial fishermen's organizations, Native groups, fish and game advisory committees and the news media reaching coastal Alaska and the fishing fleets.

SUBJECT: CSHB 227 (Fish Buyers' Bonds)

Attached is a committee substitute for House Bill 227 (An Act relating to surety for collection of wages and payment). As you may recall, we decided last session to hold the original legislation over the interim for additional work.

Under existing law (AS 16.10.290), fish buyers and processors are required to post a \$10,000 bond with the Department of Labor conditioned upon the promise to pay commercial fishermen for raw seafood, and wages owed processing workers. In response to reports that many fishermen in Western Alaska were not being paid by fish buyers, Representative Binkley proposed in HB 227 to raise the amount of the bond to \$100,000.

The legislation was held for additional work when it became clear during committee hearings that the higher bond amount would cause significant problems for smaller seafood processors and fish buyers. The Senate Resources Committee made a similar determination in regard to companion legislation (SB 165).

Scores of fishermen from such widespread locations as Ruby, Haines and Klawock reported difficulties in obtaining payments for deliveries of salmon during the 1985 fishing season.

The proposed committee substitute was worked out in conjunction with staff to the Senate Resources Committee. It would raise the amount of the required bond only for those fish buyers and seafood processors who have final judgments levied against their bonds or other security deposits. The amount of the bond would be raised to \$50,000 or \$100,000 according to the amount of judgments.

The draft substitute is designed to ensure that operators who fail to pay their fishermen are required to post additional security for future purchases, while those who have a clean record are not. The proposed committee substitute would avoid undue impacts on smaller buyers.

Existing statutes provide for a waiver of the bond requirements for processors who do not purchase fish from others or hire non-family members. Section three of the committee substitute would change the waiver to an exemption so these "mom and pop" operations no longer have to apply to the Department of Labor for the waiver. If the measure is signed into law, such operators would only have to sign a form saying they qualify for the exemption when they obtain their tax security bonds from the Department of Revenue. The Department of Labor expects to receive about 300 such waiver applications this year.

The proposed substitute also provides for an immediate effective date to allow implementation for the 1986 fishing season.
