10 \* Section 1. The sum of \$10,000,000 is appropriated from the general  
11 fund to the Alaska Permanent Fund.

12 \* Sec. 2. This is not a one-year appropriation, and AS 37.25.010 does  
13 not apply.

14 \* Sec. 3. This Act takes effect July 1, 1978.

Under the authority of art. The purpose of this appropriation is to increase the permanent fund by approximately the amount of surplus expected to result from FY 79 revenues and expenditures.
