Short analysis of HB 792

Section 1(a) would prohibit the publication of more than a minimum number of copies of a report to the legislature or the governor, and would prohibit use of color in a report to the legislature or governor. What is meant by "a minimum number" is not specified, and could technically be as low as three, one for the Senate president, one for the Speaker of the House, and one for the governor. More appropriately, the minimum number would fall somewhere between 62 and 100, allowing for file copies. The main idea behind the term "minimum number" is to keep the volume low.

Section 1(b) requires the personal approval of the head of the agency or department as well as that of the governor before state money may be spent on color in a publication that is not a report to the legislature or governor. Because all funds disbursed from the state treasury must be allocated to specific executive departments, even though the publication may be purchased by a quasi-governmental agency or a designated grant recipient, the head of the department can, and must, have final approval authority over the use of color.

Section 1(c) requires that publications using color must be identified and recommended by the Governor in his budget request. Currently, costs of publishing reports are buried within contracts, subcontracts and other budgetary wizardry. One of the basic problems in researching these costs was that nobody within the departments could figure out where to find the figures.

The main thought here is that if everybody concerned is made more aware of the actual costs of publications, those costs can be evaluated in real terms of need or appropriateness.

The recommendation of the governor under AS 37.07.060(a) shall identify the amount of the budget of a state department or agency necessary for the publication containing the use of color.

Status report on the percent for art program

The percent for art program, made possible by legislation passed in 1975 and amended in 1976 and 1980, has enabled 61 artists to execute works for public spaces in Alaska.

Some program statistics are:

- \$ 840,050 total dollars spent for works of art
- 67 separate commissions awarded
- 61 artists directly involved (including collaborations)

HB 836: An act repealing the state program that provides for funding of art in public places.

According to Jon Scribner, the assistant Deputy Commissioner of Design and Construction in the Department of Transportation and Public Facilities, the average amount allocated for art in public facilities in the future will probably be about \$500,000/year.

Previous to 1980 those public buildings which were built in remote areas or simply did not receive substantial public use, such as a remote fish hatchery, did not qualify under AS 35.27. In 1980, however the art in public places fund was established, so now, even though a building may not receive substantial public use 1% (or in the case of a rural school 1/2 of one %) of the construction cost of every building constructed by the state (except for transportation facilities such as harbors, docks, etc.) will go into this fund for providing art for other buildings.

If we are going to allocate 1% of the construction costs of every state building for art purposes, why not another 1% for hunting? fishing? or health care?

The Alaska State Council on the Arts has the responsibility for encouraging the growth of the role of the arts as an integral part of the lives of Alaskans by assisting in the development of Alaska's artists, and providing education and creative experiences for observers and participants.

Alaska State Council on the Arts

Government support of the arts has historic and long-range implications for all Americans, and is an area of national debate and concern at this time. Since the establishment of the National Endowment for the Arts in 1965, governmental support has been the key which has unlocked tremendous new sources of private and corporate monies. Alaska's governmental support has performed a similar and dramatic function in allowing a variety of artistic organizations to begin to produce a rich Alaskan cultural climate. Whereas before it was often necessary for the State Council to provide direct programs and presentations, the emergence of community-based arts organizations with strong management capabilities permits lasting results to accrue to the use of both private and governmental funds. It is in providing equitable financial support to such organizations, and serving as the agency responsible for the final oversight of their fiscal practices and their artistic integrity, that the Council expends the bulk of its resources. It is a fact that the amazing success of such organizations has led to the increased demand for their services which in turn causes their requests for funding through ASCA to continue to outstrip our ability to provide all that is requested in such support.

Operating under instructions from the Governor, the practice of individual organizations directly seeking line-item funding from the legislature has been replaced by an orderly organization of cooperating non-profit entities, whose efforts have provided clear information about actual needs and have helped to allow ASCA to project an orderly growth pattern. ASCA has developed a variety of citizen panels in all artistic media, to advise in matters related to their area of specialization. This orderly assembly of constituents allows the Council to expend more time in providing technical assistance to less well organized efforts, and thereby increase the efficiency of the system which transmits the state's arts money to its citizens.

The benefits of a strong and healthy cultural community reach into our lives at every level we can imagine: on a mundane but essential level, the arts provide jobs, increase tourism, enhance basic education; on a more esoteric level, the arts give us the opportunity to fine-tune our senses and go beyond the surface of daily events.

The Council's work since its inception has brought us to a point where the accomplishments have become, to a degree capable of self-perpetuation. (This is a matter of great pride to us; we believe it is evidence that we have so far carried out the legislative mandate creating the Council with success in achieving the desired goals enunciated in the mandate.) Now the council must be responsive to a new generation of needs; we must provide mechanisms whereby those monies provided by the state to produce the arts of Alaskan citizens are equitably shared and accounted for with unswerving and scrupulous honesty; we must continue our efforts to preserve, protect and present our rich Native heritage; and we must continue to listen to the expressed artistic needs of all of our citizens, so that we might carry their thoughts back to the legislative process.

1.0 PURPOSE

1.1 To promulgate standard departmental procedures for the selection of Artists and Artwork for public buildings and facilities.

2.0 POLICY

2.1 To select Artists and Artwork for public buildings and facilities in an objective manner resulting in the acquisition of Artwork consistent with A.S. 35.27, and 44.27.

3.0 DISTRIBUTION

3.1 All holders of the Policy and Procedures Manual and the Alaska State Council on the Arts (ASCA).

4.0 DEFINITIONS

4.1 Artwork - All original forms of visual art objects created by an Artist which may include paintings, drawings, ceramics, fiberwork, sculpture, graphics (not signage), murals, photographs, metalwork, mixed media work, limited edition original prints (not reproductions) and Native crafts objects.

4.2 Artist - A practitioner in the visual arts, generally recognized by critics and peers. A project Architect or a member of the Architect's firm will not be considered an eligible artist.

4.3 Agreement - A legal document that prescribes legal, regulatory and administrative provisions affecting the rights and obligations of the parties and the work or services (eg Artwork) to be provided.

4.4 Architect - The project designer engaged by DOT/PF.

4.5 Project Manager - DOT/PF representative and Artist's primary point of contact with DOT/PF.

4.6 Client Agency - The Department, Division, School District, Municipality, etc., that generated the project for which funds are designated for Artwork.

4.7 Construction Cost - The cost of building or facility construction approved by the State legislature, exclusive of the cost of land acquisition, site investigation, design services, administration, equipment and any other costs not specifically incurred within the construction contract. Participatory construction funding by a Federal Agency or by the Division of Risk Management is not included in such cost as used within this procedure.

4.8 Public Buildings and Facilities - Schools, office buildings, court buildings and other facilities designed for substantial public use and vessels of the State ferry system.

5.1 Page 6 contains a summary diagram of this procedure. Each activity is identified by two numbers (eg 19-20) which are referenced in the procedural discussion herein.

6.0 PROCEDURE


6.1 (Activity 1-2) Following each legislative session, DOT/PF (Planning and Programming) provides ASCA with an informal summary of capital projects which identifies proposed buildings and facilities for which Artwork may be required.

6.2 (Activity 2-3) DOT/PF (Design and Construction Regions) assigns a Project Manager for each building and facility, who will concurrently initiate this procedure for procurement of Artwork and the selection procedure (P&P 28-8000) for architectural services.

6.3 (Activity 3-4) Project Manager and the designated Client's representative for the project decide if a percentage (amount) for public Artwork is required in accordance with AS5.17.020 and 44.27.060. The amount for public Artwork shall be at least one percent of the construction cost.

- A. If a project consists of new construction or remodel/renovation of existing building or facility, the amount for public Artwork is required. However, remodel/renovation does not include maintenance, repair, code upgrade, heating renovation, etc.
- B. If the estimated construction cost is \$250,000 or less or if the building or facility is not for substantial public use, the amount for public Artwork shall be deposited in the Art in Public Places Fund after final acceptance of the facility (paragraph 6.14).
- C. If the estimated construction cost is greater than \$250,000, the amount for public Artwork shall be expended only for the actual costs of design (which may include engineering for the Artwork itself, exclusive of the architectural engineering design of the facility or site where the Artwork will be displayed), production and mounting of Artwork and direct administrative costs of Artists. Administrative costs of DOT/PF, ASCA and the Architect related to Artwork, costs related to a dedication or "unveiling" of Artwork, and the Client Agency's maintenance and recurring operational utility costs shall not be charged to the amount for public Artwork.

6.11 (Activity 17-18) Project Manager shall withhold Notice to Proceed to the Architect or the Artist(s) for Artwork production until a construction contract for the building or facility is awarded and shall attempt to insure that Artwork design is completed and approved by the Committee prior to bidding for the construction contract.

6.12 (Activity 18-19) Following receipt of Notice to Proceed, Artist(s) will produce, deliver and install Artwork in accordance with Agreement(s). The Architect or Project Manager shall coordinate delivery/installation with construction progress of the building or facility.

6.13 (Activity 19-20) Committee or its designated representative shall view the completed Artwork(s) installed within the building or facility and provide written approval and acceptance to the Project Manager. The Artist(s) may then receive final payment contingent upon receipt by the Project Manager of the documentation required for the public Artwork program in accordance with the Artwork Agreement(s). Client Agency owns Artwork after installation and final acceptance of the building or facility.

6.14 (Activity 20-21) Upon final acceptance of the building or facility, the unused amount for public Artwork shall be placed in the Art in Public Places Fund (amount not to exceed one percent of the sum of the original construction contract plus construction contingency, unless construction change orders changed the original program of the major activities for which the building or facility was constructed in which case the amount shall equal one percent of the construction contract plus the applicable change orders.)

7.0 IMPLEMENTATION

7.1 Regional Directors are responsible for coordinating with ASCA and establishing any supplementary procedures necessary to augment this Department procedure as applicable to each region's functions.

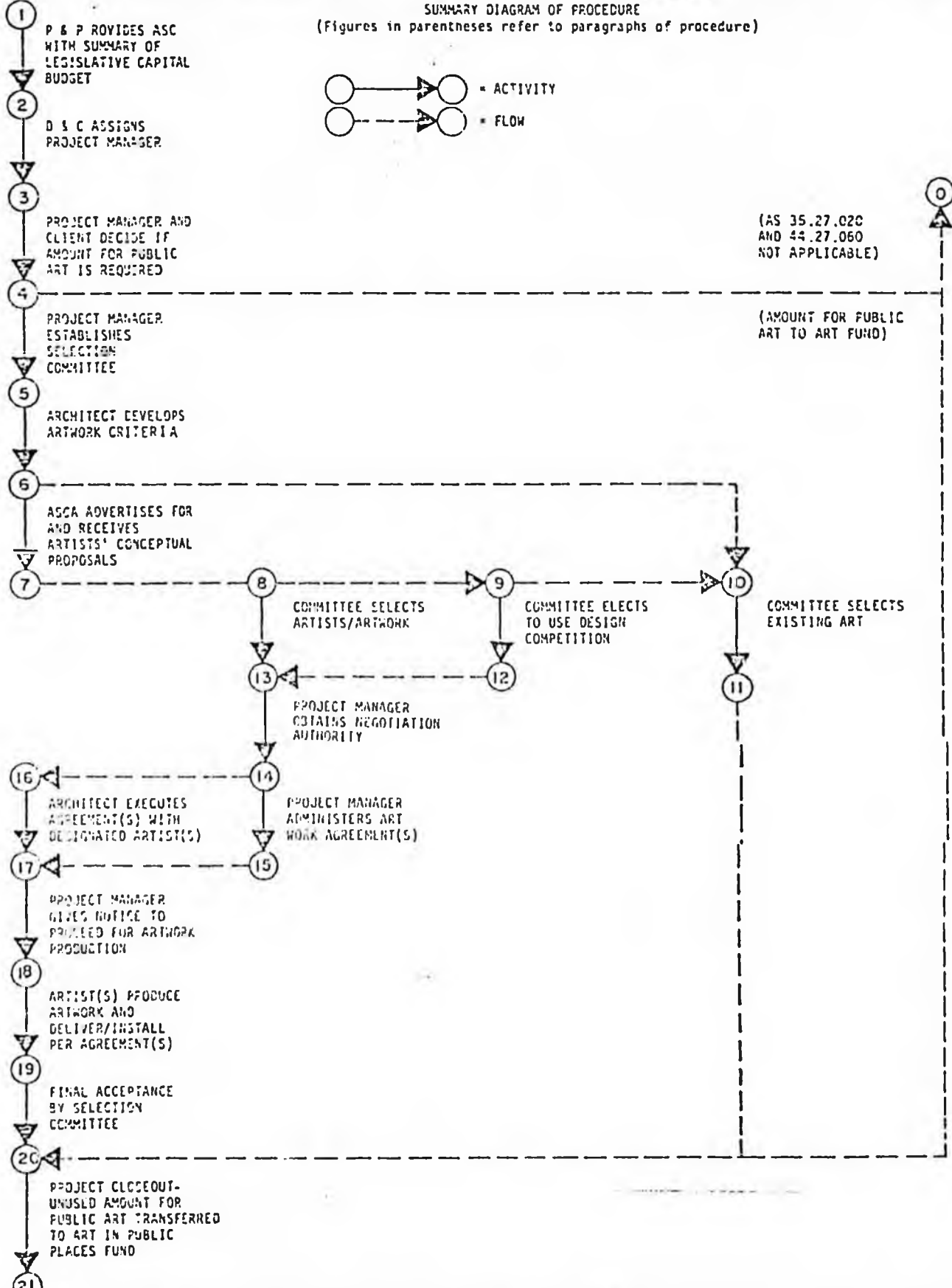




The Juneau Arts Council is concerned over House Bill #836 currently before the House State Affairs Committee that would repeal the Art-In-Public-Places Program.

- university campus structure in Anchorage, Fairbanks and Juneau
- ferry terminals in several Southeast communities
- Tok Visitor's Center
- Harborview Developmental Center, Valdez

HB 836: An act repealing the state program that provides for funding of art in public places.

According to Jon Scribner, the assistant Deputy Commissioner of Design and Construction in the Department of Transportation and Public Facilities, the average amount allocated for art in public facilities in the future will probably be about \$500,000/year.

Previous to 1980 those public buildings which were built in remote areas or simply did not receive substantial public use, such as a remote fish hatchery, did not qualify under AS 35.27. In 1980, however the art in public places fund was established, so now, even though a building may not receive substantial public use 1% (or in the case of a rural school 1/2 of one %) of the construction cost of every building constructed by the state (except for transportation facilities such as harbors, docks, etc.) will go into this fund for providing art for other buildings.

If we are going to allocate 1% of the construction costs of every state building for art purposes, why not another 1% for hunting? fishing? or health care?

Status report on the percent for art program

The percent for art program, made possible by legislation passed in 1975 and amended in 1976 and 1980, has enabled 61 artists to execute works for public spaces in Alaska.

Some program statistics are:

- \$ 840,050 total dollars spent for works of art
- 67 separate commissions awarded
- 61 artists directly involved (including collaborations)
- 16 commissions awarded to artists not residing in the state (including Alaska Natives, Alaskan by birth and former residents)
- 35 separate facilities
- 25 school districts have requested and received some form of technical assistance from Council staff and the DOE-funded handbook on percent for art compliance at rural schools

Works commissioned through the program can be categorized by media:

- sculpture (16)
- painting (12)
- carved relief (stone or wood) (6)
- enamel on steel panels (3)
- fiber (17)
- ceramic tile or relief (4)
- Native Alaskan masks/crafts (individual direct purchases)

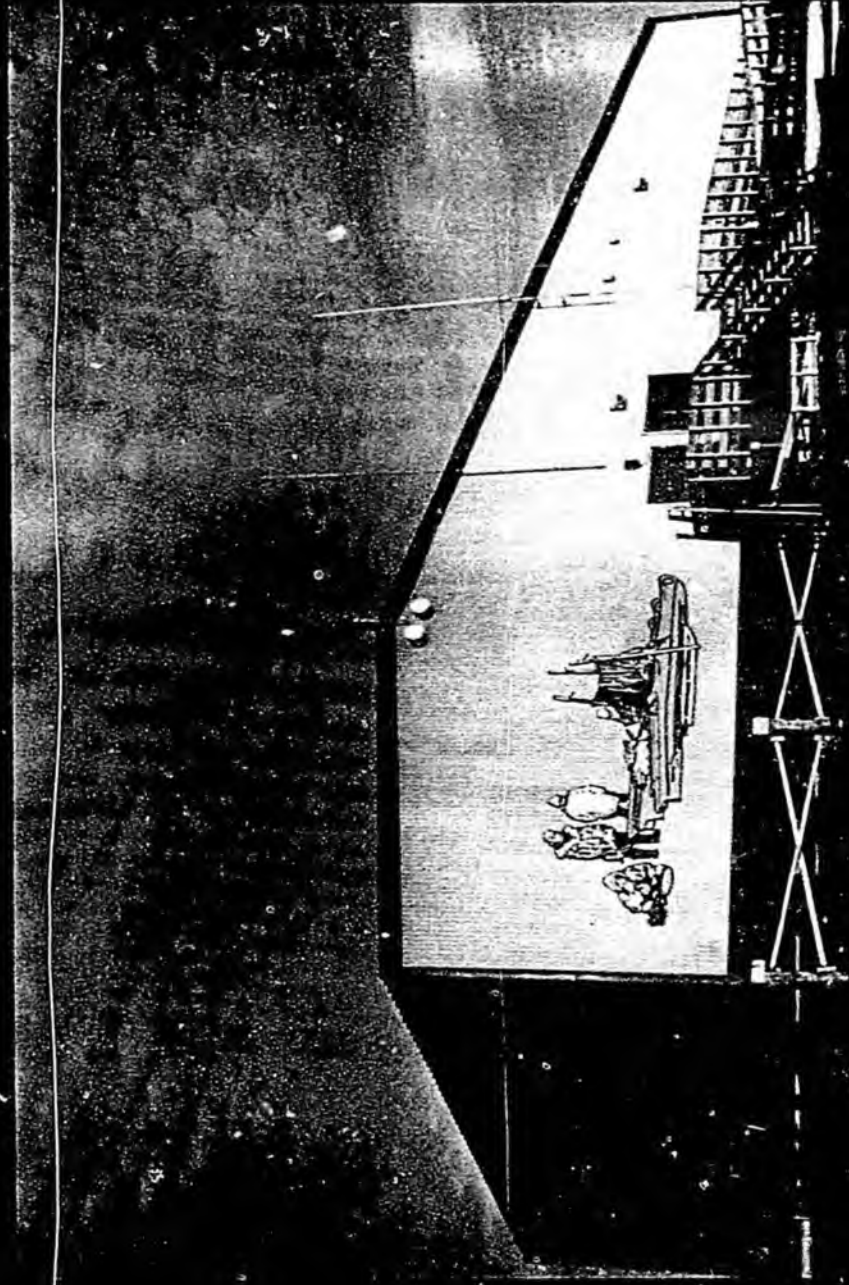




The Juneau Arts Council is concerned over House Bill #836 currently before the House State Affairs Committee that would repeal the Art-In-Public-Places Program.

The percent for art program, authorized by legislation passed in 1975 and amended in 1976 and 1980, has enabled over 63 artists to execute works for public spaces throughout Alaska.

Some program statistics are:

- 63 artists directly involved
- 18 commissions awarded to artists not living in the state of Alaska. This figure includes former residents of the state, Alaskans by birth and Native Alaskans who are living elsewhere
- 36 separate facilities have been served through the program
- 30 rural schools have received direct assistance from Arts Council staff

Works commissioned through the program can be broken down by media:

- sculpture (16)

- carved stone or wood relief (6)

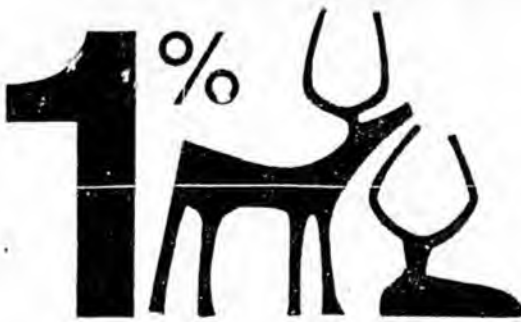

## PERCENT FOR ART PROJECT ANNOUNCEMENT

---

In accordance with Alaska Statute 35.27.010-030 as amended, the Yukon Koyukuk School District announces an open competition for a work of art to be installed on the gym walls of the Nulato School. The work, which should relate in some way to the Athapaskan Indian life on the Yukon River, may be paint on panels or canvas or some kind of carved relief. The gym wall which is the location for the work is approximately 98' 6" in length. The wall itself is divided into an upper area of white plaster board (the location of the artwork) which extends 9' 3" down from the ceiling. Below that is a brown wood paneled section extending 7' 2" up from the floor. The photographs in this prospectus show the wall area. The basketball hoops and electric scoreboard will be relocated to another wall.

**ART SELECTION COMMITTEE:**

The artwork for the school will be selected by a local committee from Nulato.

**PROJECT BUDGET:**

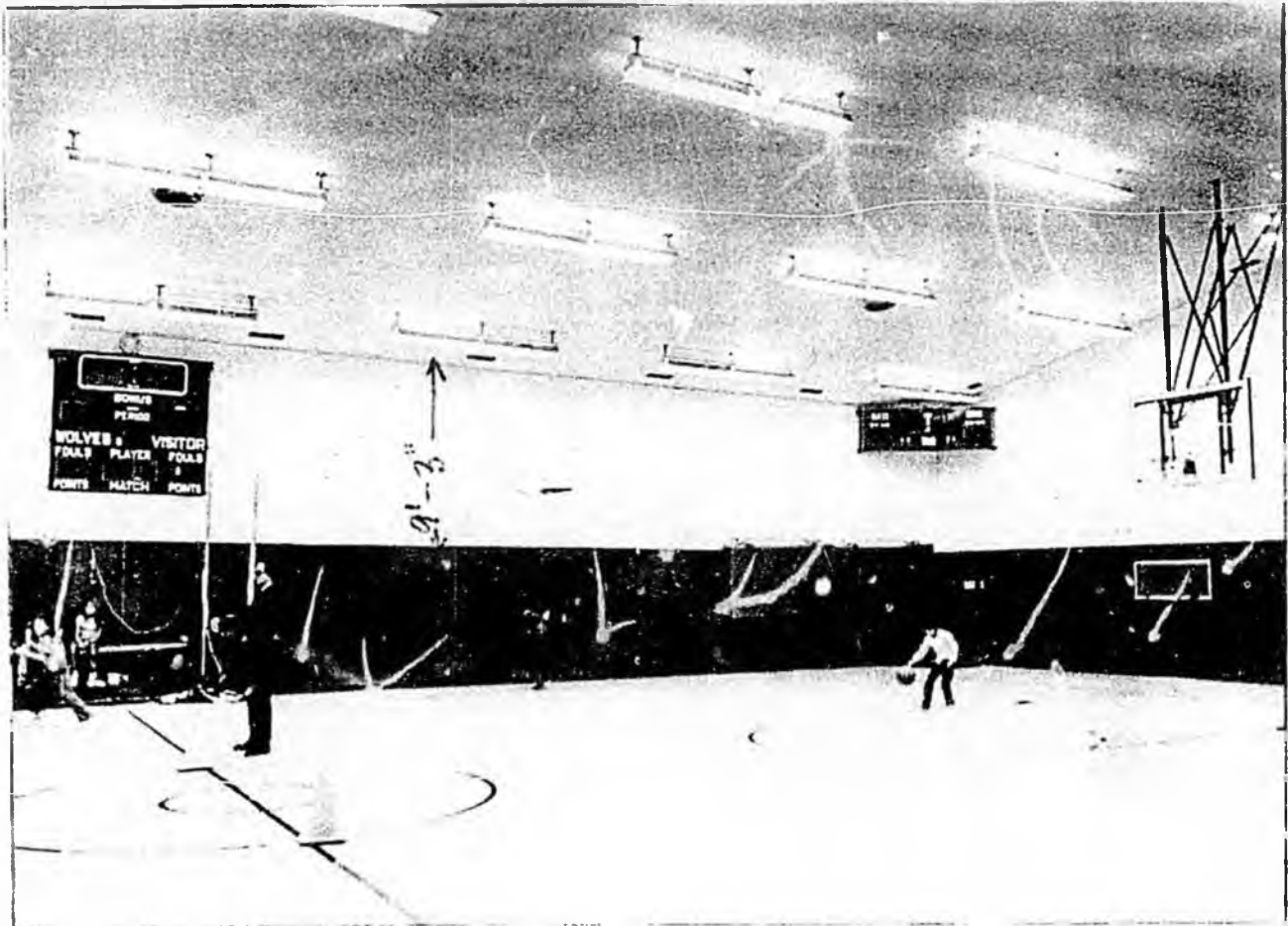

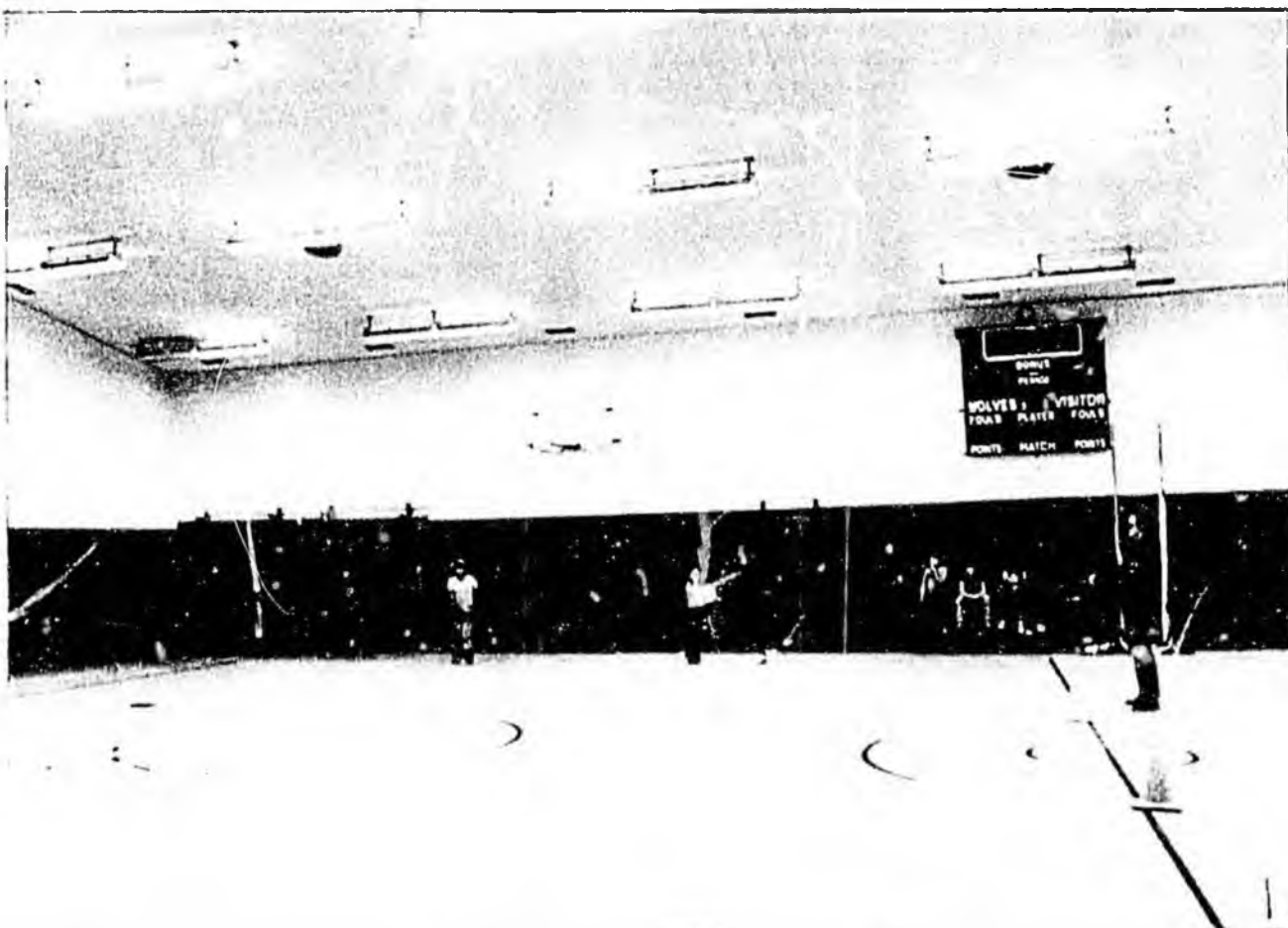
