2787 SRES APPOINTMENT CONFIRMATIONS

6 -- ". . . ASSIST THE SALMON INDUSTRY IN RECOVERING . . .?"

- A - Set an example by eating canned salmon, from the can, on the floor of the Legislature;
- B - Enhance quality control efforts, including appropriate staffing levels, to insure and VERIFY quality through the entire cycle of harvest, processing, shipping, and marketing;
- C - Authorize (and provide appropriate funding) for the ASFMI to VICOROUSLY engage in the process of improving markets for the product (starting at home -- it will be a great day when our kids eat Alaska Salmon in the school's lunch program!);
- D - Expand the present loan programs to fishermen, as well as processors, in order to assist the industry through what will be some unavoidably lean years;
- E - Provide "price supports" to fishermen, not processors. It is clearly inappropriate to reward processors for their own failures; rather, the support should be provided to the harvesters, permitting the processors and marketers to suffer the consequences of their own deficiencies.
- F - In consultation with both the fishermen and the processors, attempt to devise a price arbitration system which would go into affect long before the run begins so that both could plan effectively. Also, support a "closed shop" fishery, insuring that scabs don't reap the benefits of stalled negotiations.
- G - If all of the above sounds too harsh on processors and non-union fishermen, I would only say that NO ONE has a more important vested interest in the long-range health of the commercial fishery in Alaska than the fisherman him/her-self. Therefore, it is those individuals, collectively, whose interests I feel the greatest obligation to support and protect.

# Fishery dispute may renew board confirmation fight

Juneau — A confirmation fight appears to be shaping up again for members of the Alaska Board of Fisheries with legislators responding to a variety of user groups by casting barbs at the seven-member panel.

Sen. Don Bennett, R-Fairbanks and co-chairman of the powerful Senate Finance Committee, said Thursday that he found the board's decision about limiting dipnetting along the Copper River Basin "totally unacceptable."

Bennett was referring to the panel's unanimous decision to redefine requirements for subsistence fishermen, creating a new class in that area for personal use dipnetters.

That revision would have the effect of limiting their salmon take, a move extremely unpopular among many of Bennett's Fairbanks area constituents who hold dipnet permits and who previously had qualified as subsistence users.

Among other things, the new rules would require that subsistence users be limited to those living in the Copper River Basin or the communities of Tok, Tetlin, Northway, Dot Lake or Tanacross. All others wanting to do any dipnetting would qualify as personal use fishermen.

Personal use dipnetters would be limited to 10 salmon per season, down from the previous 15 for individuals, and a household of two would be restricted to 25 salmon per household from the previous 30.

Ron Jolin, chairman of the Fish Board, said Thursday from Anchorage that the panel didn't have much choice in the matter since it was following an attorney general's opinion about subsistence fishing.

"We took the recommendations of three advisory committees," Jolin said. "From the data we received, I don't think we're really impacting too many people. They were only catching about 10 fish per year as subsistence fishermen.

"What people are overlooking is that we also took 60,000 fish out of commercial fishing which had been allowed in escapement numbers," he said. "That should have some favorable up-river implications.

"We're looking at preserving the resource," Jolin said. "That's the first priority. And the second is seeing that all groups get a good shot at it. And I think we did it."

"Evidently, they've seen fit with the new composition on the board to wipe it out," Bennett said

about the panel, a reference to the fact that six of its seven members are commercial fishermen with none from the Interior. "It's appalling and a slap at the face of resident Alaskans . . . when they're relegated out of their fair share of an Alaska resource so it can be sent to Seattle and canned and sold at 10 times the price.

"Dipnetting is a wholesome activity, something that puts fresh fish on people's tables," Bennett said. "Any board that doesn't allow this is shortsighted and may be short in tenure."

Shortly after making his speech on the Senate floor, Bennett told a reporter that the dipnetting decision was part of a "turf fight" between personal use and commercial fishermen.

"Cordova fishermen want all the salmon," he said. "But there's potentially over 100,000 people (upriver) who like to go down and catch fish on the weekend."

Sen. Dick Eliason, R-Sitka and a commercial fisherman whose Senate district extends to Cordova, said it's "difficult to defend the board's decision to cut back on the resource because we had a record number caught last year.

"I do think the board's going to have to be sensitive to the needs of subsistence and sports fishermen," Eliason said. "We had this last year and you know the results of that. A lot of good people were dumped off the board . . . and I think we're in for more of the same this year."

None of the members appointed by Sheffield was confirmed last year, forcing him to appoint a new panel whose confirmation is now pending before the legislature.

Rep. Ramona Barnes, D-Anchorage and House Majority Leader, said Thursday "there's a good likelihood the appointments will fail.

"The governor made a promise to the sports fishermen of the state about appointing a sports fisherman to the board and didn't keep his promise.

"I will vote against confirmation," Barnes said.

Gov. Bill Sheffield was out of town Friday and couldn't be reached for comment. But press spokesman John Greely said Sheffield changed his mind about appointing another sports fisherman to the board "after looking at the fisheries issues and looking at the board of fisheries.

"It has been obvious to the governor that the need for having a diversity of knowledge outweighed regional or political considerations.

"The governor can only hope that the legislature looks at each appointment individually, with their different backgrounds and opinions," Greely said.




I once again extend my sincere congratulations on your victory. There is no doubt in my mind that you will be one of the "Great" Governors of our State.

Purpose.** It is the purpose of AS 39.05.070 — 39.05.110 to provide procedural uniformity in the exercise of appointive powers conferred by the legislature to eliminate, insofar as possible, recess or interim appointments except in the event of death, resignation, inability to act or other removal from office and the exercise, insofar as possible, of appointive powers only when the legislature is in session. (§ 1 ch 64 SLA 1955)

Section repugnant to tacit confirmation. — The expressed intention of this section is repugnant to tacit

confirmation of appointments. Munson v. Territory of Alaska, 16 Alaska 580 (1956).

**Sec. 39.05.080. Procedure for all appointments.** Appointments shall be made in the following manner:

(1) The appointing authority shall, within 30 days of the convening of the legislature in regular session, present to the legislature for confirmation the names of the following persons: (A) persons appointed to a position or membership who have not previously been confirmed by the legislature or either house of it; (B) persons appointed by him subject to confirmation to fill an existing position or membership vacancy; (C) persons to be appointed subject to confirmation to fill a position or membership the term of which shall expire before July 2, following the session of the legislature. If an appointment is made after that deadline but while the legislature is in session, the appointing

authority shall, within five calendar days after the appointment is made, present to the legislature for confirmation the name of the person appointed. The deadline may be extended by the legislature by the approval of a concurrent resolution.

(2) When appointments are presented to the legislature for confirmation,

(A) the presiding officer of each house shall assign the name of each appointee to a standing committee of that house for a hearing, report and recommendation; standing committees of the two houses assigned the same person's name for consideration may meet jointly to consider the qualifications of the person appointed and may issue either a separate or a joint report and recommendation concerning that person; then

(B) the legislature shall, before the end of the session in which the appointments are presented, in joint session assembled, act on the appointments by confirming or declining to confirm by a majority vote of all of the members the appointments presented.

(3) When the legislature declines to confirm an appointment, the legislature shall notify the appointing authority of its action and a vacancy in the position or membership exists which the appointing authority shall fill by making a new appointment. The new appointment shall be presented for confirmation to the legislature within 20 calendar days following receipt by the appointing authority of the legislature's notification of its refusal to confirm the prior appointment. If the name of a person is submitted and is not confirmed, the appointing authority may not, upon resubmission of appointments, submit again the name of the person whose confirmation was refused for the same position or membership during the session of the legislature at which confirmation was refused. The person whose name is refused for appointment by the legislature may not thereafter be appointed to the position or membership during the interim between legislative sessions. Failure of the legislature to act to confirm or decline to confirm an appointment during the session in which the appointment was presented is tantamount to a declination of confirmation on the day the session adjourns.

(4) Pending confirmation or rejection of appointment by the legislature, persons appointed shall exercise the functions, and have the powers and be charged with the duties prescribed by law for the appointive positions or membership. (§ 4 ch 64 SLA 1955; am §§ 1-3 ch 1 SLA 1964; am § 1 ch 2 SLA 1967; am § 1 ch 65 SLA 1974; am § 2 ch 82 SLA 1975)

The reason for dual consideration of prospective officeholders is the benefit of the considered opinion of the legislators, to avoid the possibility of incompetency and injury to the public which may otherwise be perpetrated *Munson v. Territory of Alaska*, 16 Alaska 580 (1956).

**Affirmative rejection not required.** — Paragraph (2) of this section does not demand affirmative rejection. *Munson v. Territory of Alaska*, 16 Alaska 580 (1956).

**Failure of legislature to act on an appointment is, in effect, rejection.** *Munson v. Territory of Alaska*, 16 Alaska 580 (1956).

**And not tacit confirmation.** — In acting upon an appointment, the legislature is not exercising a prerogative granted it in its own interest or that of its

members; there can be no waiver of that duty so that inaction would be the equivalent of a tacit approval of an appointment. *Munson v. Territory of Alaska*, 16 Alaska 580 (1956).

**Tacit confirmation negated by paragraph (3).** — The language of paragraph (3) of this section tends to negate any argument of tacit confirmation. *Munson v. Territory of Alaska*, 16 Alaska 580 (1956).

**The question of confirmation is determined at the first vote under paragraph (2) of this section.** *Munson v. Territory of Alaska*, 16 Alaska 580 (1956).

**The purpose of paragraph (4) of this section is to vest authority in necessary interim appointees.** *Munson v. Territory of Alaska*, 16 Alaska 580 (1956).

**Sec. 39.05.090. Time limits in AS 39.05.080.** The time limitations concerning the submission and resubmission of names as prescribed in AS 39.05.080 do not apply to those appointments which by law require recommendations by professional groups. (§ 3 ch 64 SLA 1955)

**Sec. 39.05.100. Qualifications for appointment.** (a) A person appointed to a board or commission of the state government, shall be and have been before the last general election, (1) a registered voter in the state, if the appointment is made at large or (2) a registered voter from the judicial district, if the appointment is made from a specific judicial district.

(b) A member of a board or commission of the state government who ceases to reside in the state during his term terminates his membership upon the board or commission. For the purposes of this section, the acceptance of employment outside the state for a six-month period or longer, or physical absence from the state for one year or longer, or registration as a voter in a municipal, county, district, state, or national election in a voting precinct outside the state is considered as discontinuing residence in the state. (§ 5 ch 64 SLA 1955; am § 1 ch 167 SLA 1957)
