I am taking this opportunity to respond to a letter addressed to Representative Boucher from Charlie Bussell concerning opposition to the confirmation of Walter R. Gardner's appointment to the Board of Electrical Examiners.

Mr. Gardner has held an electrical administrator's license (#AA240) in this state since 1972. He is one of 46 out of approximately 520 persons licensed in Alaska who is qualified in all categories of electrical administration. These categories include: inside wiring, outside wiring, residential wiring, outside communications, and inside communications.

You can see from his resume that Mr. Gardner has over thirty years experience in the field of large construction with over twenty years experience in the Alaska construction industry, including engineering and management, electrical power and communications, and as field surveillance officer for the Trans-Alaska pipeline. His qualifications include expertise in arctic and subarctic construction.

Mr. Bussell's reference to an applicant he felt was unjustly reviewed by the board should be directed to Nancy Dunn, Director of the Division of Occupational Licensing, for investigation.


In closing, I must respond to the last paragraph of Mr. Bussell's letter with regard to appointments of women and minorities to boards and commissions during this administration. Mr. Bussell states that Natives and women have been "sorely overlooked by the present administration."

Statistics compiled in February 1986 reveal that 22 percent of the appointments made by Governor Sheffield since he took office have been of minorities. This thrust by the Governor underscores his continuing concern to have minority representation on official state boards. These same statistics indicate that 41 percent of the Governor's appointees have been women.

The fact that women and minorities have enjoyed an increased opportunity to serve on boards and commissions during this administration is now, and will continue to be, a direct reflection of Governor Sheffield's priorities.

Dear Representative Boucher:

Thank you, for asking me to comment on the acceptability of Mr. Gardner and Mr. Boyd for positions on the Board of Electrical Examiners.

I have, as I mentioned to you via tel-con earlier this week, made a number of calls to many people, throughout our industry, regarding these two men. Generally, I believe it fair to say, almost 100% of those I spoke with had little or no problem with Mr. Boyd's being appointed. I believe it also fair to say almost 100% of those who knew Mr. Gardner, expressed concern and opposition to his being considered for such a position.

As for my personal thoughts on the subject, I concur with the previous comments. Although I do not know Mr. Boyd, I know several people who spoke highly of him, and no one spoke negatively about him or his work in the industry.

I do however, know Mr. Gardner and have known him for many years. Throughout those years I have never known Mr. Gardner to have personally performed any electrical work in any of the numerous sections of our industry. I note in his resume, he mentions having done nothing but engineering, estimating, inspection or supervision throughout those years, or for that matter since he has arrived in Alaska.

I spoke by tel-con to the Mt. Wheeler Power Company in Ely Nevada, where Mr. Gardner says he worked as an apprentice line/journeyman lineman, and found no one who could remember him, or any such program in Ely Nevada. This of course is not to suggest Mr. Gardner did not work for Ely Light & Power (now Mt. Wheeler Company), but such a work period, as indicated, would hardly have qualified him to be more than a "grunt" in those days.

I found no listing for, and was unable to locate a company called "Shock Electric," in Las Vegas, Nevada, where Mr. Gardner indicates he completed apprenticeship program, advanced to journeyman wireman, advanced to foreman, advanced to project superintendent, and had 80 men under direct supervision.

A normal apprenticeship program is four to five years in length, and the journeyman program another two years.

The time span indicated for Mr. Gardner's rapid advancement would raise a large red flag to most of us in the industry about his training, or perhaps lack of it. Maybe those facts help explain his recent acts of so forcefully preventing a young man who was an applicant for an electrical administrators license in our great state. This young man was not only a third generation electrician, but a graduate electrical engineer. Mr. Gardner led the argument against even allowing this young man an opportunity to be examined. The narrow vision displayed by Mr. Gardner's actions in this instance seem to characterize the fears I and many others have about his appointment to this, or any other policy and decision making board.

Representative Boucher, Alaska has many highly qualified and able persons willing to serve on the Board of Electrical Examiners. Please oppose this appointment and urge perhaps the selection of a female or an Alaskan Native for the position. The native population of the state, as well as the states women are affected greatly by this and other policy making boards, and have been sorely overlooked by the present administration.

Thank you for your letter of March 11, 1986, concerning the impact of sunseting the Board of Electrical Examiners. Since the introduction of SB 384, we have not been involved in any public hearings concerning this bill and are not aware of the Senate Labor and Commerce Committee's disposition on it.

The effect sunseting the board would have on recently proposed regulations depends largely on the Legislature's own action. It would be possible for the Legislature to sunset the board but retain the licensing function within the Department of Commerce and Economic Development. This would likely include retention of the regulations in existence now and the authority to adopt new regulations.

If the Legislature simply does not extend the termination date of the board and does not also repeal the statutes which the board operates under, the department would likely request an opinion from the Attorney General's Office regarding the department's authority to continue the licensing function without the board. Their opinion would also have to address the validity of all regulations currently filed in the Alaska Administrative Code.


The department cannot anticipate the final action of the Legislature. However, if we knew the board would be sunsetted, the department would, under AS 08.03.020, facilitate the operation of the Board of Electrical Examiners as a fully functioning, statutorily authorized board until it actually terminates. This would necessarily include the processing of proposed regulations in a fair and reasonable manner until the board terminated.

March 21, 1986

Aside from questions regarding whether or not the board will sunset, it is unlikely at this time that current funding will permit the board to take action on these regulations via a short teleconference meeting in April or May. It is possible that no action will be taken until the board meets face to face, which will happen in early Fiscal Year 87. In that case, the board's decision will be made in light of whatever action the Legislature has taken on SB 384.

Your concerns for these regulations will be expressed to the board.

It was good to hear from you in regards to your letters about the Board of Electrical Examiners on February 12 and 20. My apologies for the delay in response, but the past two weeks numerous legislators and staff, including myself, have been quite ill with some viral pneumonia bug that has been going around.

I took the liberty of passing on a copy of your February 12 letter regarding the proposed regulation changes of the Board of Electrical Examiners to Senator Zharoff as Chair of Senate Labor and Commerce, to Rep. Navarre as Chair of House Labor and Commerce, and to Commissioner Lounsbury.

There is currently no bill dealing with extension of sunset of the Board of Electrical Examiners in the House; and in Senate Labor and Commerce SB 384 had a hearing already. While nothing specific was decided, it appears that that Committee is leaning towards sunseting the Board, in accordance with the Legislative Budget and Audit report and recommendation on the matter. I have enclosed a copy of that report for your reference.

Because the Legislative Budget and Audit Report recommends that certain functions such as licensing be retained by the Dept. of Labor if the Board is sunsetted, this would require that a bill be passed by the legislature to allow this. I am not certain, but it appears you are opposed to any regulation or licensing by the Board or the Department, and hence, the passage of any bill at all.

I would appreciate your reading the enclosed LBA report and passing on your comments back to me. There are safety and insurance problems that would have to be worked out if licensing were completely eliminated; your comments here would be helpful.

It appears that with the Senate already beginning to hold hearings on this matter, it is only a matter of time before the bill starts to move. Meanwhile, I will request of the Commissioner of Commerce that approval of the newest proposed regulations be held up until the hearings are complete on the Board sunset.

I look foward to hearing from you.

As you know I have long been opposed to the operations and procedure employed by the board of electrical examiners. I have personally suffered greatly from their acts or failure to act. The behavior of the Department of Commerce personnel and the appointed board members, should at the very least prompt an investigation by the legislature before allowing further funding.

Notice is hereby given that the Department of Commerce and Economic Development, Board of Electrical Examiners, under authority vested by AS 08.40.045, AS 08.40.050 and AS 08.40.195, proposes to adopt, repeal and amend regulations in Title 12 of the Alaska Administrative Code dealing with the qualifications for an electrical administrator license in outside linework and inside wiring categories, inspection of examination papers, exemptions from continuing education requirements, certification of supervision, change of employer affiliation, and other general provisions to implement AS 08.40.045, AS 08.40.050, and AS 08.40.195 as follows:

1. 12 AAC 32.011 is amended to accept experience as an electrical inspector or instructor toward meeting the requirements for a license in the outside linework category;
2. 12 AAC 32.090 is amended to accept experience as an electrical inspector or instructor toward meeting the requirements for a license in the inside wiring category;
3. 12 AAC 32.240, which provides for inspection of a failed exam up to 30 days before the next exam, is repealed;
4. 12 AAC 32.350 is amended to provide for exemption from continuing education requirements for reasons other than "reasonable cause or excusable neglect";
5. 12 AAC 32.900 is amended by adding a new subsection (c) to require that an electrical administrator certify in writing his or her supervision of a project when it is demanded by the Department of Commerce and Economic Development or the Department of Labor in compliance with AS 08.40.195;
6. 12 AAC 32.910, DEFINITIONS, is renumbered to 12 AAC 32.990, DEFINITIONS;
7. 12 AAC 32.910 is added as a new section to require an electrical administrator to notify the department in writing of a change in employment or company affiliation; and
8. 12 AAC 32.990(7), formerly 12 AAC 32.910(7), defining "reasonable cause or excusable neglect," is repealed.

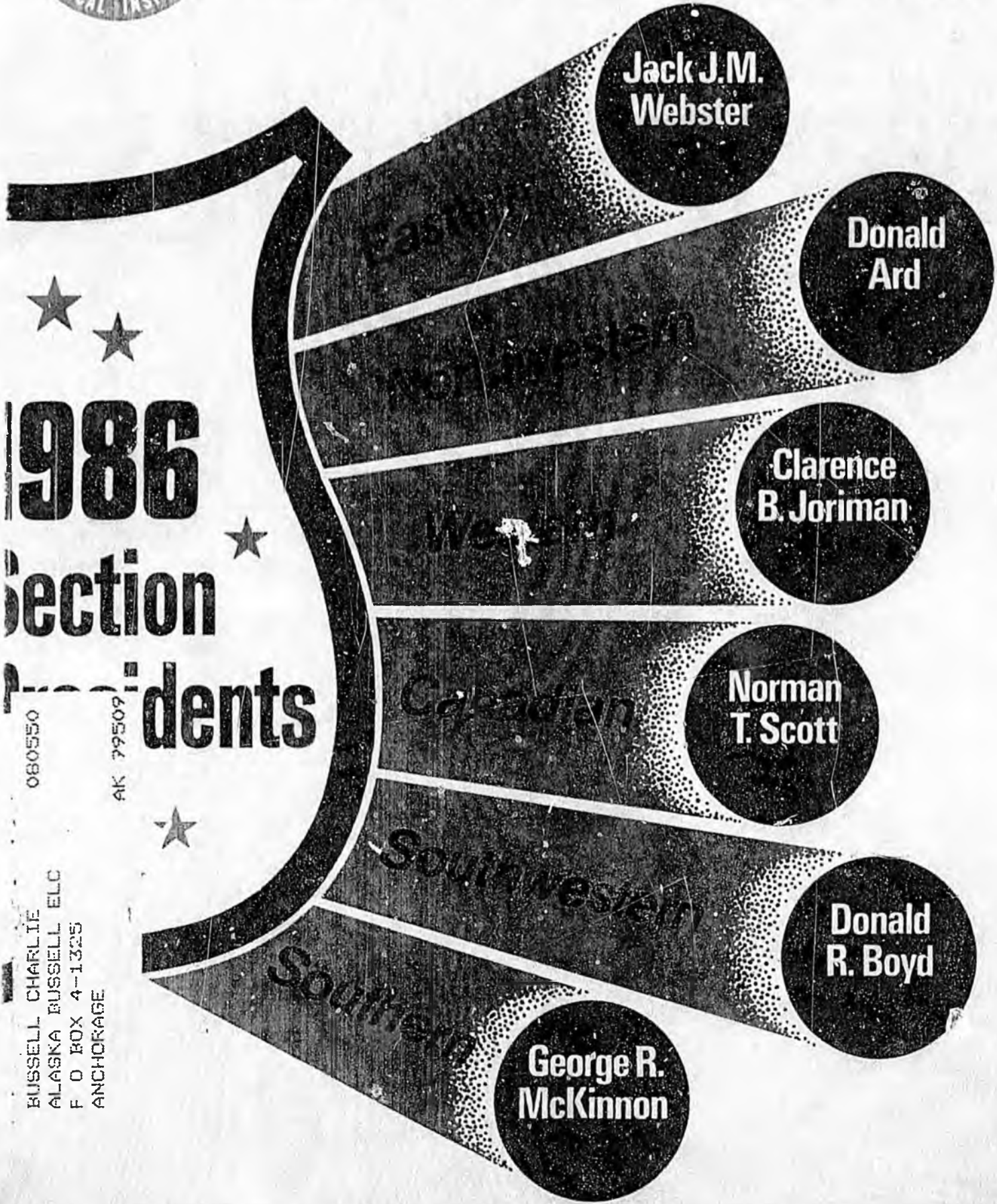

license, clearly should have the examination waived and be issued a license, that is one of the reasons we have the state journeyman's examination that is given by the Department of Labor. No one can perform electrical work without obtaining the certificates of fitness by passing that examination.

As for Commissioner Lounsbury's response to recommendation number 6, he is simply mistaken on several points. I am licensed in a number of states, and have personally spoken to several of their board members. I have found no one who has been contacted by anyone from the state of Alaska regarding this matter, nor has anyone indicated even the slightest reluctance to responding in a helpful manner, if asked.


The commissioner has also received some bad information regarding the development of multi-state electrical testing. There are such tests and services available. I have enclosed a copy of a short article which appeared in the March/April issue of the IAEEI news. This article perhaps will answer any questions you may have about this matter. The passion for obstruction continually employed by this administration must be extinguished.

As for the \$85,000.00 mentioned by the commissioner to develop a new examination, you may wish to see just who received the money, and what the state in fact received for it. When you learn who received the grant money let me know, it may be interesting.

1. We should sun-set and, or through, other legislation rid ourselves of the present highly costly and ineffective system.
2. We should limit licensing to smaller projects such as single family homes, duplexes, perhaps even 4 or 6 plexes. Small projects most often have little or no involvement with an architectural or licensed engineering firm which develop or oversee building or project construction. This is the area of greatest risk to the general public and other states have, and are turning to this form of license.
3. The state should begin treating the administrators for what they are. Many Alaskan electrical contractors are prevented, because of there union labor agreements, from even picking up a screw driver, or speaking directly to a journeyman electrician at a project. From my point of view, I have little problem with these and other similar industry wide work rules. The installing journeymen electricians and their foreman, are highly skilled, highly paid, and highly motivated professionals. They are that way not because the state wants them to be, but because the industry demand it of them, and they, not the state, built the industry.

Once again, thank you for asking me to comment on this matter. If I can be of further assistance please do not hesitate to contact me. By working together we can change things, and do something positive about the state we are in.

MULTISTATE ELECTRICAL LICENSING TEST Licensing Examinations For Electricians

MANY MEMBERS OF THE INTERNATIONAL Association of Electrical Inspectors are familiar with the Construction Code Inspector Certification Examinations developed by Educational Testing Service (ETS). The joint goal of this testing program was to provide nationally recognized evidence of competence and professionalism in construction code enforcement. The expertise of this same organization, ETS, has also been used in developing an examination program for licensing electricians. It's called the Multistate Electrical Licensing Test (MELT) and offers examinations in two areas:

- journeyman electricians
- master electricians/electrical contractors

MELT was created to meet the need of electrical boards for tests that would allow licensing candidates to demonstrate their technical competence, including their knowledge of and ability to apply the National Electrical Code. MELT is an all-inclusive testing program performing the following services for electrical licensing agencies:

- providing candidate test registration forms, information bulletins containing sample questions and a content outline of the examinations, and specific fact sheets for each jurisdiction including its fees and testing locations;
- registering candidates, issuing admission tickets, and distributing a candidate roster to the licensing agency;
- administering the test every other month, including all provisions for testing sites and staff;
- developing new versions of the examinations each time the tests are given, and providing statistical assurance that scores from any version of the test are comparable to scores from every other testing; and

- scoring the examinations, performing quality control checks, and issuing individual score reports for candidates as well as a score roster for the licensing agency.

The charge for these services can be covered in a testing fee paid directly by the licensing applicant, therefore requiring no expenditure on the part of the licensing agency. Participation in the program can actually save money for the licensing agency by eliminating expenses for test development, test administration, and test scoring.

ETS began test development by conducting a job analysis with expert representation from licensing jurisdictions across the nation. These representatives identified the actual tasks involved in the electrical jobs to be tested. The MELT job analysis identified 54 tasks as critical and important to the job of journeyman and/or master electrician/electrical contractor. A list of these tasks is available by calling any of the representatives listed at the end of this article. The tasks were grouped into nine sub-areas:

- raceways,
- service feeders and branch circuit equipment,
- motors and generators,
- utilization and general use equipment,
- special occupancies,
- grounding and bonding,
- calculations and computations, and
- administrative/management activities.

These tasks and groupings form the blueprint for the examinations. Each test must match this blueprint in order to assure that it meets the objectives for the test, that each content area is covered, and that the section for each content area includes the same number of questions as are contained in that section in all other forms of the test. This is one of the ways in which standardization and fairness are assured for all candidates.

After the task list was completed, the committee of electrical experts began the process of developing examinations. The

committee worked with ETS professional testing staff to develop test specifications derived from the job analysis, and were then trained to write test questions based on those test specifications. During the next six months, the examinations were pretested by several joint Apprenticeship Training Council classes, and committee members worked with ETS to improve the final test questions and format of the tests.

The MELT Advisory Committee continues the same process today. Representatives from user jurisdictions meet annually to review the job tasks, write new test questions, and recommend policy direction for the program.

This full-service program is providing electrical licensing tests for the states of: Arkansas, Connecticut, Delaware, Idaho, Massachusetts, Montana, and Wyoming. The MELT program is available for use by local licensing agencies as well.

ETS provides a secure, fair, and objective examination program, developed to assess national standards of competence in electrical occupations. Educational Testing Service has been in the business of developing and administering examinations for almost 40 years. MELT and the Construction Code Inspector Certification Examination are developed by a division of ETS, the Center for Occupational and Professional Assessment (COPA). The COPA staff works solely on providing examinations and services in occupational and professional fields. COPA works with federal, state, and local government agencies, a wide variety of professional and occupational associations, and private industry.
