Primary Transportation Committee Objectives for 1985

1. Legislative Response to Repeal of ATC

Problem: The ATC has been abolished, and the public perceives there will be safety problems left in the void. The administration will apparently propose a bill to transfer the embodiment of the ATC (including much of its economic regulatory authority) into DPS. Chairman Coghill, on the other hand, does not intend that the will of the electorate be violated, and proposes a bill to simply establish safety inspections for the trucking industry.

2. Highway maintenance and shoulder widening

Problem: General highway maintenance throughout the system is never enough; additionally, the lack of shoulders on extensive portions of highways in the Interior continues to be a leading cause of traffic accidents and fatalities. The chairman would like to examine DOT/PF highway projects now on the drawing boards, and determine with the department which could be delayed in order to free up funds for highway shoulders. This would be most successfully accomplished under the banner of highway safety upgrades.

3. Alaska Marine Highway

Problem: What place, if any, can high-speed ferries have within the marine highway system? DOT is satisfied that there is a need for economically-operated high speed ferries in Southeastern, although not necessarily jetfoils. Commissioner Knapp has isolated the biggest money loser to be the deep southeastern village runs with ferries of the Aurora class, carrying crews of about 27, and seldom full. He would like to replace these slower ships on those runs with catamarans, surface-effect ships or other high speed, low crew alternatives.

Problem: To what extent will the Ketchikan Maintenance Facility be developed and put to use? The construction of the maintenance facility is progressing on schedule, however, DOT will be looking for funding for a ship-lift or drydocking apparatus in order to fully utilize the facility's potential. With such a device, the maintenance facility would be capable of actually hauling-out the ferries, as well as other large commercial or coast guard vessels, if needed. Without it, the maintenance facility will not actually offer anything more than is already available in Ketchikan. Opposition to completion and use of the facility will come from Seattle interests who stand to lose business when the ferries pull their maintenance out of that port, as well as from crewmembers who prefer to spend the 2 or 3 months in Seattle, rather than Ketchikan.

Problem: Warehousing. It is DOT's intention to reduce to a minimum its warehouse space at Pier 48 in Seattle when the new maintenance facility comes on line, and thereafter warehouse most of its

spare parts in Ketchikan. Offices, waiting rooms and ferry access ways in Seattle would be renovated at that time.

Problem: Availability of ferry space during the tourist season. This problem would probably be alleviated somewhat if the LeConte and the Aurora are freed up from village runs by the inception of high speed service.

Problem: Labor. Ferry workers have taken a strike vote, and are authorized for an April 1 strike, if negotiations on their new 3-year contract break down. The State is in a position in these negotiations where the farm was given away long ago, and we are now having to recoup, and try to bring the wages and benefits in line with industry standards.

Problem: Westward expansion. Should ferry service from Southeastern to Southcentral be contemplated by the State? What problems and costs can be expected?

Problem: Haines-Juneau connection. Should Juneau become the northern terminus of the Southeast run, with the highway extended to Haines and Skagway, connected by a shuttle ferry across Lynn Canal? What costs and problems are involved, compared to continued mainline ferry service?

4. Alaska Railroad Oversight

Problem: The State has just established the Alaska Railroad Corporation, taking over ownership and control of the line on January 5. Should the committee contract to have the operation of the railroad monitored, as House Transportation is apparently going to do, or should we leave the board alone for an initial honeymoon period, simply monitoring it from here?

5. DOT/PF Capital Projects

Problem: DOT has a year-old Capital Projects Cleanup project, due to wrap up its activities this Spring. Its objective is to get under control all the CIPs with which DOT is charged, and, in the process, establish an accounting system designed to ensure that the morass is not allowed to grow again. We will need to receive the report and understand it; we will need to have a working knowledge of the new CIP tracking system in order to properly be able to put its information to use.

6. Jones Act

Problem: The Federal Merchant Marine Act has the undesirable effect in Alaska of raising the price of virtually everything shipped into the state. How active should be the committee's role in the effort to persuade Congress to repeal the Act? The Governor has been instructed by the electorate, through Ballot Measure 3, to do all he can

to get Congress to repeal it, and to report on his efforts and the effect of the Act annually until it is repealed. The committee, short of an active role itself, might at least monitor the Governor's activities in relation to the initiated law.

7. Oil export to the Far East

Problem: By Federal law, Alaskan oil cannot be exported, yet, economically, it doesn't make sense not to. Should the committee take an active lead in lobbying Congress to repeal the provision disallowing export, or should we merely monitor the situation, keeping members informed on the issue? Should oil export be viewed in context with other exportables - coal, timber, minerals, foodstuffs, etc?

8. Gas pipeline

Problem: To bring North Slope Gas south to tidewater for market to the Pacific Rim. How deeply involved should the committee become with the Hickel group promoting the pipeline? What realistic alternatives are there to it? Will the State get involved in its financing?

9. High Float Emulsion

Problem: Asphalt may not be the ideal material for roads located in northern regions. DOT is experimenting with roadways surfaced with high float emulsion, a process developed in Yukon. Progress and conclusions regarding experimental surfaces ought to be monitored by staff to keep committee members informed. If the new materials are successful in maintaining a longer-lasting, lower cost road surface, the Legislature probably would want to use it throughout the system.

10. Overlapping road-building authorities

Problem: Road-building capabilities and authorities overlap among State agencies to the extent that often one agency doesn't know what the other may be doing, and proper maintenance is neglected as a result. For example, in DNR the division of parks builds trails and roads in parks, the division of forestry builds roads for timber sales and for fire-fighting, and the division of agriculture is responsible for putting roads into agricultural areas. To what standards these roads and trails are constructed apparently varies, and what may be required to upgrade them as public use demands remains a mystery, because there is no central clearing-house to keep track of them. Perhaps another category of road ought to be created, somewhere between a trail and a secondary highway; something like a "resource road". Some study ought to be given to how these roads ought to be managed, and by whom. For example, if there is a 1 mile long road connecting a village to an airstrip, perhaps the division of aviation ought to be responsible for it.
