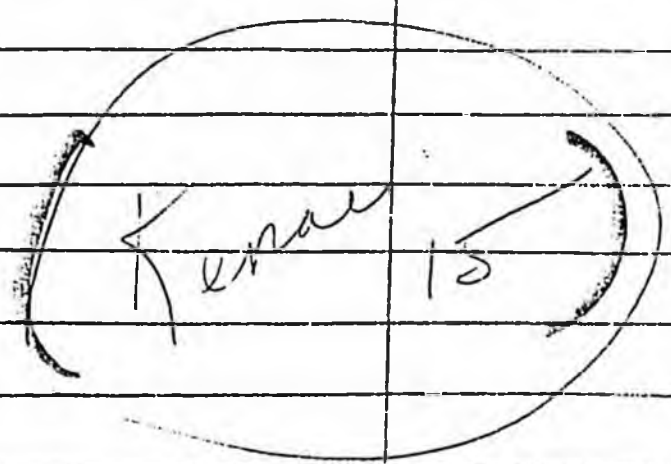

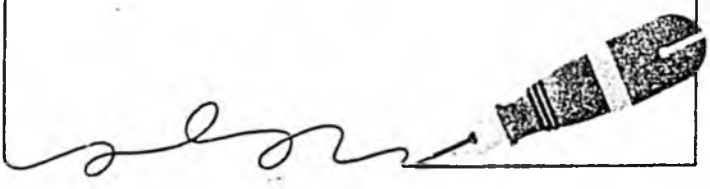

POSITION PAPER

HOUSE CS FOR CS FOR SB 226

For an Act entitled: "An Act relating to the violation of compulsory education laws."

This bill would amend AS 14.30.030 to provide procedures for referring children who do not comply with AS 14.30.010 - 14.30.040 to the Department of Health and Social Services for adjudication as a child in need of aid. This bill would also amend AS 47.10.010 (a) (2) to include habitually absent from school as a reason to adjudicate a child as a child in need of aid after the procedures in AS 14.30.030 have been exhausted.

School attendance is compulsory under AS 14.30.010 for "every child between seven and 16 years of age." Section 14.30.020 indicates that a person violating the attendance laws is "guilty of a misdemeanor and upon conviction is punishable by a fine of not less than \$50 nor more than \$200, plus the cost of prosecution, and may be imprisoned until the fine and costs are paid or until he has served one day for every \$2 of the fine and costs, at which time the fine and costs are automatically discharged." The Department would recommend that this section be implemented to handle truancy problems.

In 1977 a Children's Code Task Force, after considerable study and deliberation, recommended that truancy be eliminated as a reason for justifying adjudication of a child as a child in need of aid. The Department supported this recommendation which was accepted by the Legislature and became law. The Department does not consider truancy alone as sufficient justification to intervene in family matters and to initiate court action. If the Department is required to assume this additional responsibility it would be very costly, requiring the hiring of staff to deal with this problem area. In addition, if a child protection situation such as abuse, neglect, or abandonment exists in addition to habitual truancy, the Department can intervene and initiate court action under AS 47.10.010 (a) as it presently reads. Under AS 47.17.010, schools are required to report child abuse and neglect situation to the Department of Health and Social Services.

AS 14.30.050 authorizes governing bodies of school districts to appoint truant officers, if law enforcement agencies are not able to enforce AS 14.30.010. The Department of Health and Social Services believes that the truant officer function appropriately remains within school districts and should not be subsumed under the Department of Health and Social Services.

CONTINUATION of FISCAL NOTE ANALYSIS

For Bill/Resolution No. SB33

This bill amends AS 14.30.20 by deleting a provision in the current statute that, at the end of the school year, discharges and releases persons from penalties arising from the violation of the state's compulsory education law. Current statute provides that a parent, guardian or other person having control of a child between the ages of seven and 16 years may be fined between \$50 and \$200 for each violation, plus the cost of prosecution. A violator may be imprisoned until the fine and costs are paid or until the person convicted has served one day for every \$2 of the fine and costs.

Deletion of the end of the school year discharge and release provision will probably result in 15 to 25 new prosecutions each year. This minimal number of minor cases will not have any fiscal impact. It is problematic that the department will be able to handle any increase in workload, particularly of this minor nature, given the substantial decrease in attorney resources that the department faces in the coming fiscal year. Certainly, this additional prosecution tool will be available in the most egregious of cases.
