Dear Governor Cowper:

I'm writing to express my grave concern over your recent nomination of Samantha Castle to the Board of Game. In recent statements at the last meeting of this Board, Ms. Castle took the time to explain her game management philosophy and her views on the subsistence priority and the Division of Subsistence. I've enclosed a transcript of her remarks for your information. It's with this philosophical statement that I have problems.

As you know, the state has been deeply wounded by the debate over whether or not residents living in rural Alaska who depend on fish and game resources for their livelihood ought to have a priority over the taking of those resources. In 1978, and again in 1986, the legislature enacted statutes that established the taking of fish stocks and game populations for subsistence use as the priority use. In addition, the 1978 statute established a Division of Subsistence within the Alaska Department of Fish and Game to gather information which would enable the Boards of Fish and Game to implement that priority.

The implementation of the 1978 statute was initially fraught with controversy. Many of the problems were purposely caused by members of the Boards who opposed the priority and tried to prove that it could not be implemented. As a result, the controversy did not begin to die down until 1982 when voters, on a statewide ballot, affirmed their support for the priority and new members were appointed to the Boards. Since then, the Board members have worked in good faith to implement the priority in a fair and reasonable manner.

It's because the subsistence law has been working that I find the recent remarks of Ms. Castle's so troubling. On her own initiative, at the Board of Game's last meeting, Ms. Castle explained her game management philosophy and her views on the subsistence priority and the Division of Subsistence. After

reading the transcript, her hostility to the Division of Subsistence and to the implementation of the subsistence priority in the manner the legislature has intended is clear and unequivocal.


In 1986 the legislature took extraordinary care to identify the group of Alaskans who engage in "subsistence uses" of fish and game. The legislature did not delegate the Board of Game the authority to determine which Alaskans engaged in "subsistence uses" should benefit from the priority and which should not. And contrary to Ms. Castle's understanding of the situation, the legislature did not intend the Board to only implement the priority in situations in which the Division of Subsistence can prove the need to do so by presenting evidence that meets a higher standard than "beyond a reasonable doubt".

I also find troubling Ms. Castle's game management philosophy as outlined in the transcript in which she professes she intends to "consistently vote against the non-resident reduction of allocation" and "vote for liberalization of all seasons for all groups of users". To do this would be to take a giant step backward. There are simply too many people competing for the opportunity to hunt too few animals. It's this type of philosophy that contributes to the hardships on villages who directly depend upon access to game populations for their survival.

We have made too much progress since 1982 in implementing the subsistence priority in a fair and reasonable manner to take a step backwards now. Individuals who sit on the Board of Game have a responsibility to uphold the laws of our State regardless of their own personal views. The recent statements made by Ms. Castle leave a very large question of doubt as to whether or not she would be able to fulfill that responsibility.

I would urge you to review the transcript and her nomination, in light of these recent statements. Thank you very much for your attention to a matter which is of serious concern to AFN and its members.

Let the record show that Castle, Bennett, Johnson and Huntington are present this morning in order to reach a positive action on a proposal we have to have the consent of four. Last night when we left the meeting we had Table Proposal 131 and had quite a bit of discussion and interactions with the advisory committees in that area. Does anyone wish to bring it back on the table? Samantha, Sidney moved, is there a second? Seconded by Samantha. Samantha.

SAMANTHA CASTLE

I'd like to speak to this proposal and also this proposal by the way is 131, is that the one we are working on?

Yes ma'am.

Ok. And also to some other trends that I see developing that are making me very nervous. As a new Board member I just need to discuss these things with you. First of all, John I want you to take note here, I want to be properly quoted. I want to introduce myself. People have been asking who I am, and what sort of philosophy I have and it's all kind of summarized in Proposal 131. So I want to introduce myself properly to you today. I'm Samantha Castle. I'm your new Board member and I'm going to try to tell you the things I believe in. The last couple of days have really been hell for me as those of you who

have been here know, and out of respect for the Board members and the learning process, the immense amount of information that I've been having to process, I have chosen not to be very vocal. But we're embarking on what I think are some dangerous trends and I can't be quiet any longer, as those of you who know me very well realize its been a struggle. So I want to tell you what I believe in and how I'm going to vote consistently.

I believe in Sid Huntington. I have more respect for Sid than anyone else in this room. His honesty and his concern for the people and the animal resources of Alaska are absolutely beyond reproach. Sidney, you know how much I care and how much I appreciate your years of service on this Board, but I'll tell you something, I'm going to disagree with you today.

I believe in the people of Alaska and I believe they can manage their own resources - what's left of them. I appreciate the assistance given by the federal government and the dollars spent by them, but I also understand that this is a reciprocal arrangement. Much land has been put aside for public viewing and study populations. Alaska provides a great opportunity for citizens of the world to participate in the resources Sidney and I love so much. I believe that what's left in the state needs to be managed for maximum sustainable yield. Each of our animals

has great value. I believe that we should be good stewards of what we have to provide for maximum yield for the people of Alaska.

And I believe in the subsistence priority. Those people who need these resources are top on my list. My actions throughout my adult life have proven that I am aware of these people who have needs much greater than my own and I've spent all of my non-working time actively working on a one to one basis to see that those needs are being met. My reputation for doing that type of work is one of the prime factors in the Governor's decision to put me on this Board. But I know the differences between need and greed. At Thanksgiving I don't give turkeys to Natives who think that it's their right to get one. I take the limited supply of the resource at hand and allocate it to the people who are legitimately in a tough spot, and sometimes that means I say no.

Yesterday this Board decided to extend the subsistence season by 11 days to the people of the Northway area and shorten both the resident and the non-resident season by 10 days. I contend that the Division of Subsistence had no evidence to support the idea that the people of Northway did not have a reasonable opportunity to get what they need. This was an arbitrary decision based on some sort of hidden agenda that a new Board member did not and should not be aware of. And while I'm on the subject of the

Subsistence Division, though I admire it - actually feel awe for the volume of work that is done, I do not feel that in some cases I am receiving the type of information which allows me to make an informed decision. I believe that I am a logical and consistent person and I'm having to work too hard to justify the decisions made. Please do not tell me Subsistence Division, even one more time, that the information that I needed to make that decision was presented last year. I wasn't here last year. I don't care and the two or three new Board members who come next year won't care either. I really appreciate Chris' efforts with the Division of Game to present enough information for a new Board member. I know that he actively did that and I very much appreciate it.

I believe that this allocation problem is a very serious one and I will use a rule of thumb in my decision making process. I will vote no on any move from resident/non-resident classification and of subsistence unless Subsistence Division has verifiable evidence that the people this law was designed to help are actually in need. When the situation appears to be a need vs. greed situation, my vote will be a consistent no. The first time I find that families do not have meat for the table and they have actively made an effort to get it and they really can't get it, my vote will be yes, but you better prove it to me.

Also I will consistently vote against the non-resident reduction of allocation. I believe that the professional guides provide beans to add to the local moose meat and the legal guiding industry in this state is a real asset. At least three times during this Board meeting I have seen discrimination against guides with the handling.

Also I will consistently vote for humans in this allocation problem. We have a limited resource, and there are several factors which can be manipulated, I'm going to vote as the cheerleader for the humans. If the department has to manipulate habitat or predators or whatever, then they can do it. I think the people of Northway and Fairbanks should have meat on the table and I'm going to fight to get it there. I will vote for liberalization of all seasons for all groups of users. I hope you can manage with the idea that humans want a piece of the caribou pie too.

This Board seems to think that it has the responsibility of regulating ethics. I suggest that we should remove the logs from our own eyes before we suggest how someone else should behave. I will vote for all game management tools that are required to get the job of good stewardship of these resources done. I will not tie the hands of the department to provide an opportunity to reach their management objectives. Unethical behavior to me is not in providing for all the needs to manage the resource for the

greatest public good. I did not for one minute think that the Governor would expect me to ignore the needs of the local users in this decision making process of allocation. He appointed me to listen objectively to all needs and to try to strike a balance. I do not see that these issues that face us are decisive but rather they are problems to be solved. They are things that we all need to work on together. Since he appointed me, if he disagrees with my method of problem solving, he can certainly dis-appoint me too. But until he does, I will vote in the consistent ways that I've outlined above and my first vote will be against this discussion of Proposal 131 because it's not focused to solve the real problem of the unregulated outfitter, and the suggested amendments, though we haven't adopted them, would encourage the taking of ruddy moose for subsistence users and that is not good game management. Thank you.

Thank you Samantha. Would you like to speak to Proposal 131.

I vote no on 131.

JOEL BENNETT

I see the morning has turned into something different here than what I expected. I didn't bring a prepared address, but I feel like I need to make a short statement myself because unless anyone sort of interprets what we may feel individually by our

silence. I've been on this Board for 11 years now, and I've seen a lot of Board members come and go. I think it's fair to say that most Board members have the same goals and the same objective and share the same goals and objectives when they enter service on the Board. Some of those goals and objectives Samantha mentioned, and I would like to re-mention them, among them are sound wildlife management, sustained yield harvest, fair allocations between users, and consistent regulations, and I think last but not least in my little short list is a pledge to obey the law whether its federal or state or whether we agree with it or not. It's not the position of this Board to sit here and try to decide whether they agree with a law, whether it's right or not, and it applies to the subsistence law in particular. I've seen Board members sit here and try to use, in the decision making process, a personal preference about whether a law should have been passed or not, and I don't believe that has a place on this Board.

Where I differ somewhat with Samantha is that reasonable people, and I mean Board members, general public, and even biologist differ on how to interpret something. And they differ often on how to accomplish something, what means to use to accomplish something. Reasonable people differ. No person on this Board has all the answers or has the clearest way to see something. I don't think anybody that I've ever seen serve on this Board had the magic ability to be the judge of every regulation that comes

before us and every issue. That's all I have to say. On the point that Sidney raises, I think we're getting away from the regulation here. I see a real concern, I see a possible solution that we can work out here. If we were going to be consistent with addressing this type of a problem and I think we just did that up on the Noatak. Now it may be that on this river its time, as Sidney says, to anticipate a real problem and I don't see any reason why we don't do that. I don't necessarily though see that the background work has been done by Mr. Quimby or by the department to try to offer a solution to that at this point. I think we need to discuss it. What the alternatives and options may be so that this situation that Sidney just mentioned doesn't happen again. I think its necessary to do it now. We're not addressing regulations every year not and I believe that the part of this proposal that has to do with the problem that Sidney talks about is what we should be discussing now and whether there are any options at this point in time to deal with that without unfairly, without unfairly, I say that again, disadvantaging or discriminating against the kind of people that Samantha is referring to. I'd like to hear some more discussion about what possible options we have to deal with that problem.

XT PROCEDURE FOR ALL APPOINTMENTS.
Appointments shall be made in the following manner:

(1) The appointing authority shall, within 30 days of the convening of the legislature in regular session; present to the legislature for confirmation the names of the following persons: (A) persons appointed to a position or membership who have not previously been confirmed by the legislature or either house of it; (B) persons appointed by him subject to confirmation to fill an existing position or membership vacancy; (C) persons to be appointed subject to confirmation to fill a position or membership the term of which shall expire before July 2, following the session of the legislature. If an appointment is made after the deadline but while the legislature is in session, the appointing authority shall, within five calendar days after the appointment is made, present to the legislature for confirmation the name of the person appointed. The deadline may be extended by the legislature by the approval of a concurrent resolution.

(2) When appointments are presented to the legislature for confirmation,

(A) the presiding officer of each house shall assign the name of each appointee to a standing committee of that house for a hearing, report and recommendation; standing committees of the two houses assigned the same person's name for consideration may meet jointly to consider the qualifications of the person appointed and may issue either a separate or a joint report and recommendation concerning that person; then

(B) the legislature shall, before the end of the session in which the appointments are presented, in joint session assembled, act on the appointments by confirming or declining to confirm by a majority vote of all of the members the appointments presented.

(3) When the legislature declines to confirm an appointment, the legislature shall notify the appointing authority of its action and a vacancy in the position or membership exists which the appointing authority shall fill by making a new appointment. The new appointment shall be presented for confirmation to the legislature within 20 calendar days following receipt by the appointing authority of the legislature's notification of its refusal to confirm the prior appointment. If the name of a person is submitted and is not confirmed, the appointing authority may not, upon resubmission of appointments, submit again the name of the person whose confirmation was refused for the same position or membership during the session of the legislature at which confirmation was refused. The person whose name is refused for appointment by the legislature may not thereafter be appointed to the position or membership during the interim between legislative sessions. Failure of the legislature to act to confirm or decline to confirm an appointment during the session in which the appointment was presented is tantamount to a declination of confirmation on the day the session adjourns.

(4) Pending confirmation or rejection of appointment by the legislature, persons appointed shall exercise the functions, and have the powers and be charged with the duties prescribed by law for the appointive positions or membership.

The heads of all principal departments shall be citizens of the United States.

The board or commission may appoint a principal executive officer when authorized by law, but the appointment shall be subject to the approval of the governor.

SECTION 27. The governor may make appointments to fill vacancies occurring during a recess of the legislature, in offices requiring confirmation by the legislature. The duration of such appointments shall be prescribed by law.

ARTICLE IV

THE JUDICIARY

SECTION 1. The judicial power of the State is vested in a supreme court, a superior court and the courts established by the legislature. The jurisdic-

tion of courts shall be prescribed by law. The courts shall constitute a unified judicial system for operation and administration. Judicial districts shall be established by law.

SECTION 2. (a) The supreme court shall be the highest court of the State, with final appellate jurisdiction. It shall consist of three justices, one of whom is chief justice. The number of justices may be increased by law upon the request of the supreme court.

(b) The chief justice shall be selected from among the justices of the supreme court by a majority vote of the justices. His term of office as chief justice is three years. A justice may serve more than one term as chief justice but he may not serve consecutive terms in that office.

(The amendment to this section was approved by the voters of the state August 25, 1970 and became effective October 10, 1970. Subsection (b) was added.)

SECTION 3. The superior court shall be the trial court of general jurisdiction and shall consist of five judges. The number of judges may be changed by law.

Supreme court justices and superior court judges shall be citizens of the United States and of the State, licensed to practice law in the State, and possessing any additional qualifications prescribed by law. Judges of other courts shall be selected in a manner, for terms, and with qualifications prescribed by law.

SECTION 5. The governor shall fill any vacancy in an office of supreme court justice or superior court judge by appointing one of two or more persons nominated by the judicial council.

Also during the open hunt seasons went on enforcement patrols which required checking hunters for licenses and permits. Conducted winter mortality transects for deer and elk. This work consisted of in the field inspections of key winter areas; searching the area for deer/elk carcasses; determine sex and age, physical conditions and cause of death. When time permitted I also gave talks to civic groups, school classes, sportsmans groups on hunting and wildlife management programs. Attend all meetings held by the public and speak on game regulations and policies in an effort to secure public support for our programs; inform people on regulations and laws. There was also the need for capturing of live animals, use of drugs in the captures and utilizing other marking equipment.

Because of the close work with the public and the Kodiak/Afognak/Shuyak area guides it was extremely important to have a knowledge of the State and Federal laws and Alaska State Game Regulations. In this way it was easier to to make recommendations to the staff regarding changes in the hunting and trapping regulations that the public and guides were most concerned about. Then these regulation changes would be recommend to the Board of Game.


