Dear Representative Davidson:

We are writing to urge you to oppose HB 429. Wrangell Resource Council (WRC) is concerned that HB 429 will remove any incentive for the Board of Game or the ADF&G to make management decisions that avoid wolf control, since it requires that wolf control be used anywhere there "might" be a reduction in human harvest. In Southeast Alaska that reduction will most likely be due to severe winters, overhunting, or increasingly, loss of habitat due to logging. HB 429 would make wolves the scapegoat once again.

WRC is also concerned that this bill removes public participation from the management decision process. Please oppose passage of HB 429. Thank you for your consideration.


WHEREAS, permitting moose farming would provide further opportunity for economic development; and



Dear Representative Davidson:

Thank you for the opportunity to testify on HB 429 before the House Resource Committee on April 23, 1992. I appreciate the chance to address the committee despite the limited amount of time available. I would like to address several points I was unable to cover during public testimony.

We are opposed to the kind wildlife management proposed by HB 429, where single species would be manipulated to provide maximum benefit to human hunters regardless of the effects of this type of management on other species of wildlife. This "game farming" mentality which relies heavily on wolf control has been widely disputed and opposed by an overwhelming number of people. Testimony to the Alaska Board of Game over the years shows that this type of management is not acceptable to most people.

It is dangerous to assume that wildlife management can make up for the effects of natural processes such as severe winters or that more intensive management and fewer predators will ever satisfy hunter demand. HB 429, page 3 subsection E, proposes that the Board of Game consider intensive management before restricting human harvest. In cases where human overhunting has cause severe declines in prey populations, then hunting must be restricted. There is no substitute for wildlife management that is sustainable. If hunting levels are not sustainable without predator eradication or severe control programs then they need to be reduced. It is clear the proponents of this bill do not want to accept limitations on what natural systems can produce. We do not feel that wild predators should pay the consequences of insatiable human demand for ungulates.

Despite assertions to the contrary by the drafter of this bill, the words "intensive management" have almost always come down to one thing, wolf control through the use of aircraft. The bill and its supporters are attempting to direct attention away from wolf control, but even the definition of "intensive management" contained in the bill points to the expected increase in wolf kill programs.

The Board of Game can and already does most of the things that are proposed by this bill. The Board can already legally implement intensive management programs, including predator control. The difference between the current situation and this bill is that the Board would be required to do them. The other big difference is that this bill would remove the public debate over wildlife management. The Board of Game process is already heavily biased in favor of consumptive users and intensive game management even with a public process. This bill would legislate intensive wolf control and remove the public's opportunity to try and influence wildlife allocation decisions. Regardless of whether or not we agree on wildlife management, I hope that we agree that all Alaskans

should have a voice in how our wildlife is managed.

This bill would circumvent future public participation in the debate over wildlife management and would legislate the desires of one interest group. The Alaska Department of Fish and Game is supporting this bill despite the fact that they are currently engaged in a public long-range planning process that would determine exactly if and where the type of management mandated in HB 429 is going to occur. Voting for this bill is the same as admitting that the tremendous amount of money and effort that have been poured into the public planning process over wolf management has been a sham. If the public process is doomed to failure, it will be because ADF&G and the proponents of this bill are forcing intensive wolf control on the public, rather than addressing public concern that wild predators be afforded additional protection. The fact that this bill is being supported by the Administration while they are engaged in a public process to decide this issue makes a mockery of the public process.

Representative Davidson:

This letter to David Kelleyhouse pertains to HB 429, "An Act relating to the powers of the Board of Game". I don't know that the bill will still be before the House Resources committee, but if it is, here is our letter of opposition. I hope it will be of help to you in your capacity as Chairman.

HB 429 is an intensive management bill. That means that it is a wolf control bill. The Northern Center has been deeply involved in the wolf management planning process. The process is designed to identify areas of the state to be managed at varying intensities for wolves and other wildlife. I can tell you that in all the areas that may qualify for intensive management, wolf control is the recurrent method. Wolf control is the state of the art in intensive management, the very bread and butter of ungulate population enhancement. And wolf control is the one of the most controversial issues--legally and morally--Alaska may ever face.

Predictably, we oppose HB 429 on procedural and moral grounds. The enclosed letter to Director Kelleyhouse elaborates on the bill's potential to undermine two years of public planning efforts. Thank you for your time.

David:

I understand that the Department supports HB 429. Your support is confusing and alarming. Confusing because it appears to reverse the department's commitment to the Strategic Wolf Management Plan. Alarming because of its potential impact on the Plan.

The Strategic Wolf Management Plan is an expression of the public and the Board's will. Though imperfect and in need of some revision, the public and the Board of Game have invested almost two years in the planning process. Much has been made of the Strategic Wolf Management Plan and the process itself: consensus, zonal management, an attempt to accommodate all interests. From full protection of wolves to management which abides by the constitutionally-assured principle of sustained yield, the Plan is the only and most important game in town.

HB 429 attempts an end run on the public process. By siding with special interest legislation, the department sheds its thin veil of objectivity, its claim to respect all interests. By supporting HB 429, the department indicates that it has no stock in the plan and no will to see it succeed. Does the department really want to see anything but intensive management? What does the Department have to gain by supporting HB 429?

Rather than support HB 429, it would have been more appropriate and more assuring if the department had simply pointed the authors and sponsors of HB 429 to the wolf management plan to illustrate that their interests are represented--overly so in my estimation. Rather than divide attention on wildlife management, focus it on the plan.

HB 429 appears to undermine the past and ongoing efforts of the wolf management planning process. The legislation compels the Board to consider and allocate for consumptive uses first though the Board is currently required to allocate among beneficial uses of the resources. At the





conclusion of the March Board meeting, the Board deferred final action on the Area Specific Plans so the public could evaluate and possibly revise the management objectives. By legislatively establishing the preferred use of wildlife and compelling the Board to select management options consistent with sustained yield, HB 429 forecloses any meaningful revisions of the management objectives that stray from intensive management.

It seems to boil down to an either or proposition: either the department supports the wolf management planning process and the progress of the plan, or it supports HB 429 and not the plan.

I would appreciate an explanation of why the department supports HB 429, how it views its support affecting the course of the wolf management planning process, and a response to the questions and issues raised in this letter.

Recent letters to the Daily News-Miner illustrate a pervasive ignorance among those in our state who are supporting the Department of Fish and Game's efforts to rekindle wolf control.

Humans have indeed played a role in Alaska's various ecosystems for thousands of years. But now overhunting (as a result of human overpopulation) has drastically affected the way in which humans affect animal populations. There are too many people around to feel justified in hunting just because our ancestors did. Furthermore, the technology that is available to hunters today prohibits us from comparing ourselves to early hunters.

An exponential growth of hunters have been four-wheeling their way into the backcountry, spotting prey with their Super Cubs and killing every animal in sight with semi-automatic weapons. Yet they feel comfortable blaming the reduction of prey population on the wolves. I think it's a cheap shot to now try to wipe out the wolves just so the human hunters have an easier hunt still.

The Associated Press recently reported that the Denali Wolf Study has produced "no indication that wolves are limiting prey populations . . . at present. In fact, cari-

bou are increasing as wolf numbers rise."

It is time for the Department of Fish and Game to start managing human hunters instead of the wolves. It is short-sighted and arrogant to think we can do anything less.

This communiqué is in response to House Bill No. 429. I would like to state my personal views and experience as a wildlife biologist on the issue of game farming. First, commercial production of wild ungulates or game farming offers a way for conventional agriculture to diversify. This diversification is not only beneficial for the agriculture industry which would allow Alaskan producers to place "their peas in more than one pod" but it adds a missing dimension to wildlife management. Wildlife managers often forget that if we are concerned about wildlife management and production of these ungulate species then to meet the needs of today we must diversify wildlife management. Wildlife management is diversified through protected, integrated, and productive management systems. Protected systems involve Parks, however, the land base is limited in size. Integrated or compromise management systems is practiced by most agencies where there is an attempt to balance the needs of other resources with wild ungulates. The missing dimension in most systems is productive management which includes game farming, ranching, and herding. In Alaska, the productive strategies of concern are farming and herding. In the specific case of farming, permissible species can be raised on private land bases and help add this missing dimension of management to our State Goals.

It should be remembered and acknowledged that game farming will not detract from the value of wildlife. But, there will be an additional importance. In Canada, there was a study which investigated the value of wildlife to citizens. They found that while a large portion of the public obtained some value from wildlife there was another group that received no benefit and wildlife was of no importance. This addresses the issue that society is changing and has changed from years past. The issues of concern in past are not resolved by methods which are no longer applicable for today's problems. However, if the large percentage of the public that extract no value from wildlife can obtain some value then we have accomplished an important goal. There is many people in this state and outside that DO NOT HUNT and do not wish to hunt. For these persons and those that extract no value from wildlife, a taste of meat and it's association with a species could prove a benefit. If these people taste the meat and desire more they may recognize its importance and therefore more support for production. What people view as "Wild Life" will not be detracted by game farms. It has been shown in Canada that people enjoy seeing game farmed ungulates but still seeing them in the wild. It is two settings that offer two rewards but both are complementary. For many people, they would never have the opportunity for viewing if not for the game farms. But overall, we address the needs and problems of today and develop diversified wildlife management with the inclusion of productive management systems.

Disease and parasites in game farmed species has been expressed as a major concern and a threat to wildlife. However, the potential threat should be no greater than for other conventional livestock. In addition, animals entering the state will be monitored and scrutinized by the State Veterinarian. It is known that animals permissible for game farming have few unique diseases or parasites and have generally been considered to have

fewer disease/parasite problems than livestock. Because game farmed ungulates represent an economic commodity it is in their best interest to maintain healthy animals that are free of disease and treated for parasites regularly. A greater threat to the game farmer is potentially untreated wild species coming in contact with the ungulates maintained on the commercial game farm. There has been several memos that have been circulated to Legislators that refer to disease and testing and have originated from ADF&G. These memos have not presented all facts about disease testing, disease status, and the disease research conducted by the Reindeer Research Program at UAF in the proper context. In fact, some of the data and facts collected for these memos (apparently from sources other than myself who are not associated with the University) are incorrect. These issues and the overall concept of game farming will be outlined in a separate brief to Mr. Carl Rosler and a copy will be forwarded to your attention. I strongly urge you to carefully weigh the correct facts. However, in summary, brucellosis is being monitored and controlled in reindeer in Alaska. Tuberculosis is being tested for on imports - the problem is not one of a better test needs to be found but rather one for governments to adopt better techniques which are available. If you require further information please contact me.



Bill Title: An Act relating to the powers of the Board of Game and to intensive game management to achieve higher sustained yield for human harvest.

Department Position: Support with amendments.

Background/Legislative Intent: The purpose of this bill is to affirm legislative support for intensive management of game to enhance consumptive use opportunities.

Analysis of Bill/Program Effects: As written, this bill would require the board to direct the department to undertake significant new planning efforts and intensive management programs. Currently, both the board and department have the authority to accomplish the intent of this legislation.

Department Recommendations: The following amendments to the bill are suggested.

Sec. 1. (page 2, lines 19-24)

(11) requiring the department, within the department's ability, to [DEVELOP AND] conduct intensive management programs to restore the abundance or productivity of a game population [RESOURCE OR THE PRODUCTIVITY OF A GAME RESOURCE] as necessary to achieve human consumptive use [HARVEST] goals of the board in an area where [DEPLETION OF THE GAME RESOURCE, OR A REDUCTION OF THE PRODUCTIVITY OF THE GAME RESOURCE, HAS OCCURRED AND HAS, OR IS LIKELY TO, RESULT IN A SIGNIFICANT REDUCTION IN THE ALLOWABLE HUMAN HARVEST OF THE GAME RESOURCE;] it has been determined that

(A) depletion of the game population or a reduction of the productivity of the game population has occurred and may result in a significant reduction in the allowable human harvest of the game population;

(B) enhancement of the abundance or productivity of the game population is feasible; and

(C) the expected benefits to human consumptive use justify intensive management;

(These amendments remove ambiguity from the bill regarding the unit of management, i.e., the game population, and recognize that intensive management techniques have already been developed. The addition of A-C establishes criteria to be satisfied before the conduct of intensive management is required by the board. (A) requires that loss of game or productivity has had or is likely to have a significant impact on harvest. (B) requires that intensive management is feasible: biologically, logistically, and economically. (C) requires that potential benefits justify expenditures for intensive management so that high priority programs are not adversely impacted by new programs with marginal benefits.)

Sec. 1. (page 2, lines 25-28)

[(12) REQUIRING THE DEVELOPMENT AND IMPLEMENTATION OF LONG-RANGE PLANS FOR THE REHABILITATION AND ENHANCEMENT OF GAME POPULATIONS AND GAME HABITAT TO ENSURE OPPORTUNITIES FOR ENHANCED HUMAN CONSUMPTIVE USE OF GAME POPULATIONS IN AREAS IDENTIFIED BY THE BOARD; THE PLANS SHALL BE REVISED AND UPDATED AS REQUIRED BY THE BOARD.]

(This amendment would delete this entire subsection. "Game" is defined as all birds and mammals found or introduced into the state. Therefore, the department and the board may be forced into an impossible situation. Plans require significant investments of staff time and funding. The department currently lacks a large planning staff or the financial resources to accomplish extensive planning. The board and the department already may develop management plans and have completed plans for many species and areas important for consumptive use.)

Sec. 2. (page 2, lines 30-31; page 3, lines 1-2)

(e) The Board of Game shall evaluate the use of intensive management to increase the harvestable surplus of a game population before significantly restricting the taking of the game population [TO PROVIDE FOR PRIORITY USE OF THE GAME POPULATION BY A DESIGNATED SUBGROUP OF RESIDENT HUNTERS OR TRAPPERS].

(This amendment would require evaluation of intensive management before a significant restriction in harvest is imposed. There are important game populations in the state which are not subject to prioritization of consumptive uses among subgroups of resident hunters and trappers. Evaluation should address criteria suggested under AS 16.05.255(a)(11)(A-C).)

Sec. 2. (page 3, lines 3-9)

(f) In this section, "intensive management" means management of a game population [BY REGULATION] to enhance, extend, and develop the game population to maintain high levels or provide for higher levels of human harvest in accordance with the sustained yield principle, including, but not limited to, control [REDUCTION] of predation [ON A GAME SPECIES OR POPULATION], prescribed or planned [AND CONTROLLED] use of fire and other habitat improvement [MANAGEMENT] techniques [TO IMPROVE THE QUALITY OF GAME HABITAT], development or regulation of access, and other management actions; "intensive management" [DOES NOT] may include, but may not be limited to, management of a game population by customary adjustments in seasons, bag limits, areas, or methods and means.

(This amendment would not limit intensive management programs to those that must be authorized by regulation. For example, wolf control programs currently require regulation prior to implementation, but habitat improvement projects do not. The amendment also allows for the implementation of changes in seasons, bag limits, areas, and methods and means as a necessary part of an intensive management program. Regulation, as well as development, of access may be necessary for intensive management under some circumstances.)

Dear Cliff:

I urge you to support this important bill so that Fish and Game may once again take an active management role in improving our wildlife resource. From this we will gain both economic and social benefits. All too often our game management officials take the comfortable attitude that "Nature will balance itself".

The notion that, if wildlife is left alone it will be balanced by nature is idealistic and is an over simplification. Understand, even in nature's beauty, it is extremely cruel and brutal. To maintain a balance, it uses more than a predator/prey relationship. It also uses famine, disease, fire, drought, floods, earthquakes, hurricanes, volcanic eruptions, and so on.

These natural balancing measures are at work continually, not only affecting wildlife, but also human life. In an effort to protect humans, man constantly controls, manages and defends against the forces of nature. To arbitrarily control and intervene with some parts of nature and then think that other parts can successfully balance themselves without man's intervention is ludicrous.

The question is, without man's help, can nature balance wildlife against the immense weight of human impact? In other words, can nature alone balance wildlife against the development of cities, highways, and farmlands, the pollution from automobiles, factories, and chemicals, the loss of habitat, shelter, and food? The answer is no, it cannot, not if civilization is to remain as we know it today.

Since man first walked the earth, Nature has included him as an essential part of the ecosystem. Nature gave man the ability to sustain life through the consumption of meat. Today, man continues to fulfill his place in nature and is no less important to it's balance than the deer and coyote.

Man has been provided with the power of reason, so that he might manage and balance his resources to consistently provide for his needs. Thus, sparing him from the harsh and brutal realities of nature.

To those who suggest we should not manage or control our wildlife in favor of letting "Nature balance it," I must ask:

When did humanity grow so perverted, that in the name of balancing nature it allows for starvation, disease and the devastation of entire animal species? How did a school of thought become so barbaric that in the name of "Animal Rights" it accepts and encourages a pack of animals to capture another living creature and slowly tear it's flesh apart and consume it while still alive?

Would these same promoters lie down in front of a lion and allow themselves to be torn apart? Or sacrifice their children by means of wide-spread starvation and disease for the sake of balancing nature? No, I don't think so.

They will continue to manage and manipulate nature, to minimize the extent of human subjection to such misery. Yet, they would have you believe that other animals can overcome these harsh realities and live happily ever after without man's intervention.

We as a nation fight to protect our homeland, we cultivate are crops and control their pests, we provide our livestock with shelter and safeguard them from disease. We understand very well the extreme importance of managing, controlling and protecting that which is essential to our existence. Yet, some would propose that it is beneficial for our wildlife to go unmanaged, uncontrolled and unprotected.

If we allowed a fox to live within our chicken coupes we would soon have no eggs or meat. Our wildlife is just as susceptible to over-predation and just as essential to the needs of humanity as the barn yard fowl.

We cannot stop the death of an animal. We can only hope to manage our wildlife in a manner that allows for the maximum number of animals to live. And to wisely utilize those animals in a manner that continues to support life as a whole.

If we continue to encourage a "no management" wildlife policy then its future is doomed to a fate far worse than a hunters bullet. Let's apply more common sense and less nonsense to wildlife management.



HB 429: "AN ACT RELATING TO THE POWERS OF THE BOARD OF GAME"

Under Alaska's constitution and laws, The Board of Game has the authority to determine broad policy for the management of wildlife. The Department of Fish and Game has the responsibility to implement these policies. When the inevitable conflicts between user groups arise, the Board's mission is to arrive at a balance between competing interests.

As Alaska's population has grown, hunting opportunities have inevitably diminished, particularly in areas surrounding the more heavily populated communities. This has led to a demand on the part of some hunters for the Board of Game to set management policies that result in the production of greater numbers of game animals for consumptive use.

HB 429, "An Act relating to the powers of the Board of Game", would dramatically change the direction of wildlife management in Alaska by mandating intensive management of game species in certain situations. The bill also defines intensive management, and sets out the circumstances under which it would be required.

Intensive management of wildlife is practiced in some states in the Lower 48, particularly those in which the natural habitat has been extensively altered by agriculture, industrial, and residential use. However, lands in Alaska are for the most part still in their natural state, and have been substantially altered only around communities and along some transportation corridors.

AEL is opposed to HB249. Mandating intensive management unduly restricts the ability of the Board of Game to set policies for the maximum benefit of all of Alaska's wildlife, its habitat, and all wildlife users, both consumptive and nonconsumptive. While a healthy population of game animals is a desirable goal, increasing their numbers at the expense of other species, is not. Intensive management would inevitably lead to increased predator control, alteration of habitat to the detriment of species other than the ones being intensively managed, and hunting and wildlife viewing experiences more like being on a game ranch than in Alaska as we know it today.

Legislation calls for policy to produce more game

Bill Hagar says Alaskans have been cheated by the Alaska Board of Game and the state Department of Fish and Game.

Hagar, an avid Fairbanks outdoorsman who is no stranger to game board members or to state politicians, is bucking to change the direction of game management in Alaska.

He has worked with legislators to draft a bill that would redirect state board members. He is also working as a one-man lobbying agency to see that the bill becomes law.

He wants to see Alaska's countryside, or at least portions of it, supporting all the game it can.

More game would make everyone happy, according to Hagar. Wildlife watchers would have a better chance of seeing wildlife, subsistence priority wouldn't be a worry because there would be plenty of game for all, and sport hunters and guide-outfitters could better fuel

the state's economy if only there were more game.

The problem is that the state board lacks direction, he said. The state Department of Fish and Game is operating under an "eco-management" philosophy—maintaining systems of natural cycling populations rather than consistently, productive populations, he said.

Hagar's role in the game population debate began more than a year ago when he heard Fish and Game biologist Cathie Harms say on television that people take "3 to 7 percent of the harvestable surplus of game."

"So, where does the rest of it go?" Hagar said.

Hagar set about gathering Fish and Game research and extrapolated figures to tally what numbers of game exist in the state, how many animals humans take every year, and where the rest goes.

He ended up with what he calls his "balance sheet." He has circulated about 800 of the game

harvest summaries around the state.

"Everybody argues with the figures," he said. "But nobody argues with the conclusion."

The conclusion is that the other 90 percent of the game goes to natural deaths, mostly predators, he said. Hagar calls that excessive predation.

The solution, he said, is for the game board to direct the Department of Fish and Game to manage game for a 70/30 predator-human harvest ratio, instead of on the current 90/10 ratio.

"The issue has always been a shortage of game, but nobody has focused on why there is a

shortage," Hagar said. "That's what the balance sheet does. Out of that comes the revelation, now let's focus on correcting the problem."

But intensive management schemes generally are opposed by environmental groups. Rex Blazer, executive director of the Northern Alaska Environmental Center.

"Managing wildlife populations in their natural diversity is best for all, including subsistence, in the long run," he said. "Generally, the bottom line on intensive management means you disturb the ecosystem, take out the natural checks and balances and ask for problems down the line. Then if the professional biologists are unable, because of a lack of a budget or lack of knowledge, deal with the problem, then you have a bigger problem than you started with," Blazer said.

Lastly, Blazer said the diversity of Alaska needs to be considered and that "broad

brush" game management policies are "not advisable." "There is some land in this state where it would not be appropriate to manage as though it were a meat locker," he said.

Hagar claims that the writers of the state Constitution intended that "sustained yield" meant Alaska's game would be managed for human harvest.

But instead of an edict to provide food for the residents of the state, "sustained yield" has been interpreted as a guarantee that game populations will continue to exist, he said.

Hagar worked with Rep. Bert Sharp, R-Fairbanks to introduce legislation, HB 429, that would change the direction of the state's boards from one that guarantees healthy populations exist, to one that guarantees a surplus for hunters and fishermen to harvest.

The bill, now in the House Resource Committee, is in its infancy, Sharp said. This legislative session, he wants to get a

Sustained yield

Article VII, Section 4 of the Alaska Constitution states: "Fish, forests, wildlife, grasslands, and all other replenishable resources belonging to the State shall be utilized, developed, and maintained on the sustained yield principle, subject to preferences among beneficial uses."

Gordon S. Harrison, author of "Alaska's Constitution: A Citizen's Guide" explains "this means that resources such as fish, game and timber may not be harvested faster than they can replenish themselves, so that future generations can use and enjoy the same resources. The principle of sustained yield limits the rate at which resources can be harvested"

RE: Cosponsors for HB 429, an act relating to the powers of the Board of Game.

House Bill 429 requires the Board of Game to adopt regulations that provide for maximum sustained yield for human harvest through predator control and game enhancement and rehabilitation. It also requires that the Board develop and maintain a long-range plan for game and habitat enhancement and rehabilitation for the purposes of maximum sustained yield for human consumptive usage. The bill requires that the board take these actions before restricting the taking of game by Alaskan's living outside of the game management area.

This bill would mandate that the past management inaction be transformed into aggressive positive management of the game resource. Thus assuring a more rapid recovery of low game population levels. Management action that keep game levels high is the best way to avoid resource allocation battles. This bill demands performance and results for our management dollars.

Sectional Analysis of CS SSHB 429, 3/19/92

SECTION 1. (a): changes the Board of Game's mandate to include intensive management of game populations for human harvest. This would target areas where the Board determined human harvest was a preferred use of that area.

SECTION 1. (a) (11): requires the Department of Fish and Game to conduct intensive management in areas where game populations are declining and would, or are, resulting in the reduction of human harvest, ie. bag limits or closures.

SECTION 1. (a) (12): requires the development and implementation of long-range plans for game rehabilitation and enhancement for the purposes of increasing human harvest of game species in areas where the Board has determined that human harvest is the preferred use of that area.

SECTION 2. (e): requires the Board of Game to evaluate the use of intensive management of game populations before restricting human harvest to "subsistence-only" hunts.

SECTION 2. (f): defines "intensive management" to include reduction of predators, controlled use of fire to provide improved habitat and improved hunter access to game populations. It does not include current adjustments in bag limits, seasons, areas or methods or means of taking game.
