GOVERNOR'S COUNCIL FOR THE HANDICAPPED AND GIFTED
AS 47.80.030

The Governor's Council for the Handicapped and Gifted is located within the Department of Health and Social Services but is the inter-departmental planning and coordinating agency of the Department of Health and Social Services, the Department of Education, and other departments that deliver services to persons who are handicapped or gifted. In addition, the council is the state planning council for the purposes of federal laws relating to the handicapped or gifted.

Purpose: The council is to serve as a forum by which issues and benefits regarding current and potential services to handicapped and gifted persons may be discussed by consumer, public, private, professional, and lay interests. The council is also to advocate the needs of handicapped and gifted persons before the executive and legislative branches of the state government and before the public. In addition, the council is to perform a number of other functions that relate to services to handicapped or gifted persons.

Originating Legislation: Chapter 165, SLA 1978

Status: Active. Meets approximately three times a year.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: None.

Board Membership: The council consists of no fewer than 18 nor more than 23 members appointed by the governor as follows:

- (1) at least one-third of the members shall be representatives of the principal state agencies concerned with services for handicapped or gifted persons;
- (2) at least one-third of the members shall be developmentally disabled persons or parents or guardians of such persons, who are not officers or directors of an entity, or employees of a state agency, which receives funds or provides services under PL 91-517 or PL 94-103; and
- (3) the remaining members shall be appointed to represent the public at large, local agencies, non-governmental agencies, and groups concerned with services to handicapped or gifted persons.

GOVERNOR'S COUNCIL ON VOCATIONAL AND CAREER EDUCATION
AS 14.35.010

The Governor's Council on Vocational and Career Education is established in federal public laws and is budgeted within the Department of Education.

Purpose: The council advises the Governor, Legislature, State Board of Education, Job Training Council, Board of Regents and the business community concerning the:

- (1) the coordination taking place between, and the effectiveness of implementation of, the Job Training Partnership Act;
- (2) the extent to which vocational education and employment and training programs meet the economic needs of the State;
- (3) implementation of the state plan under the Perkins Act;
- (4) greater incentives for joint planning for vocational education and employment and training programs; and
- (5) the council's review of the Department of Correction's education programs.

Originating Legislation: PL 101-392, 20 U.S.C. 2322

Status: Active with approximately four meetings annually.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: None.

Board Membership: The council has thirteen members appointed by the governor as follows:

- (1) five members from business, industry, trade organizations and agriculture;
- (2) two from labor organizations; and
- (3) six representing the public sector.

**HAZARDOUS SUBSTANCE SPILL TECHNOLOGY REVIEW COUNCIL
AS 46.13.110**

There is established in the Alaska State Emergency Response Commission the Hazardous Substance Spill Technology Review Council.

Purpose: The council shall review and recommend to the Department of Environmental Conservation (DEC) research topics for it to pursue; establish testing protocols to be used by DEC to evaluate the effectiveness of hazardous substance spill technologies for use in the State; identify sources of money that may be available for discharge-related research; make proposals to the governor, commission, and other entities to encourage and fund prevention, response, cleanup and mitigation of future discharges of hazardous substances; and compile and maintain specific hazardous spill technology information.

Originating Legislation: Chapter 190, SLA 1990

Status: Active. Meets approximately four times a year.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: None.

Board Membership: The council consists of 11 members as follows:

- (1) the commissioner of the Department of Environmental Conservation;
- (2) the adjutant general of the Department of Military and Veterans Affairs;
- (3) a representative of the University of Alaska appointed by the governor;
- (4) the governor's senior science advisor;
- (5) a representative of the Prince William Sound Science Center in Cordova appointed by the governor; and
- (6) four other members, one from each judicial district of the State, appointed by the governor, with broad experience or expertise in one or more of the following areas: physical or biological science; oil technology, transportation, or management; fisheries; economics; environmental engineering; or law.

The U.S. Coast Guard and the Environmental Protection Agency may each appoint a federal employee to the council to represent their agencies as non-voting members.

HEALTH RESOURCES AND ACCESS TASK FORCE
House CS for CS for Senate Concurrent Resolution No. 10

The Health Resources and Access Task Force is a temporary Task Force within the Department of Health and Social Services.

Purpose. The purpose of the Task Force is to: (1) design a cost-efficient program that allows access to a basic level of health care services for all state residents; (2) continue the work of the Health Care Cost Containment Task Force in seeking to achieve savings in the cost of health care in the State; and (3) define a strategy for implementing a health care program covering all Alaskans and a strategy for continuing to contain the costs of health care in the State.

Originating Legislation: House Committee Substitute for Committee Substitute for Senate Concurrent Resolution No. 10, SLA 1991

Status: Active. Due to terminate February 1, 1993.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: None.

Board Membership: The Task Force consists of 17 members as follows:

- (1) three members of the Senate appointed by the president of the Senate;
- (2) three members of the House of Representatives appointed by the speaker of the House of Representatives;
- (3) three persons representing the executive branch, appointed by the governor; and
- (4) eight members chosen by the members appointed under (1) through (3) above as follows: one individual representing the medically indigent, one individual representing private employers who are not health care providers, two individuals representing health care providers, one individual representing a health insurer that offers health insurance in the State, one individual representing nonprofit organizations, one consumer of health services who is not an employer or health care provider, and one individual representing labor organizations.

HISTORIC SITES ADVISORY COMMITTEE
AS 41.35.110

The Historic Sites Advisory Committee is created in the Department of Natural Resources (DNR).

Purpose: The purpose of the committee is to develop criteria for the evaluation of state monuments and historic sites and all real and personal property which may be considered to be of historic, prehistoric, or archeological significance as would justify their acquisition and ownership by the State. The committee also cooperates with DNR in formulating and administering a statewide historic sites survey under 16 U.S.C. 470-470n (PL 89-665, National Historic Preservation Act of 1966). The committee also performs other duties as they relate to historic sites and state historic, prehistoric, and archeological resources.

Originating Legislation: Chapter 130, SLA 1971

Status: Active. Meets approximately three or four times a year.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: None.

Board Membership: The Historic Sites Advisory Committee members are appointed by the governor and confirmed by the legislature meeting in joint session. The committee consists of seven members as follows:

- (1) the director of the Alaska State Museum;
- (2) the state liaison officer appointed under 16 U.S.C. 470-470n (PL 89-665, National Historic Preservation Act of 1966);
- (3) three persons with professionally relevant backgrounds appointed from each of the following fields: history, architecture, and archeology; and
- (4) two persons appointed to represent indigenous ethnic groups.

HISTORICAL RECORDS ADVISORY BOARD
National Historic Publications and Records Commission

The Historic Records Advisory Board is not created within any specific department but is affiliated with the Department of Education.

Purpose: The purpose of the committee is to review project requests and grant applications relating to historic publications and records.

Originating Legislation: None

Status: Active. Meets approximately twice a year.

Travel and Per Diem: As authorized by federal government.

Compensation: As authorized by federal government.

Board Membership: The Historical Records Advisory Board consists of at least nine members appointed by the governor. One member must be involved in local government records. A majority of the members must have recognized professional experience in administration of historical records or in a field of research that makes extensive use of such records. Members should also be representative of public and private archival and research institutions and organizations. Two member must be the State Historical Records Coordinator (State Archivist) and a designee from the Office of History/Archaeology yet these two members serve as ex-officio.

AS 18.80.010-.300

This is created in the office of the governor a State Commission on Human Rights.

Purpose: The purpose of the commission is to seek out and eradicate discrimination in employment; credit and financing practices; places of public accommodations; and the sale, lease, or rental of real property.

Originating Legislation: Chapter 15, SLA 1963

Status: Active. The commission shall hold a regular annual meeting and shall hold special meetings as necessitated.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: None.

Board Membership: The commission consists of seven commissioners, appointed by the governor and confirmed by the legislature.

Special Facts: The commission is a quasi-judicial agency.

Compensation: None.

Board Membership: The Humanities Forum has 13 members. Ten members are appointed by the Humanities Forum in the following categories: University personnel (academic humanists) and general public with consideration given to geographical representation. Three members are appointed by the governor as gubernatorial representatives on the forum.

INCENTIVE AWARDS BOARD
AS 39.51.110-.200

The Incentive Awards Board is established in the Division of Personnel in the Department of Administration.

Purpose: The board may authorize the commissioner of a department or the executive head of an agency other than a department to pay an employee a cash award and incur necessary expense for the honorary recognition of the employee if the employee has contributed to the efficiency, economy, or other improvement of state operations by a superior suggestion, invention, accomplishment, or other superior personal effort in connection with or related to the employee's official employment.

Originating Legislation: Chapter 60, SLA 1989

Status: Statutes for the Incentive Awards Board will be repealed as of July 1, 1993.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: None.

Board Membership: The board consists of:

- (1) the director of the Division of Personnel in the Department of Administration;
- (2) the directors of the Office of Management in the Office of the Governor; and
- (3) a public member from the private sector with experience in accounting and management appointed by the governor.

Special Facts: Meetings of the board are open to the public. The board shall adopt regulations and conduct hearings under the Administrative Procedure Act. The board shall submit a report regarding the operation of the awards program to the governor and the legislature by January 15 of each year. The report must include the name of each person who received an award, the basis for making the award, and the amount of the award. Members of the board may not receive an award.

The Interstate Oil and Gas Compact Commission is a national commission representing 35 states.

Purpose: The purpose of the Interstate Oil and Gas Compact Commission is to work for laws, regulations, and advanced technology to conserve oil and gas, to research topics concerning enhanced recovery, environmental problems, legal and engineering concerns and geothermal potential.

Originating Legislation: Congressional Authorization in 1935

Status: Active.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: None.

Board Membership: The governor serves as the State's representative to the commission. Each governor also appoints an official representative to the interstate Oil and Gas Compact Commission to represent the State in the event the governor is not able to be present. An associate representative is also appointed by the governor.

JOB TRAINING COUNCIL
 PL 97-300 and State Administrative Order No. 110

The Job Training Council is within the Department of Community and Regional Affairs.

Purpose: The purpose of the council is to facilitate training and employment opportunities for individuals with serious barriers to employment. These individuals are the economically disadvantaged, people dislocated from employment including older workers and disabled individuals, and youth at risk of economic disfranchisement due to educational deficiencies.

Originating Legislation: Administrative Order No. 74, March 1983 and PL 97-300

Status: Active.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: None.

Board Membership: The council is composed of at least 20 members who reasonably represent the population of the State. The governor may designate other cabinet level or executive office officials, in addition to those specified as full voting members.

Currently there are 22 members appointed by the governor. These members are:

- (1) six chief executives/operating officers from private business;
- (2) one senator;
- (3) one representative;
- (4) the commissioner of the Department of Community and Regional Affairs or designee;
- (5) the commissioner of the Department of Health and Social Services or designee;
- (6) the commissioner of the Department of Labor or designee;
- (7) one postsecondary representative;
- (8) two local government/education representative;
- (9) three organized labor representatives;
- (10) three community based organization representatives; and
- (11) two public representatives.

**JOINT FEDERAL-STATE COMMISSION ON POLICIES AND PROGRAMS
AFFECTING ALASKA NATIVES**

The Joint Federal-State Commission is established in federal public law.

Purpose: The purpose of the commission is to identify specific actions that may be taken by the United States and the State of Alaska to help assure that public policy goals are more fully realized among Alaska Natives.

Originating Legislation: PL 101-379, August 18, 1990

Status: Active. This commission will cease to exist 180 days after submission of its report which shall be 24 months from the date of its first meeting. The first meeting took place February 25, 1992.

Travel and Per Diem: All members of the commission shall be reimbursed for travel and per diem in lieu of subsistence expenses during the performance of duties of the commission. Travel and per diem is paid only while the member is away from home or their regular place of business, in accordance with subchapter 1, Chapter 57 of Title 5, United States Code.

Compensation: Each member of the commission not otherwise employed by the United States government or the State of Alaska shall receive compensation at a rate equal to the daily rate for GS-18 of the General Schedule under section 5332 of Title 5, United States Code, for each day, including travel time, such member is engaged in the actual performance of duties (including service on a task force) authorized by the commission. State and federal employees serve without additional compensation.

Board Membership: The commission consists of seven members appointed by the president and seven members appointed by the governor. In addition, there are ten ex-officio members. Three of the presidential appointees must be natives.

JUDICIAL COUNCIL
Alaska Constitution IV-8

The Judicial Council is located within the Alaska Court System.

Purpose: The purpose of the Judicial Council is to nominate persons to the governor for any agency in an office of supreme court justice, court of appeals judge, superior court judge, district court judge or the public defender. The council also conducts studies for improvement of the administration of justice and evaluates judges standing for retention election and publicizes findings and recommendations.

Originating Legislation: Alaska Constitution, January 3, 1959

Status: Active. Meets approximately four times a year.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: None.

Board Membership: The council consists of seven members. Three non-attorney members appointed by the governor, three attorneys appointed by the Bar Association, and the chief justice.

JUVENILE JUSTICE AND FAMILY SERVICES ADVISORY COMMITTEE

The Juvenile Justice and Family Services Advisory Committee is in the Department of Health and Social Services.

Purpose: The purpose of the committee is to assist the Department of Health and Social Services in strengthening and improving the social services and juvenile justice systems at all levels.

Originating Legislation: Juvenile Justice and Delinquency Prevention Act of 1964 and Title IV-B

Status: Active. Meets four times per year.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: None.

Board Membership: The board consists of 15 to 33 members appointed by the governor. Members include representatives of state agencies concerned with services; representatives of professional, civic, or other public or private organizations; private citizens interested and experienced in service programs; and recipients of assistance or services. At least one-fifth of the committee shall be under the age of 24, three of whom have been under the jurisdiction of the juvenile justice system.

LOCAL BOUNDARY COMMISSION
AS 44.47.565-.583

There is in the Department of Community and Regional Affairs a Local Boundary Commission.

Purpose: The commission shall: make studies of local government boundary problems; develop proposed standards and procedures for changing local boundary lines; and consider a local government boundary change requested of it by the legislature, the commissioner of the Department of Community and Regional Affairs, or a political subdivision of the State. The commission develops standards and procedures for the extension of services and ordinances of incorporated cities into contiguous areas for limited purposes upon majority approval of the voters of the contiguous area to be annexed. The commission also prepares transition schedules and prorated tax mill levies as well as standards for participation by voters of these contiguous areas in the affairs of the incorporated cities furnishing services.

Originating Legislation: Chapter 64, SLA 1959

Status: Active. The chairman of the commission or the commissioner with the consent of the chairman may call a meeting or hearing of the local boundary commission. All meetings and hearings shall be public.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: None.

Board Membership: The commission consists of five members appointed by the governor for overlapping five-year terms. One member shall be appointed from each of the four judicial districts described in AS 22.10.010 and one member shall be appointed from the State at large. The member appointed from the State at large is the chairman of the commission.

Special Facts: Public notice of a hearing of the commission shall be given in the area in which the hearing is to be held at least 15 days before the date of the hearing. A local government boundary change may not be proposed to the legislature unless a hearing on the change has been held in or in the near vicinity of the area affected by the change.

MANPOWER SERVICES COUNCIL
AS 44.99.010

The Alaska Manpower Services Council was created without identification of a specific department. At one time, the council was identified with the State Department of Labor, yet more recently was identified with the Department of Community and Regional Affairs. No members have been appointed to this board since 1983. Similar duties are now handled by the Job Training Council.

Purpose: The purpose of the commission was to review and monitor all manpower activities within the State and advise and make recommendations concerning manpower activities to the governor, prime sponsors under the Comprehensive Employment and Training Act of 1973, State manpower, and the public.

Originating Legislation: Chapter 174, SLA 1975

Status: Inactive. The last appointment was made in 1983.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: Statutes are silent concerning compensation.

Board Membership: AS 44.99.101(b) requires the membership of the council to be as provided in the Comprehensive Employment and Training Act of 1973 (PL 93-203; 29 U.S.C. 801) Our review showed that on October 13, 1982, the president signed into law the Job Training Partnership Act (PL 97-300) which, among other things, repealed the Comprehensive Employment and Training Act.

Administrative Orders No. 122, 113 and 74, signed by former Governors Cowper and Sheffield established the Job Training Council to meet requirements under the Job Training Partnership Act of 1982.

MARINE PILOTS, BOARD OF
AS 08.62.010-.990

The Board of Marine Pilots is within the Department of Commerce and Economic Development.

Purpose: The board shall: provide for the maintenance of efficient and competent pilotage on the inland and coastal water of and adjacent to the State; adopt regulations establishing the qualifications of and required training for pilots and providing for the examination of pilots and the issuance of original or renewal pilot licenses to qualified persons; and adopt by regulation maximum tariffs that may be charged by pilots for the provision of specific pilotage services.

Originating Legislation: Chapter 106, SLA 1970

Status: Active. The board shall hold at least three regularly scheduled meetings each year. The board may hold special meetings at the call of the chair or at the request of a majority of the members of the board.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: None.

Board Membership: The board consists of:

- (1) two licensed pilots who have been actively engaged in piloting on vessels subject to Chapter 62 (Marine Pilots);
- (2) two agents or managers of vessels subject to Chapter 62;
- (3) two public members in accordance with AS 08.01.025; and
- (4) the commissioner of the Department of Commerce and Economic Development or the commissioner's designee.

Special Facts: Board members are appointed by the governor. All board members must be residents of the State.

Purpose: The goal of the local panel is to reunite the children with their families by ensuring the services are available and appropriate for reunification, and if reunification is not in the best interests of the child to expeditiously place the child in a secure, permanent home. The panel is to review the case plan of certain children (under AS 47.10.080(b)(3), (c)(1), or (c)(3), 47.10.142, or 47.10.230(c)) in the custody of DHSS who is in a placement other than the child's own home. The local panel is to review a case required within 180 days after the child is initially removed from the child's home and every six months thereafter. A court review may be substituted for a review required under this subsection if the court review meets the requirements of this subsection.

Originating Legislation: Chapter 117, SLA 1990

Status: Inactive since inception due to lack of funding. The departments appoint their own local panels to meet the same goals and ensure compliance with federal requirements.

The Yukon-Taiya Commission was created in the Office of the Governor. No members have been appointed to this board since 1974.

Purpose: The purpose of the Yukon Taiya Commission is to seek the initiation of a joint U.S./Canada study of the Yukon-Taiya hydroelectric project and related resources development. The commission is authorized to conduct studies, compile and publish information, and provide the good offices of the State for encouraging the development.

Originating Legislation: Chapter 85, SLA 1967

Status: Inactive. The last appointment was made in 1976.

Travel and Per Diem: Standard as authorized under AS 39.20.180.

Compensation: Statutes are silent concerning compensation.

Board Membership: The commission consists of five persons to be appointed by the governor. The governor shall appoint a chairman. Legislators are eligible for appointment to the commission. Each member serves at the pleasure of the governor

Special Facts: The commission shall report annually to the state legislature and the governor concerning the work of the commission and shall recommend legislation by Congress and the State to carry out the proposes of this chapter.

I. INTRODUCTION

Governor Hickel appointed the Governor's Task Force on Boards and Commissions in October 1991. It was formed for the purpose of making recommendations to the Governor on reducing the cost and management demands of boards and commissions.

The task force was given 4 specific goals:

1. Review the purpose and intent of each board and commission.
2. Review the constitutional accountability of each board and commission, as well as statutory accountability, and identify federal requirements.
3. Identify the actual cost to the State of Alaska for each board and commission, including revenue source.
4. Analyze the data collected and make recommendations for improving the efficiency, determining the necessity for existence, and evaluating the performance of each board and commission.

II. SCOPE OF STUDY

Background information on each board was reviewed by members in order to gain an understanding of the function and purpose of each board's existence. Information such as the membership composition and size, number of meetings each year, workload of board members, legal or advisory functions, statutory, constitutional, or public law authorities was used in the task force's study. Membership on boards and commissions totals almost 1500 people.

A. Board Duties.

In terms of the power, or authority, that is held by a board, there are basically three categories.

- Quasi-Judicial: Legal findings can be made and enforced. Such is the case with the Workers' Compensation Board. This board can make legal determinations on disputes under the Workers' Compensation Act.

- Regulatory: Policies and procedures of an industry are regulated. The occupational licensing boards are examples of regulatory boards.

- Advisory: Principal responsibility is to do research, gather public input, and advise an agency, commissioner, the governor, or legislature. The Governor's Council on Developmental Disabilities and Special Education is an advisory board.

In addition, there are public corporations, temporary task forces, and boards that serve to direct the operations of a particular agency, such as the Board of Education, that don't fall neatly into these 3 categories. All boards which rely on the governor for appointments or nominations, regardless of their varying jurisdictions, are included in the task force's recommendations.

B. Board Authorities.

This study included boards with statutory, constitutional, and federal authority, or a combination of these authorities. It also included interstate commissions and temporary task forces, and all other boards which depend upon governor's appointments or nominations. Boards were divided into categories, based upon their authorizing law. (See Appendix C for categories.)

C. Public Process

To present a starting point for the task force's deliberations, a list of preliminary recommendations was prepared. Input was sought and received from departments, boards and members of the public. Productive discussions, debates, and correspondence resulted from the original and amended preliminary recommendations. The process included 5 statewide teleconferences, with 15 sites across Alaska participating overall.

D. Cost Analysis

Funding sources and amounts vary tremendously with each board. To produce the operating cost of all boards and commissions, each department prepared fiscal notes for all boards, commissions, panels, committees, and councils under their administration, using the standard fiscal note form. Some boards are not a part of an agency's budget component, but are still dependent upon an agency for support, using agency staff, travel monies, etc. Cost estimates were requested for these boards, and were compiled, along with the costs of boards that have specific budgets, to produce the following summary.

III. RECOMMENDATIONS

The task force has several recommendations which it presents to Governor Hickel. Many of these recommended changes would require statutory revision. In cases where federal requirements exist, the task force intends that any statutory changes be done in accordance with the federal requirements authorizing or funding that particular board.

Reductions

Beginning with 158 boards and commissions, the task force recommends that:

- Sect. I. 19 be consolidated into 8
- Sect. II.A 11 be eliminated
- Sect. II.B 9 not be extended past their sunset/termination date
- Sect. III 98 preserve their status as separate boards
- Sect. IV 2 new boards be established
- Sect. V 19 have no recommendation at this time, but should be held for further review

If these recommendations were put into effect, and no changes were made to the 19 being held for further review, the total number of boards and commissions would be 127, a reduction of 31 boards and commissions.

A. General Recommendations

* All licensing boards be required to establish professional fees sufficient to cover their costs plus a prorated share of the overhead costs of agency services to these boards and commissions.

* The Commissioner of the Department of Commerce and Economic Development be allowed to contract on an annual basis with professional associations to perform licensing, subject to a yearly, independent audit.

* Compensation to board members should be standardized.
